<u>Speaker Hofschneider</u>: We're back to our session. For the benefit of the members please insert GOV. COMM. 13-207, which is in your materials but inadvertently left out on the agenda. This has to do with the deadline of July 1 for a submission on any revision to the budget submission and pursuant to the requirements, it was submitted on July 2nd. Essentially in the message, the Department of Finance projected a decrease in the revenues previously submitted to the Legislature as a result of the poker license fee being increased. Therefore, logically, that will be less machines renewed or applied for and on the basis of the letter, the Secretary of Finance has projected a "best estimate" that thirty percent of the licensed machines will not be renewed. Therefore a revision on the estimated 2003 revenue purports to go downwards. In anticipation of that, the Administration submitted a cushion in the form of a gaming machine jackpot tax increase from ten percent to twenty percent. This is purported to cushion the downward projection on poker licensing. So please include GOV. COMM. 13-207. Floor Leader?

Torres: Mr. Speaker, relative to House Communications 13-6 and 13-7 just to apprise the members, I read in the paper yesterday and today that the shareholders-Directors are still adamant and arguing that the \$1.3 million dollars is not their money anymore and they are trying to convince the court that the court should handle it. I think that interprets or ... trying to get away from criminal action. Mr. Speaker, I would like to take the opportunity under the House Communications if I may? I have a speech to deliver. [M]y dear Mr. Speaker and fellow colleagues, I am on the verge of a head-on collision with our Governor on two issues: the current dilemma of (1) the salary cap and (2) contractual obligations incurred within our Executive Branch. I am not satisfied with the way this administration is heading. The Governor's course is like the Titanic's maiden voyage to America. When she left England, it was said that she unsinkable. Our Governor too, during the election was unsinkable. But with the current trend, he is heading towards a political debacle. As we are the elected representatives of the people, we must come to a closure on these two issues that I have mentioned. It is our constitutional responsibility to safeguard the way our government operates and ensure that taxpayers are protected in how their money is spent. What is disturbing is that this administration promised changes and hope; but what I see is different. To me, the fox has become a permanent fixture in the chicken coop and has forgotten his manners. Basically, we have laws that are not being obeyed. It seems that when one is appointed or sole sourced by the Governor, they are given a free reign to decide how much they should make and not comply with our laws. When we came into office as our people's representatives, we swore to uphold the laws. I am sure that those souls that were appointed have done likewise. In all fairness, when they chose to accept their appointment, they also chose to serve the people. Public service is a virtue not a means for a pay raise or to carry over their higher salary. The next item is about Mr. Chuck Jordan's contract with the Governor. On June 24, 2002, I requested the Public Auditor to provide your Committee on Ways and Means for copies of Mr. Charles (Chuck) Jordan Statement of Financial Interest. They declined to release such. However, they recommended I ask Mr. Jordan for a waiver, in order to get such documents. Two days ago, I wrote a letter to Mr. Jordan to authorize the Public Auditor to release these documents. Mr. Jordan responded that he would not waive such right and wanted to protect his privacy. Mr. Speaker and fellow colleagues, it disturbs me that he would use this to protect his privacy. If nothing is amiss, then why should he hide? Another aspect that disturbs me most of Mr. Jordan's current contract with the Governor is that it creates a new type of employment status within our government. The proposed status that the Governor wants us to accept is that Mr. Jordan would become both an employee of the CNMI and a contractor. Since, Mr. Jordan has chosen to enter the doors of being a public servant and contractor, and in the best interest of our taxpayers, I am asking this house to authorize your Committee on Ways and Means to conduct a full investigation into Mr. Charles Jordan. This investigation is needed and comes not a minute too late, since we are all accountable and must ask ourselves: Do we really need another Special Assistant for CIP and a contractor at the same time? Wouldn't it be more reasonable for the Governor to rely on the Department of Public Works for technical matters of such magnitude? While the financial aspect of CIP projects be resolved with the CIP Administrator at the Office of Management and Budget. I think these type of pipedreams need to stop and we could better use the money saved for more pressing issues. Therefore, Mr. Speaker, I again ask this house for immediate approval and support for this investigation. Furthermore, your Committee solicits your approval to issue a subpoena to secure a copy of any and all Statement of Financial Interest submitted to the Office of the Public Auditor, by Mr. Charles Jordan. In closing, I've included copies of correspondences in regards to this matter and what really confuses me is that when Mr. Jordan responded to my request, he used the Governor's letterhead!!! Again, is he an employee of the government or a contractor? Commonsense would dictate that using a Governor's letterhead would originate from a true

bonafide government employee and not from a contractor. *Ai adai*, Mr. Speaker, *ton-tu este na taotao*. Thank you. [Stamped and numbered as HSE. COMM. 13-10]

It adds to the layer of consensus by a majority to allow the Speaker or the Presiding Officers to issue a subpoena. Any more comments? Vice Speaker Tenorio?

<u>Vice Speaker Tenorio</u>: Point of information, Mr. Speaker. In the subpoena aren't we required to be specific in what we're after and what would that be that we're looking for?

<u>Speaker Hofschneider</u>: Representative Stanley Torres, in the request seeking a preparation of a House Resolution, could you go over your request specifically on what you intend to acquire?

Rep. S. Torres: At this time, the document that Mr. Jordan has filed with the Public Auditor's Office. I don't know if I can add any other but at this time that's about where I am focusing. But in the event that a document or information arises, I ask the body to probably allow flexibility for another subpoena to be issued to other agencies that requires subpoena.

<u>Speaker Hofschneider</u>: Representative Quitugua, to answer your question specifically under our CNMI statute, Chapter 13, subsection 1301(b), every investigating committee when authorized by either house or both houses, as the case may be, may issue by a majority vote of all of its members subpoenas requiring the attendance of witnesses and subpoena duces tecum requiring the production of books, documents or other evidence in any matter pending before the committee. So it does require the consensus of majority. Any other discussion? Representative Quitugua?

Rep. Quitugua: Mr. Speaker, I'm supporting the issuance of a subpoena to the good Chairman of Ways and Means and Committee. I would like however, Mr. Chairman, that the specifics of the subpoena be articulated so that we go after a specific purpose. I realize, Mr. Speaker, that his power to subpoena documents, to subpoena individuals to appear an appropriate committee is an awesome power. And although I trust the good Chairman of Ways and Means of his prudent pursuit for information, I just want, Mr. Speaker, for the record to state that we use that as prudently as possible. Thank you, Mr. Speaker.

Speaker Hofschneider: Clerk, roll call.

The roll was called the motion offered by Representative Torres, Chairman of Ways and Means for a House Resolution to be prepared sanctioning subpoena power to be granted the Committee relative to documents required by the Committee relating to Mr. Chuck Jordan's contract, which was carried by roll call vote.

Floor Leader Attao: Ready.

There was no discussion and the motion carried by voice vote.

Speaker Hofschneider: Vice Speaker?

<u>Vice Speaker Tenorio</u>: Mr. Speaker, you went too fast on the motion. I just wanted to find out what particular resolutions we're going to be entertaining? And it's odd because I'm sure part of that suspension of motion we passed may be First and Final Reading and maybe some of the members have to review more closely what we're adopting.

<u>Speaker Hofschneider</u>: Floor Leader, could you restate the House Resolutions and the House Joint Resolutions for the benefit of the Vice Speaker?

Floor Leader Attao: Okay, previously adopted H. J. R. NO. 13-012, H. J. R. NO. 13-013, H. R. NO. 13-059 and H. R. NO. 13-060. The other two Resolutions are H. R. NO. 13-057 and H. R. NO. 13-058 to be adopted.

Vice Speaker Tenorio: This is only House Resolution, Mr. Speaker not a House Joint Resolution.

Speaker Hofschneider: H. J. R. NO. 13-012, H. J. R. NO. 13-013 and the rest are House Resolutions. Short recess.

The House recessed at 11:27 a.m.

The House reconvened at 11:35 a.m.

The Chair recognized the Floor Leader.

Floor Leader Attao: Mr. Speaker, I now move for the adoption of H. R. NO. 13-057 and H. R. NO. 13-058.

The motion was seconded.

The Chair recognized the Floor Leader.

Floor Leader Attao: Thank you, Mr. Speaker. I now move for the acceptance of SEN. COMM. 13-054 and SEN. COMM. 13-055.

The motion was seconded.

There was no discussion, and the motion carried by voice vote.

<u>Speaker Hofschneider</u>: SEN. COMM. 13-054 and SEN. COMM. 13-055 are hereby accepted by the House. I recognize the Floor Leader under Bill Calendar.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. On Item 16, Bill Calendar, I move to withdraw from the Committee H. B. NO. 13-111 for today's action.

Speaker Hofschneider: Could you state the title of the Bill?

<u>Floor Leader Attao</u>: H. B. NO. 13-111: A Bill for an Act to amend Section 7 of Public Law 12-64 to appropriate funds to build dialysis treatment facilities on the islands of Tinian and Rota.

Speaker Hofschneider: Thank you. Is there a second?

The motion was seconded.

<u>Speaker Hofschneider</u>: A recall motion on H. B. NO. 13-111 from the Committee has been seconded. Discussion on the recall motion?

There being no discussion, the motion was carried by voice vote.

Speaker Hofschneider: H. B. NO. 13-111 is hereby placed on Calendar. Floor Leader?

Floor Leader Attao: Thank you, Mr. Speaker.

Rep. S. Torres: Mr. Speaker?

The Chair recognized Representative Torres.

Rep. S. Torres: I'd like to recall from the Committee H. B. NO. 13-084, entitled, To create a Marshal Service Division, to be placed on today's calendar, please, for action.

Speaker Hofschneider: Chairman on JGO, what is the status of that Bill?

Rep. Ada: The Report is actually ready, Mr. Speaker, except the forty-eight hours rule for prefiling of reports.

The Chair recognized Representative S. Torres.

Rep. S. Torres: I don't want to put words to my colleague's mouth but I think there ... [end of recording] [beginning of recording] ... report prepared for the approval. So I am recalling that for the House to take action as a full House, if I may make that into motion.

Speaker Hofschneider: Is there a committee report ready?

Rep. Ada: Yes, Mr. Speaker, we have the original. I am in support of the Bill.

<u>Speaker Hofschneider</u>: Floor Leader, to be in line and in order, you don't want to deviate from the House Rule of forty-eight hours reporting for the privilege of the members. Let's all agree to suspend the motion to allow the committee report to appear today until the next session for action so that everyone can digest the committee report.

Floor Leader Attao: Is that for the next session, Mr. Speaker?

Rep. Ada: May I, Mr. Speaker? This Bill is quite controversial but as Chairman and after meeting with the Chief Justice and the Presiding Judge, I have all the backing to justify and defend this part of the Bill and the passage of the Bill.

Rep. S. Torres: Mr. Speaker, I have no problem putting that for the next session. The more it weighs probably, the more members would agree to pass.

<u>Speaker Hofschneider</u>: Chairman Ada, please submit the report to the Floor Leader for the suspension or placement under the Standing Committee Reports.

Rep. Ada: For next session?

Speaker Hofschneider: For next session.

Rep. Ada: Thank you.

Floor Leader Attao: Thank you.

The Chair recognized the Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. Mr. Speaker I would like to make a motion to place H. B. NO. 13-146, H. B. NO. 13-148, H. B. NO. 13-001, HS1, HD1, SD1 (SEN. COMM. 13-054) and also H. B. NO. 13-138, SS1 (SEN. COMM. 13-055) on today's Calendar for action.

Speaker Hofschneider: Floor Leader, my computer is not working today, can you rephrase that motion?

The motion was seconded.

<u>Speaker Hofschneider</u>: Motion for placement on the Calendar for today's action H. B. NO. 13-146, H. B. NO. 13-148, H. B. NO. 13-138 relative to SEN. COMM. 13-055 and H. B. NO. 13-001, HS1, HD1, SD1 relative to SEN. COMM. 13-054 has been seconded. Discussion on the motion? Ready?

Several members voiced, "ready."

The motion was carried by voice vote.

Speaker Hofschneider: Motion carried. Floor Leader?

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. I now move for the suspension of Rule VII, Section 10, Rule IX, Section 9, 10 and 11 for the passage of the following Bills: H. B. <u>Speaker Hofschneider</u>: Suspension motion for those House Bills and Senate Bill has been seconded. Discussion on the motion? Vice Speaker?

Vice Speaker Tenorio: Can I have a copy of the Bills or at least the title before we act on the motion?

Speaker Hofschneider: May we dispose of the suspension motion first and then discuss that? Ready?

Floor Leader Attao voiced, "ready."

The being no discussion, the motion was carried by voice vote.

Speaker Hofschneider: Motion carried. Floor Leader, for the benefit of everyone can we go one by one?

Floor Leader Attao: You want me to read all the Bills now?

Speaker Hofschneider: No, for the passage now.

<u>Floor Leader Attao</u>: Mr. Speaker, I think the procedure is to go one by one. I now move for the passage of H. B. NO. 13-138, SS1 on First and Final Reading.

The motion was seconded.

<u>Speaker Hofschneider</u>: By a vote of seventeen yes, one absent, H. B. NO. 13-138, as amended by the Senate is hereby passed by the House. Floor Leader?

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. I now move for the passage of H. B. NO. 13-001, HS1, HD1, SD1 on First and Final Reading.

The motion was seconded.

H. B. NO. 13-001, HS1, HD1, SD1: A BILL FOR AN ACT TO AUTHROIZE THE MARIANAS PUBLIC LANDS AUTHORITY IN CONJUNCTION WITH THE COMMONWEALTH DEVELOPMENT AUTHORITY TO INCUR PUBLIC DEBT IN AN AMOUNT OF UP TO FORTY MILLION DOLLARS (\$40,000,000.00) FOR THE SETTLEMENT OF LAND COMPENSATION CLAIMS AGAINST THE COMMONWEALTH; AND FOR OTHER PURPOSES.

Speaker Hofschneider: Discussion on the Bill?

Several members voiced, "ready."

The Chair recognized the Floor Leader.

<u>Floor Leader Attao</u>: This is just for the record. On page 3, Section 4 subsection 3, the Senate made an amendment to include, subject to the approval of claims by the Board and also on page 4, Section 8, land exchange option. Those are the two amendments made by the Senate. This is just for the record, Mr. Speaker, Thank you.

<u>Speaker Hofschneider</u>: Since this is a borrowing endeavor it requires a two third majority. Clerk, roll call. Before roll call, Representative Ada?

Rep. Ada: Hagas ha' ta nanga este na Bill. Esta kuarentai kuatru anos yu pa'go. Fa'naan anai disisieti anos yu guenao na tiempo. Na'magof este para i taotao-ta yan hagas ha' ta didibi. Maolek este ti bai hu maleffa ni este na lehislatura yan i gubietno ni para hu sign este. Thank you, Mr. Speaker.

The Chair recognized Representative Stanley Torres.

Rep. S. Torres: Just before we vote on the measure, I'd like to declare conflict of interest. However the magnitude and the length and the benefit it outweighs is my conflict, I will be voting in favor of the Bill.

Speaker Hofschneider: State your conflict, Representative Torres.

Rep. S. Torres: I am still awaiting for my title for land exchange on my Capitol Hill area.

Speaker Hofschneider: Are you seeking monetary compensation?

Rep. S. Torres: No, I'm waiting for an exchange. The previous three governors have approved it; however, I think it's only a paperwork delay. It's considered done.

<u>Speaker Hofschneider</u>: Then you don't have a conflict because you're not seeking monetary compensation. That's a separate business; it's land-to-land exchange; it's not included in the Bill. Thank you. Vice Speaker?

<u>Vice Speaker Tenorio</u>: Thank you, Mr. Speaker. Mr. Speaker, I talked earlier with you about this issue. At first I thought that I might not have a conflict of interest but after reviewing the people that will be receiving funds, I found out that I'm one of the recipients from land I purchased years ago. While this land is still in contest at the court, there's potential that I might be receiving money. So, I looked at the research again myself and I thought that I have a potential conflict of interest. I voted yes on the original package of the Bill and then I found this out so I thought that you should know.

Speaker Hofschneider: You hold title to the property?

<u>Vice Speaker Tenorio</u>: It's a deed that I have, it's questionable now.

<u>Speaker Hofschneider</u>: Vote conflict, Representative Tenorio.

Vice Speaker Tenorio: Thank you.

The Chair recognized Representative Deleon Guerrero.

<u>Rep. Deleon Guerrero</u>: Mr. Speaker, point of clarification. When you mentioned that Representative Torres is not in conflict because this issue of monetary exchange I just want to offer a point clarification because Section 8, subsection (d) does provide for land exchange and he may in fact have a conflict.

<u>Speaker Hofschneider</u>: The statute in existence allows for land-to-land compensation and in practice also monetary compensation. This legislation has to do with borrowing specifically to retire those that are seeking monetary compensation and not land compensation, since it is in place in the Constitution and statutorily provided for. Unless the legislation is specifically granting land exchange, then he has a conflict.

Rep. Deleon Guerrero: Mr. Speaker, that's what this subsection 8(d) provides for. I just want to commend Representative Torres for declaring his conflict.

The Chair recognized Representative Quitugua.

Rep. Quitugua: Mr. Speaker, to what extent does conflict of interest apply that requires a representative to declare?

<u>Speaker Hofschneider</u>: If you have the potential of receiving benefits or interest directly or indirectly on any of the legislations that you are voting for then you are in conflict.

Rep. Quitugua: How about a family member?

Speaker Hofschneider: A family member? Explain.

<u>Rep. Quitugua</u>: On the listing that was provided early on when we were discussing the Bill in the House I found out that my father is one of the individuals that may be receiving either land exchange or compensation, whichever he decides to go for. I just wanted that for the record.

Speaker Hofschneider: Do you expect any benefit of him?

Rep. Quitugua: Personally, no.

The Chair recognized Representative Ada.

Rep. Ada: I think I'll be one of the recipients. Remember Nan Ocha Road? The newly finished road? We have been advised that it has taken a portion of our land. So do we just abstain from voting?

The Chair declared a short recess at 11:41 a.m.

RECESS

The House reconvened at 11:44 a.m.

Speaker Hofschneider: We're back to our session and for further clarification on conflict of interest. Under our CNMI law under Chapter 3 on Conflict of Interest, Subsection 8535(c) a public official may participate in, vote on, or influence, or attempt to influence an official decision if the only pecuniary interest or potential benefit that may accrue to the public official is incidental to the public official's position or which accrues to the public official as a member of a profession, occupation or a larger class. Large class to no greater extent than the pecuniary interest or potential benefit could reasonably be expected to accrue to all other member's of the profession, occupation or a large class. So if you don't have an overriding benefit other than the larger class of your family for instance, this is what it means then you can vote on it.

The Chair recognized Representative Palacios.

Rep. H. Palacios: Mr. Speaker, I would like one of these days to get that terminology changed because the more interest you have the more you would vote yes.

Speaker Hofschneider: Exactly. And the more you're inclined not to vote the more you're in conflict.

Rep. S. Torres: Mr. Speaker, can you expand the meaning of incidental? I know the meaning in my understanding but can you expand?

The Chair declared a short recess at 11:45 a.m.

RECESS

The House reconvened at 11:55 a.m.

Speaker Hofschneider: We are back to our session. Under discussion. Ready?

Several members voiced, "ready."

The Chair recognized the Floor Leader.

Speaker Hofschneider: For the House record, these two legislations represent a good portion of our accomplishment on our agenda in the economic revitalization here in the Commonwealth. The \$2.6 million is much needed infusion into the aggressive promotions and advertising for the tourism industry, we have accomplished that. The forty million would be further augmenting the revitalization of the economy by providing in the hands of those recipients greater economic buying power and hopefully they spend it on island and not elsewhere. So we need the economy to rebound itself. We still have one other legislation in the local delegation and that is the Garment User Tax Increase which is the final component to the economic stimulus package of the House and hopefully we all see eye-to-eye on the issue and support the legislation increasing the Garment User Fee for the tourism revitalization project in Garapan, clean it out and retrofit the Garapan as a central focal point of our island in the Commonwealth for the tourism and the citizens alike. With that, Clerk, roll call.
