Speaker Hofschneider: Any comments on the Messages from the Governor?

Floor Leader Attao: Mr. Speaker?

The Chair recognized the Floor Leader.

<u>Floor Leader Attao</u>: On GOV. COMM. 13-316 relative to the Appropriation and Budget Authority Act of Fiscal Year 2003, I move that the House override all line item vetoes on H. B. NO. 13-170, HD1, Appropriation and Budget Authority Act of Fiscal Year 2003 pursuant to Rule IX, Section 14.

The motion was seconded.

<u>Speaker Hofschneider</u>: Motion pursuant to House Rule for the override of specific line item vetoes for the year 2003 Budget Act is seconded. Discussion on the motion?

Several members voiced, "ready."

Speaker Hofschneider: Ready? Vice Speaker Tenorio?

<u>Vice Speaker Tenorio</u>: Thank you, Mr. Speaker. If I recall correctly during our leadership meeting the legal counsel is supposed to look at the fourteen items that the Governor line item vetoed and to give the members the opportunity to look at it before we take action. I just wonder if that is by-passed so that we can act on this for whatever reason?

<u>Speaker Hofschneider</u>: Yes. After discussing with our counsel, the line item vetoed sections of the budget is the intent of this House and reflected on the consistent views by the Senate reciprocating without amendments. Therefore, the entire provisions of the budget is a product of the House consistent with our voting for the purposes of emplacing those guidelines for the expenditure of 2003 budget. In comparison, the Governor submitted his justification for those specific line item vetoes particularly some sections that he has decided to strikeout in its entirety. More importantly to consider is the fact that some of those line item vetoed are not permitted by law or constitution. One specific example I believe that we've discussed a length in the leadership is that the line item veto exercised by the Governor attempts to reverse the contention of the Legislature, that's not permitted -- from a negative to a positive or from a positive to a negative. The line item vetoes from the Governor is simply that it is the province of this House that we have emplaced some guidelines and we firmly believe those guidelines to be appropriate for the expenditure of public funds for the year 2003. Put that together with the Message from the Governor. No legal and no constitutional issue was raised in his line item vetoes. It is a matter of difference in policy opinion. On one of the sections, which is critical for the Legislature and

the Judiciary is on the issue of limitation -- limits on reducing judiciary and legislative allotment authority. As you recall, this is the first time that the Legislature control that section under impoundment or recession or reduction of allotments to the extent that the Governor is not deprived of that authority but limits its capability, its authority by imposing a three percent rule. He can exercise that section of the Planning and Budgeting Act if the revenue declines appropriately across the board reduction. The safeguard on imposing a three percent maximum ceiling for the Legislative and the Judicial Branch simply preserves the essence of separation of powers. What we have gone through this fiscal year is an exercise in encroachment of the separation of powers when substantive reduction in the appropriation of the budget of the other three branches, the second and the third, the Judicial and the Legislative, almost to a point of incapacitating or paralytic objectivity, it is the concern of this House to preserve its nature and its existence. He disagrees with the three percent rule. Unless we enjoy pain by having to weather out again another twelve percent or sixteen percent cut of each members budget then I rest my case. Three percent is a good rule, it was tested in Connecticut and we did not re-invent the wheel. We follow by examples and in other jurisdictions it is appropriate to preserve the three-branch entity of government. Usurpation by incapacitation, usurpation of power or the jurisdiction of the third branch by reducing the ability of the third branch to function appropriately is in fact an encroachment in the authority and the separation of powers of the third branch. He can disagree all he wants, but it is this house's privilege and province to preserve its very existence. If we do not understand that then we fail to understand the three branch of government and the separation and balance of powers. It's not about money, it's the preservation principal that attacks that section that the Governor disagrees with the Legislature. Having said that, all in all no legal, no constitutional issue was raised. It's a matter of opinion and indifference with an administration. We have to resolve the issue of salary cap and sanctions. We have to control government runaway expenditures. It is the responsibility of the Legislature, particularly the House, to appropriate. The most cardinal of all responsibility of the Legislature rest with appropriation and it rests with the House of Representatives. Not with the Executive Branch, not with the Senate, the House of Representatives and it is found in the Constitution. Unless we disagree with the Constitution then, again, I rest my case. The issue of having controls, an oversight of expenditure by providing those specific languages for the expenditure of certain departments and agencies appropriations or allotments is an historical practice of this government. We did not re-invent the wheel, we did not invent a new wheel, it is, and it has always been, and it has worked, the oversight power of the House and the entire Legislature. If you don't understand that then you have a misconception of your role as a representative. If we do not understand that prescription then we failed to represent the people. Nothing in the Budget Act that was vetoed impairs, diminishes or deletes the Governor's ability to administer programs and services under the Executive Branch, nothing. Strict guidelines are for a purpose quite flexible in nature if one wants to work with those provisions of the Budget Act and as a political suggestion. It is not fitting for a House or a member to spit on the ground and lick it back. The virtues of having casted your "yea" vote must be preserved, the essence of principally governed individuals. We emplaced our intentions clearly, we voted unanimously for those prescriptions in the budget, we ought to do the same and consistent with the override being fully supported. Ready?

## Vice Speaker Tenorio: Clarification, Mr. Speaker.

The Chair recognized the Vice Speaker.

<u>Vice Speaker Tenorio</u>: Thank you, Mr. Speaker. Mr. Speaker, I don't intend to raise any issue that we have on the budget based on the Governor's message for the fact that they're not properly, legally sound. I only raised the issue because we have discussed during the leadership meeting that the legal counsel will come up with the legal reasons behind our plan to override the veto message by the Governor. I realize that everybody in this chamber is aware that he has his own responsibility as a Representative and we also know that the appropriations and the budget is in the purview of the House and you don't have to repeat that. And I don't think that we're licking up our saliva by asking the question. I just want to raise the question because I want everybody to make a sound decision when they override the veto, including myself. I'm glad that you took your time to at least address the various concerns that were raised by the Governor in his veto message. That's all, Mr. Speaker.

### Speaker Hofschneider: Thank you.

Floor Leader Attao: Ready.
