SECOND REGULAR SESSION, 2002

Seventh Day October 30, 2002

The House of Representatives of the Thirteenth Northern Marianas Commonwealth Legislature reconvened on Wednesday, October 30, 2002 at 9:18 a.m., in the House Chamber, Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Heinz S. Hofschneider, Speaker of the House, presided.

<u>Speaker Hofschneider</u>: The House session is hereby convened from recess yesterday and we have a continued quorum. We left the session yesterday at Item 7, House Communications and before we proceed, if any member wishes to go back to Prefiled and Introduction Bills, and Prefiled and Introduction of Resolutions now is the time to request. Representative Palacios.

<u>Rep. A. Palacios</u>: Thank you, Mr. Speaker. If there's no objection, I would like to go back to Prefiled and Introduction of Resolutions.

There being no objection; the House went back to Prefiled and Introduction of Resolutions.

COMMUNICATIONS FROM THE RESIDENT REPRESENTATIVE

The Chair recognized Representative Torres.

Rep. S. Torres: Mr. Speaker, I'd like to request to go back to House Communications.

Rep. Babauta: No objection.

There being no objection; the House went back to House Communications.

HOUSE COMMUNICATIONS

Rep. S. Torres: Mr. Speaker, this is with regards to my letter to DEQ and Division of Sanitation about an overflowing sewage in front of the St. Jude Church in As Lito. As a result of that letter, I received a joint letter from CUC and CPA explaining the main sewer project by PDL. I am a little bit confused or let's say I'm upset because it seems that PDL is holding this project hostage. The two agencies sound like that are appealing to the contractor to consider continuing the project -- as if they are pleading. I also learned that PDL, the contractor is requesting a tax waiver for moneys that they earned from the project. I'd like these two agencies to probably come up here and explain to us in detail what the real problem is. I understand that this project has been put on hold for two years now and it seems that the contractor is the man in charge of this project. If the proper committee would maybe call them in, let's hear what the real problem is. Thank you.

<u>Speaker Hofschneider</u>: Thank you. With that request, I hereby ask the Committee on Public Utilities, Transportation and Communications Chairman Joseph Deleon Guerrero to immediately set up a meeting with the committee and maybe the House members would also like sit in and find out the status of the project and what are the impediments that we cannot complete ... I believe it is going on for more than six years and we need to put a resolution to the project. I know that one of the problems that they have are easement acquisitions. That stalled the project substantially.

Vice Speaker Tenorio: Privilege, Mr. Speaker.

Speaker Hofschneider: State you privilege.

<u>Vice Speaker Tenorio</u>: Mr. Speaker, I want the record to show that I'm present for today's session. Thank you.

Speaker Hofschneider: Thank you, Vice Speaker. Representative Palacios.

Rep. A. Palacios: Mr. Speaker, on the same issue of sewer, sewer lines and whatnot. I think that the assignment to the committee should expand to request from CUC and CRM information relative to the seemingly perennial problems of sewer overflows on the island. I think it's continuous. So I ask that the Committee on Public Utilities, Transportation and Communications in his letter to also advice them to answer some questions relative to sewer systems in the whole island of Saipan.

<u>Speaker Hofschneider</u>: Chairman of the Committee on Public Utilities, Transportation and Communications, take a note of that. I believe that it is an operational intent to discharge sewage in front of PIC, American Memorial Park and some of the Beach Road sewer manholes are spilling in a consistent basis and we need to find out why those occurrences continue. Representative Aldan.

Rep. Aldan: Mr. Speaker, I also want the Chairman to address the Tanapag sewer overflow problem. It seems that every six weeks we have an overflow and it's right there on the beach where the pavilions are, where the people are barbequing every weekend. That problem is very consistent and it needs to be addressed right away.

<u>Speaker Hofschneider</u>: Thank you. It seems like with the exception of Precinct 2, they don't have a sewer problem. Include Precincts 1, 3 and 4 unless the Representative from Precinct 2 ...

Rep. Salas: Mr. Speaker, the Chairman is to my left and I'll be talking to him about it today.

Speaker Hofschneider: Thank you.

<u>Rep. Deleon Guerrero</u>: Mr. Speaker, I believe Representative Palacios' comments included every precinct. He said to look into sewer problems on this island so I think that would be inclusive of all the precincts.

Speaker Hofschneider: Thank you for the correction. Representative Cabrera.

<u>Rep. Cabrera</u>: Mr. Speaker, for the benefit of the members with respect to Precinct 4, I was informed that DEQ has issued a citation against CUC on that overflow -- finally, after so many overflows. And also just yesterday before the session I had the privilege of speaking with various Board members of CUC to prioritize the sewer problem.

<u>Speaker Hofschneider</u>: Find out if they have a master plan to remedy this on a long-term basis rather than to approach it from a citation and a sporadic occurrence.

Rep. Deleon Guerrero: So noted.

Speaker Hofschneider: Thank you.

<u>Floor Leader Attao</u>: Yes, suspension motion for the passage on First and Final Reading H. B. NO. 13-060, H. B. NO. 13-064, HS1, and H. B. NO. 13-173, and to accept Senate amendments on H. B. NO. 13-106, SD1 and H. B. NO. 13-107, SD1.

Speaker Hofschneider: Suspension motion for the passage of the following bills on First and Final Reading: H. B. NO. 13-060, H. B. NO. 13-064, HS1, H. B. NO. 13-173, H. B. NO. 13-106, SD1 and H. B. NO. 13-107, SD1 has been seconded. Discussion on suspension motion?

Several members voiced, "ready."

Speaker Hofschneider: Motion carried. Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. I now move for the passage on First and Final Reading, H. B. NO. 13-106, SD1 as amended.

The motion was seconded.

H. B. NO. 13-106, SD1: A BILL FOR AN ACT TO EFFECTUATE THE TERMS OF THE MEMORANDUM OF AGREEMENT BETWEEN THE COMMONWEALTH DEVELOPMENT AUTHORITY AND THE COMMONWEALTH UTILITIES CORPORATION BY REQUIRING THE COMMONWEALTH DEVELOPMENT AUTHORITY TO WAIVE \$16,068,750.00 OF THE PRINCIPAL OWED AND TO WAIVE CERTAIN SPECIFIED INETEREST PAYMENTS; AND FOR OTHER PURPOSES.

<u>Speaker Hofschneider</u>: Motion for the passage on First and Final Reading H. B. NO. 13-106, SD1, CDA/CUC Waiver has been seconded. Discussion on the bill?

Rep. Babauta voiced, "ready."

<u>Speaker Hofschneider</u>: Mr. Chairman, could you put some legislative history behind it? This is an important legislation and we have to put some legislative history behind it.

Rep. Deleon Guerrero: Thank you, Mr. Speaker. Mr. Speaker, H. B. NO. 13-106 and H. B. NO. 13-107 is a product of both the Administration and the Thirteenth Commonwealth Legislature to legitimize a Memorandum of Agreement between CUC and CDA to address a long standing issue between the two parties regarding a debt. This issue, Mr. Speaker, has gone through several Administrations, several Legislatures and I would like to take this opportunity to thank you, Mr. Speaker and also recognize the efforts of both CUC and CDA to settle this matter out of court. These bills and the Memorandum of Agreement will result in a tremendous benefit not only for the two parties but for the CNMI government in general and most especially to our CNMI taxpayers. So I want to thank all of you for your support, for finally putting this issue to an end and I want to congratulate everybody for their participation and efforts. Thank you, Mr. Speaker.

Speaker Hofschneider: Thank you. I'd like to add a bit more to that and that is, principal plus interest called over almost twenty years for infrastructure development in the Commonwealth amounted close to about a hundred million dollars. It is almost impossible for CUC to live up to its obligation with the loan agreement as originally stipulated with CDA. The original purpose/intent of that loan agreement is for the repayment to be used for economic development opportunities by the citizens of the Commonwealth. They may avail themselves of CDA financial assets to get into business, entrepreneurship. As a result, over a time, we have neglected the ability of the loan or lived up to the conditions. The importance of H. B. NO. 13-106 is converting sixteen million some dollars of the loan itself to specifically dedicate it for sewer and water to be converted into amicable solution and having CUC be able to contribute back to the infrastructure development without using cash as a means of repaying the debt. That's the whole principle of the MOA agreed upon. The accompanying legislation H. B. NO. 13-107 talks about preferred stocks of \$45,000,000.00 and the Senate amendment and included nontransferable. It is contrary to future opportunities for the people of the Commonwealth but we will accept that amendment for now. In the future the people ought to have a participation in the equity of CUC as an investment and these legislations H. B. NO. 13-106 and H. B. NO. 13-107 are the beginning of privatization. It puts the government in a better position to leverage its assets by resolving obligations or debts attributed over time. CUC now is in a better position or posture to be able to

look at a competitive proposal. The non-transferability amended by the Senate preempts the people from actually being offered stocks when CUC power generation is privatized. We will deal with that and I hope that the legislative history speaks clearly that power generation is a moneymaking asset of any public institution and when it is privatize the people ought to partake in those opportunities whether it be a \$10.00 investment in a stock or a \$100.00 so long as the participation is there. That's the merit of H. B. NO. 13-106 and H. B. NO. 13-107. Ready?

NO. 13-064, HS1: A BILL FOR AN ACT TO AMEND TITLE 4, DIVISION 5, CHAPTER 5, ARTICLE 3 BY ADDING NEW SECTIONS TO ENSURE THAT ALCOHOLIC BEVERAGES BOTTLED OR IMPORTED FOR SALE IN THE COMMONWEALTH CONTAIN HEALTH WARNINGS ON THEIR CONTAINERS IN COMPLIANCE WITH FEDERAL LAWS AND REGULATIONS AND TO ENSURE THAT THE COMMONWEALTH DEPARTMENT OF COMMERCE, ALCOHOLIC BEVERAGES AND TOBACCO CONTROL DIVISION HAS THE POWER TO ENFORCE THE REQUIREMENT FOR SUCH LABELING; AND FOR OTHER PURPOSES.

<u>Rep. Babauta</u>: Mr. Speaker, just a simple clarification. May I kindly ask the Chair whether or not the traditional alcoholic beverages are incorporated for such as labeling and stuffs like that?

Speaker Hofschneider: Are you talking about tuba and sakao?

Rep. Babauta: Yes.

Rep. Andrew S. Salas: Thank you, Mr. Speaker. The intent of this bill is to safeguard our people in terms of alcoholic beverages that are imported into the CNMI. As far as the tuba and the sakao, no, Mr. Speaker. [end of recording] [beginning of recording] and that is to help the Division of Customs assess their excise tax and to assist consumers in knowing what they buy when they go to the store because many of the alcoholic beverages are alleged to be food commodities instead of alcoholic beverages and thereby not getting the full assessment of the excise tax due to the CNMI government. And also to fall in line with the federal regulations that tells all US territories that they must comply with federal laws in regards to alcoholic beverages imported into US territories. Thank you, Mr. Speaker.

Speaker Hofschneider: We're under roll call, we're not suppose to be discussing.

Rep. Babauta: Can we have a short recess to clarify something with the legal counsel?

<u>Speaker Hofschneider</u>: Let's finish the roll call and if you have questions that needs to be revisited, we'll recall our action. This is an improper procedure. Clerk, continue.

Rep. Babauta: Thank you, Mr. Speaker.

Speaker Hofschneider: Yield?

Rep. Babauta: Yes, on page 2 there's some reference to line item 21: "State. Includes any political subdivision of any State, the District of Columbia, CNMI, Puerto Rico, American Samoa, ... Midways Islands," and so on. May I ask the counsel why is this incorporated in the bill?

At this time, the Chair declared a short recess at 10:22 a.m.

RECESS

The House reconvened at 10: 31 a.m.

<u>Speaker Hofschneider</u>: We're back to our session and we're the discussing the Alcoholic Beverage Labeling Act that we have just passed. Under discussion I recognize Representative Babauta.

Rep. Babauta: Mr. Speaker, no further discussion. Thank you.

The Chair recognized Representative Deleon Guerrero.

Rep. Deleon Guerrero: Thank you, Mr. Speaker. Mr. Speaker, I would like to offer a motion to recall H. B. NO. 13-033, CS1 from the Committee on Ways and Means, if there's no objection. I'd also like to offer a floor amendment, Mr. Speaker, to this ...

Floor Leader Attao: Out of order, Mr. Speaker.

Floor Leader Attao: Is that a withdrawal from the committee?

Rep. Deleon Guerrero: Yes, recall.

Speaker Hofschneider: Put it on your list, Floor Leader. Thank you. At this time, I recognize the Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. I move for the passage of H. B. NO. 13-060 on First and Final Reading.

The motion was seconded.

H. B. NO. 13-060: A BILL FOR AN ACT TO ESTABLISH A DOCTORAL PROGRAM FOR RESIDENTS OF THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS; AND FOR OTHER PURPOSES.

<u>Speaker Hofschneider</u>: Motion for the passage on First and Final Reading H. B. NO. 13-060 has been seconded. Discussion on the bill? Representative Quitugua.

Rep. Quitugua: Thank you, Mr. Speaker. Mr. Speaker, I would like to offer a floor amendment to the bill. On page 4, line 5 delete "Public Law 12-44" and on line 6 after Public Law 11-25 insert the phrase "not to exceed the total amount on section 5 (c)."

<u>Speaker Hofschneider</u>: Representative Quitugua, could you please submit the committee substitute first and have that adopted so that the subsequent amendments could be in order? We're amending the original bill but there is a committee substitute to be offered today.

Rep. Quitugua: That is correct, Mr. Speaker. After consulting with the Floor Leader, I will withdraw my offered amendment.

Speaker Hofschneider: And the committee has to place the committee substitute 1 officially on the floor.

Rep. Babauta: So moved.

Floor Leader Attao: So moved.

<u>Speaker Hofschneider</u>: And that wasn't a motion from the Chair. That was not a motion. It has to come from the committee.

Rep. Quitugua: Mr. Speaker, I would like to offer a committee substitute on H. B. NO. 13-060.

The motion was seconded.

<u>Speaker Hofschneider</u>: Motion for a committee substitute that has been offered by Representative Quitugua has been seconded. Discussion on the committee substitute? Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. Mr. Speaker, I would like to offer a floor amendment. On page 3 ...

Rep. S. Torres: Point of information, Mr. Speaker.

Speaker Hofschneider: State your point.

Rep. S. Torres: Has the committee substitute been distributed?

At this time, the Chair declared a short recess at 10:36 a.m.

RECESS

The House reconvened at 10:44 a.m.

Speaker Hofschneider: We're back to our session and, Floor Leader, you have the floor.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. Mr. Speaker, I'm very pleased to offer a written floor amendment. On page 3, Section 5 (b), delete "its entirety" and insert "The Secretary of Finance shall reserve 20% of the fees collected under (Public Law 11-25) 4 CMC 1503 (a) (2) to fund the doctoral scholarship program assistance for local residents who are domiciled in the Commonwealth. Provided further that all unused funds shall revert back to the general fund."

The motion was seconded.

<u>Speaker Hofschneider</u>: Floor amendment offered by Representative Attao has been seconded. Discussion on the floor amendment?

Several members voiced, "ready."

There was no discussion, and the motion was carried by voice vote.

<u>Speaker Hofschneider:</u> Motion carried. We're back to H. B. NO. 13 060, CS1 as amended. Representative Palacios.

Rep. A. Palacios: Thank you, Mr. Speaker. Notwithstanding and seeing the merits of this legislation, Mr. Speaker, I believe that last session that we discussed H. B. NO. 13-060 there were some questions as to part of this legislation, which requires that a graduate has to work at the college or at PSS. I believe we called some questions to the author and to the Chairman. I wonder if those recommendations have been taken and discussed with the committee or the author so that some amendments could be offered? I would also like to just for a point of information, Mr. Chairman, I'd like to find out how much this program is going to cost and what we're looking at of the lifespan? Are we looking at a six-year lifespan? It's a scholarship program and I wonder how much it's going to cost? What is the funding impact and is it going to be under existing scholarship programs?

The Chair recognized Representative Quitugua.

Rep. Quitugua: Thank you, Mr. Speaker. The good Congressman was quite correct, Mr. Speaker. There were concerns raised during the last session when the bill was calendared for discussion. One of the concerns that was raised actually was the concerns made by Representative Deleon Guerrero to which he was concern of the fact that in his view this is kind of restrictive rather than inclusive because it only addresses the needs for the Public School System as well as the college. However, we pointed it out that it is not limited only to the PSS and the college. The language inserted in the bill also includes individuals that he was concern of. As matter of fact, we discussed that earlier and he's very much in agreement to let the current language stand rather than amend it. Further, Mr. Speaker, the duration of the program is stipulated in the bill as well as the amount of money that it takes to successfully carry on the program. I would also like to add, Mr. Speaker, that the program has a lifespan as it was noted in the bill. And one of the primary targets was the fact that the CNMI college at the moment if you take an inventory of its staff we're lucky if we have ten percent, five percent even lesser than five percent of its current professorial staff that composes of local population and that's one of the reasons why we are offering this program so that we can have some capacity building at the CNMI college as well as the Public School System whereby it promotes the infusion of local citizens into the staff at the CNMI college. Now some will argue that that's not quite wise because then you're restricting your intellectual capacity. I beg to differ, Mr. Speaker, because I think cases in the past have proven that our people are more than capable to compete as well as to teach. Thank you, Mr. Speaker.

<u>Speaker Hofschneider</u>: Mr. Chairman and committee, may I point your attention to page 5? On line 1 beginning with the sentence when the first six doctoral students the operative words in that sentence are "shall provide them employment." Then you look at perhaps a contradicting intent to the previous sentence that if in the event the two are not congruent to the intent of "shall provide" obligatory and, "if NMC and PSS are unable to offer employment." That's a contradicting intent right there. Can we fix that?

Rep. Quitugua: Come again, Mr. Speaker.

<u>Speaker Hofschneider</u>: On the first line on page 5 beginning with the sentence, "when the first doctoral students graduate NMC and/or PSS shall provide," that's the operative word to provide them employment. Then the sentence continues, "the students must accept such offers as a condition of the scholarship," then the next operative mechanism in that paragraph is, "if NMC and PSS are unable." So which is it? Can we fix that? It's colliding with itself. Short recess.

The House recessed at 10:51 a.m.

RECESS

The House reconvened at 10:59 a.m.

<u>Speaker Hofschneider</u>: [beginning of recording] H. B. NO. 13-060, CS1 as amended by Representative Attao and we're under discussion of the bill on page 5 and I recognize Representative William Torres. The Chairman? Representative Quitugua.

Rep. Quitugua: Thank you, Mr. Speaker. The point that you raised earlier, Mr. Speaker, is very well taken. A compromise solution to that will be to delete the entire sentence on page 5, on line 3 all the way down to line 5, the last sentence of that, "if the Northern Marianas College and PSS are unable to offer," delete the entire sentence.

Speaker Hofschneider: Is that a motion?

Rep. Quitugua: Yes, Mr. Speaker.

Floor Leader Attao: Second.

<u>Speaker Hofschneider</u>: Oral floor amendment offered by Representative Quitugua has been seconded. Discussion on the oral floor amendment?

Several members voiced, "ready."

There was no discussion, and the motion was carried by voice vote.

Speaker Hofschneider: Motion carried. Ready?

Several members voiced, "ready."

The Chair recognized Representative Cabrera.

Rep. Cabrera: Mr. Speaker, just a point of concern. On page 3, line 4, subsection (c) ... actually, that and the entire bill. I have a concern about this with respect to the previous point that was made. And the concern is this is an exceptional program, no doubt about it. Whether it's appropriate for this time or not, is debatable. But, if I were someone who wants to compete and apply for this program and I want to get my Ph. D. in a specific field such as an epidemiologist or something else that will be of great use to the CNMI ... I see the bill as a little restrictive basically is what I'm saying but that's just for the record, Mr. Speaker.

Speaker Hofschneider: Thank you. Ready?

<u>Speaker Hofschneider</u>: By a vote of 15 "yes", 1 "abstention", H. B. NO. 13-060, HS1 as amended is hereby passed by the House. Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. Mr. Speaker, earlier we adopted S. C. R. NO. 13-057 relative to the National Guard. However, Mr. Speaker, it is not calendared and if there's no objection from the members, I would like to make a motion to place S. B. NO. 13-11, HS1 on today's calendar for action.

There was no objection.

Speaker Hofschneider: Thank you. Continue.

<u>Speaker Hofschneider</u>: S. B. NO. 13-11, HS1 is hereby passed by the House on First and Final Reading. I'd like to call upon the Vice Speaker to rise please.

<u>Vice Speaker Tenorio</u>: I recognize Representative Hofschneider.

Speaker Hofschneider: Thank you. Today and another day will be the closing of tenth month of the Thirteen Legislature. I believe that so far the House has done well in its responsibilities both, in doing what legislatively is appropriate for the people and also being the safeguard, in the checks and balances, of democratic principles of three branches of the government. I don't think that one can say that the House of Representatives is failing in the respect of its Constitutional responsibilities. It is difficult for the last ten months because of primarily the economic situation that we're facing, and nine out of ten reasons that one can pin our economic hardship or difficulties on. Those nine elements are beyond our control. It is outside the Commonwealth. Economically speaking, we're so vulnerable to everything, particularly the Asia-Pacific

Region experiences or goes through. Majority of our island economy relies on how well our neighboring economic powers do. Japan is particularly important to the economy of the Commonwealth simply because most of the investments in the Commonwealth are of Japanese origins. Tourism is predominantly Japanese, our market focus is predominantly in the Japanese market. We operate because we by virtue of the Covenant operate with US currency and however strong the US currency it does impact us locally. And no matter what instrument, legislatively speaking, we take in the Thirteenth Legislature we have no control over those elements that we rely on outside the Commonwealth. I had an opportunity as a Speaker of the House to have a reassessment so to speak. Reassessment in whether the House is being led appropriately and I'm happy to say that the House is in the right direction. Fundamentally speaking, we are in the right direction. Politically speaking, we are not appropriately behaving because in the observation of the public, the great concern is the House of Representatives is composed of a super majority Republican members and the Administration is Republican Administration. And in the eyes of the public the Senate is very cooperative both in the aspect of its relationship with the House and in the aspect of its relationship with the Administration. But there is less to be said about the relationship between the House and the Administration simply because of what appears to be political differences in objectivity simply because we are fundamentally following what the House of Representatives is mandated by the Constitution and the composition of the House of Representatives in the Thirteenth Legislature philosophically speaking. But I also must be pragmatic and listen to the desire of our constituency and that desire is to have our differences somehow be amicably discussed and in a statesmen's like appropriately agree to disagree. I must admit that I have a firm believe and conviction and at times overtly emotional on issues that I know that the House of Representatives is right and the House of Representatives should adhere to and should follow. At times I know that deep in your heart and minds you, the leadership and members, question whether my convictions or my stern positions in opinions are in any way have ulterior motives in themselves. I want to put a rest to that and say to you all there are no hidden motives, political agendas or hatred. I appeal today. I appeal to the Governor and to the Lieutenant Governor that cooperation is an open door policy as it should be always, and we have never denied access or communication to the Administration. I want that to be very clear to the people. Approaches are different and we will continue to have differences in approach. But what prompted me to talk to you and appeal to the people and appeal to the Governor and the Lieutenant Governor, the Administration, is there's a looming crisis that is just hovering around the corner. We have a financial dilemma or crisis is the right word. I don't want this statement to be an alarmist statement but I'd rather be wrong than for the day to come and we said and did nothing about it. Today I'm appealing to the Governor and to the Lieutenant Governor to meet with us all and put our efforts and our capabilities to prevent what I honestly feel is an impending disaster of public service. I am talking about our cash flow situation. When we begin to hear members raising to the Speaker that even their newspaper subscription have been turned back for lack of cash as insignificant as a subscription. But what prompted me today is the seriousness of our cash flow problem has now touched the health care system to a point that the government health insurance is in trouble, is in jeopardy. They're being rejected, they're not accepting even at the government hospital, CHC. More so this morning, the Chairman on the Committee on Health and Welfare, Representative Benjamin Seman, informed me that he needed to step out of the chamber and advice the Governor to allow medical referral patients in Honolulu to avail themselves of their medication. These are people with cancer medication, rejection medications for instance and others. They cannot access their medications because our medical insurance is in trouble. I know that when I was away the Acting Speaker had meeting with the Retirement Fund, the Administrator of the program, with grave concern about assistance. We owe \$1.4 million in our obligations with medical services. When the priorities of cash is so obvious that garnishment of premiums, employees who subscribe to government health insurance, are not being remitted on time and in the correct amount to the administration of the program then we have to face the cash flow problem altogether. There are revenue legislations that we all agreed in the leadership meeting to hold off simply because of the Governor's statement in one of the local papers the other day made it very clear there will be no new taxes. Under the advice of the leadership I sent the Governor a letter delineating some, not all, some of those revenue legislations and asking if the position of the Administration is so, as stated on the paper the other day, no new taxes. Conflicting policy direction from the Administration is inappropriate for the House to do its work cooperatively. It sends wrong or mixed signals to the entire House of Representatives, which is entrusted under the Constitution for revenue legislations, all revenue legislations start in the House of Representatives. If that is the case we need to meet at the most expedient and the earliest time. We do not have the luxury of time on our side. There is great concern about the possibility of next payroll not being met. There's even a gentleman that tried to cash his check in one of the local banks and was turned away, a government check. If those are the cases that we are beginning to see and hear then let's not discuss all the problems in an antagonistic approach. But I'm appealing to the Governor and to the Lieutenant Governor to accept my invitation to meet with the House of Representatives and with the Senate and collectively come up with solutions to cushion and prevent the inevitable. We don't want to see that. No one wants to allow that. And as much as we differ in approach this house has always welcome the Administration and I ask everyone in the House to contribute and cooperate with the Administration. But more importantly I'm appealing for cooperation with the Administration and meet at the earliest possible time. We have a problem and it is a very serious problem. Let's not deviate, let's not deflect it. Let's confront the problem that we have. It's very real. And I ask you all to please join in the effort and let's all work towards a solution with the Governor and the Lieutenant Governor. This is the priority today and for the days to come. We have a serious cash flow problem. Thank you.

<u>Vice Speaker Tenorio</u>: Thank you, Representative Hofschneider. Under Miscellaneous Business does any member have any comments?

MISCELLANEOUS BUSINESS

The Chair recognized the Floor Leader.

Rep. Quitugua: Thank you, Mr. Speaker. I would like, Mr. Speaker, to request the Chair to consider the possibility, I don't know whether it's timely but it doesn't have to be done tomorrow, but it's something that the Chair can consider for a later date. As you know, Mr. Speaker, the people of Tinian as well as the people of Rota are very unfortunate in the sense that they are unable to actually follow the proceedings of the House as well as the Senate for the obvious reason. However, Mr. Speaker, I sincerely understand the current financial situation of the government and I join you in your effort to meet jointly with the Executive Branch together with the Senate to address this critical problem. I would like however, Mr. Speaker, to request that a session or two can be held in the island of Rota or the island of Tinian so that the depressed people of Rota can regain some strength and find some hope that their government is still functioning on their behalf. So I would like for [end of recording]

<u>Speaker Hofschneider</u>: ... previous Legislatures, we owe it to the other senatorial districts also to hold sessions. That has always been the practice and we will consider at least one this year and possibly one, two or several next year. We will take that under consideration and see how our financial situation is and if it permits us by all means we have to have one in the other senatorial districts. Thank you for that suggestion. Representative Torres?

Rep. W. Torres: Are we on Miscellaneous Business?

Speaker Hofschneider: The Vice Speaker has ruled.

Rep. W. Torres: Mr. Speaker, your Committee on United States and Foreign Affairs is happy to report through its hard work that we'll be meeting shortly with the good Secretary of Finance to find out whether the CNMI government have received the over \$10 million that we have yet to receive from the Federal Government as was reported early this year. We will be pursuing this very closely. Members of the committee are very hard at work in making sure that the Commonwealth we'll receive this amount of money from the Federal Government. This is an amount of money for which we used for our local revenues and that we still have not receive reimbursement, that's number one. Number two, your Committee on United States and Foreign Affairs also is very much at work in trying to recover what the Commonwealth spent on

Compact Impact clients, and that's in the millions of dollars. We have taken the opportunity to link up with the other impacted territories, with Guam and Hawaii. The good Vice Speaker has traveled to Hawaii and met with the delegates for the sole purpose of uniting on this very same issue, on the issue of presenting to the United States Congress a unified position, a defensible formula. That would put this issue to rest once and for all. As you know there is great disparity among the impacted territories as to the amount of reimbursement they have received. The Commonwealth is no different from Hawaii nor Guam. Fortunately, the territory of Guam has received higher amount relative to the CNMI and the State of Hawaii, and I guess credit should go to their delegate for that effort. So given that the Commonwealth has not yet gained a delegate status to the United States Congress the least that we could do at this point is to unite all the impacted territories to unite and present the united upfront before the US Congress on this very issue. The amount of funds coming out of two sources is rather substantial. It has taken us a long, long time to realize that really in these kind of issues where we have common problems sometimes we just need to unite and that's exactly what your committee is doing, trying to unite with Guam and the state of Hawaii on this very issue of compact impact. And hopefully, Mr. Speaker, this will contribute substantially to our situation that we are faced with which are our declining resources. So I would like to say this on behalf of the committee so that to realize that there is hope out there. We just need to push the envelope a little bit more, but there is hope and I think we should be optimistic. Thank you.

The Chair recognized the Floor Leader.

Floor Leader Attao: I move to recess subject to the call of the Chair.

The motion to recess subject to the call of the Chair was seconded and carried by voice vote.
