PREFILED AND INTRODUCTION OF BILLS

The Chair recognized Vice Speaker Tenorio.

<u>Vice Speaker Tenorio</u>: Thank you, Mr. Speaker. H. B. NO. 13-251 was prefiled by Representative Ada, who is on official business. I would like to introduce it in today's session per request.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. Pursuant to Rule 10, Section VII, I move to recall H. B. NO. 13-148 from the Governor, entitled, A Bill for an Act to create a Workforce Investment Agency within the Office of the Governor and to promote employment training and services; and for other purposes.

The motion was seconded by Rep. Babauta.

<u>Speaker Hofschneider</u>: Motion to recall H. B. NO. 13-148 from the Governor has been seconded. Discussion on the motion?

Floor Leader Attao voiced, "ready."

Speaker Hofschneider: Ready. Clerk, roll call.

<u>Speaker Hofschneider</u>: Representative Quitugua asked to be excused because he's returning to Rota. He is hereby excused. With a vote of 11 "yes", 7 "absent" the House hereby recalls H. B. NO. 13-148. Floor Leader?

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. I move for reconsideration, per instruction of H. B. NO. 13-235, HD1, entitled, A Bill for an Act to amend 4 CMC § 2301(d) and 1 CMC § 2702(a); and for other purposes.

The motion was seconded by Rep. Babauta.

H. B. NO. 13-235, HD1: A BILL FOR AN ACT TO AMEND 4 CMC § 2301(D) AND 1 CMC § 2702(A); AND FOR OTHER PURPOSES.

<u>Speaker Hofschneider</u>: Reconsideration motion has been seconded. This is to reconsider our action on H. B. NO. 13-235, HD1, relative to the MVA field operations transfer. We've passed it, but upon review before transmittal to the Senate we found some glaring problems so we are going to fix that now. Discussion on the reconsideration motion?

There was no discussion, and the motion was carried by voice vote.

<u>Speaker Hofschneider</u>: Motion carried, therefore, H. B. NO. 13-235, HD1 is now on the floor. And with that, I'd like to offer a floor amendment.

Speaker Hofschneider offered the following amendment:

On page 1, Section 3 is modified as follows: Section 3. Transfer. Notwithstanding Public Law 13-24 and any law to the contrary, the MVA Field Operations Division in Saipan including its records, property listed on its schedule of fixed assets, facilities, equipment, supplies, its current 28 FTEs and total personnel costs including health insurance, retirement, and medicare, as provided in a Memorandum of Understanding (MOU) between MVA and the Department of Lands and Natural Resources (DLNR), are hereby transferred to the Division of Parks and Recreation within the Department of Lands and Natural Resources (DLNR). MVA and DLNR are hereby authorized to execute a Memorandum of Understanding (MOU) that effectuates the transfer authorized by this Act and which shall specifically provide: (a) A listing of Aall tourist sites on Saipan currently maintained by MVA. (b) Assistance by Coordination of DLNR personnel for MVA events. (c) Reimbursement of overtime salaries by MVA and DLNR for manpower during the events as specified in the MOU. Twenty percent of the current operational costs for MVA's field operations Division in Saipan for Fiscal Year 2002 2003 shall remain with MVA and the other remaining eighty percent 80% shall be transferred to the Division of Parks and Recreation as provided in the MOU. No current liabilities other than personnel costs will shall be transferred to DLNR.

On page 2, Section 4 is modified as follows: Section 4. <u>Tourist Site Maintenance</u>. (a) 1 CMC § 2702(a) is amended to read as follows: "(a) "Commonwealth park" means an area set apart and designated as a Commonwealth park <u>or a tourist site</u>, <u>unless otherwise provided by law</u>, by the Division of Parks and Recreation including any public facilities located within the boundaries of the park."

The motion was seconded.

<u>Vice Speaker Tenorio</u>: Mr. Speaker, can we have a copy of the bill?

The Chair declared the House recessed at 3:35 p.m.

RECESS

The House reconvened at 3:42 p.m.

<u>Speaker Hofschneider</u>: We're back to our session. I offered a floor amendment on H. B. NO. 13-235, HD1. The motion for the floor amendment has been seconded. Discussion on floor amendment?

Rep. Babauta voiced, "ready."

The Chair recognized Representative Torres.

Rep. S. Torres: On "Section 3. Transfer. Notwithstanding Public 13-" – the word "Law" is missing here.

Speaker Hofschneider: Where are you? On the floor amendment?

Speaker Hofschneider: Short recess.

<u>Speaker Hofschneider</u>: We're back to our session and for clarification, there's typographical error, after the word "Public" insert "Law". Ready for the question?

Several members voiced, "ready."

There was no further discussion, and the floor amendment offered by Speaker Hofschneider to H. B. NO. 13-235, HD1 was carried by voice vote.

Speaker Hofschneider: Motion carried. We're back to H. B. NO. 13-235, HD2. Ready?

Floor Leader Attao voiced, "ready."

Speaker Hofschneider: Clerk, roll call.

Floor Leader Attao: Thank you, Mr. Speaker. I move to place H. B. NO. 13-252 on today's Bill Calendar.

The motion was seconded by Rep. Babauta. There was no discussion and the motion to place H. B. NO. 13-252 on the calendar was carried by voice vote.

Speaker Hofschneider: Motion carried. Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. Mr. Speaker, I move for the suspension of Rule VII, Section 10, Rule IX, Sections 9, 10 and 11 for the passage of H. B. NO. 13-252 and H. B. NO. 13-235, HD1 on First and Final Reading.

The motion was seconded by Rep. Babauta.

Speaker Hofschneider: Floor Leader, correction H. B. NO. 13-235 is finished. Esta ma pasa.

Floor Leader Attao: H. B. NO. 13-235, HD1 is on the calendar.

<u>Speaker Hofschneider</u>: It's done. We've reconsidered and passed it – short recess.

The House recessed at 3:49 p.m.

The House reconvened at 3:49 p.m.

Speaker Hofschneider: We're back to our session.

<u>Floor Leader Attao</u>: I would like to make a subsidiary motion to correct the main motion to exclude H. B. NO. 13-235, HD1 and include H. B. NO. 13-246.

The motion was seconded and carried by voice vote.

Speaker Hofschneider: Motion carried. Floor Leader.

<u>Floor Leader Attao</u>: Thank you, Mr. Speaker. I now move for the passage of H. B. NO. 13-252 on First and Final Reading.

The motion was seconded by Rep. Babauta.

H. B. NO. 13-252: A BILL FOR AN ACT TO APPROPRIATE TWO MILLION FIVE HUNDRED THOUSAND DOLLARS (\$2,500,000.00) FOR THE COMMONWEALTH PRISON PROJECT; AND FOR OTHER PURPOSES.

<u>Speaker Hofschneider</u>: Motion for the passage on First and Final Reading H. B. NO. 13-252 has been seconded. Discussion on the bill? Ready?

Several members voiced, "ready."

Vice Speaker Tenorio: Mr. Speaker?

The Chair recognized Vice Speaker Tenorio.

<u>Vice Speaker Tenorio</u>: Point of information, Mr. Speaker. Can you clarify what we are trying to do here, Mr. Speaker? I see that \$1 million is coming from the Kagman waste water system. Are we in fact saying that we're taking \$1 million from the Kagman waste water system and putting it into the prison project?

Speaker Hofschneider: Yes.

<u>Vice Speaker Tenorio</u>: Why is that, Mr. Speaker?

<u>Speaker Hofschneider</u>: Based on the CIP Coordinator Vicky Villagomez and the Administration, the \$1 million is not encumbered so it can be moved to supplement the prison project shortfall.

<u>Vice Speaker Tenorio</u>: I am sure that there's \$10 million for the first phase of the Kagman wastewater facility project. That project, Mr. Speaker, needs another \$10 million to put it in place, and here we are cutting the funding before the first phase of the project even started? How are we going to pay for it or reimburse the project with this? Can we get assurance from the members that we can find funds for that – because as far as I'm concerned, Mr. Speaker, those prisoners can be put some place else. Let the Kagman project go on. We need the facility over there. What are we doing here, Mr. Speaker?

<u>Speaker Hofschneider</u>: Thank you. The Administration has assured that the forthcoming CIP, which was reduced in 2000 by \$3 million, is now being replaced or replenished this fiscal year. Because the project is

under planning stages, design phase, and the construction phase has not initiated yet, there is ample time to replenish the \$1 million, which they have done so similar to the \$3 million we have taken away from the landfill. It's being replaced by the U. S. Congress in the forthcoming CIP.

<u>Vice Speaker Tenorio</u>: The CIP funding for 2004 is only around \$17 million and we have a lot of projects to do for Precinct I – not only in Kagman but the Dandan sewer line as well, and there's a big problem now with the Airport Road. That'll probably require another \$5 million for land acquisition, the resurfacing and doing the necessary drainage system. Precinct I requirements, Mr. Speaker, it should – almost 60% of the people of this island live in Precinct I and we continue to deny the people there the opportunity for CIP. I don't know if it's right for you, and I, as a Representative from Precinct I, to endorse this kind of request unless we can get assurance. They're always saying that they'll do this and do that but there's nothing in writing, Mr. Speaker, that I can, in all fairness, clear my conscience and say we'll go ahead and cut this and be assured that the money is coming in the next phase of the CIP funds.

Speaker Hofschneider: Believe me, Vice Speaker, I raised that with the Administration and they have assured that they will replace that because of the timeliness of the construction is not there yet. This Kagman sewer project is under design phase and we have a clock against us on the prison project due to the consent decree. And if we procrastinate or delay that, that would compound the problem. In fact, it may have all or some of our CIP funds impounded for the purpose of completing the prison project. So I ask the indulgence of the members in that we have reassurance from the Administration since they have submitted this as a request. CDA drafted the bill in cooperation with the CIP people in the Administration and they've assured that they will in fact replenish and add on to the sewer project appropriation. Okay. Ready?

Rep. Deleon Guerrero: Mr. Speaker, have we gotten any feed back from CUC in terms of the schedule for the Kagman sewer? Because what the newspaper reported yesterday was that the project was stalled but I have been involved in some meetings with CUC and the matter of identifying the location for the wastewater treatment plant is not a big problem. They've identified alternative sites and it's a matter of a short time to determine which of those sites would be used. And if that is the only obstacle, then we're looking at that project progressing in the very near future.

Speaker Hofschneider: Representative Deleon Guerrero, there's an added complication to the sewer project in Kagman. Originally, the Kagman sewer project was intended to develop the first constructed wetland -- the terminology -- as opposed to the traditional or typical sewer treatment plant that we have in Puerto Rico and Agingan Point because the other agencies involved, DEQ for instance, have reservations as to the wetland treatment plant. CUC is reassessing together with the Administration, if they would go with the traditional treatment plant and I think that they're moving towards that direction to identify a suitable lot for a change in plant design and move for the traditional treatment facility. So that's where the hitch lies. Two, it's still in the design phase. This morning, Chuck Jordan and Vicky Villagomez reassured that the design phase is not going to materialize until the end of the year and construction will probably begin next year. So in the meantime they have reassured that they will in fact replenish the money to the sewer project in Kagman. Representative Torres?

Rep. S. Torres: Mr. Speaker, what is the meaning of traditional treatment plant?

Speaker Hofschneider: Standard.

Rep. S. Torres: And wetland treatment plant?

<u>Speaker Hofschneider</u>: They construct an open pit and use sand filtration for seepage and that's how they treat it. Basically the standard treatment plant is what we see down at Puerto Rico and Agingan Point.

<u>Rep. S. Torres</u>: I just hope that the assessment for the smelly odor is included taking into account the Puerto Rico plant. Did they take that into consideration?

Speaker Hofschneider: That's why they're still going back and forth on the environmental issues. Ready?

Several members voiced, "ready."

The Chair recognized Representative Palacios.

Rep. A. Palacios: I understand the concerns of my colleagues from Precinct I but if I understand you correctly, Mr. Speaker, they're still going back and forth as to which system to use then I can assure you it's not going to happen next year. It'll probably take another year and a half at the most, so I think that the money would be there and we can assure them of replenishing this project. The prison project is ongoing and needs to be supplemented. I believe that, like you said, the funds will be there by the time that we're ready to do the Kagman treatment plant. I will keep that in mind also if the time comes that the money is ready to be appropriated and that we replenish these funds to this sewer treatment plant.

Speaker Hofschneider: Thank you. Ready. Clerk, roll call.

<u>Vice Speaker Tenorio</u>: Mr. Speaker, one reason is why – and I haven't made up my mind yet how to vote but I don't like it. I'd like to hear more discussion on the issue, Mr. Speaker, just get reassurance that whatever money that's taken away from the project is replenished in time because I don't believe in this nonsense that this is not going to happen in one year. If the contractor can't do it, they should be fired. They can't be continuously sitting on this and wasting their time. That's not a reason. According to Congressman Deleon Guerrero they already have three sites picked out to do the project. I don't see that it'll take one year for them to make up their minds which site to use. But the fact of the matter, Mr. Speaker, I have seen projects in Precinct I stay idle for a long time and the Legislature, this body, continue to salvage little by little until we can't do the project. And I hope this doesn't happen to this very important project. This is for health reasons. That place is very crowded and something needs to be done to address the problem of the sewage

because if we don't do it, sooner or later we're going to have a huge health problem there, Mr. Speaker. That's my only concern. I don't know if I can ask my two colleagues to reconsider their vote but I hope that I can shed more light to this and with the assurance...

<u>Speaker Hofschneider</u>: Vice Speaker, I reassure you that if we cannot trust Vicky Villagomez, Chuck Jordan and CDA that they will in fact replenish that...

<u>Vice Speaker Tenorio</u>: Mr. Speaker, I trust Vicky and CDA but I cannot trust Chuck Jordan for heaven's sake. Let me put that on record. How many projects do we have that have been idle...

Speaker Hofschneider: Then let's trust Vicky and CDA. Honestly, with all sincerity, we raise that so...

<u>Vice Speaker Tenorio</u>: Mr. Speaker, just to...

Speaker Hofschneider: I ask you to support it, Vice Speaker, please, and ask the two to reconsider ...

<u>Vice Speaker Tenorio</u>: I know that if I vote "no" the bill will pass anyway.

Speaker Hofschneider: Well, I think, Vice Speaker, we have an urgency with the consent decree.

<u>Vice Speaker Tenorio</u>: But I trust you, Mr. Speaker, and I trust we do have a consent decree to abide with and that we are building a very beautiful and very expensive jail to put the prisoners in and there goes the Kagman wastewater project, Mr. Speaker. With your support, Mr. Speaker, and I know that you're not going to lie to us...

Speaker Hofschneider: I won't.

Vice Speaker Tenorio: I vote yes.

<u>Speaker Hofschneider</u>: Clerk, I'm going to ask reconsideration from Representatives Palacios and Deleon Guerrero. Representative Deleon Guerrero?

Rep. Deleon Guerrero: Mr. Speaker, the reason I voted no is because you did not answer my question. I asked if CUC has been advised of this matter...

<u>Speaker Hofschneider</u>: I believe so. According to Vicky Villagomez she will not move any fund because it has to go to the Department of the Interior anyway for any reallocation or re-appropriation. So I believe that she has done her part. It will not reach the House by way of request if they have not cleared the matter.

Rep. Deleon Guerrero: I'm sorry, Mr. Speaker. I know you already have enough votes to pass this and until such time that I get some assurance myself, I cannot in all good conscience support this. That Kagman project is underway as far as I'm concerned and while there are a few glitches, I cannot participate in any action that would stop that progress. I cannot. I am the PUTC Chair, I know right now Kagman -- everyday that we wait has the potential to impact the livelihood of those people in the Kagman community because the wells are situated within the homestead area, among the houses, and it accumulates waste everyday. I cannot.

<u>Speaker Hofschneider</u>: Thank you, Representative Deleon Guerrero. Representative Palacios, if there's no reconsideration then we'll continue with the vote.

Rep. H. Palacios: Mr. Speaker, if I can have reassurance in writing I will vote yes.

Speaker Hofschneider: You want it now?

Rep. H. Palacios: As soon as possible.

Speaker Hofschneider: Clerk, continue.

Rep. A. Palacios: Mr. Speaker, this infrastructure problem continues to haunt us after we develop homesteads. Kagman community is a product of our Homesteading Program. It really manifest the lack of planning on our part, on our agencies that are responsible. It calls for infrastructure development, which we give to CUC and homestead development, which we have mandated to MPLA. I think that if anything we need to go back and require MPLA also to pitch in funds for this sewer treatment plant. If anything we should require MPLT to fund part of this project rather than looking for investments in some "lala land" programs that we've had in the past few days. Because these homesteaders, these people who have been issued homesteads are of Northern Marianas descent and the community that they live in is of public land program mandated by our Constitution, Mr. Speaker. So I urge my two colleagues to consider legislation requesting MPLA and MPLT to finance part of this cost of the sewer plant. Thank you.
