Mistress of Ceremony Clarissa D. Sablan: Hafa Adai, Tirow Woomi, good morning, and welcome to the House of Representatives. We will now begin the House of Representatives' installation ceremony of the Seventeenth Northern Marianas Commonwealth Legislature. Before I introduce the members-elect I ask the Sergeant-at-Arms to please escort the Honorable Miguel S. Demapan, Chief Justice of the CNMI Supreme Court and Reverend Father Jesse Reyes, to the dais. (Pause.) I am honored to present to you the Representatives-elect of the Seventeenth Northern Marianas Commonwealth Legislature. Cabrera, we are also honored with the presence of the Honorable Donald P. Flores, Mayor of the Municipality of Saipan, The Commissioner of Education: Dr. Rita A. Sablan, and from the 12<sup>th</sup> CNMI Youth Congress: Vice Speaker Seong Bin Lee and Floor Leader Sunny Frank Aldan, former Senator Herman R. Guerrero, Former Congressman Oscar M. Babauta, Former Mayor of Saipan, Juan B. Tudela, Former Congresswoman Ana S. Teregeyo, Former Congresswoman Malua T. Peter . I would also like to recognize the honorable former Representatives Ana Teregeyo and accompanying the Governor, we have Department Secretaries and Directors. Families, friends, and supporters of our members-elect, I welcome all of you to the Commonwealth of the Northern Mariana Islands Legislature, House of Representatives. I will now recognize Representative-elect Eliceo Diaz

Representative-elect Cabrera: Good morning, *Hafa Adai*, *Tirow Woomi*, ladies and gentlemen. Welcome to the House Chamber. I am very pleased and honored to announce that it is the consensus of the Representatives-elect of the 17<sup>th</sup> House of Representatives that Representative-elect Stanley Tudela McGinnis Torres shall be the Speaker Pro Tem and Representative-elect George Norita

Camacho as the Floor Leader Pro Tem of the First Organizational Session of the House until the election of the Speaker and the Floor Leader.

Mistress of Ceremony Clarissa D. Sablan: Thank you Representative-elect Cabrera. Ladies and gentlemen, it gives me great pleasure to introduce to you the Speaker Pro Tem, Representative-elect Stanley Tudela McGinnis Torres and Floor Leader Pro Tem, Representative-elect George Norita Camacho for this Organizational Session of the 17 Northern Mariana Commonwealth Legislature. And now I ask the Sergeant-at-Arms to please escort the Speaker Pro Tem up to his throne.

(Speaker Pro Tem was escorted to the Dais).

Mistress of Ceremony Clarissa D. Sablan: Please all rise. I now call upon the Marianas High School Junior Reserve Officer Training Corps. Color Guards for the posting of the Colors, and I also call upon the Marianas High School Junior Reserve Officer Training Corps. Cadets to lead us sing the United States National and the Commonwealth Anthems.

(National & Commonwealth Anthems were sung)

Mistress of Ceremony Clarissa D. Sablan: Please remain standing as I call upon Reverend Father Jesse Reyes for the Invocation.

(Reverend Father Reyes gave the Invocation)

Mistress of Ceremony Clarissa D. Sablan: Please be seated. Thank you, Father Jesse. It is with great honor and pleasure that I call on Speaker Pro Tem, Representative-Elect Stanley Tudela McGinnis Torres, to officially call the House of Representatives' Organizational Session of the Seventeenth Northern Marianas Commonwealth Legislature to order. Speaker Pro Tem, please.

#### CALL TO ORDER

The House of Representatives of the Seventeenth Northern Marianas Commonwealth Legislature was called to order in its First Day, First Regular Session on the eleventh day of January the year two thousand and ten at 10:36 a.m. in the House Chamber, Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

Speaker Pro Tem Stanley McGinnis-Torres: Thank you Mistress of Ceremony. Before I call the session to order, I would like to make a short speech. Buenas Dias, Tirow and Good Morning, to the Honorable Governor Benigno Repeki Fitial, Lieutenant Governor, the Honorable Eloy Inos, if the Bishop is present to, his Excellency Bishop Tomas Camacho, Chief Justice Miguel Sablan Demapan, Pale Jesse Reyes, honored guests from the US mainland, Mr. Pula and Congressman Greg "Kilili" Camacho Sablan, Governor Camacho from Guam, Governor Toribiong from the Republic of Palau, Consulate of the Republic of the Philippines, Consulate of Japan, Mayor Flores, honored guests. To my colleagues, Honorable members of this august body, I am taking this opportunity to make this short privilege statement from this chair so that none amongst you will question why I am up here. First, I asserted that I would be also again be designated the Speaker Pro Tempore for the second consecutive Inauguration among the twelve majority of coalition – you know who they are and which none of has objected to it and if anyone thinks it is unconstitutional I say, let it be. I therefore, inform all of you that I will also proclaim myself the rule and I will overrule anyone who would not agree with me sitting up here – even if Mr. Harry Blalock is still listening. Honorable members of this Body, again, our guests, family members and friends and supporters, I Speaker Pro Tem Stanley Torres also known as Stanley Tudela McGinnis-Torres, officially calls this Organizational Session on this Eleventh Day, of January the year two thousand and ten of the House of Representatives of the Seventeenth Northern Marianas Commonwealth Legislature to order. Please all rise for a short of legislative prayer. All representatives-elect please repeat after me: Lord

Jesus Christ, grant us the wisdom and courage to do what is right and good for our people. Hail Mary, Mother of our Lord, pray for us. Amen. Before I call on the House Clerk, I need to organize the House in order to legally conduct this session. I hereby make the following appointments: For Senior Chief Sergeant-at-Arms, Mr. Peter Olopai Towai, for Deputy Sergeant-at-Arms, Sylvestre R. Sablan, for House Clerk, Ms. Evelyn Castro Fleming, for House Lead Counsel, Ms. Antonette Ramon Villagomez and her Associate Legal Counsel Joey P. San Nicolas. Now that this House is in order and secured, House Clerk, please call the attendance of the representatives-elect.

Chief Justice Miguel S. Demapan: Please raise your right hand and repeat after me.

"I do solemnly swear that I will support and defend the Constitution and laws of the Commonwealth of the Northern Mariana Islands, the Covenant to establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, the applicable provisions of the Constitution, laws and treaties of the United States of America, and that I will faithfully discharge my duties to the best of my ability, so help me God."

Chief Justice Miguel S. Demapan: Congratulations. (Applause)

<u>Speaker Pro Tem Stanley McGinnis-Torres</u>: State your privilege, Representative Tebuteb.

<u>Representative Tebuteb</u>: Thank you, Mr. Speaker Pro Tem and members. I have immediate family matter that requires my presence if there is no objections from this Body I would like to be excused for the remainder of the Organizational Session. Thank you.

There were no objections raised on the floor.

<u>Speaker Pro Tem Stanley McGinnis-Torres</u>: There being no objections, Representative Tebuteb is excused. Let us now proceed for the election of the Speaker.

Speaker Pro Tem Stanley McGinnis-Torres: State your clarification, Representative Benavente.

Representative Benavente: I do not dispute the outcome of the election of the Speaker, Mr. Speaker Pro Tem, as a matter of fact, I voted yes on the nomination, but it is rather odd and inappropriate that our elected Speaker did not vote for himself or did not vote for the position of the Speaker. I just wonder should there by any clarification that goes with that decision, if not then I rest at this time.

<u>Speaker Pro Tem Stanley McGinnis-Torres</u>: Representative Froilan Cruz Tenorio, would you cast your "yes" vote please for the record.

Representative Froilan Cruz Tenorio: My vote is "yes".

## NOTIFICATION OF THE SENATE AND THE GOVERNOR

Speaker Froilan C. Tenorio: Under the Notification of the Senate and the Governor, I now appoint Representatives Teresita Apatang Santos and Edmund Sablan Villagomez to inform the Senate that the Seventeenth House of Representatives is organized and ready to conduct official business. And I appoint Representatives Raymond Demapan Palacios and Eliceo Diaz Cabrera to advise the Governor that the Seventeenth House of Representatives organized and ready to conduct official business.

Representative Raymond D. Palacios: Mr. Speaker, privilege.

Speaker Froilan C. Tenorio: Under privilege, I recognize Representative Raymond Palacios.

<u>Representative Raymond D. Palacios</u>: Are we going to be out of order if we are not to inform the Governor's Office because both the Governor and Lieutenant Governor are here onsite. Do we need to go ahead and inform them?

<u>Speaker Froilan C. Tenorio</u>: Yes, I would like for the two Representatives that I just appointed to come up to the dais and inform them. I recognize Representative Yumul.

Representative Yumul: Can we take a short recess while we wait for the two appointed members to return and I understand that the Senate members are right outside the door and are waiting to approach you.

There were no objections.

Speaker Froilan C. Tenorio:: This session is now on recess.

The House recessed at 10:55 a.m.

**RECESS** 

The House reconvened at 10:59 a.m.

<u>Speaker Froilan C. Tenorio</u>: This House is back in session. I wish to inform you that the Senate has notified that they have organized themselves and which are ready to conduct official business.

Representative Benavente: Point of information, Mr. Speaker.

<u>Representative Benavente</u>: You were saying that the Senate has informed us of their organization and I would like to ask at this time if you would please announce to all the members the officers of the Senate.

<u>Speaker Froilan C. Tenorio</u>: I am sorry Representative Benavente, the Senate has not conveyed any message to me. I wish to also announce that the Eleventh Saipan Municipal Council has also organized itself and ready to conduct official business, the Chairman of the Council is, Mr. Ramon B. Camacho and the Vice Chairman and Secretary is, Mr. Eric D. Diaz. There are only two members. The Chair recognizes, Representative Yumul.

<u>Representative Yumul</u>: Mr. Speaker, the Mayor of Saipan is present in the gallery, perhaps we could ask that question as to the third member and also to inform us as well.

Speaker Froilan C. Tenorio: We move on to Communications.

#### **COMMUNICATIONS**

<u>Speaker Froilan C. Tenorio</u>: We are now under Communications. Are there any communications? The Chair now recognizes, Representative Benavente.

<u>Representative Benavente</u>: Thank you, Mr. Speaker, under Communications, I wish to inform you and the members of the Seventeenth Legislature that the Minority Office has met and I have been given the honor and elected as the Minority Leader for the Seventeenth House of Representatives.

(Applause)

Speaker Froilan C. Tenorio: Let us now move on to the Statement of Members.
