The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its Fifth Day, Third Regular Session on Friday, March 16, 2018 at 10:04 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

A moment of silence was observed.

<u>Speaker Rafael S. Demapan:</u> Thank you all for coming on today's session. Before we begin, let me take the time to acknowledge and recognize the presence of Mr. Aaron Sami. He's an associate professor from the University of Guam and of course everyone that are here today. Before we move on to our next Order of Business, let me first delegate Representative Angel Demapan to be the Floor Leader Pro Tem. Any objection to that?

Several members voiced "no objection."

<u>Speaker Rafael S. Demapan:</u> So without any objection, Representative Angel Demapan will be the Floor Leader Pro Tem. Clerk.

(a) Bills and resolutions shall be read by title upon introduction and (except as provided in subsection (b), the Speaker shall refer such measures to an appropriate committee or to more than one committee, jointly or sequentially. The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the Journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred.

(b) The Speaker may place a resolution directly on the Resolution Calendar, rather than refer it to a committee, subject to appeal to the House.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Again, your motion has been seconded. Discussion on that motion? Recognize Representative Dela Cruz.

<u>Representative Francisco S. Dela Cruz:</u> Thank you, Mr. Speaker. I know we're acting on a amended – the Senate amended a version. Throughout the legislation it speaks of the retiree death payments due to the survivors. The Senate made a staunch amendment and that now it includes all living retirees as well. So, I guess the question is whether the obligation that the government has to pay both the spouses of the deceased retirees and the living retirees whether the obligations can be met. I don't know what the number of living retirees is at probably three to four-thousand. So it somehow takes away the limit of just for the spouses of the decease retirees and what does this mean in terms of financial numbers that now the government is obligated to pay and whether it has the funds. I have no problems accepting the living retirees, they're just as well old. My concern is whether the funds will be available to cover the additional number of living retirees. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Dela Cruz. Let me just recognize the author or the mover of the legislation. Recognize the Floor Leader.

<u>Floor Leader Pro Tem Angel A. Demapan:</u> Thank you, Mr. Speaker. So the amendment added by the Senate was Section 3, which is the retroactive application. If we read the retroactive application it's still consistent with the intent of the bill. The intent of the bill was to guarantee the payment of 25% portion of the death benefit. Right now for the retirees that have passed away and the retirees that will pass away – their beneficiary is receiving 75% of the death benefit from the settlement fund, however the 25% portion is not a function of the settlement fund and this bill would obligate the CNMI government through the Secretary of Finance who also serves as the administrator of the Northern Marianas Retirement Fund to pay the 25%. I am a little bit confused by the inquiry of colleague Chairman Dela Cruz about living retirees because these benefits don't get paid to living retirees. They get paid to the beneficiary of every retiree that passes away. In terms of funding, in crafting this bill initially, I was consulting with the Secretary of Finance and there are still funds for now – the Northern Marianas Islands Retirement Fund because there are still a handful of DB members in that program. So, there is still funding in there supporting the old Northern Mariana Islands Retirement Fund and it will be through that source

of funding that these death benefits would be paid up. So, I hope I answered your concern Chairman Dela Cruz. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Representative Angel. Thank you for that clarification. Further discussion? Ready? Clerk for the roll call.
