Tuesday, April 24, 2018

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its First Day, First Special Session on Tuesday, April 24, 2018 at 9:47 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS Section 8. Referral of Bills and Resolutions

The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the Journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred.

Speaker Rafael S. Demapan: Si Yu'us Ma'ase, Clerk. With all 20 members voting in the affirmative, House Concurrent Resolution 20-2 hereby passes the House. Thank you, members. Now that we just approved the Concurrent Resolution, I ask each member especially the members from the Ways and Means to focus on the upcoming budget. Thank you, members. So with that, we will go ahead and go down to item XVI and before we begin, can I ask for a short five minutes recess. Recess.

The House reconvened at 11:01 a.m.

BILL CALENDAR

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Back from our recess. Prior to our recess we were on item XVI, Bill Calendar. Let me now recognize the Floor Leader for the first House Bill to be motioned.

The Floor Leader offered a motion to pass the following House Bill on First and Final Reading:

H. B. NO. 20-164

To appropriate fifteen million dollars (\$15,000,000) from the Special Casino Gross Revenue Tax Account, earmarked under 4 CMC §2308.

REP. ANGEL A. DEMAPAN of Saipan, Precinct 1 (for himself, Representatives Blas Jonathan "BJ" T. Attao, and John Paul P. Sablan)

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Floor Leader. Again, your motion has been seconded. Discussion on that motion? Let me recognize Representative Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. As I mentioned earlier, one of the first items here on House Bill 20-164 involves a \$7 Million Dollar appropriation for the removal and remediation of mold and rehabilitation and procurement of a new air-conditioning system for the *Guma Hustisia*. The Chair would like to thank the Director of Courts, Ms. Sonia Camacho who provided the members with a copy of the communications between the judiciary and the CIP office as well as the breakdown with anticipated cost and finally the cost summary provided by WM Engineering Services, LLC as a result of RFP 17-Judiciary-03 entitled "The assessment for mold remediation and eradication design." Mr. Speaker, I understand that most if not all the members have several concerns that they'd like to be addressed regarding this appropriation. We do see from these documents that have been submitted that WM Engineering Services have submitted a quotation or estimated project cost of \$4.3 Million Dollars and the court has submitted a proposed budget for other collaterals which bring the total up to \$7 Million Dollars and so for the sake of clarification Mr. Speaker and if there's no objection from the members, I would like to recommend that we dissolve to the Committee of the Whole to entertain the judiciary at this time.

Several members voiced "no objection."

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Angel. Let me ask the Floor Leader for the proper motion to effectuate a motion to dissolve into a Committee of the Whole so we allow the judicial to also enlighten the members and as stated by Representative Angel to do some clarification on the figures. Floor Leader.

<u>Floor Leader Glenn L. Maratita:</u> On that note Mr. Speaker, I move that we dissolve into Committee of the Whole.

The motion was seconded.

There was no discussion and the motion to dissolve into Committee of the Whole was carried by voice vote. There was no nay vote.

The House dissolved into Committee of the Whole at 11:08 a.m.

COMMITTEE OF THE WHOLE

The House reconvened into plenary session at 12:39 p.m.

<u>Floor Leader Glenn L. Maratita:</u> I would like to make a motion that we rise back to our plenary session. So move.

The motion was seconded.

There was no discussion and the motion to reconvene into plenary session was carried by voice vote. There was no nay vote.

Speaker Rafael S. Demapan: Floor, can I ask you to restate the motion?

<u>Floor Leader Glenn L. Maratita:</u> Motion is for the passage on Final Reading, Mr. Speaker, House Bill 20-164.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Thank you. Your motion has been seconded. Discussion on that motion? Recognize Representative Propst.

Representative Edwin K. Propst: Thank you, Mr. Speaker. I think it's safe to assume or we can tell from all of our comments from our colleagues that we are all in support and I thank the Chairman of Ways and Means for putting this bill together and for pushing this funding for our court. Again, my only concern is that we just got this. I personally would like more time to review this — we just got the assessment and I would like to have time to ask a few more questions. I ask this because we do know that the timeline as Director Sonia had mentioned is about 365 days for completion of this contract, this RFP that would put from start to finish. If

you look at an actual RFP that's put together normally takes two to three months or something. So we're looking at it's not going to happen tomorrow even if we were to appropriate it today, the courts are not going to open up tomorrow. I am not asking for three months or six months, we're asking for time until our next session to have time to look at this, analyze it, ask critical questions that we may have that we may not have right now because again I am trying to absorb all of this but I do have some questions that I'm sure will come up later. I need to look at description of things and compare it and contrast to other places to try to get a better analysis. I do – I am aware this is not the actual quote and this is just an idea of how much it's going to cost, but I do want to just have a little bit more time and that is what I have been requesting Mr. Speaker and I would encourage that we have a feedback and input from our community that might help as well. I know that we have a strict timeline, but again this just came out today – this bill and we're about to vote on it on First and Final Reading. I would definitely support in our next session if we can have just a little bit more time. That's all I'm asking. Thank you, Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Propst for your comment. Further discussion? Let me recognize Representative Angel Demapan.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker. In non-judiciary related issue. I would like to offer a floor amendment to House Bill 20-164.

Representative Angel A. Demapan offered the following floor amendment:

AMENDMENTS:

1. Page 2, Line 16:

Delete "Five Million dollars (\$5,000,000.00)" and insert "Three Million Seven Hundred Thousand dollars (3,700,000.00)".

2. Page 2, Line 21:

Add new subsections (d) and (e) to read as follows:

- "(d) Six Hundred and Fifty Thousand dollars (\$650,000.00) shall be used to pay Docomo Pacific, Inc. as the CNMI Government's cost share for the installation and operation of a new fiber network on Tinian as referenced in the Memorandum of Understanding between the Government of the CNMI and Docomo Pacific, Inc dated March 10, 2016. The Secretary of Finance shall be the expenditure authority for the funds appropriated under this section.
- (e) Six Hundred and Fifty Thousand dollars (\$650,000.00) shall be used to pay Docomo Pacific, Inc. as the CNMI Government's cost share for the installation and operation of a new fiber network on Rota as referenced in the Memorandum of Understanding between the Government of the CNMI and Docomo Pacific, Inc dated

March 10, 2016. The Secretary of Finance shall be the expenditure authority for the funds appropriated under this section."

Consistent with the intent of the forgoing amendment(s), I hereby also move to allow the Legal Counsel together with the House Clerk to make further non-substantive technical amendments that are strictly necessary to effectuate the intent of this floor amendment prior to transmittal.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Representative Demapan. Your floor amendment has been seconded. Discussion on the amendment? Floor Leader recognized.

Floor Leader Glenn L. Maratita: Thank you, Mr. Speaker. I just thought I'd put this on record about the amendments that was made. I am not really sure if the Tinian Delegation had the opportunity to meet with Mr. Dino Manning from Docomo Pacific, but for the benefit of the members and transparency of course, the figure of \$650,000.00 for Rota and Tinian came about from Docomo representatives in itself in our meeting back in April 4th – I was given the assurance that also \$1.7 Million of that coverage was suppose to come from CIP. So to briefly state the reason of having to appropriate or set aside \$1.3 Million is because of these information Mr. Speaker and I would like to ask the indulgence of the members to support this amendment. Thank you.

Speaker Rafael S. Demapan: Si Yu'us Ma'ase, Floor Leader. Recognize Representative Donald Barcinas.

<u>Representative Donald C. Barcinas:</u> Thank you, Mr. Speaker. I just wanted to inquire about the inability of the CIP program to get the funding and what happened to that?

Speaker Rafael S. Demapan: Thank you. Let me recognize Representative Angel Demapan.

<u>Representative Angel A. Demapan:</u> Representative Barcinas, are you referring to the \$1.7 Million he just mentioned – the Floor Leader just mentioned? That \$1.7 Million is going to be paid if not already paid by the CIP office. \$1.3 Million is the remaining and that's split into two between Rota and Tinian.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Angel for that clarification. Further discussion? Ready? Recognize Representative Frank Dela Cruz.

Representative Francisco S. Dela Cruz: Thank you, Mr. Speaker. I know that there's some funding from House Bill 20-29, HD1, SD2 to pay for Tinian's obligation on this fiber optic interconnection by Docomo. Now we're proposing \$1.3 Million Dollars, \$650,000 Rota and \$650,000 Tinian. I guess we need to be clear on why these amounts are being paid to this private

company. It was because back in the day when Docomo Pacific decided to lay their ATISA cable between Saipan and Guam, Tinian and Rota were not included in the package. So as a government and just to be clear, I wasn't in the legislature at that time. As a government it saw fit that our two islands be also included, but that came at a cost - a cost of about \$6.9 Million Dollars to include Rota and Tinian in this new fiber optic cable and of course Docomo said we can do it you have to pay, but I'm thinking we're one Commonwealth. Who is this private company to tell us that "if you don't pay us we cannot include Rota and Tinian." You're a private company, you're going to make profits from the consumers, the people of the Commonwealth, but no. So here we are paying this private company to profit from our Commonwealth. I don't know where this happens. Surely doesn't happen in the US or Hawaii. You're a private company, you are going to make a profit otherwise you wouldn't go into business and they new this, but the CNMI government gave way and said "okay, we don't want to leave Rota and Tinian behind, so we'll fork out the six point something million." Mr. Speaker and members, I totally disagree with this. I was not in a position to oppose this at the time but let us not make the same mistake to other companies that come in or even Docomo for that matter of trying to do business in the Commonwealth and at the same time sticking it to the people that are giving them this opportunity to do business here. I just wanted to state that for the record and I know that the amendment offered by Chairman Demapan is somewhat comingled with the \$7 Million Dollars so it's almost like we're torn. I wouldn't have voted for this payment to Docomo if it was a standalone legislation, but it's almost like a package deal. Don't vote for Docomo, we hurt the judiciary. Again Mr. Speaker, I just wanted to share this issue. Thank you.

Speaker Rafael S. Demapan: Thank you, Representative Dela Cruz. Let me recognize the mover.

Representative Angel A. Demapan: Thank you, Mr. Speaker. Just in response to Representative Dela Cruz, although his concerns are valid none of us like Representative Dela Cruz were in a position to influence the memorandum of agreement that was exercised between the Commonwealth and Docomo Pacific. However, we're in a position to decide whether we want to satisfy an outstanding obligation of the government. How we got there, beyond our control but the power is here and the power of the decision to satisfy outstanding obligations is here. We can choose not to fund the commitment to Tinian and Rota's fiber optic network. Docomo Pacific at that time in 2016 also had a choice to decide whether to connect to Rota and Tinian because it was not a requirement. They could have easily connected to Saipan and that was it but our government although it's not the legislature, bound Docomo Pacific and the government into a commitment. In order for our residents of Rota and Tinian to have the opportunity to enjoy the connectivity to the world. If we decide today that we don't want to satisfy these obligations - I believe the Floor Leader has met with Docomo Pacific and has been informed that Docomo Pacific is okay without us satisfying the obligation, but they would terminate the services and disconnect the fiber optic connection to Tinian and Rota. I want to remind everybody in this body and the general public that when IT&E entered the Commonwealth to lay the first fiber optic network, although IT&E was not given \$1.3 Million Dollars in subsidy it was given exclusivity that made them profit far and beyond any profit Docomo Pacific stands to realize as a result of this subsidy. Again, we were not a party to that agreement. We were not a party to that negotiation, but what we are a party to today is the governments financial obligation and this is one of them. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase,* Representative Angel Demapan. Before I recognize Chairman Edwin, let me recognize Representative Deleon Guerrero.

Representative Lorenzo I. Deleon Guerrero: Thank you, Mr. Speaker. In regards to the proposed allocation \$650,000 for Rota and Tinian to pay Docomo. I have in front of me a Memorandum of Agreement it was signed by the Governor, President and CEO of Docomo and Chairman of Docomo and I did ask this question prior. How effective is this document that we are now considered in debt? I wanted to ask Legal Counsel. How effective is this Memorandum of Understanding and why hasn't it passed through the office of the Attorney General? Thank you.

Speaker Rafael S. Demapan: Let me allow the Legal Counsel to respond to that question.

<u>Legal Counsel John Cool:</u> I have not reviewed the Memorandum of Understanding, but your questions are legitimate. I don't know how it didn't go through, apparently, it's not signed by the Attorney General. It was an obligation that was taken on by the Governor as the Chief Executive of the Commonwealth. It was relied upon by Docomo and they performed, but I do have serious questions just as you do as to why they didn't go through at least the proper channel of having an Attorney General review it because it is a contract. At that time, as the law related to the responsibilities of the Attorney General is that the Attorney General is suppose to review all contracts for legal sufficiency and capacity. In this case, apparently the law was not complied with.

Speaker Rafael S. Demapan: Thank you, Counsel. Further?

Representative Lorenzo I. Deleon Guerrero: Thank you, Counsel for agreeing with me.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Deleon Guerrero. Let me recognize Representative Edwin Aldan.

Representative Edwin P. Aldan: Thank you, Mr. Speaker. Mr. Speaker and members, like every other previous speaker have commented on this issue even during yesterday's leadership this obligation was consummated by the Administration and Docomo. Here we are again, the municipality are trying to find ways to make sure that the services are not interrupted or cut – or Tinian and Rota cut from the entire world. Communication is very essential to our livelihood in Tinian. As we speak, we are starting to do telemedicine, broadband educational system's that have been provided through NMC and PSS. We do not have science labs on Tinian for our students so they are connected to the schools here on Saipan. I am not going to sit around and wait for somebody to pay for it when we know that Docomo is knocking on the door telling us "you don't pay come June, we're going to disconnect you." As a Representative of Tinian and I am glad that Representative Angel and other members are considering and I ask for your support. So once and for all we pay this amount. The amount we have on a different bill is \$450 because that's all we have that we could afford to pay upfront but actually its \$650 that we needed. Like yesterday's leadership discussion we were talking about this to accommodate Tinian and Rota and I thank the other members for supporting this and I urge other members to please support this. This is not only going to particular projects in Tinian and Rota but for a very essential project that is undertaken and is providing services to our people on the islands of Tinian and Rota. I continue to urge the support of the members. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase*, Representative Aldan. Let me recognize Representative Joe Deleon Guerrero.

Representative Joseph P. Deleon Guerrero: Thank you, Mr. Speaker. For those members who are considering this amendment, I think it's important that we shed some light – a little bit of history about this issue and Representative Dela Cruz as he stated was not there when this issue was raised. After the internet blackout happened in July 8, 2015 when the fiber optic cable was severed, I think most of you remember that the impact it had and how reliant we all were on internet services, using your ATM cards, trying to withdraw funds from the bank our payroll, just about every service relies heavily on this connectivity. When that happened, it was a wakeup call. At that time, we only had one fiber optic cable servicing our islands. That incident made us aware of how important redundancy is. How we needed to have not just one, at least two or more cables so that in the event such an incident happen we could still function. If you recall at that time, IT&E tried to rely on the microwave to service our needs, but it was incapable. It didn't have the capacity to meet our needs. Subsequent to that Docomo did approach this body and I was there and some members probably were there at that time. Their proposal was to link Guam and Saipan it did not include Tinian and Rota because of the cost they claimed, but that by having spurs to service Tinian and Rota it would drive the cost up by 60%. We tried to convince them that we understand the economies of scale that Saipan was where the market was but we could not leave Tinian and Rota behind. They were entitled to the same services that Saipan would get for obvious reasons. Whether it would be telemedicine, for the schools or you know payroll. The important thing here was that – I would like to commend the former Governor for taking the initiative to negotiate to find ways so that our neighboring islands could also be serviced. We were not partied to that but I think if you read the memorandum, his approach was to try to secure additional CIP funding to ask Interior for additional funding to accommodate this that was the primary plan. And still that was the primary source of payment to cover these costs. I think that having Tinian and Rota as a municipality be burdened with the cost to provide these services to those islands is not their responsibility. This is a CNMI government responsibility. Yes, the government committed the CNMI government, but as a whole it is not a municipality cost. We are a CNMI, not a municipal government. So, understanding that I hope the members can consider and support the proposed amendment. I also want to mention for the record Mr. Speaker that we just passed Standing Committee Report 20-113 and in it on page 5 under Section 3 was an amendment by the Senate to appropriate \$485,000 to the Second Senatorial District to cover this cost. They did that because they didn't want these services to be terminated if it's not paid. For the record Mr. Speaker, we cannot amend that any further that bill as it came from the Senate we can only accept or reject it. If we do pass this amendment what we can perhaps do is maybe a letter from the Speaker informing the Governor of our actions that we are already are going to satisfy these obligations and to perhaps line item veto that section so that the funding can stay at our solid waste revolving fund. That's all Mr. Speaker. Thank you.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Representative Deleon Guerrero. Let me recognize the Vice Speaker.

<u>Vice Speaker Janet U. Maratita:</u> Si Yu'us Ma'ase, Mr. Speaker. Ya hu ha bai tattiyi si Representative Frank Dela Cruz pot este – pot i munga hit hu ma ayuda i mañelu-ta giya Luta yan Tinian pot este na sibishu. I punto guini hunggan obligasion esta este ni para hita ni taotao Marianas or i gobietnamento na debi di ma apasi este sa i Memorandum of Understanding. Lao

kompania estigue ma'ma' sala'lape. Este na kompania ma charge iyo-ta siha consumers pot i sibishu siha. Pues yaki gi esta guaha i gobietnamento ha asiste este na kompania pot parao ma na posible i fiber optic. Pues hayi gai-iyu pa'go este man ma'matitinas salape pa'go i Docomo ya munge i finatinas niha para tati gi taotao ta? Taya. Ya disde nai'an i executive branch siña ha cho'gue este na klasen Memorandum of Understanding considering the separation of powers. The Legislature I think is the most appropriate branch to come up with perhaps a resolution or some kind of – you know like what we used to do for the Flame Tree, Little League and so forth. I think we have to stop this kind of practice. We should never appropriate or give money to a profit-making company or any other entity. Mr. Speaker, I hope this would be the last. Pot fabot we really need to get a return investment for our community, for our people and again Docomo Pacific is making a huge amount of money charging television, telephone and so forth. We are paying millions and I have not objection to assisting our sister-islands in this regard, but my only concern is what is it for our people that we - I think Docomo Pacific should start giving discounted rate to the people of Rota and Tinian so that at least we have something for them to be making a huge profit. I believe that they should share it back to the people of Rota and Tinian. That is all Mr. Speaker, I just wanted to echo the sentiments again of Representative Dela Cruz that this is a profit-making company and therefore I strongly oppose to this payment, but since it's an obligation of the government, I just have to go ahead and support the bill. Thank you.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Vice Speaker. Let me recognize Representative Frank Dela Cruz.

Representative Francisco S. Dela Cruz: Thank you, Mr. Speaker. I know that we are bound to live up to the commitment of the Commonwealth, but if it's one thing that I will never agree to is the fact that this company from what I'm hearing is threatening the Commonwealth that if we don't make payment, they are going to pull out their cables and their equipment from Rota and Tinian. I guess the beauty of it all is that we don't have a monopoly now. They can't pull out if that's what they want. Let them take their cable, let them take their equipment's, this Commonwealth should not be threatened. They are here to make a profit. Somebody once said it's unscrupulous and we're being bamboozled by this corporation. Let me tell you a little story. At one time, I got a call from this lady in Guam Docomo. She goes, "Hey, Mr. Dela Cruz we have this bundle that we can offer you." I said, "a bundle?" "Yes, a bundle." "Well what does it got?" "It's got internet, it's got cable, landline, wireless." So, I asked the question, "How much is this bundle?" She goes, "Mr. Dela Cruz, it's \$220.00 a month." So, I looked at all my expenses for all these little utilities and it was a good deal. So for two months I was paying my \$220.00 a month bill. On the third month I received a bill for \$560.00. So, I said to myself, "there must be a mistake because this is not what I signed up for, I signed up for the \$220.00 bundle." The lady goes "Mr. Dela Cruz you over exceeded your data bucket." I said, "What? What data bucket? Nobody told me anything about this data bucket." "Yes, you have a data bucket and you over exceeded it." I said, "Oh boy, I got bamboozled." I am wrapping Mr. Speaker. I am just wrapping up right now. So, one month down the road I stopped this bundle because I cannot pay \$560.00 a month to watch cable, to use the phone. Guess what, two months later they removed the data bundle and I was asking some of the people there, they said "we were losing a lot of customers." They were moving to the other company and I said "wow, that sounds familiar that's just like me." So, I guess this are the unscrupulous things that can happen when we're not careful especially with these telecommunications companies. I am sure a lot of people out there has experience this aside from myself. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Representative Dela Cruz. Again, the floor amendment is before each one of us. It's a policy call on our part. Further discussion?

There was no further discussion and the motion to adopt the floor amendment offered by Representative Angel A. Demapan was carried by voice vote. There was no nay vote.

<u>Speaker Rafael S. Demapan:</u> Thank you, colleagues. Further discussion? Recognize Representative Blanco.

<u>Representative Ivan A. Blanco:</u> Thank you, Mr. Speaker. Just – perhaps we just forgot. Chairman Lee Pan, on page 2, line 7 are we still keeping "wet lands?"

Representative Joseph Lee Pan T. Guerrero: Yes that's right.

Representative Ivan A. Blanco: Thank you, Mr. Speaker. That's all.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. If I may, after serious discussions with our regulatory agencies and serious thought in getting this project going under this source of funding and of course after serious thought let me ask the assistance of the Clerk if we can use the ELMO. I would like to officially offer a floor amendment on House Bill 20-164

Speaker Rafael S. Demapan officially offered the following floor amendment:

FLOOR AMENDMENT TO H. B. NO. 20-164

H. B. No. 20-164 is amended as follows:

- I. Page 2, lines 16 to 20, are amended to read:
 - "(c) Five Million dollars (\$5,000,000.00) Three Million dollars (\$3,000,000.00) shall be placed in a secured account to be accessed in the case of disasters or emergencies. The Secretary of Finance shall be the expenditure authority for the funds appropriated under this section.
- II. Page 2, line 21. Add a new subsection (f)
 - (f) Seven Hundred Thousand dollars (\$700,000.00) for the rehabilitation and improvement of Sugar Dock including architectural and engineering design. The Secretary of the Department of Public Works shall be the expenditure authority for the funds appropriated under this section.

Consistent with the intent of the forgoing amendment(s), I hereby also move to allow the Legal Counsel together with the House Clerk to make further non-substantive technical amendments that are strictly necessary to effectuate the intent of this floor amendment prior to transmittal.

Speaker Rafael S. Demapan: No, we're taking out only \$700 from here. As we all know, Sugar Dock is not just a precinct issue it's a Commonwealth issue and a lot of our residents would go and enjoy, but more so on the safety issue. I stated briefly that we have continue to dialogue with our regulatory agencies and this is just part of the estimated cost that would be needed for the completion of the Sugar Dock. So, I respectfully ask each member to please support the amendment. Recognize.

Representative Lorenzo I. Deleon Guerrero: Thank you, Mr. Speaker. I would like to support this floor amendment, but \$700,000 for the design and rehabilitation improvement of the Sugar Dock. Was there an assessment done and what engineering firm and is \$700,000 would be enough? I read in previous media the intent was to demolish the entire dock and rebuild it? That is not the case now?

<u>Speaker Rafael S. Demapan:</u> That is correct. And this is just half of the estimated cost. A real assessment will come on a later date, but to begin the process from RFP to procurement and so on this is just a portion of that. So again, I ask each member to support it's a health issue and it's long overdue. Further discussion? Ready?

There was no further discussion and the motion to adopt the floor amendment offered by Speaker Rafael S. Demapan was carried by voice vote. There was no nay vote.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Further discussion? Recognize Representative Angel.

Representative Angel A. Demapan: Sorry Mr. Speaker, just one very brief amendment and if the Counsel can pull up on ELMO page 2, just going to insert one word for the benefit of landowners whose land were taken by the government and sometimes are left out in the category of land compensation. So, on item (b) page 2, lines 5 and 6 to insert the word "taking" in between "land" and "compensation." So move, Mr. Speaker.
