# **CALL TO ORDER**

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its First Day, First Regular Session on the Ninth day of January the year Two Thousand and Seventeen at 10:23 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

Speaker Pro Tem Joseph P. Deleon Guerrero: Thank you, Mr. Nicholas. As such, I also wish to welcome all of our guests from here and from afar, ladies and gentlemen and thank you to Father Jesse for your prayers and also would like to welcome the Honorable Chief Justice Castro who will be administering the Oath of Office to the members. Again, *hafa adai*, welcome *tirowami*. At this time, I am proud to call this Twentieth Northern Marianas Commonwealth Legislature, House of Representatives Organizational Session to order. At this time, I will now recognize our House Clerk to call the roll.

<u>Speaker Pro Tem Joseph P. Deleon Guerrero:</u> Thank you, Madame Clerk. Let the record reflect that all 20 Representatives-Elect are present and a quorum is hereby constituted. Before we go to the next item, the swearing-in of members, let me just take this moment to also extend our congratulations to those that were sworn in this morning the Municipal Councils and the CNMI State Board of Education. Congratulations.

### **SWEARING IN OF MEMBERS**

<u>Speaker Pro Tem Joseph P. Deleon Guerrero:</u> Let us now go to our next Order of Business and that is the swearing-in of Representatives-Elect. I ask my fellow Representatives-Elect I ask each one of you to rise for our swearing in as members of this House of Representatives and ask the Honorable Chief Justice Alexandro C. Castro to administer the Oath of Office. Please rise.

Chief Justice Alexandro C. Castro: Please raise your right hand and repeat after me.

The following was repeated by all the Representatives-Elect:

"I do solemnly swear that I will support and defend the Constitution and laws of the Commonwealth of the Northern Mariana Islands, the Covenant to establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, the applicable provisions of the Constitution, laws and treaties of the

United States of America, and that I will faithfully discharge my duties as a Representative of the 20<sup>th</sup> Northern Marianas Commonwealth Legislature to the best of my ability, so help me God."

Chief Justice Alexandro C. Castro: Congratulations.

<u>Speaker Pro Tem Joseph P. Deleon Guerrero:</u> Members, you may be seated. Thank you, Chief Justice for the swearing-in of the members of this House. The next Order of Business is the Introduction and Adoption of the House Rules. The Chair now recognizes Floor Leader Pro Tem Representative Angel Aldan Demapan.

#### INTRODUCTION AND ADOPTION OF THE HOUSE RULES

Floor Leader Pro Tem Angel A. Demapan: Si Yu'us Ma'ase, Mr. Speaker Pro Tem. At this time, I am honored to introduce **House Resolution Number 20-1**, "A House Resolution to adopt the Rules for the House of Representatives and to appoint an Ad Hoc Committee to review the rules; and for other purposes." Mr. Speaker Pro Tem, I move for its adoption.

<u>Speaker Pro Tem Joseph P. Deleon Guerrero:</u> Thank you, Floor Leader Pro Tem. A motion has been offered for the adoption of our House Rules and it has been seconded. Is there any discussion on the motion?

Several members voiced "ready."

There was no discussion and the motion to adopt House Resolution 20-1 was carried by voice vote. There was no nay vote.

<u>Speaker Pro Tem Joseph P. Deleon Guerrero:</u> At this time, we will now move on to the election of the Office of the Speaker. Is there any nomination for the Office of Speaker? The Chair recognizes Representative John Paul Sablan.

# **ELECTION OF SPEAKER**

Representative John Paul P. Sablan: Thank you, Mr. Speaker Pro Tem. At this time, it is with great honor and privilege that I nominate my colleague from the precinct election Precinct 2, Representative Rafael Sablan Demapan.

Speaker Pro Tem Joseph P. Deleon Guerrero: Any second?

The motion was seconded.

<u>Speaker Pro Tem Joseph P. Deleon Guerrero:</u> Thank you. A nomination has been placed on the floor by Representative John Paul Sablan for Speaker, Representative Rafael Sablan Demapan and it has been seconded. Are there any other nominations? The Chair recognizes Representative Gregorio Sablan.

Representative Gregorio M. Sablan, Jr.: Mr. Speaker, I move for acclamation.

*The motion was seconded.* 

<u>Speaker Pro Tem Joseph Pinaula Deleon Guerrero:</u> Thank you. Motion has been offered for the election of Representative Rafael S. Demapan for the Office of Speaker by acclamation it has been seconded. Any discussion on the motion?

Several members voiced "ready".

There was no discussion and the motion to elect Representative Rafael Sablan Demapan to the Office of the Speaker was carried by voice vote. There was no nay vote.

<u>Speaker Pro Tem Joseph Pinaula Deleon Guerrero:</u> Congratulations. Sergeant-at-Arms could you please escort our Speaker to the dais.

# **ELECTION OF VICE-SPEAKER**

Representative Alice S. Igitol: Thank you, Mr. Speaker. It is my privilege that I nominate Representative Janet Ulloa Maratita to the Office of the Vice Speaker for the Twentieth Legislature.

<u>Speaker Rafael S. Demapan:</u> Thank you. There was a nomination for the election of the Vice Speaker. Recognize Representative Lee Pan Guerrero.

Representative Joseph Lee Pan T. Guerrero: Thank you, Mr. Speaker. Mr. Speaker, I move for acclamation.

Floor Leader Pro Tem Angel A. Demapan: Point of order, Mr. Speaker.

Speaker Rafael S. Demapan: Recognize the Floor Leader.

<u>Floor Leader Pro Tem Angel A. Demapan:</u> I believe we need to second the nomination by Representative Igitol.

Speaker Rafael S. Demapan: That is correct.

Floor Leader Pro Tem Angel A. Demapan: Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you for that point of clarification. Do I hear any second for the nomination of the Vice Speaker?

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> There is a nomination and was seconded. Discussion on that motion?

Several members voiced "ready".

Speaker Rafael S. Demapan: Again let me ask Representative Guerrero to restate your motion.

Representative Joseph Lee Pan T. Guerrero: Thank you, Mr. Speaker. Mr. Speaker, I move for acclamation.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Representative Guerrero. Is there an objection to that motion?

Several members voiced "no objection".

<u>Speaker Rafael S. Demapan:</u> So without any objection the motion for the acclamation for the Vice Speaker Janet Maratita is hereby carried. Congratulations Representative Maratita for the Vice Speakership. Moving along we will go down to our next Order of Business and this is the Election of the Floor Leader. Recognize Representative Blanco.

#### ELECTION OF THE FLOOR LEADER

<u>Representative Ivan A. Blanco:</u> Thank you, Mr. Speaker. It is my privilege that I nominate Representative Glenn Lizama Maratita to the Office of the Floor Leader for the Twentieth House of Representatives.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Blanco. Your motion has been seconded. Recognize Representative Frank Aguon.

Representative Francisco C. Aguon: Mr. Speaker, I move for acclamation.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Aguon. Do I hear any objection to that motion?

Several members voiced "no objection".

<u>Speaker Rafael S. Demapan:</u> So with that the motion for the Floor Leader is carried to be by acclamation. Thank you, Representative Maratita. Can I ask the Sergeant to escort the Floor Leader to his proper seat. *Si Yu'us Ma'ase*, Sergeant.

#### NOTIFICATION TO THE GOVERNOR AND TO THE SENATE

Speaker Rafael S. Demapan: Moving along to our next business and this is the notification to the Governor and Senate. I would like to appoint Representative Frank Aguon and Representative Edwin Aldan to inform the Senate and Representative Ivan Blanco and Representative Greg Sablan to inform the Governor that the House of Representatives is duly organized and ready to conduct business, but before that let me ask the members before we go on recess, I would like to ask the members that we immediately come up to the dais and have a group photo and after that representatives assigned will go to their respective duties in informing the Senate of the organization. So with that short recess.

The House recessed at 10:40 a.m.

#### **RECESS**

The House reconvened at 10:58 a.m.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Back from our recess. Prior to our recess we were on the item on Notification of the Governor and the Senate. Just to put more clarity on what had transpired without any objection, I would like to go back to the Election of the Vice Speaker. Is there any objection?

Several members voiced "no objection".

<u>Speaker Rafael S. Demapan:</u> This is also for the Floor Leader. So without any objection, I would like to go back to the item on electing a Vice Speaker. Do I hear a nomination for the Vice Speaker? Recognize Representative Alice Igitol.

# **ELECTION OF VICE-SPEAKER**

Representative Alice S. Igitol: Thank you, Mr. Speaker. It is my privilege that I nominate Representative Janet Ulloa Maratita to the Office of the Vice Speaker for the Twentieth Legislature.

Speaker Rafael S. Demapan: Thank you, Representative Igitol. Do I hear any second?

## *The motion was seconded.*

<u>Speaker Rafael S. Demapan:</u> The motion has been seconded. Recognize Representative Lee Pan Guerrero.

Representative Joseph Lee Pan T. Guerrero: Thank you, Mr. Speaker. Mr. Speaker, I move for acclamation. Thank you.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Guerrero. Discussion on that motion? Recognize Representative Edmund.

<u>Representative Edmund S. Villagomez:</u> Thank you, Mr. Speaker. And maybe for the benefit of the public, can you explain why we are going back to these items and re-electing the officers? Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you for that point of clarification. The reason why I decided to do this because at the beginning of the nomination for the Vice Speaker and the Floor Leader, I just noticed that it was not really clear although I am certain that we are in line with what had transpired, but for the sake of clarity I wanted to make sure that I pose the question is there any "ayes" and "nay" for that nomination. So with that I hope I clarify myself. Since we are under the motion of electing a Vice-Speaker is there any objection to that?

Several members voiced "no objection".

There was no further discussion and the motion to elect Representative Janet Ulloa Maratita to the Office of the Vice Speaker was carried by voice vote. One member voiced nay.

<u>Speaker Rafael S. Demapan:</u> It appears that the "ayes" have it therefore, Representative Janet Maratita is the Vice Speaker. Now moving along and again to put more clarity on what transpired. Do I see any nomination for the Floor Leader? Recognize Representative Ivan Blanco.

# **ELECTION OF THE FLOOR LEADER**

<u>Representative Ivan A. Blanco:</u> Thank you, Mr. Speaker. It is my privilege that I nominate Representative Glenn Lizama Maratita to the Office of the Floor Leader of the Twentieth Commonwealth Legislature House of Representatives. Thank you.

*The motion was seconded.* 

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Blanco. Again, your nomination has been seconded, discussion on that nomination? Recognize Representative Frank Aguon.

Representative Francisco C. Aguon: Mr. Speaker, I move for acclamation.

The motion was seconded.

There was no discussion and the motion to elect Representative Glenn Lizama Maratita to the Office of the Floor Leader was carried by voice vote. There was no nay vote.

<u>Speaker Rafael S. Demapan:</u> Again, Representative Glenn Maratita is hereby the new Floor Leader. That took care of the clarification. Going back to our next item, which is the notification to the Senate and to the Governor. Now I would like to recognize Representative Frank Aguon.

#### NOTIFICATION TO THE GOVERNOR AND TO THE SENATE

<u>Representative Francisco C. Aguon:</u> Thank you Mr. Speaker and members, Representative Edwin Aldan and I notified the Senate that the House is duly organized and ready to conduct business. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Aguon. Mind if I ask did we notify the Senate?

Representative Francisco C. Aguon: Yes, we did.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Aguon. Recognize Representative Edwin Aldan.

<u>Representative Edwin P. Aldan:</u> Yes, we did. At the same token Mr. Speaker the Senate Pro Tem is aware of the notification just to have the members understand that the Senate had just started their session.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Aldan. We will deal with that as we continue to move on. Now let me recognize Representative Ivan Blanco.

<u>Representative Ivan A. Blanco:</u> Thank you, Mr. Speaker. Mr. Speaker and members, Representative Greg Sablan and I have notified the Honorable Governor Torres that this body is duly organized and ready to conduct business. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Blanco. Again, members the notification to the Governor as we all know the Governor was just here with us so yes indeed the Governor has been officially notified of our reorganization. Moving along which is the statement from the Speaker on behalf of the members.

# STATEMENT OF SPEAKER ON BEHALF OF THE MEMBERS

<u>Speaker Rafael S. Demapan:</u> So with that let me go ahead and say a few words. As Speaker of the House, I was given the privilege to be the voice today to reorganize and acknowledge on behalf of the members, the dignitaries here including our Governor Ralph Torres and Lieutenant Governor Victor Hocog, also with us is Guam's Speaker BJ Cruz, members of Guam *Liheslaturan*, Executive and Judicial Branches of government and most especially the most hardworking staffs of government and staff of the Legislative Bureau and legislature. I recognize our business community, our faith based community, and our GOP officials and our respective

election campaign committee members, families and friends from here and who traveled a distance to be here with us. Thank you for all your support and welcome to the 20<sup>th</sup> Northern Marianas Commonwealth Legislature. In the days leading to this special day, I reflected on what today's inauguration event meant to me and to each of us. With 20 House of Representative members in this 20<sup>th</sup> Legislature with a 15 body Republican super majority and 5 body minority bloc, I have quite a role and shoes to fill once again as Speaker of the House. We can say that today marks about 40 years since we first established our Commonwealth Legislature and though it was not very long ago when I was 40 years old myself and still in my 40s, perhaps I would like to think that like a 40 years old man or woman and I am proud to acknowledge the strength of a woman; in fact we have two women serving this body, our Legislature today also has reached a point where it is not as young but yet not as old either. Like a person in his or her 40s, it is wiser, mature and with many life experiences have gained a sense of identity and may have also experienced many changes in life where even clothes do not fit or look right for our age anymore, but yet we still feel young, strong, active and also still searching for answers to better reach our purpose in this world and mark in life. This milestone for our Commonwealth is somewhat like that of a person's mid-life, mid-life crisis some will say and where perhaps we are at a crossroads in our political and government journey and so our work in the next two-years in one that I will be marked with much attention, intention and care. And like shepherds as Bishop Ryan stressed in his homily at our Red Mass on Saturday let us chart the course together with purpose and with an understanding and wise heart. Our dear Commonwealth of the Northern Marianas has certainly been through so much in its journey, may it be adjusting and adapting to the U.S.-Commonwealth political relationship and way of life to embracing the tourism industry, building of our first economy and welcoming of different people and cultures into our doors in our early years to crawling out of the collapse of our garment industry and the global economic crash to now walking out of our economic slump and now realizing for the first time in many hard years an economic revival that perhaps feels like it is moving faster than we can keep up with. My colleagues and people of this Commonwealth, we are at our prime. My colleagues and people of our dear Commonwealth let us commit to each other today to bind our heads and hearts together, let us commit to use and share our talents, knowledge and experience with each other to secure a prosperous and thriving Commonwealth and as I shared at my 19<sup>th</sup> Legislature Sine Die speech as I reflected on Pope Francis' New Year's message last Sunday at the Vatican before a crowd as big as the population of the CNMI, he said, "The year will be good in the measure that each one of us with the help of God seeks to do good day after day," he told the crowd. So with that my colleagues and people of our dear Commonwealth let us commit to use the still so vibrant 40 years old energy, wisdom and drive in this 20<sup>th</sup> Northern Marianas Commonwealth Legislature to make our mark and to do good for ourselves and our families. Let us commit to do good for our people and great Commonwealth today and for generations to come. Let us seek out the possibilities and the potential in all of us and our great Commonwealth and as reflected at the Red Mass on Saturday, we are shepherds of our people and the good Lord up above. Let us commit to seek good. In closing and in the name of seeking out good, I commit to lead as your Speaker with tender loving care, but one that will be bold, pointed and one where we will chart a course forward together where we are not just waiting for our future. We are going to make our future where we are not waiting for things to happen, we will make things happen. Si Yu'us Ma'ase, Olomwaay, God bless us all. Gee, I reflected a lot on what the Pope and our Bishop have said on his speech. Bishop Ryan commented at the Red Mas on Saturday that former Speaker Joe Guerrero sounded like a deacon after acknowledgement address. I think Bishop Ryan will say I sound like a priest in my Inaugural message here. So former Speaker Joe do not worry we are in

this together. We are indeed the real shepherds. So I thought I would share that with all of you. So moving along, I do understand that the Senate is still ongoing with their ceremonial so with that we will go ahead and go down to the announcement.
