Tuesday, February 28, 2017

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its Third Day, First Regular Session on Tuesday, February 28, 2017, at 1:42 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

A moment of silence was observed.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Before we begin, let me just make a short announcement. Right after the roll call, the Speaker will call a Committee of the Whole so that we can allow presentation to Mr. Joe Ayuyu and also to receive Mount Carmel sixth-graders to make a short Q&A before the House of Representative. So with that Clerk for the roll call.

ROLL CALL

The Clerk called the roll and all twenty members were present.

<u>Speaker Rafael S. Demapan:</u> Thank you, Clerk. With all twenty members present we do have a session for today. So with that let me go ahead and recognize the Floor Leader to make a motion – move to dissolve into the Committee of the Whole.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Mr. Speaker. With that I move to dissolve into Committee of the Whole. So move, Mr. Speaker.

The motion was seconded.

There was no discussion and the motion to dissolve into Committee of the Whole was carried by voice vote. There was no nay vote.

The House dissolved into Committee of the Whole at 1:44 p.m.

COMMITTEE OF THE WHOLE

The House reconvened in plenary session at 2:21 p.m.

Speaker Rafael S. Demapan: Now, I ask the Floor Leader to rise back to our plenary session.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Mr. Speaker. On that note, I would like to offer a motion to rise back to our plenary session. So move.

The motion was seconded.

There was no discussion and the motion to reconvene in plenary session was carried by voice vote. There was no nay vote.

<u>Speaker Rafael S. Demapan:</u> Now back to our plenary session. Before we go further, let me ask the Floor Leader again before we get down to item II, which is the Public Comment. Can I ask the Floor Leader for a motion to suspend rules.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Mr. Speaker. I would like to move to suspend Rule IX, Section 4 (d) so that the House amends its agenda to include unnumbered bill, resolutions and communications. So move, Mr. Speaker.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS.

Section 4. Format of Bills and Resolutions.

(d) Bills and resolutions for introduction may be pre-filed with the House Clerk for formal introduction at the next session, provided that it is pre-filed in sufficient time to appear on the session agenda as required under Rule III. The 72-hour notice and agenda requirements may be dispensed with for Special Emergency Sessions and Sessions called by the Governor in accordance with Rule III.

<u>Speaker Rafael S. Demapan:</u> Thank you, Clerk. Any comment or discussion on Messages from the Governor? Recognize Chairman Guerrero.

Representative Joseph Lee Pan T. Guerrero: Thank you, Mr. Speaker. I know everyone is tired of hearing me Mr. Speaker, but on Governor's Communication 20-19 seems like here is another Assistant Attorney General that is milking the pot of gold. Apparently – I know for a fact that the Casino Commission is being charged for service rendered under this Assistant Attorney General and now here is the Attorney General giving a hefty salary increase and when you compare 20-19 and 20-20, I feel that I am obligated to defend the Public Defender knowing that they probably only have four Public Defender – they are serving together higher salary than fifty-eight five. So with that Mr. Speaker, I hope that this is something that the Governor would closely look and monitor because somehow the AG has been very vindictive with the Legislature in terms of all issues. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase,* Floor Leader. A motion has been seconded. Discussion on that motion? Recognize the Minority Leader.

Representative Edmund S. Villagomez: Thank you. I just wanted to ask the Chairman Representative Angel Demapan. Yesterday, I received two emails, one from the Gaming Commission and PSS. Are we going to include this as part of the – I mean I know it is on for action. Basically I wanted to ask if you did receive these emails.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Villagomez for the response. Recognize Chairman Angel.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker. In response, I received one of the two. I have received the communication from the Casino Commission only.

Speaker Rafael S. Demapan: Further?

Representative Edmund S. Villagomez: Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Minority Leader. Further discussion. Recognize Chairman again.

Representative Angel A. Demapan: Thank you, Mr. Chairman. And as the mover of the bill and Chairman of the committee that worked on this bill, I just wanted to point out some of the highlights of marking this bill up for the sake of the members that are not in the Committee of Ways and Means, but mainly some of the important parts that warrant the attention to mark up this bill and ask the support of the members is one to create the casino gross revenue tax account that would make these accounts separate from the general fund so that we can take care of the entities that are listed in subsection 2308 as it is being proposed to be amended. Second, we also looked at the retirees pension issue, so we included provisions here to ensure that when there is a shortage in the 25% reduction in retiree benefits that this particular section can be used to cover any deficiency in funding needed to make that 25% reduction pension payments in whole. Third, we also realize when the developer or the licensee on this case first executed their license agreement with the government they paid upfront casino license payment for the first and fifth year. The fifth year is coming up as we know because they paid for it ahead of time, we are not expecting any payment in the amount of Fifteen Million Dollars for the fifth year and in anticipation of that we also included provisions to reserve Seven Thousand Five Hundred Dollars from the casino gross revenue taxes collected for the years 2017 and 2018 and those funds equaling Fifteen Million Dollars will be used for the intended purpose for the license fee to take

care of the 25% portion of the retirees pension. So in addition to adding a few more recipients to the eligibility list these are the three important highlights of the bill that warrant our attention and as Chairman of the Committee of Ways and Means after working with the membership of the committee I ask for the support of the members in adopting this committee report and furthermore the support of the members when we get to the Bill Calendar. In further response to the Minority Leader, I did receive the communication from the Casino Commission, however that communication was just received yesterday if I am not mistaken so the committee did not have a chance to entertain that request. As Chairman just from my cursory review of that communication, I believe that we can entertain the request in other legislations particularly the upcoming annual budget. The Casino Commission has submitted their budget request for the new fiscal year and they have included the same funding needs that that they are identifying in their communication regarding casino gross revenue. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Chairman, just to clarify because you have mentioned about using the number Seven Thousand is that a correct figure or \$7.5 Million?

<u>Representative Angel A. Demapan:</u> Seven Million Five Hundred Thousand - \$7.5 Million is the correct figure. Thank you very much.

Speaker Rafael S. Demapan: Thank you, Chairman. Further discussion? None.

There was no further discussion and the motion to adopt Standing Committee Report 20-3 was carried by voice vote. There was no nay vote.

Speaker Rafael S. Demapan: Floor Leader.

The Floor Leader made a motion to adopt the following Standing Committee Report:

S. C. R. NO. 20-4: Reporting on H. B. No. 20-8, entitled: "To restrict the use of cellular/mobile telephones while driving vehicles; and for other purposes." *Your Committee on Public Utilities and Communications recommends that the House pass the bill in the form of H. B. NO. 20-8, HS1.*

The motion was seconded.

There was no discussion and the motion to adopt Standing Committee Report 20-4 was carried by voice vote. There was no nay vote.

Speaker Rafael S. Demapan: For the last committee report Floor Leader.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Mr. Speaker. Again, I move for the adoption of Standing Committee Report 20-5 –

S. C. R. NO. 20-5: Reporting on H. B. No. 20-23, entitled: "To define industrial port use, port related operations and to amend 1 CMC §2806 (g), Public Lands: Fundamental Policies; and to allow government agencies on the islands of Tinian and Rota to lease public lands, conveyed to them by Public Lands, for legitimate public purpose related to

their agency's mandate." Your Committee on Natural Resources recommends that the House pass the bill in the form of H. B. NO. 20-23, HD1.

<u>Speaker Rafael S. Demapan:</u> Floor Leader, if I may sorry to interject. I believe as we did discuss this during our leadership and through the request of the respective Chair to hold on to this. Can I get further clarification on that? Representative Chairman Edwin Aldan.

Representative Edwin P. Aldan: Thank you, Mr. Speaker. For the members this bill is almost the same as what Senator Jude – that we are going to entertain that we just placed on the Bill Calendar and what we wanted to do was pass that first and see from there and then put this on the committee status because we do not know the AG's opinion on this one because we did seek for an opinion – the Senate did seek for an opinion and there was no response for this. So I request that it would be placed on hold on committee until such time we see what is the outcome of the AG's opinion on this one.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Chairman. So having said that we are going to go ahead and keep it on the Standing Committee Report item. So with that Standing Committee Report 20-5 still remains on the Standing Committee Report. Moving forward to item XIII, Reports on Special and Conference appears to be none. XIV, Unfinished Business – now move to...

Representative Francisco S. Dela Cruz: Mr. Speaker, just for clarification.

Speaker Rafael S. Demapan: Recognize Chairman Frank Dela Cruz.

Representative Francisco S. Dela Cruz: Are we then referring Standing Committee Report 20-5 back to the Committee on Natural Resources and if so, I believe that we need to make a motion to do just that. It is already on the floor and we are basically deliberating on the Standing Committee Report. So if we choose to have it in the committee, we need to refer it back to that committee because right now it is on the floor. I hope that is correct Counsel if I am not –

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman. I believe the intent here and maybe the Counsel can come in and – the intent here is to just leave it on the Order of Business, which is the Report on Standing Committee and not refer it to the committee. Did I clarify that? Alright. So with that we will go ahead and go down to item XV, which is the Resolution Calendar and I now recognize the Floor Leader.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Floor Leader. A motion has been seconded, discussion? Recognize Representative Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. I have a technical error that needs to be fixed and if I can refer to Legal Counsel on a omission that occurred during the deliberation in committee to state that the intent is to have fifteen members in the Committee of Ways and Means instead of the fourteen that is reflected in the committee report.

Speaker Rafael S. Demapan: Thank you, Chairman. Any objection to that technical?

Several members voiced "no objection".

Speaker Rafael S. Demapan: Further discussion? Recognize Chairman Deleon Guerrero.

Representative Joseph P. Deleon Guerrero: Before we adopt the motion which we will adopt our House Rules, I just wanted to point out for the benefit of the members. One of the things this rule does is clarify how bills get to the calendar and get passed. If you do not mind me kind of talking about that. You know I have always had this – it is always unclear despite how many years in this House what constitutes First Reading, Second Reading and Final Passage. As our Legal Counsel has stated different legislatures do it differently. Our House Rules right now, First Reading is when the bill gets to calendar and the motion is offered to passed that would be our First Reading. If it passes – if the motion would be to pass it on First and Final Reading. Once on calendar an amendment is made it cannot be passed that would have to be – it will have to stay on the calendar and in the next legislative session it will read be read as Second Reading. If there are no further amendments then it would pass in the Second and Final Reading. If we amend it again on the Second Reading then it cannot go for passage it stays again on the legislative calendar and can continue to stay. In other words, any amendments to a bill on the calendar would have to stay there one legislative day. I think the intent has been for transparency and to allow any amendments to afford anybody who wants to make a public comment or even us to properly review it. So any amendments would keep again on the calendar for another legislative day. So to me that is the big change. I think it is about time it is clarified you know when we pass it and sometimes a bill is substituted and passed. And the bill is a totally different animal, but this House Bill now the way it is currently written is - does well for transparency and for proper review. And so that is how the reading is in our rules and so I urge the members to support the rules as written unless there are other technical changes that need to be made. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman Deleon Guerrero. Recognize Representative Attao.

Representative Blas Jonathan "BJ" T. Attao: Thank you, Mr. Speaker. And this is just to ask question in line of what Representative Joe Guerrero mentioned. We all know that the budget does not pass for one amendment or two amendments or three amendments. So are we going to be put in a situation where we are going to make an amendment, hold another session to make another amendment, to hold another session to make another amendment? Or can we do multiple amendments and consider one amendment on First Reading. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative. Let me allow the Chair to respond to that Chairman Angel.

<u>Representative Angel A. Demapan:</u> I am sorry Mr. Speaker. The Floor Leader is the ad hoc Chairman. I am just a member. I yield to the Chairman of the ad hoc committee.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Chairman Angel. In response to our good colleagues question. We did review Rule IX, Section 9 and 10 to resolve that issue – one of us may offer a suspension motion to that regard so that we can act on that matter at the same day or the same calendar day. And Counsel you may chime in if you wish to.

<u>Legal Counsel John Cool:</u> Actually you do not need the suspension motion. On the First Reading you can have multiple amendments. The idea – this is the original rule it really has not changed we just simplified it a little bit more, but the idea is that the First Reading that is when you make your amendments and you can make multiple amendments to the bill and once it is completed it goes on to the calendar for Second Reading at the next session. The purpose is to give the public notice of the changes to the bill so that they have any additional public comments they wish to make to inform them what is going on and to apply with the provision to the Open Government Act. So multiple purposes.

Speaker Rafael S. Demapan: Thank you, Counsel. Representative Attao you wanted to?

Representative Blas Jonathan "BJ" T. Attao: Yes, Mr. Speaker. This is just a concern because the budget bill is not like any regular bill that we are going to or any other appropriation bill that we are going to be introducing to this body. We are on a timeline when it comes to the budget and if we do have to wait till the eleventh hour and then we are going to make amendments to all of these stuff – I mean why don't we just fix it in this specific – on our House Rules and allow at least the budget to be flexible in time. I mean we have worked here long enough to know that the budget process takes a while and the last two fiscal years almost eleventh hour. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative. Let me recognize Chairman Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. In response to colleague Attao's concern and also in expounding on Legal Counsel. This is not a new provision in this rule it has always been here, we have just decided to read it and so it has been here, but there is a solution when we get to times like the budget bill and that is when the Floor Leader will exercise offering

the motion to suspend this pertinent rule so that we can move on with the budget process. This is a rule that has been here so we did not take it out we just decided to honor the word of the rule. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman. Recognize again Representative Deleon Guerrero.

Representative Joseph P. Deleon Guerrero: Thank you, Mr. Speaker and everybody who has talked so far is correct. I think if anything and the budget bill could be the exception where we may need to resort to suspension of rules, but for the most part I think what it also does is kind of forces members to think ahead and make motions and I did not clarify earlier. Amendments that are made on that legislative day could be one it could be twenty amendments pushes it to a second reading. So it forces the members to try to resolve any amendments in that session so that we do not have to keep pushing the bill back, but there is a way and that is to suspend the rules. I think leaving this rule here finally clarifying it so that we are all clear what First Reading is and Second and Final Reading is. In other words, the only time it can move for passage – the vote – is when it is no longer – there is no further amendments that is the big difference. As Angel said it has been in the books, we just have not been really following it to the T. Thank you, Mr. Speaker.

Speaker Rafael S. Demapan: Thank you. Further discussion. Recognize.

<u>Representative John Paul P. Sablan:</u> Real quick Mr. Speaker. So to the Legal Counsel, so I am reading here in the Second Reading we cannot offer further amendments. Is that – so when we come to Second Reading it is all about the vote already?

<u>Legal Counsel John Cool:</u> Correct. If you get to the Second Reading and you need to make further amendments you would make a motion to reconsider on First Reading and then you would move it back to First Reading, make your amendments and then it would proceed back on to Second Reading.

<u>Representative John Paul P. Sablan:</u> So when it reflects on the agenda under Second Reading meaning that we cannot offer any further amendments and we must proceed to the vote. Is that how it is reading in the rule? If you look at Second Reading.

<u>Legal Counsel John Cool:</u> Yes. Unless you need to make further amendments then you would bring a motion to reconsider under First Reading so you would be moving back from Second Reading for reconsideration back to First Reading. So that is what you would do.

<u>Representative John Paul P. Sablan:</u> John that is where I am trying to come about. It is reflecting on Second Reading on a legislative day. So in order for us to make further amendments we have to make a motion to put it back to First Reading?

<u>Legal Counsel John Cool:</u> Correct.

Representative John Paul P. Sablan: So clarified, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman Sablan. Further discussion? Ready. Clerk for the roll call.
