The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its First Day, Third Special Session on Friday, May 5, 2017, at 10:08 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase*, Clerk. Any comments or discussion on Messages from the Governor. Recognize Representative Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. I just want the record to reflect that this is an ongoing pattern that we have been seeing after several legislatures. I think the issue here is the salary cap – over the salary cap law states that the Governor certifies the OTC to the legislature and that basically ends the process. So it is pretty much for informational use here and nothing that – no action that we can take on whether we affirm or disaffirm. So I would like for this body to consider reviewing 1 CMC subsection (e) to 40 (b) as amended by Public Law 8-6 Section 4 and probably to review just how much enforceability there is regarding this law and what its intended purpose and is it accomplishing its purpose. While we agree that professional positions like this may warrant over the salary cap. What this particular section of the code does not do is provide a guideline, a structure of what that salary level should be and it is coming at the discretion of the Attorney General and often times what is concerning is these are all Assistant Attorney General who hold the same position often times come at the same time, but the salary levels are just determined without any specific guidelines and so I think that is something important to do. We have done it with the civil service pay scale. We have taken that step to upgrade it and make sure that it is commensurate to the duties and responsibilities and I also think that is something that needs to be applied to a professional positions such as attorneys. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Mr. Chairman. Again, thank you for that information and well noted. Let me now recognize Chairman Joseph Deleon Guerrero.

Representative Joseph P. Deleon Guerrero: Thank you, Mr. Speaker. Mr. Speaker, during our meeting yesterday, the Legal Counsel pointed out the salary adjustment act that was passed recently may have repealed these requirements this provision. I wanted to ask if we can have the Legal Counsel clarify that on record. Thank you.

Speaker Rafael S. Demapan: Thank you, Chair. Counsel, can you clarify?

<u>Legal Counsel John Cool:</u> In the process right now of pulling up Public Law 19-83, which was the one that adjusted the compensation schedules for civil service and as part of that act it repealed –

Speaker Rafael S. Demapan: Can you on the microphone?

<u>Legal Counsel John Cool:</u> As part of that act it repealed the section on the certification and imposed another requirement which is simply a reporting requirement that would be done each year by any agency or department or government that is hiring employees that are being paid over the salary cap. I am in the process of pulling up the provision right now and I will be able give it to you in a minute or so.

<u>Representative Joseph P. Deleon Guerrero:</u> Thank you and if you could perhaps prepare a draft for the Speaker's signature to the Governor to remind him that he signed that into law and this provision is no longer relevant or this communication is no longer relevant.

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman. Counsel so as soon as your done let me know so that we can have that communication from this body to the executive. <u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Floor Leader. Your motion has been seconded, discussion on that motion? Recognize the Chairman.

Representative Angel A. Demapan: Thank you, Mr. Speaker. Coming from the Committee on Ways and Means, I want to thank the members and yourself for allowing the committee to review this concurrent resolution because there were some questions that we needed to pose to the Secretary of Finance and the Special Assistant for Management and Budget and those were concerns that we felt if not addressed may lead to skewing the numbers that were projected in the Governor's proposal and thereby compromising the integrity of this concurrent resolution. However, Mr. Speaker following the Committee on Ways and Means meeting; I am pleased to

report that we have addressed the issue of contention that was the \$1 Million Dollar transfer-in reflected from MPLT. We addressed that situation because we were concern that under current law, MPLT is not obligated to transfer that \$1 Million Dollars to the general fund until the existing loan that the government has with MPLT is fully paid off. The Secretary of Finance was able to clarify that the insertion of the \$1 Million Dollar transfer-in is followed by a \$1 Million Dollar transfer-out to basically be a washout provision to reflect that in their books \$1 Million Dollars would have come in and it would have gone back out as part of the government's payment to the existing loan. So it is basically an issue of leisure entry and we also just wanted to make sure that that reflection is in compliance with the generally accepted principles of accounting. We believe that they have met that requirement and we believe that the concurrent resolution is ready to move forward. To the question of why concurrent resolution is recommended for adoption in the form of HS1 because there were some non-substantive amendments. Basically just removing one typographic error reflecting fiscal year 2017 to 2018 and that is found on line 20, page 3. Others were just a matter of fixing some errors in the language. So it was non-substantive and because of that and the report on the \$1 Million Dollar issue, your committee concurs and desires to approve the resources which are available for appropriation in fiscal year 2018. Thank you, Mr. Speaker.

"A resident is a person who has been in the CNMI for at least 12 months prior to applying for a marriage license. Such person must have established residency in the CNMI by keeping a current mailing address for at least 12 months before applying for a marriage license or having maintained and continue to maintain accounts at the Commonwealth Utilities Corporation or having paid income taxes for more than six-months for the year prior to submitting an application for a marriage license or having maintained and continue to maintain a local account or accounts with a banking institution doing business in the CNMI." Mr. Speaker, while these definitions are alright in principle to define what a resident is some concerns have been raised with the alienation of people of Northern Marianas Descent who do not meet these criteria because they may be in service in the armed forces, they are active duty and they have not been able to maintain all these accounts and stuff here, but at the end of the day they are NMD's who will at some point in their lives return to our Commonwealth. The last thing we want to see is that people who fall in that category who are rightfully people of our land come back to their island and have to pay nonresident marriage license fees. So in resolution in attempt to resolve this issue I am offering a floor amendment.

- (b) If a bill passes First Reading, the Clerk shall place it on the Bill Calendar for Second Reading the next legislative day.
- (c) First Reading of a resolution shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

Section 10. Second Reading of Bills

- (a) When a bill is read in the House a second time, it shall be considered in the same manner as for First Reading, except that further amendments shall be in order without regard to whether or not they are proposed by the committee reporting the bill.
- (b) Second Reading of a bill shall be the final reading, and upon its passage, which shall be by Call of the Roll, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

Introduced by REP. JOSEPH LEE PAN T. GUERRERO of Saipan, Precinct 1 (*for himself*) on April 21, 2017; and was subsequently referred to the Committee on Natural Resources.
