1st Day, Fourth Special Session

Tuesday, June 6, 2017

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its First Day, Fourth Special Session on Tuesday, June 6, 2017, at 10:18 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

A moment of silence was observed.

ROLL CALL

The Clerk called the roll and seventeen members were present; Representatives Francisco S. Dela Cruz, Alice S. Igitol and Janet U. Maratita were absent and excused.

Speaker Rafael S. Demapan: Si Yu'us Ma'ase, Clerk. Let the record reflect that I did receive a communication from the Vice Speaker Janet Maratita, Representative Alice Igitol and Chairman Francisco Dela Cruz notices that they are off-island and not able to make it on today's session. So with that we have 17 members present and 3 members absent, we do have the numbers to proceed on today's session. Before we go down to our Order of Business, I would like that we go on a recess. There is a presentation today for the Bridge Capital the folks are here. So with that we will go ahead and go into recess for the presentation of the House Resolution to the folks from Bridge Capital.

The House recessed at 10:20 a.m.

RECESS

The House reconvened at 10:31 a.m.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Back from our recess. Before we go further let me recognize our mayor. Mayor Apatang, thank you for showing up and of course our former Representative John Tenorio welcome to your House. So with that let me go ahead and recognize the Floor Leader for the motion.

The Floor Leader made a motion to suspend Rule V, Section 8.

RULE V. DECORUM AND DEBATE.

Section 8. Dress Code.

All members and officers appearing on the Floor of the House shall be suitably attired. Members shall wear business shirt and tie, and on Fridays may wear formal island wear.

The motion was seconded.

(d) Bills and resolutions for introduction may be pre-filed with the House Clerk for formal introduction at the next session, provided that it is pre-filed in sufficient time to appear on the session agenda as required under Rule III. The 72-hour notice and agenda requirements may be dispensed with for Special Emergency Sessions and Sessions called by the Governor in accordance with Rule III.
