The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its First Day, Fifth Special Session on Tuesday, June 27, 2017, at 1:56 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

A moment of silence was observed.

#### ROLL CALL

The Clerk called the roll and eighteen members were present; Representatives Edwin P. Aldan and Edmund S. Villagomez were absent and excused.

The Floor Leader made a motion to suspend Rule IX, Section 4 (d).
