Friday, July 28, 2017

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its First Day, Sixth Special Session on Friday, July 28, 2017, at 10:09 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

A moment of silence was observed.

ROLL CALL

The Clerk called the roll and nineteen members were present; Representative Edmund S. Villagomez was in at 10:44 a.m.

<u>Speaker Rafael S. Demapan:</u> Thank you, Clerk. I understand the Minority Leader will be here late. So with 19 members present this session will move forward. Thank you. I also understand that there are communications and legislations bills to be introduced. Before that let me ask the Floor Leader for a suspension motion. Recognize the Floor Leader.

Floor Leader Glenn L. Maratita: Thank you, Mr. Speaker. At this time, I would like to suspend Rule IX, Section 4 (d) so that the House amends its agenda to include unnumbered bills, resolutions and communications. So move.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS

Section 4. Format of Bills and Resolutions

(d) Bills and resolutions for introduction may be pre-filed with the House Clerk for formal introduction at the next session, provided that it is pre-filed in sufficient time to appear on the session agenda as required under Rule III. The 72-hour notice and agenda requirements may be dispensed with for Special Emergency Sessions and Sessions called by the Governor in accordance with Rule III.

INTRODUCTION OF BILLS

To require all future road developments within the Commonwealth of the Northern Mariana Islands to include bicycle lanes as part of the package for road constructions and/or upgrades within the Commonwealth of the Northern Mariana Islands; and for other purposes.

Representative Angel A. Demapan officially introduced the following House Bill and welcomed the members to coauthor the bill:

H. B. NO. 20-98

To require that not less than 70 percent of the Family Violence Prevention and Services Act funding that is allocated to the Commonwealth of the Northern Mariana Islands, shall be for the primary purpose of providing immediate shelter and supportive services to adult and youth victims of family violence, domestic violence, or dating violence and their dependents in accordance with 42 U.S. Code §10408(b)(2).

REP. ANGEL A. DEMAPAN of Saipan, Precinct 1 (for himself)

The Chair referred House Bill 20-98 to the Committee on Social and Human Services and recognized Representative Angel A. Demapan for the next introduction.

Representative Angel A. Demapan officially introduced the following House Bill and welcomed the members to coauthor the bill:

H. B. NO. 20-99

To amend 4 CMC §2308 to clarify that the casino gross revenue tax funds are separate from the general fund; and for other purposes.

REP. ANGEL A. DEMAPAN of Saipan, Precinct 1 (for himself)

Speaker Rafael S. Demapan: Thank you, Chairman. You may proceed.

Representative Angel A. Demapan: Thank you, Mr. Speaker. House Bill 20-99 includes the main provision of previously passed by the House, House Bill 20-15 which was amended by the Senate and was rejected by the House and ended up in conference committee. Absent the appointment of conferees from the Senate, Mr. Speaker, I am introducing this provision which only includes a provision to set the separate account from the general fund. Because this is a provision that we have acted on previously and because of the urgent need of the provision, I am requesting that this bill be placed on calendar.

Several members voiced "no objection".

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Chairman. I hear no objection, so let me recognize the Floor Leader for the placement on the Bill Calendar.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Mr. Speaker. On that note, I would like to offer a motion to suspend Rule IX, Section 8 that is the referral of bills and resolutions so that we may place House Bill 20-99 on the Bill Calendar. So move.

REP. ANGEL A. DEMAPAN of Saipan, Precinct 1 (for himself)

Speaker Rafael S. Demapan: Si Yu'us Ma'ase, Representative Demapan. You still have the floor.

Representative Angel A. Demapan: Thank you, Mr. Speaker. Mr. Speaker, House Bill 20-103 is introduced on the premise of ongoing proceeding in the court. House Bill 20-103 is a product of collaboration between the Office of the Attorney General, the Administration and the Legislature to make whole the largest debt of the government in land compensation to the stakeholders and landowners of Lot No. 353 New-G. In this regard Mr. Speaker and with supporting documents filed in the court by way of declarations from the Secretary of Finance and then Acting Governor Arnold Palacios. Mr. Speaker, I am making a request barring no objections from the members, we place House Bill 20-103 on today's Bill Calendar.

Several members voiced "no objection".

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman. So with that let me ask the Floor Leader for a motion to place on today's Bill Calendar.

Representative Angel A. Demapan: Mr. Speaker, if there is no objection, I would like to move that this bill be placed on calendar given that this is a product of the Committee on Ways and Means as we conducted budget hearings and deliberations and because we are cognizant that we

did not meet the requirement of the Open Government Act, we ask for its placement to remain on calendar no action today, but to be acted on the next session. Thank you, Mr. Speaker.

The House reconvened at 11:01 a.m.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Back from our recess and prior to our recess we were on the Bill Calendar. First let me recognize the Floor Leader for the first motion.

Floor Leader Glenn L. Maratita: Thank you, Mr. Speaker. On our Bill Calendar we have House Bill 20-103, but before I offer the motion for passage first I would like to offer two suspension motion so that we are in order. With that, I would like to offer a motion to suspend Rule VII, Section 9, which is the committee report. I understand that this bill has been referred for action today. So, with that Mr. Speaker, so move.

RULE VII. COMMITTEES GENERALLY Section 9. Committee Reports; Other documents

- (a) Standing or Special Committees shall submit a written report to the Speaker within 60 days from the date the matter was referred to the committee, unless a shorter or longer time is ordered by the Speaker pursuant to a decision by the House Leadership. Subcommittees shall submit reports on matters referred to them as prescribed by the Standing Committee Chair. Standing, special and conference committees shall submit their reports in writing and provide an electronic copy to the Clerk who shall number the reports consecutively in the order received, cause such reports to be reviewed for legal sufficiency, reproduced, and furnished each member of the House at least twenty-four hours prior to the session at which it is to be considered. A committee report shall state findings of facts and conclusions based thereon together with a specific recommendation as to the manner in which the bill, resolution, or other matter referred to the committee should be disposed of by the House. A report recommending a bill or resolution for passage shall clearly state the purpose of the bill. A report on a bill or resolution shall show clearly any proposed amendments and the Clerk shall place such a bill or resolution on the appropriate calendar.
- (b) A report shall be considered adopted by a committee when the Chairperson and a majority of the members of the committee have signed the report concurring therein. A member or members not concurring in the report of the majority may so indicate by submitting a minority report which shall be attached to the committee report or by signing with "I do not concur".
- (c) When a committee recommends that a bill or resolution be formally filed (indefinitely postponed), the recommendation is reported to the House floor as a committee report to be confirmed by majority vote. Adoption of the committee report by the members has the effect of officially filing the bill.
- (d) When, by majority vote, the House adopts a committee report recommending favorable action on a bill or resolution, the bill or resolution as reported by the committee shall be placed on the appropriate calendar for House floor action.
- (e) All documents, testimonies, or other evidence submitted to any standing or special committee or subcommittee in connection with any matter referred to the committee or subcommittee shall be the property of the House. The Chair of any committee or subcommittee shall deliver all such documents, testimonies, or other evidence to the House Clerk upon expiration of the term of the House. Such documents, testimonies or other evidence may be attached to committee reports as supporting documents.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Floor Leader. Again, your motion has been seconded, discussion on that motion? Recognize Chairman Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. This morning when we suspended the rule to include additional communications not previously included in our agenda – one of those communications is Governor's Communication 20-52, which identifies available amounts of \$28,067, 951.00 as available funds from the Casino Operator's Business Gross Revenue Tax account. In this communication the Governor identifies in addition to the \$16.2 Million Dollars for the Commonwealth versus Lot No. 353 New-G. The Governor identifies other estates that are the highest accruing interest estates and land compensation judgements that currently are outstanding by the government and owed to the heirs. Mr. Speaker, this includes \$2.9 Million in Marianas Public Lands Authority versus the Heirs of Rita Rogolifoi that includes \$858,000 in Lizama versus the Department of Public Lands. It also includes \$509,000 for the Estate of Muna versus the Commonwealth and it includes \$83,000 in the case of Commonwealth versus Lot No.

218-5 R/W. Mr. Speaker in consideration of these additional judgements that are being requested to be funded in the identified revenues of \$28 Million Dollars I am offering a substitute bill to House Bill 20-103 to include these additional estate judgements so that if passed we save the government from accruing about \$1 Million Dollars in interest alone every year. By way of this substitute Mr. Speaker, the total appropriation now comes out to \$20,713,572.03. Mr. Speaker this substitute bill is so offered.

<u>Speaker Rafael S. Demapan:</u> Thank you, Chair but before we recognize that motion we would have to first dispose of this motion and that is to suspend Rule VII, Section 9 and when we do that then you would have to introduce that. Again, Floor Leader.

<u>Floor Leader Glenn L. Maratita:</u> Yes, Mr. Speaker if I may. Again, can I just point out that I actually offered two suspension motion. So the first is for Rule VII, Section 9 and subsequent suspension would be Rule IX, Section 9 and 10. So if we can get that out of the before we accept the substitute then I think we will be in order.

<u>Speaker Rafael S. Demapan:</u> Well noted. Your motion has been seconded. Discussion on that motion?

Several members voiced "ready".

There was no discussion and the motion to suspend Rule VII, Section 9 was carried by voice vote. There was no nay vote.

Speaker Rafael S. Demapan: You may proceed Floor Leader.

<u>Floor Leader Glenn L. Maratita:</u> At this time, I would like to offer a motion to suspend Rule IX, Sections 9 and 10. So move.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS

Section 9. First Reading of Bills and Resolutions

- (a) When a bill or resolution is read in the House the first time, the Clerk shall report the bill by title, unless a majority orders it read in full, or by such subdivisions as the motion to read may indicate. The House shall then proceed to debate the measure, and amendments shall be in order. At the conclusion of a debate the House shall vote on passing the measure on First Reading after affording an opportunity for one motion to recommit with or without instructions. If the Measure passes with amendments, the Clerk shall engross such amendments and cause the measure, or any page thereof, to be reprinted as provided in Sections 4 and 6 of this Rule. [Note: Rule IX, Section 9, amended by H. RES. 20-4]
- (b) The First Reading of a bill without amendment shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.
- (c) If a bill passes First Reading with amendment, the Clerk shall place it on the Bill Calendar for Second Reading the next legislative day.

(d) First Reading of a resolution shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

Section 10. Second Reading of Bills

- (a) When a bill is read in the House a second time, it shall be considered in the same manner as for First Reading, except that no further amendments shall be in order. [Note: Rule IX, Section 10, amended by H. RES. 20-4]
- (b) Second Reading of a bill shall be the final reading, and upon its passage, which shall be by Call of the Roll, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

The motion was seconded.

There was no discussion and the motion to suspend Rule IX, Sections 9 and 10 was carried by voice vote. There was no nay vote.

Speaker Rafael S. Demapan: Again, recognize Floor Leader.

The Floor Leader made a motion to pass the following on First and Final Reading:

To appropriate \$16,296,263.89 to pay the judgment in Commonwealth vs. Lot No. 353 New-G et al, Civil Case No. 97-0266.

REP. ANGEL A. DEMAPAN of Saipan, Precinct 1 (for himself)

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase*, Floor Leader. Again, your motion was seconded. Discussion on the motion? Recognize Chairman Demapan.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker. For the reasons that I stated earlier, I am now officially offering a substitute bill for House Bill 20-103 in the form of House Bill 20-103, HS1.

The motion was seconded.

Speaker Rafael S. Demapan: Thank you, Chairman. You still have the floor.

Representative Angel A. Demapan: Thank you, Mr. Speaker. I just submitted the substitute version and it is being copied now for distribution to the members.

<u>Speaker Rafael S. Demapan:</u> Can we have a short recess until the copies are passed out. Short recess.

The House recessed at 11:08 a.m.

RECESS

The House reconvened at 11:27 a.m.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Back from our recess. Now I give back the floor to Chairman Angel. Chairman Angel, can I ask that you restate your motion?

Representative Angel A. Demapan: Thank you, Mr. Speaker. As I have stated earlier, I am offering House Bill 20-103, HS1 to take into account the new figures provided by the Governor in his communication 20-52 and for the inclusion of other estates, judgments that are accruing the highest interest rate against the government. With that regard Mr. Speaker, this new substitute bill will appropriate the following amounts: \$16,291,763.36 is appropriated for Commonwealth versus Lot No. 353 New-G. Mr. Speaker, I have just got off the phone with the Secretary of Finance and with the Governor and the amount of \$16,291,763.36 is the updated amount and that is what is reflected in the substitute bill. Because of the change in calculation of compounding interest due to an earlier cut-off date in which this estate is going to paid off. So that is the explanation for the Five -Thousand Dollar difference in the previously noted figure in the original version of the bill. The substitute version Mr. Speaker also includes \$2,970,534.57 in MPLA versus the Heirs of Rita Rogolifoi. Another \$858,533.21 for Lizama versus Department of Public Lands. The substitute version also includes \$509,234.81 for the Estate of Muna versus the Commonwealth. Finally, the inclusion of \$83,553.08 for Commonwealth versus Lot No. 218-5 R/W. Mr. Speaker, this substitute version is so offered.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Chairman. Your motion has been seconded. Discussion of that motion. First let me recognize Representative Propst.

Representative Edwin K. Propst: Thank you, Mr. Speaker. Chairman, I just wanted to note on your recent bill this House Substitute 1 on page 2, line 17 it says, "\$16,291,736.36" I think it is a typo it should read 763. Page 2, line 17. It says 736.36 it should be reflecting 763.36. So I just wanted to make that technical if you can correct that.

Speaker Rafael S. Demapan: Recognize the Chairman again.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker. That is correct and if our Legal Counsel can clarify that we can treat that as technical?

Legal Counsel John Cool: Yes treat that as a technical.

<u>Speaker Rafael S. Demapan:</u> Thank you, Counsel. Representative Propst we will consider it as technical. Recognize Chairman Barcinas.

Representative Donald C. Barcinas: Thank you, Mr. Speaker. I yield for now it's the same issue.

Speaker Rafael S. Demapan: Recognize Representative Attao.

Representative Blas Jonathan "BJ" T. Attao: Thank you, Mr. Speaker. First and foremost, I would like to extend our thank you to the Governor for looking at different avenues to finalize all

these land obligations that are judgements in front of the courts right now. I understand that the transmittal letter of \$28,067,951.00 is coming from the BGRT collections. I guess it is more of a question to the Legal Counsel. Would this be an over expenditure for 2017?

<u>Legal Counsel John Cool:</u> I don't understand the question in respect to over expenditures.

Representative Blas Jonathan "BJ" T. Attao: We've adopted a concurrent resolution that set our ceiling for distribution and appropriations under 2017, which we amended a few months ago to include the other BGRT collections for distributions to all the entities that were listed under 1856 and other obligations of the Commonwealth government. Would these be monies under BGRT that would have to increase our concurrent resolution or would this fall under the 100% reprogramming authority that our Governor has under the current budget of 2017.

<u>Legal Counsel John Cool:</u> My opinion that an amended concurrent resolution will not be required.

Representative Blas Jonathan "BJ" T. Attao: May I ask why Counsel? I only ask this because during the last appropriations of the BGRT collections when standalone legislations were presented on the floor your legal opinion was that we needed a concurrent resolution to lift our expenditures for 2017 at the time.

<u>Legal Counsel John Cool:</u> I don't recall that. I recall that there were some proposals to appropriate the casino BGRT prior to the communication from the Governor or Finance that there was funding available that have actually been collected. The appropriation under 1803 actually requires that the funds actually be collected prior to them being appropriated.

Representative Blas Jonathan "BJ" T. Attao: 1803? Sorry, Counsel I am not following.

Legal Counsel John Cool: 4 CMC 2308.

Representative Blas Jonathan "BJ" T. Attao: So we don't need to change our expenditures under the concurrent resolution for 2017? I am just asking, I mean there's ways of doing it. Obviously, the court system hasn't taken away the legislative authority of appropriating money or directing the \$16 Million Dollars or the total amount that is being appropriated in its current legislation away from the legislature and just distribute the funds that are collected under the BGRT. If that's the case, what monies are we appropriating as a legislature, as a legislative body. Is it the BGRT that would increase our expenditures or is the 100% reprogramming authority that the Governor has currently in 2017? If it's the 100% reprogramming authority then it makes a whole lot of sense because he has that authority. Go ahead Counsel, sorry.

<u>Legal Counsel John Cool:</u> Yes, it would be a combination of both because he has not given us a supplemental message identifying additional resources above those which were previously identified that would trigger additional concurrent resolution. What he's doing is telling us that funds have been received, which are available for payment. He has 100% reprogramming authority. If the funds are still available he can reallocate among the appropriate accounts so that they would be available for expenditure. The only difference is that when we get to payment of

judgements we have that special law that requires an appropriation before judgements can be claimed.

Representative Blas Jonathan "BJ" T. Attao: Thank you, Counsel. If it's the Governor's 100% reprogramming authority under 2017 then we shouldn't have a problem. My concern is now that the \$28 Million Dollars that is under BGRT should the remittal letter of the BGRT be extended to the Legislature should be at the minimum at \$28,067,951.00 or whatever additional funds that were collected under the BGRT. Just with that Mr. Speaker, we thank the Governor again for finding the resources and using his 100% reprogramming authority in exhausting the obligations of the CNMI Government to the families that are owed with land compensation judgements. With that I rest. Thank you, Mr. Speaker.

Speaker Rafael S. Demapan: Si Yu'us Ma'ase, Representative Attao. Further discussion?

Several members voiced "ready".

There was no discussion and the motion to adopt the substitute bill offered by Representative Angel A. Demapan was carried by voice vote. There was no nay vote.

Speaker Rafael S. Demapan: Again, recognize the Floor Leader for the main motion.

The Floor Leader made a motion to pass the following on First and Final Reading:

H. B. NO. 20-103, HS1

To appropriate payment for the outstanding judgement and interest in land compensation cases.

REP. ANGEL A. DEMAPAN of Saipan, Precinct 1 (for himself)

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Floor Leader. Again your motion has been seconded. Discussion on that main motion?

- (d) When, by majority vote, the House adopts a committee report recommending favorable action on a bill or resolution, the bill or resolution as reported by the committee shall be placed on the appropriate calendar for House floor action.
- (e) All documents, testimonies, or other evidence submitted to any standing or special committee or subcommittee in connection with any matter referred to the committee or subcommittee shall be the property of the House. The Chair of any committee or subcommittee shall deliver all such documents, testimonies, or other evidence to the House Clerk upon expiration of the term of the House. Such documents, testimonies or other evidence may be attached to committee reports as supporting documents.

The motion was seconded.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS

Section 9. First Reading of Bills and Resolutions

- (a) When a bill or resolution is read in the House the first time, the Clerk shall report the bill by title, unless a majority orders it read in full, or by such subdivisions as the motion to read may indicate. The House shall then proceed to debate the measure, and amendments shall be in order. At the conclusion of a debate the House shall vote on passing the measure on First Reading after affording an opportunity for one motion to recommit with or without instructions. If the Measure passes with amendments, the Clerk shall engross such amendments and cause the measure, or any page thereof, to be reprinted as provided in Sections 4 and 6 of this Rule. [Note: Rule IX, Section 9, amended by H. RES. 20-4]
- (b) The First Reading of a bill without amendment shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.
- (c) If a bill passes First Reading with amendment, the Clerk shall place it on the Bill Calendar for Second Reading the next legislative day.
- (d) First Reading of a resolution shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

Section 10. Second Reading of Bills

- (a) When a bill is read in the House a second time, it shall be considered in the same manner as for First Reading, except that no further amendments shall be in order. [Note: Rule IX, Section 10, amended by H. RES. 20-4]
- (b) Second Reading of a bill shall be the final reading, and upon its passage, which shall be by Call of the Roll, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

We should anticipate an increase in waste that is disposed at our landfill and also around our islands in remote areas via illegal dumping. For the stores out there if you're watching this law will take effect one-year after it is signed into law if so. So you do have time to use all your bags. The bill also covers plastic checkout bags at the point of sale, so you would still have your other bags which is spelled out in the bill as well. Also most importantly this also puts us in play with other pacific island nations that are making positive environmental moves and actions. So this is a plus for us. I would like to say that the fruits of this movement will be seen as our behaviors change. I know change is hard, but this is coming to the preserve and save our environment. So with that said, Mr. Speaker I am hoping to get the support of the House and most importantly the Senate and the Administration. Thank you.
