Wednesday, September 20, 2017

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its Seventh Day, Second Regular Session on Wednesday, September 20, 2017, at 10:28 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

So, the substitute version essentially does two things. One, we increase the information in the findings to include communication that was received from the Office of Personnel Management, Civil Service Commission. This communication was transmitted to the legislature a few days after the House passed the original version. So in this communication that came late, OPM made reference to the addition of seven more employees and that was resulted in an impact of \$17,545.00. So, we made reference to that as Senate Department Message No. 20-37 in the findings and we also update the total amount for appropriation to \$1,417,545.00 that's to make whole for the \$17,545.00 difference. On Section 2 of the substitute bill, we also cure a deficiency by adding language that says the \$1,417,545.00 is from the Saipan casino licensee's gross revenue tax as identified in House Governor's Communications 20-52 and 20-54. The inclusion of these amendments Mr. Speaker and members, should satisfy the legal concerns that have been raised by the Office of the Attorney General and the Office of the Governor in terms of how the original form was language. So we hope with this amendments we're able to push this bill through and the Governor is able to sign it into law so that these employees who have been waiting for a very long time can finally be made whole with the obligations that the Government owes them pursuant to Public Law 19-75. In that regard Mr. Speaker, I offer this amendment.

A BILL FOR AN ACT

BE IT ENACTED BY THE TWENTIETH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

Section 1. Findings. The Legislature has been informed by the Governor's Office in House Gov. Comm. 20-52 and 20-54, that the amount of more than One Million Four Hundred Thousand Dollars (\$1,400,000.00) from the Saipan casino licensee's gross revenue tax is available to pay the outstanding retroactive lump-sum payment, due pursuant to 1 CMC §8213(g), to active and inactive employees, whose wages were frozen at Step 12. Senate Dept. MSG No. 20-37 from the Office of Personnel Management advises that the actual amount necessary to compensate the employees who were frozen in Step 12 is \$1,417,545. This appropriation is in addition to payment authorized for the same purpose by Public Law 19-75. In addition, the Governor advised the Legislature that "The Office of Personnel Management (OPM), in collaboration with the Department of Finance, has provided me with an update on the eligible employees, as well as the associated amounts that include Medicare, FICA, and retirement benefits." Accordingly, we hereby appropriate said funds to make these funds available as soon as possible to employees who have waited patiently.

Section 2. <u>Appropriation.</u> Notwithstanding 4 CMC §2308 and 1 CMC §7201(d), the amount of One Million Four Hundred and Seventeen Thousand and Forty-Five Dollars (\$1,417,545.00) from the Saipan casino licensee's gross revenue tax as identified in House Gov. Comm. 20-52 and 20-54 is appropriated to pay the outstanding retroactive lump-sum payment to active and inactive employees, whose wages were frozen at Step 12 pursuant to 1 CMC §8213(g). The expenditure authority shall be the Secretary of Finance.

Section 3. Severability. If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

Section 4. Savings Clause. This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of this Act shall not have the effect of terminating, or in any way modifying, any liability civil or criminal, which shall already be in existence at the date this Act becomes effective.

Section 5. Effective Date. This Act shall take effect upon its approval by the Governor or upon its becoming law without such approval.

Sometimes they find out their eligible. So, I am hoping that there's no further additions beyond these seven employees. If there are it would require us having to go through the whole appropriation process again.

I know that we have recalled this particular bill from the Administration to make corrections with the additional funds as well as the provision as to where these funds came from. During our last session, one of the board members of PSS made comments and he came here and he chastised us, he belittled us. According to him, we are playing games. We are playing games because we are not following through with initiative 18-12. HLI 18-12 in the constitution provides for 25% of all revenues that is to be appropriated. House Bill 20-108 as amended is just one form of appropriation. This fund was identified by the Administration and it's our job and duty to appropriate. \$7.2 Million Dollars that went to prior year settlement payments to the settlement funds. The \$16 Million Dollars that we appropriated for judgement payments. In some ways, I do agree with Mr. Guerrero. We need to be giving PSS their 25% and if that means taking 25% from any identified sources prior to appropriating then that's what the constitution calls for. I ask our good Chairman of Ways and Means to expedite these payments to PSS. We are seeing an increase in government

resources most especially the casino revenue tax. Let us not wait and have these funds overwhelm us while at the same time not putting in what is constitutionally mandated through 18-12. It is imperative that we need to work together and as these funds are identified, we must immediately set aside these 25% before taking care of other obligations of these government. Thank you, Mr. Speaker and members.

Speaker Rafael S. Demapan: Thank you, Representative Frank Dela Cruz. Also, let me just say a few words based on the product of the conferee. I think we gave the PSS an additional \$250,000 that was because of the communications from PSS and the conferee team. Yes, we all agree that we will continue to fund PSS in fact we gave PSS over \$36 Million Dollars on this annual budget, but to my understanding I think we are going to be seeing an identification from the Governor for further appropriation and from there we will make sure that PSS is considered on that source. Further discussion? Recognize Representative Deleon Guerrero.

MISCELLANEOUS BUSINESS

Representative Edwin K. Propst: Thank you, Mr. Speaker. I just wanted to touch up on something really briefly. Yesterday, I received a phone call from Guam Senator Fernando Esteves, he is the Chairman for the Committee on Ethics and Standards. As you are aware, I filed an ethics complaint on May 16, 2017 against Guam Senator James Espaldon for the role he played in the fraudulent GPS emergency purchase of a ten-megawatt generator with CUC. Mr. Speaker for the viewing public and for my colleagues, I just want to go over a resolution, rather quickly on their findings. On Resolution 239-04, the Committee on Ethics and Standards found that he did in fact received gratuities from Robert and Amelia Toelkes, they paid for his meals, airfare and other travel expenses and at least one trip to Korea and several trips to Saipan during his tenure and that he engaged in these actions at least in part for his own personal gain by receiving something of value. We also found conflicts of interest with his Senate staff member Phil Roberto who happen to be the Vice President of GPSM as well as the step-son of CUC Board Chairwoman Adelina Roberto as well as other conflicts of interest with Robert and Amelia Toelkes and CUC. Furthermore, they found that Senator Espaldon in fact knew or should have known that GPSM and Robert and Amelia Toelkes sought to use his influence as a Senator in order to influence CUC. He failed to consider the public's perception of his actions that his

actions reflect poorly on his office and his colleagues and that he failed to conduct his life both public and private so as to bring honor and respect to his office. The committee recommends Senator Espaldon be censored for his violation, removed of leadership positions and require that he and his staff receive 16 hours of refresher, ethics in government program within 30 days of the adoption of the resolution that his office funds and that they pay for it. Mr. Speaker and colleagues, the reason why I am bringing this up is because I wanted to remind the viewing public that there is a process involved in everything we do whether we are the Guam Legislature or the Commonwealth Legislature. Sometimes, we want things to move so quickly and expeditiously, but the fact is as public servants and public officials the process takes time, but with this process it took them almost four-months. I think I am satisfied and I think my colleagues here in the House and the Senate would be satisfied, but I would be remised if I failed to thank Chairman Frank Dela Cruz of PUC and his colleagues and also Senator Sixto Igisomar and his Public Utilities Committee also for their work, their investigations and their findings of which is some of the information that I based on my ethics complaint. Mr. Chairman, I wanted to thank you for that. This is not over. This continues as many people are thinking it's a closed door, but I continue to ask that the Attorney General Ed Manibusan continue to investigate and look into this deal because it's not clearly over and we do know that it continues. We also hope that the FBI and the US Attorney continues to look into this. Mr. Speaker, I just wanted to recognize the good work of my colleagues in both the House and Senate for their due diligence for the work that they put forth. Thank you for the opportunity to let me share this with you Mr. Speaker and my dear colleagues. Thank you.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase*, Representative Propst. Further? Anymore? Recognize Representative Angel Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. I just want to offer some information in regards to the statements made by the Board of Education member in our previous session and the statements from our colleague Dela Cruz this morning. As you know, from two communications from the Governor in one communication 20-52, the Governor identified \$28,067,951.00 and in communication 20-71 he identified an additional \$8,664,418.00 and that brings a total identification so far for a casino BGRT in the 20th Legislature a total of \$36,732,369.60. if we are to give PSS their entitlement of 25% from this amount, we owe PSS \$9,183,092.40. We have taken note of this amount and we have scheduled that this will be appropriated once we took care of the critical appropriations that we did that had deadlines, for example. What became Public Law 20-4 was a settlement agreement through the court regarding the Mangabao Estate and other outstanding judgements in which the Office of the Attorney General and then Acting Governor Arnold Palacios negotiated this with the court that we would provide an appropriation in the total amount of \$2.7 Million Dollars. So, we did that knowing and we made these statements when we acted on this bill that we understand PSS is owed 25% of these funds, but because of the immediate deadline that was before us by the court, we agreed to appropriate this amount to take care of this land compensation judgement and that we will take care of PSS entitlement and subsequent legislation. After that we received another critical deadline information from the Administration through the settlement fund stating that the audit reports had come out for 2014 and 2015 stating that the settlement fund was owed \$7.1 Million Dollars from the general fund due to an increase in revenues and those two respective years. So, because we had a deadline of August 28, I believe in that particular communication this body had to act swiftly again. Governor sent that communication over with \$8.6 Million Dollars and asked

the body to act swiftly to meet this obligation to ensure that retirees pensions were not compromised for the month of September. So that became Public Law 20-9 providing \$7.1 Million Dollars. What we have before us today is an additional \$1.4 Million Dollars in House Bill 20-108 and that's to make whole with those employees who were left behind in Public Law 19-75. One of the reasons why the House and the Senate agreed to prioritize this appropriation is because there was an issue of equity about having 300 employees receive their compensation and 300 others waiting behind because of a miscalculation of adjustments from OPM. So, we felt that we needed to assist the central government in making whole with these individuals, but in every appropriation that we passed the Committee on Ways and Means took note that in every appropriation 25% was due to PSS pursuant to the constitutional mandate. At this point in time, the funding level remains at \$9.1 Million Dollars. We're expecting an additional \$22 Million Dollars based on communications with the Administration and if that additional \$22 Million Dollars has officially been quantified and identified over to the legislature that would bring the total identified revenues to \$50 Million Dollars of which \$15 Million Dollars will be due to PSS. Having anticipate this amount, I met with the Board Chair Marylou Ada, Board Member Janice Tenorio and officials from the Commissioner's Office Mr. Thornburg, Associate Commissioner Jackie Quitugua and Mr. Ed Tenorio. In our meeting, we were well aware, we discussed this impending \$15 Million Dollar supplemental appropriations to PSS in the event that the remaining \$22 Million Dollars is identified. It was our understanding with PSS that for FY 17 their funding level is enough to bring them to September 30 and that they needed this \$15 Million Dollars to be appropriated in their FY 18 beginning October 1st. It is in that understanding that the committee is prepared to make such appropriation to fund their FY 18 operations because FY 18 includes \$1.9 Million Dollars in salary increases to the teachers and counseling staff. So we've made arrangements with PSS that we've item – in fact we've worked with PSS and they've itemized how they're going to spend the entire \$15 Million Dollars and based on that itemized list is how the bill will be appropriated. It won't just be a \$15 Million Dollar lump-sum blank check to PSS. This body will provide a clear outline on how much is allotted for what particular purpose and that purpose that were outlined and provided by PSS themselves. So, I wanted to assure the members and the public that we are doing due diligence to PSS, we are in constant communication. In fact, the board is in a meeting at this moment discussing issues similar to this and I hope that the Board Chair will relay the information that we discussed in our meeting. So, I will make another follow-up to our Secretary of Finance on the pending identification of remaining funds collected. I know that the last time I spoke to the Secretary of Finance they were in the process of reconciling their reports on what was collected versus the reports being submitted to the Commonwealth Casino Commission. So, we hoped that in due time, I will be able to get that information. Just so that everyone knows that in this point in time just basing ourselves on the \$36 Million Dollars identified revenues, we note that \$9.1 Million Dollars is due to PSS, but we believe that the remaining \$22 at least \$22 Million Dollars is identified, PSS will end up with a total appropriation of \$15 Million Dollars. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Si Yu'us Ma'ase, Chairman Angel. Thank you so much for that clarification. Further discussion? Ready? Recognize.

Representative Lorenzo I. Deleon Guerrero: Thank you. I would like to also co-mingle with the resolution presentation. Once we've decided when the resolution presentation for Lieutenant Colonel Lawrence Camacho. I believe Representative Vinny will be coordinating the dates —

would it be available to be presented by the Colonel. I also wanted to ask that we co-mingle commemorative resolution 20-10 on the same day even if it's not in the session environment. I thought I'd add that. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you. As soon as you set your date, let my office know so that we can coordinate and inform members to present on that presentation. Going down to item XVIII. Announcement.
