The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its Eighth Day, Second Regular Session on Wednesday, October 11, 2017, at 10:05 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

Representative Angel A. Demapan: Mr. Speaker, this appropriation as a result of the discussion on the conference committee on the budget bill. The amounts stated here has already been earmarked and can only be used specifically for the tobacco control fund and specifically for the four programs listed in 3CMC section 2177. This legislation basically divides the earmark funds equally into the four programs and because of that I am requesting that this not be referred to committee since it's an earmark provision in place already and does not require any more scrutiny for where the funding is going to be appropriated or how it can – there's no other way to appropriate it and because of that and because of the agreement in the House conferees and Senate conferees, we ask that the bill be placed on calendar. Thank you, Mr. Speaker.
