The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its Ninth Day, Second Regular Session on Tuesday, November 21, 2017, at 10:19 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

Representative Angel A. Demapan: Mr. Speaker, if there is no objection, pursuant to the testimony of the Executive Director of CUC this morning, I would like to request that in the interest of adverting any disruption in services to the community that this bill be placed on today's Bill Calendar as the funds that are being amended in this particular budget for CUC are their own projected revenues and not revenues of the general fund. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Demapan and thank you for that information. Before we move on let me recognize the Floor Leader for the proper motion to place House Bill 20-135 on the Bill Calendar.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS

Section 8. Referral of Bills and Resolutions

(a) Bills and resolutions shall be read by title upon introduction and (except as provided in subsection (b), the Speaker shall refer such measures to an appropriate committee or to more than one committee, jointly or sequentially. The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the Journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred.

(b) The Speaker may place a resolution directly on the Resolution Calendar, rather than refer it to a committee, subject to appeal to the House.

<u>Representative Edwin K. Propst:</u> Mr. Speaker and colleagues, I do ask that this bill move expeditiously. - (c) When a committee recommends that a bill or resolution be formally filed (indefinitely postponed), the recommendation is reported to the House floor as a committee report to be confirmed by majority vote. Adoption of the committee report by the members has the effect of officially filing the bill.
- (d) When, by majority vote, the House adopts a committee report recommending favorable action on a bill or resolution, the bill or resolution as reported by the committee shall be placed on the appropriate calendar for House floor action.
- (e) All documents, testimonies, or other evidence submitted to any standing or special committee or subcommittee in connection with any matter referred to the committee or subcommittee shall be the property of the House. The Chair of any committee or subcommittee shall deliver all such documents, testimonies, or other evidence to the House Clerk upon expiration of the term of the House. Representative Edwin K. Propst: Thank you, Mr. Speaker and thank you colleagues. I'm just going to take a few minutes. I just wanted to mention something that I saw in the paper and wanted to thank one of our colleagues for brining up Chairman Ivan Blanco. I want to thank you for your willingness to conduct an oversight for the Department of Public Safety. I do want to clarify that this – I think some people have taken it out of context and think that it's going to be something that is adversarial or to try to assess a blame at anybody and I can assure you from my conversations with our good colleagues that it is not. It's really just a matter of public concern. So, I wanted the public to be aware of that. Mr. Speaker and colleagues, as you do know we're not unique to any other place, we do have our fair share of crime – unsolved murders and other things, but there has been a lot of grief with those families that have unsolved murders or missing people case in point the late Alan Boyer Dela Cruz in his memory several of us have spoken with the bereaved families and of course they like other families want justice for their brother, their son, their nephew and everything. We kindly ask of course the indulgence of DPS to do all they can to help with this murder that took place and for others. They took two months in the making to finally be known that it was a murder as the family expected, but what we do hope and I do know that this is a local matter but we do hope that the Department of Public Safety will consider using as much resources as they possibly can Mr. Speaker and colleagues. With that said to ask for the FBI to assist them in them in this investigation. I think that we should do everything we can to help all these families in these very difficult times. I thank you for your time and indulgence. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Propst. I also ask the Committee on JGO to please proceed with cautious. As you know some of these cases are very sensitive and for that reason, I ask you to be extra care when doing some inquiries in regards to – however, you may proceed with finding out their system in a case whether something like that whether they have a system in place, who to go to and if there is such a protocol with other counterparts. Recognize Representative Deleon Guerrero.

Representative Lorenzo I. Deleon Guerrero: Thank you, Mr. Speaker. We are still under Miscellaneous?

Speaker Rafael S. Demapan: Yes.

Representative Lorenzo I. Deleon Guerrero: Mr. Speaker, I wanted to ask if the legislature have received any lease documents by DPL? And this is in regards to the lessee CMS rock quarry. As you know, two lots are already expired and they are on a month to month basis lease. I wanted to ask if we did receive any documents?

<u>Speaker Rafael S. Demapan:</u> Yes, we did receive documents from DPL in that regards. Let me ask the Madame Chair for Natural Resources to elaborate on the next step of that. Recognized.

<u>Representative Alice S. Igitol:</u> Yes, Representative Guerrero. I am waiting for Chairman of the Senate Mr. Frank Borja. So, I am just waiting for him so we're going to have this joint meeting.

Speaker Rafael S. Demapan: You may.

<u>Representative Lorenzo I. Deleon Guerrero:</u> Madame Chair, how long ago have you been tasked to meet with the Senate?

<u>Representative Alice S. Igitol:</u> In fact, I talked to him two-weeks ago, but he's off-island. So, he said he's leaving on the 14th and he'll be back.

<u>Speaker Rafael S. Demapan:</u> Representative Deleon Guerrero, if I'm not mistaken, if everything falls into place the committee from the House side and the Senate will meet sometime next week.

Representative Lorenzo I. Deleon Guerrero: Thank you, Madame Chair and Mr. Speaker, I yield for now.

Speaker Rafael S. Demapan: Recognize Representative Sablan.

Representative Vinson Edward F. Sablan: Thank you, Mr. Speaker this will be quick. I want to take this time to thank Governor Torres for signing into House Bill 20-34 this is also known as the Handgun Prohibition Revival Act. This bill is now Public Law 20-27 and I also want to thank the House members and the Senate members for passing this bill. Just to clarify the public now – clarify some parts in the law – this does not affect the mandates and clauses of the Safe Act a law which were placed our initial firearms law. The Safe Act still stands, if you remember upon the decision rendered by the US District Court in favor of Radich, the decision made our initial firearms law moot. So, at the moment of that decision when it was decided on we had no firearms law, which created a state of emergency and everyone from the 19th Legislature that is still here remember we had to come in and expeditiously craft a firearms law which will cover the CNMI. So, what public law 20-27 does just for clarification to the viewing public it's the safety net law. So, all it does is if the decision is challenged – the Radich decision is challenged and is overturned then we automatically fallback into our initial firearms law. We don't have to come back and in a state of emergency try to craft another firearm law. So, that is all it does Safe Act still stands, it's still status quo and Public Law 20-27 just acts as a safety net bill in case in

the future any decision is overturned. So, I just wanted to state that to clarify to our viewing public. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Sablan. Let me now recognize Representative Blanco.

<u>Representative Ivan A. Blanco:</u> Thank you, Mr. Speaker. In the spirit of this Thanksgiving from my staff and my family, I want to wish everyone of you and your families including the LB staff and their families a Happy Thanksgiving. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Blanco. Recognize Representative Demapan.

<u>Representative Angel A. Demapan:</u> Thank you, Mr. Speaker. Just real quick to announce and congratulate the new Secretary of Labor Ms. Viky Benavente whose nomination was confirmed by the Senate this morning about the same time we were in session. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you. Further ready? Announcement? Recognize Representative Itibus.
