Wednesday, January 31, 2018

The House of Representatives of the Twentieth Northern Marianas Commonwealth Legislature convened its Second Day, Third Regular Session on Wednesday, January 26, 2018 at 1:53 p.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Rafael S. Demapan, Speaker of the House, presided.

Representative Angel A. Demapan: Thank you, Mr. Speaker. Just for the benefit of our viewers and the stakeholders that are here. Because the bill originated as a \$500,000.00 appropriation since being embedded in the Committee on Ways and Means, the bill is now up to \$931,340.00 resulting from a combination of Cancer Fund monies from two fiscal years - what was left of FY17 and what has been collected so far in FY18 that resulted in the increase of \$431,000.00, but the provision remains the same it's just some addition for the – the original provisions remain and then the additional resources resulted in the addition of \$281,340.00 for the CNMI Medical Referral stipends for patients and escorts on medical referrals outside the Commonwealth. We furthermore provided \$100,000.00 for the Rota and Tinian interisland Medical Referral patients lodging and accommodations. \$50,000.00 for the Commonwealth Healthcare Corporation Betelnut Cessation Program. These were added to the original provisions, which still exists namely the \$150,000.00 for the Commonwealth Healthcare Corporation, Division of Public Health Services Dental Clinic Program and the \$350,000.00 to the Commonwealth Cancer Association to support its patients support services provided that the additional provisions also call for a \$50,000.00 of the \$350,000 will go to the First Senatorial District and \$50,000.00 shall be allocated for services in the Second Senatorial District. As Chair of the Committee Mr. Speaker, I just wanted to take this opportunity to enlighten the general public on the changes that have been undertaken in the Committee on Ways and Means. Thank you, Mr. Speaker.

RESOLUTION CALENDAR

The Floor Leader made a motion to adopt the following House Joint Resolution:

H. J. R. NO. 20-8

A House Joint Resolution to support the passage of S.2325, the Northern Mariana Islands U.S. Work Force Act, introduced by Senator Lisa Murkowski in the Senate of the United States Congress.

<u>Speaker Rafael S. Demapan:</u> Thank you, Floor Leader. Can I just briefly ask the mover on this joint resolution just for the benefit our viewing public. Recognize Representative Demapan.

Representative Angel A. Demapan: Thank you, Mr. Speaker. House Joint Resolution 20-8 is supporting the passage of United States Senate Bill 2325 otherwise known as the Northern Mariana Islands U. S. Work Force Act, which has been introduced by United States Senator Lisa Murkowski. This joint resolution is time sensitive because the Senate Committee on Energy chaired by the mover herself has calendared a public hearing in the United States Congress on February 6. Part of the reason is this bill is a product of a working group that receive feedback from Governor Torres Administration and the members of the Northern Marianas Business Alliance Corporation and other members of Congress. Part of the feedback and the recommendation after putting this bill together was the need to expedite action on the Senate Bill 2325 in light of the approaching April deadline of when renewals open up for FY 2019. So, if this bill is not acted on by Congress and eventually by the White House by April the USCIS will be forced to implement the second round of reduction by 5,000 CW slots so therefore bring us drastically below the current 9,000 level that we're at after the first round of reduction. So, in light of the severe labor shortage that we are foreseeing based on communications that Marianas businesses have started contacting to our CNMI Department of Labor, there is a significant need of expedited action on Senate Bill 2325 and while we are certainly grateful that Chairwoman

Murkowski has expeditiously scheduled a public hearing for next week, one of the recommendations and one of the actions that we usually take in significant legislation like this is to provide a united front from the leadership of the Commonwealth and so the Legislature having not been a participant to the working group can by way of this joint resolution provide its comments and its support to Senate Bill 2325. Our colleagues in the CNMI Senate are aware of this joint resolution and have scheduled a session for this coming Friday to concur with House Joint Resolution 20-8. In that spirit of cooperation and collaboration and for the benefit of the Commonwealth Mr. Speaker, I ask the indulgence of all our colleagues in this chamber to approve House Joint Resolution 20-8 today. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase*, Representative Demapan. Further discussion? Recognize Representative Dela Cruz.

<u>Representative Francisco S. Dela Cruz:</u> Thank you, Mr. Speaker. I noticed that there are eight signatures on the bill itself and I wonder whether the mover is amenable to introducing this under the full body and if there's no objection with the author. Thank you, Mr. Speaker.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Dela Cruz. Mover any comment or thought on that?

Representative Angel A. Demapan: Thank you, Mr. Speaker. In response to our colleague Chairman Dela Cruz, this joint resolution is laying on today's agenda and calendar from the previous session and in our last session we have already made – taken the action to introduce this joint resolution under Committee of the Whole. Thank you, Mr. Speaker.

Speaker Rafael S. Demapan: Si Yu'us Ma'ase, Clerk. With all 18 voting in the affirmative, House Joint Resolution 20-8 hereby passes the House. Thank you. Now moving down to item XVI, Bill Calendar. Before we proceed, Floor, I understand House Bill 20-71, HS1 is still in the calendar. We will go ahead and allow it for one more calendar appearance because of the new information that will be provided by the mover. I think the mover is not present today so let's go ahead and keep putting this on the calendar until the next session. Now you may proceed Floor Leader.

<u>Floor Leader Glenn L. Maratita:</u> Thank you. Before we act on any bill on the Bill Calendar Mr. Speaker. May I request a short recess.

Speaker Rafael S. Demapan: Thank you, Floor Leader. Short recess.

The House reconvened at 3:14 p.m.

<u>Speaker Rafael S. Demapan:</u> Thank you, members. Back from our recess. We will now go ahead and begin and move down to our next Order of Business, which is the Bill Calendar. Let me now recognize the Floor Leader for the first motion.

<u>Floor Leader Glenn L. Maratita:</u> Thank you, Mr. Speaker. I understand that there's an amendment to be offered by I believe Chairman Joe Guerrero. First Mr. Speaker, I would like to offer a motion that we suspend Rule IX, Sections 9 and 10, which refers to the passage of the bill on first and final reading. So move.

RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS Section 9. First Reading of Bills and Resolutions

- (a) When a bill or resolution is read in the House the first time, the Clerk shall report the bill by title, unless a majority orders it read in full, or by such subdivisions as the motion to read may indicate. The House shall then proceed to debate the measure, and amendments shall be in order. At the conclusion of a debate the House shall vote on passing the measure on First Reading after affording an opportunity for one motion to recommit with or without instructions. If the Measure passes with amendments, the Clerk shall engross such amendments and cause the measure, or any page thereof, to be reprinted as provided in Sections 4 and 6 of this Rule. [Note: Rule IX, Section 9, amended by H. RES. 20-4]
- (b) The First Reading of a bill without amendment shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.
- (c) If a bill passes First Reading with amendment, the Clerk shall place it on the Bill Calendar for Second Reading the next legislative day.

(d) First Reading of a resolution shall be the only and final reading, and upon its passage, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

Section 10. Second Reading of Bills

- (a) When a bill is read in the House a second time, it shall be considered in the same manner as for First Reading, except that no further amendments shall be in order. [Note: Rule IX, Section 10, amended by H. RES. 20-4]
- (b) Second Reading of a bill shall be the final reading, and upon its passage, which shall be by Call of the Roll, the Clerk shall dispose of it pursuant to Section 14 of this Rule.

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Thank you, Floor Leader. Your motion has been seconded. Discussion on that motion? Recognize Representative Deleon Guerrero.

Representative Joseph P. Deleon Guerrero: Thank you, Mr. Speaker. With regards to House Bill 20-113, HD1, during our leadership meeting we had discussed for those unclear about the bill. The bill in the title establishes criminal provisions for jaywalking basically, but it does not set forth any jail time. I believe our Legal Counsels recommended that a technical amendment can be made if there's no objection from the members just to clarify the title so that to remove the criminal provision and make it an infraction to be consistent with the amendments that are provided in the actual bill. So I will not be providing a specific amendment rather if we can agree that the Clerk and the Legal Counsel can just make it a technical amendment to remove "criminal" and instead use the word "infraction". Counsel any?

<u>Legal Counsel John Cool:</u> Yes, we can substitute the word "criminal provision" and put in "infraction".

Speaker Rafael S. Demapan: Can we consider it as a technical.

<u>Legal Counsel John Cool:</u> Yes.

Speaker Rafael S. Demapan: Thank you.

Legal Counsel John Cool: The bill itself when you read it, it establishes an infraction.

<u>Speaker Rafael S. Demapan:</u> Thank you, Chairman Deleon Guerrero. So, without any objection considering and changing "criminal" to "infraction" we consider it as a technical. Ready? I guess the motion is the motion to suspend and that still stands. Further discussion on that? Ready?

Several members voiced "ready."

The motion was seconded.

<u>Speaker Rafael S. Demapan:</u> Thank you, Floor Leader. Again, your motion has been seconded. Discussion on that motion? Recognize Representative Deleon Guerrero.

Representative Joseph P. Deleon Guerrero: Thank you, Mr. Speaker. Mr. Speaker, I have a floor amendment to propose and since I only have one copy, I will turn it over to our Legal Counsel so he can use ELMO for our members to see.

Representative Joseph P. Deleon Guerrero offered the following floor amendment:

FLOOR AMENDMENT TO H. B. NO. 20-19

H. B. No. 20-19 is amended as follows:

1. Page 2, lines 1 to 5, are amended to read:

"attached to a golf course.

- (1) A hotel or resort with fewer than 100 rooms shall also be exempt provided such hotel or resort is attached to an operational golf course with a minimum of eighteen (18) holes and provided that such hotel or resort has an ownership or leasehold interest in such golf course."
- 2. Page 2, line 6, a new Section 3 is added as follows:

"Section 3. Amendment. Title 4, Section 1503 is amended by adding the following new subsection:

"(x) The provisions 6 CMC §3156 (b) (1) shall not apply to the renewal or new license issued pursuant to 4 CMC §1503(a)(6) (or license issued pursuant to regulations covering 4 CMC §1503(a)(6)) to a person holding a license issued pursuant to 4 CMC §1503(a)(6) in existence on the effective date of this amendment.""

Consistent with the intent of the forgoing amendment(s), I hereby also move to allow the Legal Counsel together with the House Clerk to make further non-substantive technical amendments that are strictly necessary to effectuate the intent of this floor amendment prior to transmittal.

<u>Speaker Rafael S. Demapan:</u> *Si Yu'us Ma'ase.* The floor amendment has been seconded. Discussion on the floor amendment? Recognize Representative Dela Cruz.

<u>Representative Francisco S. Dela Cruz:</u> Thank you, Mr. Speaker. So, with this amendment that is offered. I pose a question as to whether this establishment in Chalan Laulau next to the McDonald's restaurant would be exempt from this eighteen-hole provision in the legislation?

Speaker Rafael S. Demapan: Thank you. Mover you may respond.

Representative Joseph P. Deleon Guerrero: Thank you, Chairman Dela Cruz. Yes, it would. They have already secured the license to operate. This provision or this amendment would ensure that it would not apply to those that have already been issued licenses for renewal purposes. John, did you want to add to that?

Speaker Rafael S. Demapan: Recognize Counsel.

<u>Legal Counsel John Cool:</u> Yes, this would apply to any existing licensing including the – as long as they have an existing license they can renew that license without having to apply with a provision with having an eighteen-hole golf course.

<u>Speaker Rafael S. Demapan:</u> Counsel, can I ask this question just to put more clarity. Let's say for example there are a hundred machines there and those hundred machines are being licensed and next year I wanted to increase to hundred and fifty, the additional fifty will that be licensed? Yes or no?

<u>Legal Counsel John Cool:</u> This one actually picks up the licensing provisions that are under the regulations that's the facilities license, but in respect to adding new licenses – new machines that are no licensed currently they would have to comply with the current law.

Speaker Rafael S. Demapan: Thank you, Counsel. Representative Dela Cruz further?

<u>Representative Francisco S. Dela Cruz:</u> Thank you, Mr. Speaker. And so, John what you're saying is if this legislation becomes the current law then this establishment would have to satisfy the eighteen-hole golf course provision?

<u>Legal Counsel John Cool:</u> In order to get any license that they currently do not have they would have to comply with the current requirement.

Representative Francisco S. Dela Cruz: So, I guess your answer is no?

<u>Legal Counsel John Cool:</u> To licenses yes.

Representative Francisco S. Dela Cruz: For the new machines?

<u>Legal Counsel John Cool:</u> Correct. And there's some provision in the Department of Finance regulations that relate to the license that they created administratively that could apply, but that was a difficult interact in this amendment because the Finance regulations have not been published because Finance has failed to file a proper notice of adoption but licenses are being issued by Finance. Anyway, the regulation has not been properly adopted.

Representative Francisco S. Dela Cruz: So, again just clarify this particular establishment if their license is up for renewal and they wish to add an additional number of machines. If this legislation becomes law then it would prohibit that establishment from having more machines based on the number of holes that they have which is nine and they cannot expand any further than nine because of the limited area of the land.

<u>Legal Counsel John Cool:</u> That's correct because the purpose of this legislation or the amendment was to add the requirement of eighteen-holes to any licensee or particularly the new licensee – existing licensees would be covered by the contract laws of the constitution so it wouldn't apply to the existing license, but it would apply to a new license. So, this would be a new license either by an existing licensee or a new license by an entirely new individual or company. So, the only way to make it so that they would not have to comply with license requirements in the future would simply be not to adopt the provision in the first place.

Speaker Rafael S. Demapan: Thank you. Chairman Blanco recognized.

Representative Ivan A. Blanco: Thank you, Mr. Speaker. I just wanted to reiterate the concerns from my Precinct 3 colleagues. This bill will affect and it would seem that will affect a particular business in our district so that's why we're asking these questions. Thank you.

<u>Speaker Rafael S. Demapan:</u> Thank you, Representative Blanco. Representative Dela Cruz satisfied?

Representative Francisco S. Dela Cruz: Actually not Mr. Speaker, but that is the Legal Counsels opinion. It appears that with the activities that are going on with that establishment they are building hotel rooms. Now the hotel rooms they can probably satisfy the hundred rooms that's not a problem. The problem that we have is that we have very limited property and this particular golf course to me is a historical landmark. It's been the first golf course of the CNMI, I think when I was little I used to cabby there for a couple of bucks a day and now we're setting up to failure. We're setting it up so it closes in the near future and I don't want to be a part most especially when this establishment is situated within this area here that we represent and with that thank you Mr. Speaker.

Speaker Rafael S. Demapan: Thank you. Short recess.

The House recessed at 3:31 p.m.
