Before I introduce the members-elect, I ask Sergeant-at-Arms Towai to escort to the dais Honorable Alexandro C. Castro, Chief Justice of the CNMI Supreme Court. Please stand. Distinguished Guests, Ladies and Gentlemen, I am honored to present to you the Representatives-Elect of the Twenty-second Northern Marianas Commonwealth Legislature. Please be seated at this time. I once again welcome you to the House of Representatives chamber. I also want to take this time to recognize our distinguished guests Honorable Alexandro Castro, Chief Justice of the CNMI Supreme Court, Honorable John Manglona, CNMI Supreme Court Justice, Honorable Perry Inos, CNMI Supreme Court Justice, Honorable Teresa Kim-Tenorio, CNMI Superior Court Judge, Honorable Edwin Aldan, Mayor of Tinian and Aguiguan, Honorable David Apatang, Mayor of Saipan, Honorable Vicente Santos, Mayor of the Northern Islands, Honorable Steven King, Tinian Municipal Council Vice-chairman, Honorable Joseph Santos, Council-elect for the Tinian Municipal Council and Reverend Father Michael Linden. Please stand. I call upon the Department of Public Safety for the posting of the Colors and Mr. Gus Kaipat to the podium to lead us in the singing of the United States National Anthem and the CNMI Anthem.

It is with great honor and privilege that I call on Speaker Pro Tem, Representative-Elect Blas Jonathan Tenorio Attao, to officially call this House of Representatives' Organizational meeting of the Twenty-Second Northern Marianas Commonwealth Legislature to order.

CALL TO ORDER

The House of Representatives of the Twenty-Second Northern Marianas Commonwealth Legislature convened its First Day, First Regular Session on the Eleventh day of January the year Two Thousand and Twenty-One at 10:20 a.m. in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Representative-Elect Blas Jonathan "BJ" Tenorio Attao, Speaker Pro Tem presided.

Speaker Pro Tem Blas Jonathan "BJ" T. Attao: Thank you, Mr. Tenorio. As such, I also welcome all distinguished guests, ladies and gentlemen and to Reverend Father Michael Linden of the Society of Jesuits thank you very much for your prayers and to the Honorable Chief Justice Alexandro Castro welcome to the House of Representatives and to our viewing public on Facebook and on Channel 23, welcome to your chamber. *Hafa adai* and *tirow*, I now call this Twenty-Second Northern Marianas Commonwealth Legislature, House of Representatives Organizational Session to order. Speaker Pro Tem Blas Jonathan "BJ" T. Attao: Thank you, Clerk. Let the record reflect that all Representatives-Elect are present and a quorum is hereby constituted.

SWEARING-IN OF MEMBERS

<u>Speaker Pro Tem Blas Jonathan "BJ" T. Attao:</u> We now go on to our next Order of Business and that is the swearing-in of Representatives-Elect. My fellow Representatives-Elect, I ask each one of you to rise for our swearing-in as members of this House of Representatives and I ask the Honorable Alexandro C. Castro, Chief Justice of the CNMI Supreme Court to administer the Oath of Office.

Chief Justice Alexandro C. Castro: Please raise your right hand and repeat after me.

The following was repeated by all the Representatives-Elect:

"I do solemnly swear that I will support and defend the Constitution of the Commonwealth of the Northern Mariana Islands, the Covenant to establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, and that I will faithfully discharge my duties as Representatives of the 22nd Northern Marianas Commonwealth Legislature to the best of my ability, so help me God."

Chief Justice Alexandro C. Castro: Congratulations everybody.

Speaker Pro Tem Blas Jonathan "BJ" T. Attao: Thank you, Chief Justice. You may be seated, members. Thank you again, Chief Justice for swearing-in of the members of the Twenty-Second House of Representatives. The next Order of Business in the Introduction and Adoption of the Interim Rules. I will now recognize Floor Leader Pro Tem Villagomez.

INTRODUCTION AND ADOPTION OF THE HOUSE RULES

Floor Leader Pro Tem Edmund Joseph S. Villagomez: Thank you, Mr. Speaker. I am honored to introduce House Resolution Number 22-1, "A House Resolution to adopt the Rules for the House of Representatives and to appoint an Ad Hoc Committee to review the rules; and for other purposes." So move, Mr. Speaker.

The motion was seconded.

<u>Speaker Pro Tem Blas Jonathan "BJ" T. Attao:</u> Thank you, Floor Leader Pro Tem. The motion is for the adoption and it has been seconded. Discussion on the motion?

The motion was seconded.

<u>Speaker Pro Tem Blas Jonathan "BJ" T. Attao:</u> Thank you, Representative Leepan. There's a motion for the nomination of Representative Angel Demapan for Speaker and has been seconded. Any other nominations? Representative Yangetmai please.

<u>Representative Denita K. Yangetmai:</u> Thank you, Speaker Pro Tem. It is with great privilege that I nominate the Honorable Edmund Sablan Villagomez to the Office of the Speaker of the House of Representatives of the 22nd Northern Marianas Commonwealth Legislature. I so move.

The motion was seconded.

<u>Speaker Pro Tem Blas Jonathan "BJ" T. Attao:</u> Thank you, Representative Yangetmai. Another nomination for the Office of the Speaker is Representative Edmund Villagomez and it has been seconded. Are there any other nominations? None. May I please get a motion to close nominations? Representative John Paul Sablan please.

Representative John Paul P. Sablan: Thank you, Mr. Speaker Pro Tem. I now move that we close nominations. So move.

The motion was seconded.

<u>Speaker Pro Tem Blas Jonathan "BJ" T. Attao:</u> A motion to close nomination has been presented by Representative JP Sablan and has been seconded. Discussion on that motion?

With 10 members voting for Representative Demapan and 10 members voting for Representative Villagomez and in accordance with Rule 1, Section (b) that a majority of the members and in all cases not less than 11 votes cast in his or her favor, the motion to elect the Office of the Speaker is not carried. I will now call for a 10 minutes recess and we'll get back to the chamber in 10 minutes. Short recess.

The House recessed at 10:30 a.m.

RECESS

The House reconvened at 10:49 a.m.

<u>Speaker Pro Tem Blas Jonathan "BJ" T. Attao:</u> We are back into our inaugural session. With the understanding of the members, during recess that we will move on under Order of Business down to Communications and we'll take the statements of members. We'll go to recess and allow the MC to take care of the rest of the ceremony and have our benediction. So, with that being said; Clerk, under communications.

House Clerk Linda B. Muña: Mr. Speaker Pro Tem there's none received.

STATEMENTS OF MEMBERS

Speaker Pro Tem Blas Jonathan "BJ" T. Attao: Thank you, Clerk. With no communications. We're down to Statements of members and I understand that the program says that the statement of the Speaker on behalf of the members, but unfortunately, we have no speaker at this time so we will allow the members to present their statement. If you have a written statement and would just like to present it to the Clerk and it will be added to the journal for the inaugural session that's okay also. So, let's start with our right side downward with Representative Celina Babauta.

Representative Celina R. Babauta's Statement

Thank you, Mr. Speaker Pro-Tem, Father Michael Linden, Diocese of Chalan Kanoa, Chief Justice Alexandro Castro and members of the CNMI Judiciary. Cultural representation and traditions should be explored and introduced as one of our strategies in promoting the CNMI.
