## CALL TO ORDER

The House of Representatives of the Twenty-Third Northern Marianas Commonwealth Legislature convened its First Day, First Regular Session on the Nineth Day of January the year Two Thousand and Twenty-Three at 10:20 a.m. in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Representative-Elect John Paul Palacios Sablan, Speaker Pro Tempore presided.

<u>Speaker Pro Tem John Paul P. Sablan:</u> Thank you, Master Ceremony LJ Castro. And as such, I also want to welcome all our distinguished guests, ladies and gentlemen, to Reverend Father Jesse Reyes, thank you very much for your prayers and to the Honorable Justice Perry B. Inos, welcome to your House of Representative. To the general public here, present in this gallery and the whole and also to our viewing public that are watching via livestream welcome and good morning. I now call this 23<sup>rd</sup> Northern Marianas Commonwealth Legislature, House of

Representative Organizational Session to order. At this time, I recognize the Clerk to call the roll.

<u>Speaker Pro Tem John Paul P. Sablan:</u> Thank you, Madame Clerk. Let the record reflect that all Representatives-elect are present and a quorum is hereby constituted.

## **SWEARING-IN OF MEMBERS**

<u>Speaker Pro Tem John Paul P. Sablan:</u> We now proceed further down to our next Order of Business, the swearing-in of Representatives-elect and I ask each one of you to rise as the Honorable Justice Perry B. Inos of the CNMI Supreme Court administers the Oath of Office.

Associate Justice Perry B. Inos: Good morning. Please raise your right hand and repeat after me.

The following was repeated by all the Representatives-elect:

"I do solemnly swear that I will support and defend the Constitution and laws of the Commonwealth of the Northern Mariana Islands, the Covenant to establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, the applicable provisions of the Constitution, laws and treaties of the United States of America and that I will faithfully discharge my duties as a Representative of the 23<sup>rd</sup> Northern Marianas Commonwealth Legislature to the best of my ability, so help me God."

Associate Justice Perry B. Inos: Congratulations representatives. Before you, you would have the Oath of Office, please sign them now.

<u>Speaker Pro Tem John Paul P. Sablan:</u> Members, you may be seated. Thank you once again, Honorable Justice Perry B. Inos for administering the oath. At this time, we move further down on our Order of Business and that is the adoption of the Interim Rules. And at this time, I recognize Floor Leader Pro Tem Representative Ralph Naraja Yumul.

#### **INTRODUCTION AND ADOPTION OF THE HOUSE RULES**

Floor Leader Pro Tem Ralph N. Yumul: Thank you, Mr. Speaker Pro Tem. I am honored to introduce House Resolution No. 23-1, entitled "A House Resolution to adopt Rules for Procedural Motion and on Nominations Organization Sessions and to appoint an Ad Hoc Committee to review the rules; and for other purposes." I move for its adoption.

#### The motion was seconded.

<u>Speaker Pro Tem John Paul P. Sablan:</u> There is a motion offered by Floor Leader Pro Tem for the adoption of the Interim Rules and it has been seconded. Discussion?

Several members voiced "ready."

There was no discussion; the motion to adopt House Resolution 23-1 was carried by voice vote. There was no "nay" vote.

<u>Speaker Pro Tem John Paul P. Sablan:</u> And the adoption of the interim rules that would govern this proceeding is hereby adopted. We now move to the next Order of Business, the Election of Speaker, and at this time, do I hear any nomination? I recognize Representative Blas Jonathan Attao.

#### **ELECTION OF SPEAKER**

<u>Representative Blas Jonathan "BJ" T. Attao:</u> Thank you, Mr. Speaker Pro Tem. Before I make the nomination, I would like to share a little history about this individual that will be leading the 23<sup>rd</sup> House of Representatives. This person when first elected was the youngest member of that legislature, and during that term, this individual served with a former governor, former lieutenant governor, former senate president, and former house speakers. Furthermore, this individual has faced three impeachment proceedings, a government shutdown, government furloughs, and the first to ever sign-off on contempt charges against a CNMI official. If there is an individual that faced the challenges of the CNMI in its 46-year history, I would like to say that this person is the one that has been tested in all the years served in this body. At this time, it is with great honor and privilege that I nominate my colleague from Election Precinct 3, Representative Edmund Sablan Villagomez for the Office of the Speaker. Thank you, Speaker Pro Tem. Thank you, Representative Attao. Do I hear a second?

#### The motion was seconded.

<u>Speaker Pro Tem John Paul P. Sablan:</u> A nomination has been placed on the floor by Representative Blas Jonathan "BJ" Attao for Representative Edmund S. Villagomez to the Office of the Speaker and it has been seconded. Are there any other nomination? Recognize Representative Roman C. Benavente.

Representative Roman C. Benavente: Mr. Speaker, I move for acclamation.

<u>Speaker Pro Tem John Paul P. Sablan:</u> There is a motion offered by Representative Roman Benavente for acclamation and it has been seconded. Discussion?

Several members voiced "ready."

There was no discussion and the motion to nominate Representative Edmund S. Villagomez to the Office of the Speaker was carried by voice vote. There was no "nay" vote.

<u>Speaker Pro Tem John Paul P. Sablan:</u> Congratulations, Representative Edmund Villagomez, Speaker of the House. Sergeant-at-Arms, please escort Speaker-elect to the dais.

<u>Speaker Edmund Joseph S. Villagomez:</u> My fellow colleagues, it is with great privilege and honor that you have bestowed onto me your confidence and trust by electing me to serve as your speaker. Thank you. Now let us move on to the election of the Vice Speaker. Do I hear a nomination? Recognize Representative Malcolm J. Omar.

<u>Representative Malcolm J. Omar:</u> Thank you, Mr. Speaker. Mr. Speaker, at this time it's my privilege and honor to nominate my colleague and counterpart from Precinct 4, Representative Joel Castro Camacho to the Office of Vice Speaker for the 23<sup>rd</sup> House of Representatives.

#### The motion was seconded.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you. Nomination has been placed for the Office of the Vice Speaker for Representative Joel C. Camacho and it has been seconded. Any other nomination? I recognize Representative Angelo Camacho.

<u>Representative Angelo A. Camacho:</u> Thank you, Mr. Speaker. Mr. Speaker, I move for acclamation.

#### The motion was seconded.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Angelo Camacho. A motion has been made to move for acclamation and has been seconded. Any discussion?

Several members voiced "ready."

There was no discussion and the motion to nominate Representative Joel C. Camacho to the Office of the Vice Speaker was carried by voice vote. There was no "nay" vote.

<u>Speaker Edmund Joseph S. Villagomez:</u> Congratulations, Representative Joel Camacho. Sergeant-at-Arms, please escort Representative Joel Camacho to his seat. We now move forward to the election of Floor Leader. Do I hear a nomination? Recognize Representative Ralph Yumul.

## **ELECTION OF THE FLOOR LEADER**

<u>Floor Leader Pro Tem Ralph N. Yumul:</u> Thank you, Mr. Speaker. And now I am honored and privileged to nominate my childhood friend, classmate, my *kuya*, Edwin K. Propst to the Office of Floor Leader for the 23<sup>rd</sup> House of Representatives.

#### The motion was seconded.

<u>Speaker Edmund Joseph S. Villagomez:</u> A motion has been made for the nomination of Representative Edwin K. Propst to the Office of Floor Leader and it has been seconded. Do I hear any other nomination?

<u>Speaker Edmund Joseph S. Villagomez:</u> Ready, I recognize Representative Diego Vincent F. Camacho.

<u>Representative Diego Vincent F. Camacho:</u> Thank you, Mr. Speaker. Mr. Speaker, I move for acclamation for my former boss.

#### The motion was seconded.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Diego Vincent Camacho. A motion has been made for acclamation and it has been seconded. We ready?

Several members voiced "ready."

There was no discussion and the motion to nominate Representative Edwin K. Propst to the Office of the Floor Leader was carried by voice vote. There was no "nay" vote.

#### **NOTIFICATION TO THE GOVERNOR**

<u>Speaker Edmund Joseph S. Villagomez:</u> Congratulations Representative Edwin K. Propst. Sergeant-at-Arms, please escort Representative Propst to his seat. Thank you, colleagues. We now move down to the Notification to the Governor and to the Senate. I would like to appoint Representative Marissa R. Flores and Julie A. Ogo to inform the Senate and Representative Angelo A. And also, so the Chief Justice's schedule is also tied up at this time. As for Representative Marissa Flores and Representative Julie Ogo, as soon as we are informed that the Senate has elected their officers we will take a quick recess so that you can inform the Senate that we are duly organized. Thank you, colleagues. We now move down to communications. I want to recognize the Clerk. Clerk, do we have any communications?

And in terms of agriculture, diversification of local crops and support of our local farmers. Defending and preserving our indigenous language, culture, practice, and traditions by integrating them into modern day values and ways, but most importantly, providing a true, honest, and transparent government for the people who entrusted us to be their voice. However, these cannot be achieved by one man, not by me, the Governor, our government, or any of us, you, my colleagues, but this will only be possible by all of us collectively, together. In the past several years, we've endured a series of events unprecedented in our history. We have proven to be a community of compassion, resilience, strength, and unity.
