H. L. B. NO. 23-4: To amend 10 CMC §14106 to amend the Rota Resident Identification Card fee; and for other purposes. Introduced by REP. JULIE M. A. OGO of Rota, Precinct 7 (*for herself*) on February 3, 2023.

H. B. NO. 23-7: To amend 4 CMC §1401(d) to increase revenues by properly taxing tobacco products. Introduced by REP. JOHN PAUL P. SABLAN of Saipan, Precinct 2 (*for himself*, Representatives Blas Jonathan "BJ" T. Attao, Roman C. Benavente, Angelo A. Camacho, Joel C. Camacho, Manny G. T. Castro, Marissa R. Flores, and Ralph N. Yumul) on February 3, 2023; subsequently referred to the House Committee on Ways and Means.

H. B. NO. 23-8: To require all contractors to be licensed in the Commonwealth of the Northern Mariana Islands. Introduced by REP. DENITA KAIPAT YANGETMAI of Saipan, Precinct 3 (*for herself*) on February 3, 2023; subsequently referred to the House Committee on Judiciary and Governmental Operations.

H. B. NO. 23-9: To require legislative appropriation for all non-locally-sourced funds allocated for the Commonwealth of the Northern Mariana Islands. Introduced by REP. DENITA KAIPAT YANGETMAI of Saipan, Precinct 3 (*for herself*) on February 3, 2023; subsequently referred to the House Committee on Ways and Means and to the House Committee on Judiciary and Governmental Operations.

H. B. NO. 23-10: To amend 8 CMC §1204, as amended by Public Law 22-25, to create an exemption to the requirement that a marriage certificate include the "places of residence". Introduced by REP. JOHN PAUL P. SABLAN of Saipan, Precinct 2 (*for himself*, Representatives Blas Jonathan "BJ" T. Attao, Roman C. Benavente, Angelo A. Camacho, Diego V. F. Camacho, Joel C. Camacho, Manny G. T. Castro, Joseph A. Flores, Malcom J. Omar, Edmund S. Villagomez, and Ralph N. Yumul) on February 3, 2023; subsequently moved and placed on the Bill Calendar.

H. B. NO. 23-11: To amend Title 1, Division 8 of the Commonwealth Code by establishing a Veterans' Preference employment provision for the CNMI Government; and for other purposes. Introduced by REP. VICENTE C. CAMACHO of Saipan, Precinct 3 (*for himself*) on February 3, 2023; subsequently referred to the House Committee on Federal and Foreign Affairs.

H. B. NO. 23-12: To amend 1 CMC § 7831 to provide for direct legislative appropriation to the Office of the Public Auditor, and for other purposes. Introduced by REP. VICENTE C. CAMACHO of Saipan, Precinct 3 (*for himself*) on February 3, 2023; subsequently referred to the House Committee on Ways and Means.

[ADDED-2/3/2023] H. B. NO. 23-13: To amend the Crimes and Criminal Procedure Code definitions of dangerous weapon and serious bodily injury. Introduced by REP. MARISSA R. FLORES of Saipan, Precinct 3 (*for herself*) on February 3, 2023; subsequently referred to House Committee on Judiciary and Governmental Operations.

[ADDED-2/3/2023] H. B. NO. 23-14: To amend the punishment for the crime of vandalism to include the option of confinement. Introduced by REP. MARISSA R. NO. 23-15: To amend Title 6 of the Commonwealth Code by adding a new Chapter to enact provisions associated with public corruption, other unlawful influence and related offenses for public officials; and for other purposes.
