INTRODUCTION OF BILLS

To impose an additional five percent (5%) on any licensed construction contractor that earns a yearly gross revenue of Two Hundred Fifty Thousand Dollars (\$250,000.00) or more for a period of three years.

Representative Blas Jonathan "BJ" T. Attao: Thank you, Mr. Speaker and I thank the chairman of Ways and Means for getting this concurrent resolution prepared for our action today. Just for informational purpose for the members, I actually spoke to the Senate President and they've done their analysis on the budget, but she thought that with the settlement fund payment was inclusive of the 25% that's obligated to our retirees. Unfortunately, those information are coming from the general appropriations. It's not an earmark. So, we do not have to change the concurrent resolution as written right now, at least the numbers that were submitted by the Administration until they come up with new numbers then we will be amending the numbers on the concurrent resolution. So, I just want to put that for the record that those monies that are potentially new monies for the actual budget will be reflective on the budget bill itself, but it will not change the ceiling of this current budget. Thank you, Mr. Speaker.

Representative Ralph N. Yumul: Thank you, Mr. Speaker and thank you members for adopting House Concurrent Resolution 23-1. <u>Speaker Edmund Joseph S. Villagomez:</u> I recognize Representative. Attao.

Representative Blas Jonathan "BJ" T. Attao: Thank you, Mr. Speaker. I didn't know where the Chairman of Ways and Means was going, but I believe that obviously we have the numbers in front of us, whatever is submitted by the Administration. I think all the members should participate in this. We have such a short window to get this bill taken care of so we can at least not disrupt the functions of the government. I guess the target date to effectuate the 72-hours is April 1st. So, if we can put our minds together, work on the provisions, it's the provisions that are the meat of this legislation. We have the numbers, but if we put the provisions and tighten it up

so that we, in the legislature also, up to date and pressed with all the information, most especially the collections that we'll be getting here on forward so that we can be able to determine what FY 2024 is going to look like and we will be getting that submission by May 1st. So, please members, if you are available, let's work with the Chairman and the members of the committee on Ways and Means at 3:00 p.m. we'll try to get this bill taken care of. Try to get it out of this body so the Senate have any changes that they may want to add. We can go to conference committee and address it. I hope we don't have to get to that point and whatever concerns that they may have right now with the current submission by the Administration we can address in the House, so we can smoothly pass the Senate and get to the Governor's desk for action and it'll give our people some opportunity to prepare themselves come April 1st. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you, Representative Attao. Chairman Yumul you're good?

Representative Ralph N. Yumul: Yeah. Thank you Speak. I yield.

<u>Speaker Edmund Joseph S. Villagomez:</u> Thank you and on that note too, we'll just wait in terms of the, you know, the process and the progress of the Ways and Means Committee in terms of the revised budget and I'm looking at maybe calling a session either Friday afternoon, probably the latest, might be Saturday morning, depending on when the Ways and Means gets the budget going out of committee. Okay. Just heads up. All right. Floor is still open under Announcements. Ready?

<u>Speaker Edmund Joseph S. Villagomez:</u> All right. We'll move down to Adjournment and I recognize the Floor Leader.
