The House of Representatives of the Twenty-Fourth Northern Marianas Commonwealth Legislature convened its First Day, First Regular Session on Monday, January 13, 2025, at 10:17 a.m., in the House Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Representative-Elect Blas Jonathan "BJ" T. Attao, Speaker Pro-Tempore presided.

Speaker Pro-Tem Blas T. Attao: Thank you, Ms. Santos. And as such, I welcome all of our distinguished guests, ladies and gentlemen. And to Reverend Father Nelson, thank you for your prayers. <u>Clerk Linda Muña:</u> Mr. Speaker, all twenty representatives-elect are present.

Speaker Pro-Tem Blas T. Attao: Thank you, Madam Clerk. Let the record reflect that all Representatives-Elect are present. A quorum is hereby constituted. We now proceed to the next order of business, the Swearing-In of Representatives-Elect, and I ask each and every one of you to please rise as the Honorable Chief Justice Castro of the CNMI Supreme Court administers the Oath of Office.

SWEARING-IN OF REPRESENTATIVES-ELECT

Chief Justice Alexandro C. Castro: Please raise your right hand and repeat after me.

The following was repeated by all the Representatives-Elect:

"I do solemnly swear that I will support and defend the Constitution and laws of the Commonwealth of the Northern Mariana Islands, the Covenant to establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, the applicable provisions of the Constitution, laws and treaties of the United States of America and that I will faithfully discharge my duties as a Representative of the 24th Northern Marianas Commonwealth Legislature to the best of my ability, so help me God."

<u>Chief Justice Alexandro C. Castro:</u> Congratulations! I believe you have your Oath of Office in front of you. You cannot change your mind now; you have to sign it. Thank you all. Congratulations, again.

<u>Speaker Pro-Tem Blas T. Attao:</u> Members, please sign your Oath of Office. Thank you, Chief Justice, for administering the Oath of Office to the members of this House. Moving forward to the next order of business, the Introduction and Adoption of Interim Rules, and I recognize Floor Leader Pro-Tem Malcolm Omar.

INTRODUCTION AND ADOPTION OF INTERIM RULES

<u>Floor Leader Pro-Tem Malcolm J. Omar:</u> Thank you, Mr. Speaker Pro-Tem. I am honored to introduce House Resolution No. 24-1, entitled, "A House Resolution to adopt the rules for the House of Representatives and to appoint Ad Hoc Committee to amend the rules; and for other purposes." I move for adoption.

The motion was seconded

Speaker Pro-Tem Blas T. Attao: Thank you, Mr. Floor Leader Pro-Tem. A motion for the adoption of House Resolution No. 24-1 has been made and has been seconded. Any discussion?

There was no discussion on the floor, and the motion to adopt H. Res. 24-1 was carried by voice vote. There was no "nay" vote.

<u>Speaker Pro-Tem Blas T. Attao:</u> House Resolution 24-1 is hereby adopted. We will now move to the next order of business, the election of Speaker, and I recognize Representative Marissa R. Flores.

ELECTION OF SPEAKER

Representative Marissa R. Flores: Thank you, Mr. Speaker Pro-Tem. At this time, it is with great honor and privilege, that I nominate my colleague from Election Precinct 3, Representative Edmund S. Villagomez.

The motion was seconded.

<u>Speaker Pro-Tem Blas T. Attao:</u> Thank you, Representative Flores. A nomination has been placed on the floor by Representative Marissa R. Flores for Representative Edmund S. Villagomez to the Office of the Speaker, and it has been seconded. Are there any other nominations?

There were no further nominations made on the floor, and the Speaker Pro-Tem recognized Representative Roman C. Benavente.

<u>Representative Roman C. Benavente:</u> Mr. Speaker Pro-Tem, I would like to move for acclamation on the position for the Speaker.

The motion was seconded.

Speaker Pro-Tem Blas T. Attao: Thank you for that, Representative Benavente. A motion of acclamation has been presented by Representative Benavente and has been seconded. Any discussion on that motion?

There was no discussion on the floor, and the motion to nominate Representative Edmund S. Villagomez to the Office of the Speaker was carried by voice vote. There was no "nay" vote.

<u>Speaker Pro-Tem Blas T. Attao:</u> The motion carries. Representative Edmund S. Villagomez is the Speaker of the Twenty-Fourth Legislature. Sergeant Towai, kindly escort Speaker Villagomez to the dais.

Speaker Edmund S. Villagomez: Thank you, members of the Twenty-First Legislature. I am sorry. My fellow colleagues, it is a great privilege and honor that you have bestowed upon me, once again, the confidence and the trust in being your Speaker of the Twenty-Fourth House of Representatives. Thank you very much! And with that, let us move on to the election of the Vice-Speaker, and I now recognize Representative Joel C. Camacho.

ELECTION OF VICE SPEAKER

<u>Representative Joel C. Camacho:</u> Thank you, Mr. Speaker, and congratulations. It is my privilege and honor that I nominate Representative Diego Vincent F. Camacho to the office of the Vice Speaker for the Twenty-Fourth of the House of Representatives.

The motion was seconded.

<u>Speaker Edmund S. Villagomez:</u> Thank you, Representative Joel C. Camacho. A nomination for Vice Speaker for Representative Diego Vincent F. Camacho has been made, and it has been seconded. Any discussions?

There were no discussions on the floor, and the Chair recognized Representative Vincent S. Aldan.

Representative Vincent S. Aldan: Thank you, Mr. Speaker, I move for acclamation.

The motion was seconded.

There were no discussions on the floor, and the motion to nominate Representative Diego Vincent F. Camacho to the Office of the Vice Speaker was carried by voice vote. There was no "nay" vote.

<u>Speaker Edmund S. Villagomez:</u> Sergeant-at-Arms, please escort Representative Camacho up to the dais. Thank you, once again, colleagues. And congratulations, once again, Representative Diego Vincent F. Camacho. We now proceed to the election of the Floor Leader. I now recognize Representative Julie Ogo.

ELECTION OF FLOOR LEADER

<u>Representative Julie A. Ogo:</u> Thank you, Mr. Speaker, and congratulations. It is my privilege that I nominate Representative Marissa R. Flores to the Office of Floor Leader for the Twenty-Fourth House of Representatives.

The motion was seconded.

<u>Speaker Edmund S. Villagomez:</u> Thank you. A nomination has been placed on the floor to elect Representative Marissa R. Flores to the Office of Floor Leader, and it has been seconded. Any discussions?

There being no discussions on the floor, the Chair recognized Representative Denita K. Yangetmai.

Representative Denita K. Yangetmai: Mr. Speaker, congratulations. I move for acclamation.

The motion was seconded.

<u>Speaker Edmund S. Villagomez:</u> Thank you. A motion has been made for acclamation, and it has been seconded. Any discussions?

There were no discussions on the floor, and the motion to nominate Representative Marissa R. Flores to the Office of the Floor Leader was carried by voice vote. There was no "nay" vote.

Speaker Edmund S. Villagomez: Congratulations again, colleagues, and also to the new officers of the Twenty-Fourth Northern Marianas Commonwealth Legislature in the House of Representatives. We now move down to our next business, the Notifications to the Governor and to the Senate. I would like to appoint Representatives John Paul Sablan and Angelo A. Camacho to inform the Governor and Representatives Julie Ogo and Patrick San Nicholas to inform the Senate, and lastly, I would like to appoint Representatives Joel C. Camacho and Blas Jonathan "BJ" T. Attao to inform the NMI Judiciary that the Twenty-Fourth House of Representatives is duly organized and ready to conduct business. At this time, I call for a short recess.

NOTIFICATIONS TO THE SENATE, GOVERNOR, AND JUDICIARY

The House recessed at 10:30 a.m.

Recess

The House reconvened at 10:44 a.m.

<u>Speaker Edmund S. Villagomez:</u> Before we went on recess, the Chair appointed members to inform the Judiciary, Senate, and the Governor that we have duly organized and are ready to do business. At this time, the House will receive the report on the notifications to the Governor, the Senate, and the NMI Judiciary. At this point, I would like to recognize Representative Angelo A. Camacho.

<u>Representative Angelo A. Camacho</u>: Thank you, Mr. Speaker. Mr. Speaker and members, Representative John Paul Sablan and myself, have notified the Governor that the House is duly organized and ready to conduct business. Thank you.

The Chair recognized Representative Julie A. Ogo.

Representative Julie A. Ogo: Thank you, Speaker. Members, Representative Patrick H. San Nicolas and myself, have notified the Senate that the Twenty-Fourth House of Representatives is duly organized and is ready to conduct business.

The Chair recognized Representative Joel C. Camacho.

Representative Joel C. Camacho: Thank you, Mr. Speaker. Mr. Speaker and members, Representative Blas Jonathan "BJ" T. Attao and myself have notified the NMI Judiciary that the Twenty-Fourth House of Representatives is duly organized and is ready to conduct business. Thank you, Mr. Speaker.

<u>Speaker Edmund S. Villagomez:</u> Thank you, Representative Joel C. Camacho. We will now proceed down to the next item on the agenda, which is Communications, and at this time I now recognize the Clerk. If there are any communications received.

COMMUNICATIONS

Clerk Linda Muña: Thank you, Mr. Speaker. At this time, there are no communications received.

Speaker Edmund S. Villagomez: Thank you, Clerk. As we await, we will go ahead and move down to the next item on the agenda, which is Statement of Members, as we await the Senate's formal notification of being duly organized. The floor is now open for members who wish to deliver their statements. Members are encouraged to either read their statements out loud or submit them in writing to the House Clerk for inclusion in the official journal and for public record. Please note

that written statements submitted without being read will also be considered as having been presented. Members, are there any objections to this process?

Members of the House voiced "no objections."

Speaker Edmund S. Villagomez: Okay, with no objections, we will proceed. I am going to start from my left. Okay. So, from left to right, the floor is open for statements by the member. Representative Vincent Aldan.

The Chair recognized Representative Raymond U. Palacios.

Representative Raymond U. Palacios: First, I want to thank and praise the almighty God for the blessing of his creation and for the eternal gift of his son, our Lord Jesus Christ. Good morning, and congratulations, Mr. Speaker, and to all the members of the Twenty-Fourth Legislative House of Representatives. With God on my side and the Lord who gives me strength, I, as an elected member of Precinct 1, am a humble servant of God with a mission and purpose to serve his people with transparency, fairness, empathy, dedication, and respect. I will ensure the people's voices are heard, and their needs are addressed with integrity, wisdom, and justice, upholding the will of God and the principles of righteousness in all legislative actions for a better quality of life for all. With utmost respect, I want to extend my sincere appreciation and love to the community of precinct one, to my wonderful wife, Josephine, my children, my mother, Esperanza Ulloa Palacios, my brother, Gus, seated behind me, to all my siblings and in-laws present here today, and those from afar for their untiring support and love. Hu guiya hamyo! Also, I want to thank and recognize the Legislative Bureau Team and those who assisted with the preparation with their valuable time and effort in making today's special ceremony a success for us all. In closing, I love you all, and may God bless the people of the CNMI! Thank you, Father, it is done! Thank you.

The Chair recognized Representative John Paul P. Sablan.

Representative John Paul P. Sablan: Thank you, Mr. Speaker and members. Congratulations to all of you. In the interest of time, I do want to submit my full statement. I do want to thank a few people, and I want to start with my family and friends. Most especially to my wife, Juanette; our

children, PJ, Chloe, and our granddaughter, Chleo; and our daughters, Gwendolynn and Halia, for their love and encouragement that keeps me going on. I could not have done this without you. To the precinct two committee club, thank you for your hard work and your dedication during this campaign. And to all my supporters, you are the heart of this journey, and I am so grateful for each of you. This victory is ours. Lastly, I want to thank my incredible people of Election Precinct 2. Thank you from the bottom of my heart for reelecting me as your congressman. Your trust and support over the past twelve years mean everything to me. Being reelected as your congressman is an honor I do not take lightly, and I am excited to keep working for you and representing our community. Congratulations, members, and thank you, Mr. Speaker.

The Chair recognized Representative Elias M. Rangamar.

Representative Elias M. Rangamar: Chief Justice Castro, distinguished guests, colleagues, family, and friends, todu taotao Marianas, I grace your presence today. Mr. Speaker, I will submit my full statement later. Typically, when I am handed the phone, it is with KSPN Bob Coldeen with the intro, "Tara-dat-tara-dat. Hafa adai, sports fans!" So, this is a new ballgame for me—a new arena. Those that know me, they know that, for almost forty years, they have never seen me wear long pants. I have been in short pants—an island boy. Even through my travels, I have been to Russia in the winter. People were taking pictures of me; they thought I was crazy because I was wearing shorts and slippers. But when you travel and they tell you where you are going, we do not have those things here: coats and stuff. So, I toughed it out. But I always represented the island as the island boy ambassador. Joking aside. With that said, I would like to respectfully congratulate and recognize our reelected leaders, our new leaders, Speaker of the House Mr. Edmund Villagomez, Vice Speaker Mr. Diego Vincent Camacho, and our Floor Leader Ms. Marissa Flores, and our counterparts in the Senate, and our newly elected Congresswoman, Ms. Kimberly King-Hines. Congratulations on your triumph. Well deserved. Additionally, I extend my gratitude to the incredible team working behind the scenes, the Legislative Bureau, and Mr. Perry Tenorio. Great job. To my committee, Chairman Raymond Tebuteb, Secretary Sonia Olopai, Treasurer April Repeki, Mr. and Mrs. Jerry Ayuyu, family, friends, and supporters, I thank you from the bottom of my heart for standing with me, believing in me, and working so hard to make this vision a reality. Lastly, this moment is not mine alone. I just want to share it with the people who have been with me, unwavering support, my compass, and my greatest source of strength, my family. I want to recognize my wife, Delores, back here, for doing an amazing job raising our kids, our family. The family I brought today is just the tip of the iceberg. We have so many extended families. I apologize to them if I did not mention their name. They know who they are. To my children, from my eldest daughter, Leiseschangmwar-back here, Rachel, who just came from Hawaii, Li'amwar, Bella Liasaar, Kina Neisuupe, and Bwilitomwar. If you are wondering, "Does he have a son, a boy?" Yes, I do. It is the last one, Bwilitomwar. I named him after my dad. But we were not supposed to have him. My wife did not want to have any more, but I was persistent. So, I promised her, "If I coach you to a gold medal, will we have one?" During the MICRO games, she actually did not know she was already pregnant, but she won the medal. I got my wish. I was so excited I told her we were going to name our kid, "Atlas.". Not the titan; what do you call that, the Greek mythology? Atlas, for I have a son! To my constituents, today I stand before you with profound gratitude and a deep sense of responsibility. Our island is more than a place. It is a home, a heritage, and a vision of what we can achieve together. Thank you for placing your trust in me to serve as your representative. Before I yield to my sister on my left, I want to share a thought. When traditional canoes set sail, the journey depends on the collaboration. To propel and guide the canoe toward the destination, it requires a sail, ropes, a master navigator, a dedicated crew, and, most importantly, the unwavering support of his community. In much the same way, our island nation relies on the collaboration within the executive, legislative, and judicial branches, as well as the active participation of the community. It is spirited that working together can navigate the challenge and chart a course towards progress. Lastly, can we all stand up? We are not going to do any jumping jacks. Can we all stand up, please? We will not do any jumping jacks, I promise. Can I do this, Speaker?

Speaker Edmund S. Villagomez: Yes, yes. No objection.

<u>Representative Elias M. Rangamar</u>: Alright! Yes, I will stand up. When we close a business deal, make a promise, or seal a covenant, we often signify our commitment through a handshake or a bow. In our daily interactions, we also—our younger generation, they pound; in the church, peace. So, I invite everyone to turn to your neighbor, to your left and right, shake hands, and pound just to show our commitment to working together.

Members of the House, distinguished guests, families, and friends all stood up and turned to one another and shook hands and signed peace throughout the Chamber.

Representative Elias M. Rangamar: With that, thank you, Mr. Speaker.

Speaker Edmund S. Villagomez: Thank you, Representative Rangamar, for that statement and that little exercise. Just knowing, like you mentioned, when we sail, it is a crew. So let us all work together. And with that, I would like to recognize Representative Denita Yangetmai.

The Chair recognized Representative Ralph N. Yumul.

Representative Ralph N. Yumul: Thank you, Mr. Speaker, and congratulations to you and your young leadership, Vice Speaker Diego Vincent Camacho and Floor Leader Marissa Flores. I, too, will be submitting my official statement. I had it on my phone, but my other son has my phone. And I am not prepared. But, first and foremost, I would like to thank Precinct 3 for putting me

back in office again. I will not be here; I think they have confidence in me, placing me here again for the sixth time. So, I am not sure if it is good or bad. Let me thank my family—my mom and dad, who are in my office right now, and my wife and my son, back here—for their support. Throughout the years they put up with me, I guess, always out with Representative Sablan and Representative Camacho. This year is a little bit different; I think I am a little bit locked down. The Chair recognized Representative Blas T. Attao.

I thank him for making everything possible through prayer; believe me, there was a lot of prayer during campaign time. I am committed to standing by, supporting, and assisting all military veterans. The army engineer pin with a model essayons means let us try in French. This pin signifies us coming together collaboratively to bring our resources together to help the community as a whole. That is why I wore the pin today. And the Judiciary pin for Chief Justice Alex Castro. I told you I wore your pin in support of the Judiciary and Law Enforcement. Three decades ago, I worked as a personal security and marshal assigned to presiding Judge Paul J. Abate and presiding Judge Alberto Lamorena. During those brief years, I grew to respect the work that core personnel perform. Last week I received a concern about potholes on Texas Road. Colleague, we need to take care of that. The Chair recognized Representative Joseph A. Flores.

Representative Joseph A. Flores: Thank you, Mr. Speaker, Mr. Speaker, I thought we were going to start the speech on our side, the right side, because I prepared twenty-six pages. Because in the last term, there were a lot. So, I will keep it short because time is of the essence. Mr. Speaker, congratulations to the Vice Speaker, newly elected Floor Leader. Another Flores in the House. Mr. Speaker and fellow constituents and colleagues, I sit here today with a heart full of gratitude and appreciation as we gather here in this esteemed chamber. I will take a moment to extend my deepest thanks to the voters of Precinct 1. It is your voice that has brought us here, and it is your trust in us that motivates our work each day. It is a profound honor to represent the people of Precinct 1 again, as this will be my fourth term in the legislature. I promise to carry your voice with me as we navigate the challenges ahead. The Chair recognized Representative Roman C. Benavente.

Representative Roman C. Benavente: Thank you, Mr. Speaker. And I would like to congratulate you also for taking the helm again as a Speaker and the new Vice Speaker. And to all the members that are here: I would just like to congratulate you too. As you can see, I am one of the senior members, too, over here. I would speak some Chamorro, I mean English, but I will also speak my native tongue. I would like to acknowledge before I move on. I would like to acknowledge the Chief Justice, Mr. Alex Castro. I have seen in the past that I have been here in the legislature for quite some time. In fact, Representative Yumul has mentioned we were like a ping pong ball. We win, and then we are out, and then we win. And thank God, really. Thank God that we are chosen to be here. All of us here that are here today are the chosen ones to be here representing the people. Because we are not going to be here if we do not get the blessings. I am not a preacher, but I know. And we are all blessed to be here to represent the people of the CNMI. So, let us, please, let us not throw away that opportunity. If our heart is in for the people, then let us move forward. We have been faced with challenges these past years, and even up to now we are still faced with challenges that we still have to face ahead and try to resolve all those challenges to put them behind us. Going back to Representative Yumul, when we lost together at one term, he passed by my house, and I was not doing anything. Well, I was doing something. But he passed by my house, and he goes, "What are you doing?" And I said, "Why do you not come down?" When he came down the garage, I was making a dining table. He said, "Can I help you out?" I said, "You got nothing to do at your house?" He said, "No. But you know I just want to get the..." Because he feels too that we are out of touch in ways. And it is true. When you run for office and then you lose, you feel like you have been neglected or isolated by something. So, that is basically how we feel. But we did not give up. Why? Because we were chosen. We were chosen to continue on, and we managed to continue on. At my age, like Chief Justice Castro over here, I have known him since he first started working for the court when I was working for Continental Airlines. And I am so proud of him too. But at the same time, I like to say this: it might be awkward, but I like to say that sometimes here in the Legislature, with the separation of power, the Legislative, Judicial, and the Administration, sometimes we do not see each other eye-to-eye. And it is good that we have our own opinion. I have behind me my wife, Andrea; she is a Native American. I am Chamorro and who knows what. Yes, because we are all mixed. But I also have my kids; I have Linoa; I have Jeremiah; I have Darrah; I have David; and I have Annrita. They are all here with me, and they are on my back. As well as all you guys, you folks also over here, all you representatives, your families are here. They are happy; they are proud. And we should be. We should be. Why? Because we are making a difference for our people, for our community. And I would just like to say to us members that are here today, thank you, and let us work together as much as possible. We have different opinions, but let us move ahead. Let us try a course that we would face forward and not get into a problem for our people and whatnot. That is the most important thing. I do not have to be technical and read all of this kind of stuff and everything. All those technical words and everything, no. Maila yi bai sangani amyu finu i Chamorro. Taya mass i protanti. Pagu ya ha'ita. Tanai gracias i saina na ta gatsa i tempu. Man mottu hit gi tempu ya todudu man guiguie guine masha guahu mas amko ginen esti. Loa esti bai sangani amyu. Todudit bindisiru ginen i saina. Anaoyo I bindension para ta'hita para tai sempre publiku. Pues maila ya ta chogui maolek ta korihi baba, ya ta chogui maolek, yu gao minaolek para famagonta gi manmanmaila. Mr. Speaker, enaoa, si yu'us ma'asi.

The Chair recognized Representative Roy A. Ada.

Representative Roy A. Ada: Thank you, Mr. Speaker. I must be honest; I have been waiting for everybody. I really need the bathroom. I do not know about you guys, but thank you for making it to me. Mr. Speaker, Chief Justice, Floor Leader Flores, and Vice Speaker, congratulations on your election to the Twenty-Fourth Legislature. To my colleagues, congratulations to you and your family. Ladies and gentlemen, honored guests. First and foremost, I would like to give thanks to God, our Lord, for bringing us all together and for blessing our family and friends. I hope for a very prosperous 2025 for all of us. I am deeply humbled and grateful to be reelected as your congressman. This is not just an honor but a profound responsibility, one I carry with great respect. Thank you for placing your trust in me once again. Your confidence assures our shared vision for the CNMI. The Chair recognized Vice Speaker Diego F. Camacho.

To our distinguished guests, dignitaries, families, and friends, welcome to your House.
