RULE IX. BILLS, RESOLUTIONS AND AMENDMENTS.

Section 8. Referral of Bills and Resolutions.

(a) Bills and resolutions shall be read by title upon introduction and (except as provided in subsection (b), the Speaker shall refer such measures to an appropriate committee or to more than one committee, jointly or sequentially. The Clerk shall endorse such reference on the measure before duplication and shall enter such reference upon the journal. In the case of error of reference, correction may be made by the House, with debate, immediately after the reading and approval of the Journal, by unanimous consent, or upon motion of either committee claiming jurisdiction or the committee to which the measure has been erroneously referred. (b) The Speaker may place a resolution directly on the Resolution Calendar, rather than refer it to a committee, subject to appeal to the House.

Representative Vincent Raymond Aldan: Thank you, Mr. Speaker. I am not sure if I should have done this in the Miscellaneous Business or not, but I just wanted to read something that came from the United States Department of Labor.

<u>Speaker Edmund Joseph Sablan Villagomez:</u> Okay. Before we go there, colleagues, if there are no objections, I would like to move back to Miscellaneous Business.

Speaker Edmund Joseph Sablan Villagomez: Thank you. I recognize Representative Vincent Raymond Aldan.

MISCELLANEOUS BUSINESS

Representative Vincent Raymond Aldan: Thank you, Speaker. I just wanted to make sure that the people understand what is really going on with the PUA and FPUC or funding. This letter came from the United States Department of Labor on March 4th, 2024 to the Governor. And it says here:

It is our understanding that CNMI is seeking authorization to utilize the remaining PUA and FPUC funds to help restore economic stability. The Department is not able to provide such authorization. Federal law only permits the use of these appropriated funds for the purposes intended – payment of PUA and FPUC benefits for the weeks of unemployment covered by the programs. These funds may not be used for any other purpose.

I just want to make sure that the people understand that all of this chaos with PUA funding and trying to use it for local government expenses is not a lot. So, I do not know. Maybe. Am I reading

this thing wrong? So, the people understand that this money, yes, it is there. But the expiration has come and gone. We have been out of this COVID situation for a couple of years already. It cannot be used. And then it says that:

"CNMI must comply with the provisions contained in the Agreement with the Department to administer PUA and FPUC and all applicable PUA and FPUC funding instruments. CNMI must also perform such duties and functions in accordance with the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards at 2 C.F.R. Part 200 and 2 C.F.R. Part 2900 applicable to all grants and cooperative agreements, including return of unused funds."

So, this money came, was not fully used, and guess what? It has to be returned. So, for those people that think they are going to get PUA funds, do not. It is gone. And the government cannot use it. At least, our local government, but it is going back to Uncle Sam. Therefore, there is no funding. Thank you, Mr. Speaker.

<u>Speaker Edmund Joseph Sablan Villagomez:</u> Thank you, Representative Aldan. I recognize the Floor Leader.

Floor Leader Marissa Renee Flores: Thank you, Mr. Speaker. Given this sad news, I would like to make a request with a sense of urgency. As budget submissions are in and budget are coming in and budget discussions are approaching, I urge the Commerce Committee- under which the Department of Labor falls, if I am not mistaken- as well as the committee chairman or JGO, or both, to meet and discuss this matter. I have constituents in my village, Precinct 3, who have yet to be paid, and there has been no communication- past or present- regarding their status. Now, this recent communication with the Governor has triggered concerns regarding the supposed \$400,000 in excess external funds under the PUA. The response back from the federal government should prompt us, as a legislative body, to bring in the key individuals who can at least provide us with an update. We do not even know how many people have yet to be paid. If it means anything to anyone, the committees that are tasked to spearhead such an investigation, I urgently request, respectfully, for my constituents and all the people of the Commonwealth that are still owed PUA. Because now we are probably faced with other concerns that have not come to the surface. Thank you, Mr. Speaker. I yield.

<u>Speaker Edmund Joseph Sablan Villagomez:</u> Thank you, Floor Leader. Any further under Miscellaneous?
