Final disposition shall not be taken on any other matter at such session. Once filed as part of this notice, the agenda may only be changed by adding items thereto by the recorded vote of the majority of the members of the House.

Clerk Linda B. Muna: Mr. Speaker, all 12 members present voted, "yes."

Speaker Edmund Joseph Sablan Villagomez: Thank you, Clerk. With all 12 members voting "yes," House Bill No. 24-45 hereby passes the House. Alright, with that, colleagues, in regards to House Bill No. 24-50, which is the bill for an act to authorize a loan between the Commonwealth government and the MPLT in the amount of \$29,000,000.00 that requires a two-thirds vote. To which we fall short of today. There are only 12 of us present, and the two-thirds is 14. So, we are going to leave this on the bill calendar for the next session to act on. Hopefully we at least get 14 members, if not the full 20, back by then. I recognize Representative John Paul Sablan.

Representative John Paul Palacios Sablan: Thank you, Mr. Speaker. In addition to that, the members of the Board of Trustees had requested a meeting to speak further on their proposed amendment. So, while we are going to put this on hold, it buys us time to even do so with the members of trustees. Thank you.

The Chair recognized the Acting Floor Leader.

Acting Floor Leader Ralph Naraja Yumul: Thank you, Mr. Speaker. I understand there is a change of request from the Chairman of Ways and Means, but the amendment was sent out to each member earlier. Can that amendment be entertained and addressed while the bill is on the calendar, or no?

The Chair recognized Representative Blas Jonathan "BJ" Attao Tenorio.

Representative Blas Jonathan "BJ" Attao Tenorio: Thank you, Mr. Speaker. I like the way the Floor Leader is thinking, but once we take action, we are going to take action to pass House Bill No. 24-50, then the amendments happen, and then we would have to go back to the main motion. Unless, the main motion is just going to die out.

The Chair recognized Representative Ralph Naraja Yumul.

Representative Ralph Naraja Yumul: So clarified. Thank you.

The Chair recognized Representative John Paul Palacios Sablan.

Representative John Paul Palacios Sablan: Thank you. And in addition to that, Mr. Speaker, just to address the concerns of the Floor Leader, the proposed substitute before us also does not include Section 104 on the request of the Board of Trustees and MPLT. That is the reason why we need to have a meeting with them to better understand what this proposal from MPLT does, if in the end we are to include it in the provisions. Thank you.

The Chair recognized Acting Floor Leader.

Acting Floor Leader Ralph Naraja Yumul: Thank you, Mr. Speaker. Does that give us the authority to list down the expenditures of what we are loaning? Meaning we are going to list down everything that needs to be addressed in the CNMI?

The Chair recognized Representative Blas Jonathan "BJ" Attao Tenorio.

Representative Blas Jonathan "BJ" Attao Tenorio: Thank you, Mr. Speaker. I believe that the \$29,000,000.00, since we cannot loan directly for operations, they are using the \$29,000,000.00-I mean, the payment to the settlement fund for Fiscal Year 2026. That would then free up \$29,000,000.00 from the General Fund. The administration would have to submit the \$29,000,000.00 as a supplemental to 2026, so we can address those shortages that we actually made cuts to. If that answers the Floor Leaders concern.

The Chair recognized Representative John Paul Palacios Sablan.

Representative John Paul Palacios Sablan: Thank you, Mr. Speaker. Just exactly what Representative Attao had mentioned. This loan authorization that is before us, as a proposed legislation, only proposes to loan \$29,000,000.00 pension obligation money. That is all that it does. And then, when it frees up that money, that supplemental coming from the administration, that is when we can itemize out of that free up \$29,000,000.00. When we decide it in the committee of Ways and Means. Thank you.

There being no further discussion on the floor, the Chair moved down to Item No. 17, Miscellaneous Business, and recognized Representative Daniel Iwashita Aquino, Jr.

# MISCELLANEOUS BUSINESS

Representative Daniel Iwashita Aquino, Jr: Thank you, Mr. Speaker. I just want to thank everyone here, in this chamber, for their support for the passage of House Bill No. 24-54. I want to thank the Legal Counsel and the Clerk that made this thing possible. On behalf of the service members, this is a long time coming. And it is the first step. I humbly ask the Senate to swiftly pass this thing so we do not have any more issues with service members who are eager to assist our nation during times of disaster. I also want to thank my wife, who kept nagging me to push this bill through. Thank you for that. And with that, thank you so much.

The Chair recognized the Vice Speaker.

Vice Speaker Diego Vincent Fejeran Camacho: Thank you, Mr. Speaker. Members, I am sure that we have been seen a lot on different media outlets and ongoing press releases from both sides of the two telecommunications entities. I think it is time, for me, to call in the Office of Broadband Policy Development. To, at least, call an audience with them to clarify some statements being made and just more of an informative session with this body, and the office. In no way, is this meant to intervene in whatever is going on. But it is more of an informative session with them. We are dealing with a big chunk of change with this grant. And, of course, nobody wants to see anything at risk. On a lighter note, I would like to wish the public and private employees a happy labor day, on behalf of the House.

<u>Speaker Edmund Joseph Sablan Villagomez:</u> Thank you, Vice Speaker. With that, I would like to task the committee on Transportation and Infrastructure to coordinate that meeting with the Broadband Policy to have an audience with them.

The Chair recognized Representative Vincent Raymond Aldan.

Representative Vincent Raymond Aldan: Thank you, Mr. Speaker and Mr. Vice Speaker. I have been communicating with the Broadband Policy Office, and also reading up on all the information, the news, and correspondence on the legal side. And they are willing and ready whenever we would like to bring them in. But I just want to make sure that everybody understands that this is not something that we should be trying to push buttons or anything like that. Because this is a federal program with federal jurisdiction in it. That is why I am not trying to say that we are not going to entertain it, but we just need to thread carefully with this. I have been communicating with them, and they are more than willing to come in any time we ask. So, I will make it happen. Thank you.

The Chair recognized Representative Denita Kaipat Yangetmai.

Representative Denita Kaipat Yangetmai: Thank you, Mr. Speaker. I just want to inform everyone that I attended the NCSL (National Conference of State Legislatures) in Boston. It was great. It is just that I was the only one there, but we know why. I am also sorry that I was not able to stay back. I could not change my reservations over there. The next one will be, I think, they mentioned Seattle. So, it would be great if we have at least one person from each committee to attend, including the staff. Because it is like professional development. It is a good way to also network and get to know other members in the states. Thank you.

<u>Speaker Edmund Joseph Sablan Villagomez:</u> Thank you, Representative Yangetmai. And thank you for representing us at the NCSL event. As you all know, we did adopt a resolution to recognize their 50 years. Yes, Representative Yangetmai?

Representative Denita Kaipat Yangetmai: Thank you, Mr. Speaker. I apologize. Yes, I presented that to the president and he was happy about it. That was when I found out from Arturo that we were, well, I was supposed to attend the committee meetings. I did not know about them. So, now I am informing you. So, we need to go early to attend the committee meetings, and come up with resolutions to the issues we have. Thank you.

The Chair recognized Representative Blass Jonathan "BJ" Tenorio Attao.

Representative Blas Jonathan "BJ" Tenorio Attao: Thank you, Mr. Speaker. And just to piggyback on Mr. Vice Speaker. And, thank you, Mr. Speaker for asking the Chairman of Transportation and Infrastructure committee to press with this meeting regarding the Broadband Office. It is definitely a sensitive issue and time is of the essence. We all know that President Trump has continuously pulled back on a lot of grants. This might be one of the potential grants. And I was just meeting one of the people in Guam last week. One of their issues was this specific broadband money that is taking its time in moving with the Guam projects down there. And their biggest fear is the deadline of, I believe, it is September 4th, if I am not mistaken. And if they do not meet that, the fear is that they might actually pull this grant away from them. And we are in the same situation right now. We do understand that in any big projects that are offered here to the CNMI that there is going to be a protest period. But we want to make sure we go through that protest period as quickly as possible so that we do not lose the potential grant that has already been afforded to the

CNMI. \$80,000,000.00 is going to do a lot of good work for the people of the CNMI. And one of the biggest things that we have continued to present to the broadband office is rather than be a spur off a line, have a main line actually going through the CNMI so that we never get cut off through technology, through the people of the rest of the world. Again, with you, Mr. Speaker, designating the Chairman of Transportation and Infrastructure, if we can get that meeting as quickly as possible. And hopefully hold off any more delays. Because this is money that is going to be infused into our economy. At the same time, obviously we will not see it right up front. But it is \$80,000,000.00 that is going to be infused into the economy, and at the same time provide better technology for each household here in the CNMI. So, thank you, again, Mr. Speaker, for asking the Chairman of Transportation and Infrastructure. We look forward to meeting with the broadband office and hopefully hold any type of delay, so that we can move forward with these projects and start spending these monies within the CNMI. Thank you, Mr. Speaker.

There being no further discussion on the floor, the Chair moved down to Item No. 18, Announcements.
