We should address ourselves at this point in time in order that when June comes we are ready to advise these individuals as to what is their future regarding their employment.

Speaker Sablan: Rather than setting up a task force, I will like the J.G.O. Committee to follow up with Resolution No. 121 which we have adopted, to follow up with the Executive Branch as to what are their plans in terms of accomodating those CNMI citizens that will be affected with the closing down of the T.T. operation here in the Commonwealth.

<u>Representative Torres</u>: I am in support of that resolution knowing that we are under the continuing resolution, I just wonder where we are going to get the money to pay these people to work with the CNMI Government. We have not identified any resources, therefore how would the Governor face these people. I think the legislature is responsible to come up with the necessary appropriation for these people. We cannot put the burden on the government. He doesn't have the funds to hire.

<u>Speaker Sablan:</u> The committee can look into this and find out position vacancies that are available in the government. Every week I receive position vacancy notice from various departments in the government.

Representative Fitial: For your information, those position vacancies are no longer vacant.

Floor Leader Nakatsukasa: Mr. Speaker at this point in time, I know that the Office of the Public Auditor is in surplus of funding. I wonder if the Speaker can get together with the Governor and perhaps request for the Director of Finance to identify some of the surplus.

Speaker Sablan: I think there is a need for us to follow up with the T.T. Headquarters in terms of the number of individuals who are affected by the reduction-in-force, then we can take that information and try to look into the government that would match their experience and their expertise.

<u>Representative Hocog</u>: Mr. Speaker would it be appropriate for the Speaker to get all those statistics and perhaps the Speaker can write a letter to the Governor to freeze hiring at this point in time for these individuals who are effected as a result of the Trust Territory Government seizing. From there on maybe we can see if the people who are affected can be place within our CNMI Government.

Floor Leader Nakatsukasa: I move for the passage of H.B. No 117, Committee Substitute 2, First and Final Reading.

Speaker Sablan: Do you want this bill to be pass on First and Final Reading?

Floor Leader Nakatsukasa: Mr. Speaker if there is no objection, I will like to make a motion that we pass H.B. Nos. 117 to 128, simultaneously.

Speaker Sablan: We need to go through the bills one by one Mr. Floor Leader. Those bills that you want to pass First and Final Reading, we need to suspend Rule 9 Section 8.

Floor Leader Nakatsukasa: Mr. Speaker in order to have the following bills pass their First and Final Reading, I move that we suspend Rule 9 Section 8 so that we can place all these bills in the First and Final Reading today.

There were several second to the motion.

Speaker Sablan: All the bills?

Floor Leader Nakatsukasa: All the bills.

Speaker Sablan: Discussion on the motion.

Representative Benigno Sablan: Ready.

The motion to suspend Rule 9 Section 8 so that H.B. No. 117, Committee Substitute 2; H.B. No. 116, Committee Substitute; H.B. No. 157, Committee Substitute 2; H.B. No. 70, Committee Substitute; H.B. No. 63, Committee Substitute; S.B. No. 4-61; S.D. 2, H.D. 1, H.D.2; H.B. No. 198; H.B. No. 228, Committee Substitute; H.B. No. 93, Committee Substitute; and H.B. No. 144, Committee Substitute, be pass on First and Final Reading, carried by voice vote.

Floor Leader Nakatsukasa: Mr. Speaker I move for the passage of H.B. No. 117, Committee Substitute 2 on its First and Final Reading.

Representative Benigno Sablan seconded the motion.

Speaker Sablan: Discussion.

Representative Francisco Cabrera: Ready.

<u>Representative Fitial</u>: There is a concern Mr. Speaker. Is it possible to require the bill not only for maximum speed limit, but also for minimum. We should not only penalize those operators for traveling beyond the speed limit but also those operators who are injuring or impeding travel especially if they are just doing it for the fun of it.

Speaker Sablan: Chairman Sablan do you wish to comment.

Representative Benigno Sablan: Yes, I have the same feeling but I think that this one is very important that we get this out of the way. I think the DPS should have this Traffic Code now to implement those that are not included in the CMC Code. The concern may very well be made into another amendment to this one. We could make that in a very simple way, one page amendment. Let us get this pass and we will continue to work on the amendments for the Traffic Code. I hope my colleague will agree to that so that we can get this going.

Representative Fitial: Yes. Let me continue. Mr. Speaker I also have another concern, after we met that day, the last committee meeting, was there anything done to rectify the solid line on the middle road?

Representative Benigno Sablan: If I remember correctly, we authorized Public Works to come into the picture when there is work on highways.

Speaker Sablan: Yes, that is one place the people are raising some concern, the solid line . . .

Representative Fitial: According to standard traffic, the rules and regulations from the Monument all the way to Tanapag, right now because of the solid line, passing is prohibited.

Representative Benigno Sablan: Not all the way to Tanapag. As a matter of fact, I think they ran out of paint. What we are talking about is No. 4 on page 11. Section 25 says "approve to design a highway location as proposed by the Department of Public Works." The concern we addressed will get this people in to participate in the actual planning of our highway signs.

Speaker Sablan: Can the Chairman follow up with Public Works immediately?

Representative Benigno Sablan: Yes.

Representative Torres: Mr. Speaker I just heard from a reliable source that the Governor and the Public Works has come together to rectify the concern raise by Congressman Fitial.

Speaker Sablan: So it seems like they are aware of the problems.

Representative Fitial: My concern was whether this bill accomodates the heading together of Public Works and the Governor.

Speaker Sablan: Any other concern?

Representative Benigno Sablan: Just for information again on Section 27 line Item E, we have decided that a moped may not be operated on any highway from 6 p.m., to 6 a.m.. We do not allow them at night. That is a drastic change in this.

Representative Fitial: Mr. Speaker this bill has a lot of teeth that some of us are now aware of.

Representative Benigno Sablan: This bill prohibits now children in the back of a pick up truck that does not have, only fourteen years and adult are permitted in there. It does not mean to say that if a fourteen year old person is there that other children below fourteen are allow in there. That is not the language of the law. The language of the law says that only adults from fourteen years can sit in the back of the truck without supervision. Anybody who is not fourteen years old and who is not adult would be illegal to sit at the back of the truck. I think right now we have instead of six we proposed ten people, no more than ten. They cannot overload. I think at a later date we will look at the Boating and Safety Act and we will do the same thing, really put teeth on the law. Like my good colleague Fitial has stated, this bill really has a lot of good teeth that will hopefully reduce the number of traffic accidents, number of fatalities, personal injuries, bodily damage.

Representative Fitial: And more importantly Mr. Speaker, it will generate revenue.

Representative Benigno Sablan: We can have now personalize license plates. It will cost you \$50.00 initially and \$25.00 afterwards.

Speaker Sablan: It will cost the vehicle operator twice as much as the regular . . .

Representative Benigno Sablan: Yes, unpersonalized license plates.

Speaker Sablan: Any further discussion?

Representative Benigno Sablan: I think we are ready for the question.

The Clerk called the roll for voting purposes on H.B. No. 117, Committee Substitute 2. The voting result, ten voting yes. H.B. No. 117, Committee Substitute 2 is hereby passed by the House on its First and Final Reading.

H.B. No. 116, Committee Substitute: "The Legislative Fiscal Discipline Act of 1985."

Floor Leader Nakatsukasa: Mr. Speaker I move for the passage of H.B. No. 116, Committee Substitute, First and Final Reading.

Representative Fitial seconded the motion.

Speaker Sablan: Discussion.

Representative Fitial: Ready.

Floor Leader Nakatsukasa: I just want to know how legal to impose such limitation from the lame duck legislature covering their one term. I feel that the members still have November and December to serve their term and legally under the law you are still a member of the congress. I need to be enlighten on this.

Speaker Sablan: Congressman Torres would you like to respond.

Representative Torres: The idea behind this bill is to restrict any spending authority in the legislature from spending that alloted in one quarter. For instance you are alloted \$500,000, you cannot go and spend \$600,000.

Representative Benigno Sablan: But can you spend the one quarter allotment?

Speaker Sablan: yes. Normally the lame duck legislature sits for one quarter and maybe one week.

Representative Benigno Sablan: But that is not what is prohibited. What is prohibited is to make sure . . .

Speaker Sablan: To spend more than one quarter allocation.

<u>Representative Torres</u>: You see the lame duck legislature tends to spend more than what is alloted. Thereby, we are creating difficulty for the incoming members.

Representative Benigno Sablan: I agree.

Speaker Sablan: Does that clarify your concern Floor Leader.

Floor Leader Nakatsukasa: Yes and under Section 4(c), "all members of the legislature shall limit their budget and surplus from personal purposes of their respective offices."

Speaker Sablan: This will prevent you from over spending the one quarter allotment because if you know that you are lame duck and you hire more than the current number of employees on October 1, then you are likely to over spend your first quarter allotment.

<u>Floor Leader Nakatsukasa</u>: Okay, but if you read this section carefully Mr. Speaker, all members of the legislature shall limit employment of personnel for operational purposes. This does not mean that it does not involve money. We are only talking about manpower. As long as you are within your personal budget I do not think, irregardless of whether you hire 100 staff, as long as you are within your operational budget. Does this preclude you from hiring more than five if your money permits you to hire ten.

Representative Hocog: Mr. Speaker I think Subsection (c) is saying that any incumbent shall not hire any additional employee during your time of the first quarter.

Representative Fitial: During your lame duck? (Laughter)

Representative Torres: The intent is that as long as you do not spend more than what you have . . .

Floor Leader Nakatsukasa: The way I interpret this bill, we are only limited to manpower and not funding, it says, "it shall limit employment."

Speaker Sablan: Yes, this is to prevent the lame duck legislature from hiring freely for a short period of time.

Floor Leader Nakatsukasa: Mr. Speaker you cannot prohibit any lame duck as long as there is still funds. That will be unconstitutional. As long as you are still in office nobody can stop you irregardless of whether you lose the election or won the election or choose not to run. Your term of office is up on the following January 9th. The bill itself is very good. My only concern is that if you are within your budget limit and you cannot hire plenty, you have to limit only five, this is my concern here.

Speaker Sablan: I think the key section of the bill is Section 3, as long as you do not exit your spending authority for first quarter allotment.

Representative Hocog: I do not see any reason myself Mr. Speaker to hire any additional employment.

Speaker Sablan: That is correct.

Representative Hocog: If my current employees are still on board, I do not see any reason why I should hire any new employees.

Representative Fitial: If you are already lame duck.

Representative Hocog: Yes if you are already lame duck.

Floor Leader Nakatsukasa: I move for the passage of H.B. No. 157, Committee Substitute, First and Final Reading.

Vice Speaker Tudela seconded the motion.

Speaker Sablan: Discussion.

Representative Hocog: Ready.

The Clerk called the roll for voting purposes on H.B. No. 157, Committee Substitute. The voting result, ten voting yes. H.B. No. 157, Committee Substitute is hereby passed by the House on its First and Final Reading.

H.B. No. 70, Committee Substitute: "To prohibit the tethering of Animals."

Floor Leader Nakatsukasa: 1 move for the passage of H.B. No. 70, Committee Substitute, First and Final Reading.

Speaker Sablan: Discussion.

Representative Fitial: Ready.

Representative Benigno Sablan: Mr. Speaker can we give time to those farmers who pasture their cows and goats next to the road, a couple of weeks extensive educational. I notice that in my precinct (laughter) there seems to be a lot. I have to go out and talk to these people and make sure that they understand this law.

Floor Leader Nakatsukasa: I will assure my good colleague that I will personally write a letter to the Attorney General and make sure that they promulgate this law as soon as we pass it.

Representative Benigno Sablan: You are challenging my statement Floor Leader. (Laughter)

Speaker Sablan: You are going to write to request the Attorney General to exclude . . .

Floor Leader Nakatsukasa: To promulgate this law prohibiting the tethering of animals.

Representative Benigno Sablan: Ready Mr. Speaker.

The Clerk called the roll for voting purposes on H.B. No. 70, Committee Substitute. The voting result, seven voting yes and three voting no. H.B. No. 70, Committee Substitute hereby passed the House on its First and Final Reading.

H.B. No. 63, Committee Substitute: "Street Directory Act of 1985."

Floor Leader Nakatsukasa: I move for the passage of H.B. No. 63, Committee Substitute, First and Final Reading.

There were several second to the motion.

Speaker Sablan: Discussion.

Representative Lifoifoi: Ready.

Representative Benigno Sablan: Mr. Speaker I want to stress on the Street Directory Act. The villages particularly like San Jose or Tanapag or San Roque, the streets to be name, we should use the names of the older people who passed away in our villages and should be given that priority. I hope that this communication will be taken seriously so that in the county Tanapag, I do not see "Charlie Brown's" name on our highway. I want to see the name of "Tun Juan Pua," or somebody who serves the village well. I want to see those names in our street.

Speaker Sablan: I think the bill provides for a public hearing before streets are named.

Floor Leader Nakatsukasa: Mr. Speaker it is very clear that names to be picked should reflect the local culture and heritage.

Representative Benigno Sablan: I am just reemphasizing Mr. Speaker.

Representative Hocog: Can we make it clear Mr. Speaker that we only name the streets after a decease person.

Speaker Sablan: The bill provides for that.

Representative Hocog: This bill prohibits us to name a road after a person who is still alive.

Speaker Sablan: Yes and there is a good reason for that. The person might be good today but tomorrow he might be something else. (Laughter) One wrong doing and that will destroy the whole thing.

Representative Hocog: Yes but after all the contribution that he has made in the community.

Speaker Sablan: Yes but one wrong doing and there it goes out the window.

<u>Representative Fitial</u>: One thing may be good for the Chamorro but seriously may not be very good for the Carolinian. The Carolinian, this is against their custom to bring back the name of the dead. I know this bill will only benefit the Chamorros.

Speaker Sablan: But it could be culture because it allows for culture heritage.

Representative Fitial: When a Carolinian dies everything that he owns or she owns goes with the dead.

Representative Benigno Sablan: But you see my good colleague, customs are changing and they continually change so eventually this will also serve the Carolinians.

Speaker Sablan: The bill also provides for flexibility in regards to culture and heritage.

Representative Fitial: I was just pointing the Carolinian custom because it is still very much alive.

Speaker Sablan: Further discussion?

Floor Leader Nakatsukasa: I move for the passage of S.B. No. 4-61, S.D. 2, H.D. 1, First and Final Reading.

Vice Speaker Tudela seconded the motion.

Speaker Sablan: Discussion.

Representative Fitial: This is a requirement that is presently practice for all elected officials under the election law.

Speaker Sablan: No that is only limited to election expenditure, campaign expenditure, but this has something to do with disclosing your financial assets, your financial condition as a public official.

Representative Fitial: For some of us without the campaign we will not have any financial disclosure.

Floor Leader Nakatsukasa: Mr. Speaker the term public official is very broad. Any government employee could be consider a public official unless we come with an actual definition as to who are this public official.

Speaker Sablan: These are elected officials.

Floor Leader Nakatsukasa: Public officials, there are some more provisions which inject the members of board and official. These are public officials.

Speaker Sablan: And also appointed officials.

Floor Leader Nakatsukasa: Yes they are appointed officials, but what about like the Board of MPLC, they are the board that requires . . .

Speaker Sablan: That is correct. It is all cover in this bill, Section 4 and 5.

Representative Benigno Sablan: This committee report should have come out of my office. I do not know how it is routed. I have not seen this and I have not sanctioned it out of my office calendar. I do not know how it got out here.

Speaker Sablan: You were off-island I think.

Representative Fitial: This was routed by a member of your staff upon the instruction of the legal counsel, Bergsma.

Speaker Sablan: I think this is one of the bill that you have instructed the legal counsel to refine.

Representative Benigno Sablan: Yes but it should come back to my office.

Speaker Sablan: Unfortunately during that time you were in Guam for the APIL.

Representative Benigno Sablan: I just want to point out the unusual route of such report.

Speaker Sablan: I think the original copy is still available if you want to put your signature.

Representative Benigno Sablan: Thank you.

Representative Hocog: Mr. Speaker in the event that any elected official do not have anything to disclose . . .

Speaker Sablan: He will disclose zero. We are required to disclose whether the amount is zero or one penny.

Floor Leader Nakatsukasa: Can I bring your attention to the heading? "A Bill for an act to establish financial requirements for elected and appointed public officials, for certain public employees and for other purposes."

Speaker Sablan: Section 5 of the bill covers "for certain public employees", page 1.

Floor Leader Nakatsukasa: Did we address ourselves Mr. Speaker to the departments whether they should disclose their financial standings? I do not think that it is fair for us to crucify Marianas Public Land Corporation and EDLF because that is where the money is. We should look into a broader sense.

Representative benigno Sablan: There are several others in here, not only MPLC.

Floor Leader Nakatsukasa: Well, Commerce and Labor, Immigration. Mr. Speaker my argument at this point in time I should put it this way, that rather than putting Immigration I rather that we put in a provision that we should not authorize them to hire any alien labors because that is where the papers for alien labors are being processed. If we are concern about corruptions even a janitor and even the employees at Public Works, there are time when we give them beer to drink while they are performing public services. If this is our intention then we should really be honest to ourselves. We should not crucify immigration because at times we hear news that one Korean guy tries to bribe some Immigration Officer \$300.00 or the Labor Department. I believe that we should exclude these two departments Mr. Speaker. The recruiting of alien labors is where the conflict exist. Now, if we are concern about money under the table, let us not fool ourselves, even the janitor at Public Works get this bribe. I move Mr. Speaker that we strike out Immigrations and Labor and Commerce.

Representative Fitial: Before any motion can be effected I will like to bring out a point also. I am in support of Section 3 and 4 and I am only partially in support of Section 5. I do not think that it is fair to require all the employees. You know some of these employees are Civil Service Employees and they have the Civil Service system, their rules and regulations to govern their contract of employment. I just feel that this is rather too much, Section 5. It is asking too much of the employees of this respective agents of government. Perhaps the top employees or those employees who are holding responsible positions in these respective agencies should be subjected to this requirement, but not all employees. Especially when you look at Section 6, the context of the statement, some of these employees may find it rather difficult to fulfill or meet these requirements. We have to consider the employees involved and the complexity of the financial statement that this law will be requiring.

Speaker Sablan: If you look at Section 8 of the bill that requires the Public Auditor to make the rules and regulations and the necessary forms to be fill in.

Floor Leader Nakatsukasa: Mr. Speaker experience will tell us that under the Third Legislature they passed a bill regarding alien labor. Under that bill they authorize the Director of Commerce and Labor to promulgate rules and regulations, up to now there is no rules and regulations pertaining to labor matter has been promulgated. Are we going to continue giving this authority to them? We might as well come up with a statute.

Speaker Sablan: The bill is for the Public Auditor, Mr. Floor Leader.

Floor Leader Nakatsukasa: I am referring to Public Auditor. We are giving the Public Auditor the authority to promulgate regulations, for how long. There is not even one public auditor report that has been presented to the legislature. Which is more important, to promulgate this kind of bill or audit the accountability of the government agency. I am not emotional this afternoon Mr. Speaker, but I think we should come out with the proper rules and procedures. Let us be fair. I am against those guys who are crook.

Speaker Sablan: Let us have a short recess Mr. Floor Leader.

The House recessed at 3:50 p.m..

The House reconvened at 4:00 p.m..

Speaker Sablan: The session shall now reconvene. Prior to recess we were discussing S.B. No. 4-61, S.D. 2, H.D. 1. Prior to recess the discussion, the concern was raise on the requirement of the legislation. I believe that the floor amendment is ready and will be offered by Chairman Ben Sablan.

Representative Fitial: Before the amendment is offered Mr. Speaker I will like to point out the discrepancy of the floor amendment. I think the word "employees" should be deleted instead of the word "or."

Speaker Sablan: No, after the word "or" insert "directors" and cross out the word "employees."

Representative Fitial: Sorry. I stand always to be corrected.

Speaker Sablan: You may proceed Chairman Ben.

Representative Benigno Sablan: I have for you the amendment, if you take a look at page 1, line 21, on Section 5, after the word "All" insert "directors, deputy directors and chiefs" and continue the rest.

Speaker Sablan: Strike the word "employees" ?

Representative Benigno Sablan: Yes, strike the word "employees."

Representative Hocog seconded the motion for the adoption of the floor amendment to S.B. No. 4-61, S.D. 2, H.D. 1.

Speaker Sablan: Discussion.

Representative Fitial: I think we have a concensus.

The motion to adopt the proposed floor amendment as offered by Representative Ben M. Sablan, carried by voice vote.

Floor Leader Nakatsukasa: Mr. Speaker on Section 8 is it necessary that the Public Auditor promulgate the regulations?

Speaker Sablan: Okay.

Floor Leader Nakatsukasa: Withdraw. I will like to reinstate another motion to place this bill on First Reading only.

There were several second to the motion.

Speaker Sablan: Discussion.

<u>Representative Fitial</u>: Mr. Speaker if I may, before the Second Reading I will like to request that Section 10(b) of Section 1, we review and possibly change to restrict the non-resident workers from getting temporary jobs.

Representative Benigno Sablan: What page?

<u>Representative Fitial</u>: Page 12, line 14 all the way down. Mr. Speaker we are encountering problems respecting the continuation of non-resident workers who are engaged in some grievances or cases in the court and the Labor Division have been granting temporary working office section, which is only supposed to be valid for 30 days, yet they have been under this authorization for more than a year, some two years and it is getting to the point where temporary is no longer an issue. I will respect the request that this particular concern be reviewed and analized so that we should prevent the extension of temporary working authorization to be no longer than 30 days.

Speaker Sablan: In other words to limit to 30 days?

Representative Fitial: No longer than 30 days.

Representative Benigno Sablan: Mr. Speaker the present practice of the Commerce and Labor is to have a temporary working permit or work authorization for 30 days and that upon the termination of the 30 days, they can reapply again so they go on a month to month basis. How do you propose to eliminate that loophole.

<u>Representative Fitial</u>: The problem with this Mr. Speaker, our Labor Division is at fault here most of the time because some cases that should be adjudicated by the Labor Division are not done. That pushes the temporary further, more than 30 days. The committee should study this and come out with a solution. Another concern Mr. Speaker is that when this agreed employees are granted temporary working permit, the temporary working permit should be limited to the classification of jobs for which they are classified originally. We do not want to see live-in maids operating the cashier or whatever.

Representative Benigno Sablan: May I ask my good colleague to point the other section in this bill because my good Chairman in R & D is not here and I have to act on it.

Speaker Sablan: I believe the Chairman of R & D will be back tomorrow.

Floor Leader Nakatsukasa: I notice that there are some provisions that are not accurate on this bill. For example, there is no provision in here that if a run away contract employee that we must give him a temporary working permit. If something happens and this employee dies, who will bear the cost to take or send the dead body to the Philippines.

Representative Fitial: Under the present law Mr. Speaker, if I may

Floor Leader Nakatsukasa: Yes but it is fair to let the original employer take the burden because the alien labor was the one that ran away to a new employer. Under this legally the contract was retain by the original employer.

Representative Benigno Sablan: No more transfers according to this bill.

Floor Leader Nakatsukasa: No?

Representative Fitial: The concern from the Floor Leader is accomodated on page 13, line 4. The temporary employer will then assume the responsibility.

Floor Leader Nakatsukasa: "Complaint by the chief" are we referring to the Fire Chief or some other chief? (Laughter)

Representative Benigno Sablan: There is a definition already on the "Chief", the Chief of Labor.

Floor Leader Nakatsukasa: This might sound funny but when the case comes up they will look into this?

<u>Representative Fitial</u>: If you take a closer look in that concern you will see that they strike out "the Division of Labor". This is because if they put the Division of Labor then this becomes redundant.

Representative Benigno Sablan: That is the reason why they struck this out. It has been defined on page 2.

Floor Leader Nakatsukasa: But the law, it doesn't matter whether it is redundant, we have to prove the language and the provisions.

Representative Fitial: Sometimes redundancy is needed for clarity. (Laughter) Ready for the question.

Speaker Sablan: At any rate, those concerns will be address before the Second Reading.

Floor Leader Nakatsukasa: Mr. Speaker I know this is not very nice for me to ask my colleagues, but this is the occasion to discuss the bill. I notice that on the Committee Report, Congressman Lifoifoi is asking for some investigation.

H.B. No. 43, Committee Substitute: "Business License Act of 1985."

Representative Hocog: Before we act on H.B. No. 43, on behalf of my good colleague, Representative Juan T. Guerrero, I will like to ask the rest of the members to endorse the floor amendment offered by my good colleague.

Speaker Sablan: We will get to that during the discussion of the bill.

Floor Leader Nakatsukasa: I move for the passage of H.B. No. 43, Committee Substitute, Second and Final Reading.

There were several second to the motion.

Speaker Sablan: Discussion. I believe that there are two proposed amendments to be offered, one is from Representative Juan T. Guerrero who has asked the Representative from Rota to offer the amendment on his behalf. Also Chairman Ben Sablan have a proposed floor amendment.

Representative Hocog: On page 6, line 24 insert the following language:

"These classifications are solely for the purpose of establishing license fees, they are not intended to change tax classifications as established in 4 CMC Sections 1303 and 1304."

Speaker Sablan: How about the rest of the proposed floor amendments.

Representative Benigno Sablan: May I offer also my floor amendment.

Speaker Sablan: Can we entertain the proposed floor amendment offered by Representative Juan T. Guerrero and then we will entertain yours. Chairman Hocog there are two proposed floor amendments, one is the one that you have just read, and the other one is to change pages 4, 5 and 6. Why don't we put that into one motion as the floor amendment at this time.

Representative llocog: So move Mr. Speaker.

Representative Benigno Sablan seconded the motion.

Speaker Sablan: Discussion on the proposed floor amendment.

Representative Fitial: Yes, question. Why do we need this language after line 24. I thought the purpose of Section 2, line 3 of page 1 already made that point very clear.

Floor Leader Nakatsukasa: Mr. Speaker I move that we defer action on this bill. The original intention of the bill I concurred with my signature. I never knew that they were to make the changes regarding licensing. I cannot tolerate to sign this bill with this kind of . . .

Representative Hocog: Privilege Mr. Speaker. We are not making any changes. We are proposing a floor amendment.

Speaker Sablan: We have not decided. We are discussing the floor amendment Mr. Floor Leader. I believe the language of the proposed floor amendment is to make it clear that this has something to do only with business licenses and do not apply to the revenue and taxation of P.L. 3-11.

Representative Fitial: That is on Section 2, "Issuance of Licenses."

Speaker Sablan: No, the fees for each classification of businesses or categories.

Floor Leader Nakatsukasa: We are looking at the proposed floor amendment. I think we should re-examine ourselves whether we are really serious in trying to help our Commonwealth Government with the present financial situation or are we just trying to play Santa Claus. I am arguing on the proposed amendment. Mr. Speaker I will give you one example, the insurance business are making about a million dollars a year especially at this place. It is lucky if they disburse \$100,000 a year, and to let them pay \$150 to \$200 license fee is a sin to Cod. (Laughter) At this time you go to any insurance business and ask them their financial statement and see how much profit they are making.

Speaker Sablan: Floor Leader even at the current license fee, the proposed floor amendment is higher a little bit than the existing fee.

Floor Leader Nakatsukasa: From the beginning I was misled when I signed this Committee Report because this was not included. Looking at this, this is a sin.

Representative Fitial: Notel fees went down very drastically from \$1,000 to . . .

Floor Leader Nakatsukasa: Mr. Speaker I know that it is an election year and I do not think the businesses will take it seriously that we are trying to impose this burden on them. I am not doing this for my own interest. Whatever the government receives from these fees, they will be distributed equally to the resident of the Commonwealth people.

Speaker Sablan: I will like to point to the members that the license fees is not where we make or generate revenue.

Floor Leader Nakatsukasa: For that simple reason that this happens only once a year because if it happens every month, even lowering it to \$50 I will agree, but you pay only once a year. How much revenue are we going to get?

Speaker Sablan: This is not for the general revenue.

Floor Leader Nakatsukasa: Irregardless Mr. Speaker. During our discussion with the committee I stated that even Jack and Jill, in order to discourage Filipinos who are here and if they have \$50 they will open their recruitment agency. I proposed to enforce \$500 license fee in order to discourage outsiders. When I went to Guam for the APIL Conference they came out and put \$150. This is not fair. What are we trying to do. We want to protect our people that is why I agreed with the original version, I proposed \$1,000 for any recruitment agency. There are about 50 recruitment agencies and most of them are owned by Filipinos. I am not prejudice, but with the present system, should they have \$50 in their banking account they could open any kind of business. I hope my good colleagues will not mind me for speaking this long, but it is not fair.

Representative Lifoifoi: Let us have a short recess.

Speaker Sablan: Let us have a short recess.

The House recessed at 5:00 p.m..

The House reconvened at 5:10 p.m..

Speaker Sablan: Prior to recess we were discussing the proposed floor amendment as offered by Representative Hocog on behalf of Representative Juan T. Guerrero.

Representative Hocog: I will like to withdraw my motion on the amendment of the bill, H.B. No. 43.

For Subsection (d) I would like to specify "Any licensee who is not a domestic business, a citizen or permanent resident of the Northern Marianas, or a citizen of the United States who violates any provision of this Act, 3 CMC Division 4, Chapter 3 and 4, or is convicted of a felony shall not be eligible for a business license and such violation shall constitute grounds for deportation and immediate revocation of all other business licenses issued."

Representative Hocog seconded the motion.

Speaker Sablan: Discussion on the proposed floor amendment.

Floor Leader Nakatsukasa: Mr. Speaker I seldom argue with my close colleague in here, but I cannot help it. I do not think it is constitutional to reject those people who are not Commonwealth or U.S. Citizens in regard to this proposed amendment offered by my good colleague. I do not think this is fair to impose this kind of provisions. In Guam under the law, if you obtain a business permit then you are privileged and I am privileged to the law to conduct a business. Whether you are Negro or Indian, if you are to be punish, you will be punish under the same provisions of the penalty. I do not believe that a Negro will get a more severe punishment than the Indian. If one breaks the law, then he or she gets punish.

<u>Representative Benigno Sablan</u>: I do not know where in my amendments that discriminates between non-residents. I am saying here that a licensee who is not a domestic business, a citizen or a permanent resident, I am not reclassifying to say those that are outsiders or non-resident or whatever. My intention are for citizens and permanent residents. I do now know where the argument comes in.

Floor Leader Nakatsukasa: What about those that are not permanent residents.

Representative Hocog: Mr. Floor Leader it says here any licensee who is not a domestic business or a citizen of the Commonwealth Resident. That means that all person doing businesses, provided however that it does not violate the law.

<u>Representative Benigno Sablan</u>: Basically what I am saying is all businesses here. I am including the citizens and permanent residents. Is that satisfactory to you my good Floor Leader?

Floor Leader Nakatsukasa: For the time being. (Laughter)

Speaker Sablan: Any further discussion on the proposed floor amendments?

Representative Ignacio Demapan: Mr. Speaker I tend to agree with Congressman Sablan, however I think deportation is quiet severe on the issue. They have to also consider the area of generating more revenues, more taxes for the government. I believe a fine is adequate for such violation.

Representative Benigno Sablan: My intention here is only eligible, shall constitute grounds, which take this to mean that you are to be deported if you violate certain information of our law. I do not think that is the gist of the amendments. What I am simply saying is that if there is grounds on this condition and somebody in the Enforcement Law and Judicial Branch will determine what that amounts to be, we are not dictating that an individual who violates will be deported by the way, it says, shall constitute for grounds of deportation. This is subject to discussion or debate on perhaps the administration or the Judiciary. I am only offering amendments that would assist in general the people of the Northern Marianas. In particular, if we have for instance like the Korean Bars who constantly violates our Civil laws, these people I think should be deported. If there is no such law that protects the deportation or word including the word that would give them that they have to be convicted in order for them to have grounds for deportation, then that grounds for deportation will be discuss.

Speaker Sablan: This legislation requires conviction of the violation.

Representative Torres: Isn't this included in the Immigration Law?

<u>Representative Benigno Sablan:</u> See there is no specific language that there will be a constitute grounds for deportation. We are adding that into the present law that we have in the Immigration Law, and so is this Domestic Business Act.

Speaker Sablan: Any further discussion?

Representative Lifoifoi: Ready.

The motion to adopt the proposed amendments offered by Representative Benigno Sablan to H.B. No. 43, carried by voice vote.

Speaker: I think there is a need for us to follow up with the T.T. Headquarters in terms of the numbers of individuals who are affected by the reduction-in-force, then we can take that information and try to look into the government that would match their experience and their expertise.

Hocog: Mr. Speaker would it be appropriate for the Speaker to get all those statistics and perhaps the Speaker can write a letter to the Governor to freeze hiring at this point in time for these individuals who are effected as a result of the Trust Territory Government seizing. Speaker: We need to go through the bills one by one Mr. Floor Leader. Those bills that you want to pass First and Finit Reading, we need to suspend Rule 9 Section 8.

Floor Leader: Mr. Speaker in order to have the following bills pass their First and Final Reading, I move that we suspend Rule 9 Section 8 so that we can place all these bills in the First and Final Reading today.

B. Sablan seconded the motion.

Speaker: Discussion.

F. Cabrera: Ready.

Fitial: There is a concern Mr. Speaker. Is it possible to require the bill not only for maximum speed limit, but also for minimum. We should not only penalize those operators for traveling beyond the speed limit but also those operators who are injuring or impeding travel especially if they are just doing it for the fun of it.

Speaker: Chairman Sablan do you wish to comment.

B. Sablan: Yes, I have the same feeling but I think that this one is very important that we get this out of the way. I think the DPS should have this Traffic Code now to implement those that are not included in the 7?7??C&d&? CMC Code. The concern may very well be made into another amendment to this one. We could make that in a very simple way, one page amendment. Let us get this pass and we will continue to work on the amendments for the Traffic Code. I hope my colleague will agree to that so that we can get this going.

Fitial: Yes. Let me continue. Mr. Speaker, I also have another concern, after we met that day, the last committee meeting, was there anything done to rectify the solid line on the middle road?

B. Sablan: If I remember correctly, we authorized Public Works to come into the picture when there is work on highways.

Speaker: Yes, that is one place the people are raising some concern, the solid line . . .

Fitial: According to standard traffic, the rules and regulations from the Monument all the way to Tanapag right now because of the solid line, passing is prohibited.

B. Sablan: Not all the way to Tanapag. As a matter of fact, I think they ran out of paint. What we are talking about is No. 4 on page 11. Section 25 says "approve to design a highway location as proposed by the Dept. of Public Works." The concern we addressed will get this people in to participate in the actual planning of our highways signs.

Speaker: Can the Chairman follow up with Public Works immediately?

B. Sablan: Yes.

Torres: Mr. Speaker I just heard from a reliable source that the Governor and Public Works has come together to rectify the concern raise by Cong. Fitial.

Speaker: So it seems like they are aware of the problems.

Fitial: My concern was whether this bill accomodates the heading together of Public Works and the Governor.

Speaker: Any other concern?

B. Sablan: Just for information again on Section 27 line Item E, we have decided that a moped may not be operated on any highway from 6 p.m., to 6 a.m.. We do not allow them at night. That is a drastic change in this.

Fitial: Mr. Speaker this bill has a lot of teeth that some of us are not aware of.

B. Sablan: This bill prohibits now children in the back of a pick up truck that does not have, only fourteen years and adult are permitted in there. It does not mean to say that if a fourteen year old person is there that other children below fourteen are allow in there. That is not the language of the law. The language of the law says that only adults from fourteen years can sit in the back of the truck without supervision. Anybody who is not fourteen years old and who is not adult would be illegal to sit at the back of the truck. I think right now we have instead of six we proposed ten people, no more than ten. They cannot overload. I think at a later date we will look at the Boating and Safety Act and we will do the same thing, really put teeth on the law. Like my good colleague Fitial has stated, this bill really has a lot of good teeth that will hopefully reduce the number of traffic accidents, number of fatalities, personal injuries, bodily damage. Fitial: And more importantly Mr. Speaker it will generate revenue.

B. Sablan: We can have now personalize license plates. It will cost you \$50.00 initially and \$25.00 afterwards.

Speaker: It will cost the vehicle operator twice as much as the regular . . .

B. Sablan: Yes. unpersonalized license plates.

Speaker: Any further discussion?

B. Sablan: I think we are ready for the question.

The Clerk called the roll for voting purposes on H.B. No. 117, Comm. Subs. 2. The voting result, ten voting yes. H.B. No. 117, Comm. Subs 2 is hereby passed by the House on its First and Final Reading.

H.B. No. 116, Comm. Subs:

Floor Leader: Mr. Speaker I move for the passage of H.B. No. 116, Comm. Subs., First and Final Reading.

Fitial Seconded the motion.

Speaker: Discussion.

Fitial: Ready.

The lame duck Floor Leader: I just want to know how legal to impose such limitation that legislature ends up covering the Kone term. I feel that the members still have November and December to serve their term and legally under the law you are still a member of the congress. I need to be enlighten on this.

Speaker: Cong. Torres would you like to respond.

Torres: The idea behind this bill is to restrict any expending authority in the legislature from expending that alloted in one quarter. For instance you are alloted \$500,000, you cannot go out and expend \$600,000.

mant B. Sablan: But can you expend the one quarter allotment? Speaker: Yes. Normally the length of each legislature is for one quarter and one week.

B. Sablan: But that is not what is prohibited. What is prohibited is to make sure .

To expend more than one quarters allocation. Speaker:

Torres: You see the logislature tends to Spend more than what is alloted. Thereby we are creating difficulty for the incoming members.

B. Sablan: I agree.

Speaker: Does that clarify your concern Floor Leader.

Floor Leader: Yes and under Section 4 (c), "all 14g1s14t4te/ members of the legislature shall limit their budget of/personal and surplus from personal purposes of their respective offices."

Speaker: This will prevent you from over spending the one quarter allotment because if you know that you are lame duck and you hire more than the current number of employees on October 1, then you are likely to over spend your first quarter allotment.

Floor Leader: Okay, but if you read this section carefully Mr. Speaker, all members of the legislature shall limit employment of personnel for operational purposes. This does not mean that it does not involve money. We are only talking about manpower. As long as you are within your personal budget I do not think, irregardless of whether you hire 100 staff, as long as you are within your operational budget. Does this preclude you from hiring more than five if your money permits you to hire ten.

Hocog: Mr. Speaker, I think Subsection (c) is saying that any incumbent shall not hire any additional employee during your time of the first quarter.

Fitial: During your lame duck (Laughter)

Torres: The intent is that as long as you do not spend more than what you have . . .

Floor Leader: The way I interpret this bill, we are only limited to manpower and not funding, it says "it shall limit employment."

Speaker: Yes, this is to prevent the lame duck legislature from hiring freely for a short period of time.

Floor Leader: Mr. Speaker you cannot prohibit any lame duck as long as there is still funds. That will be unconstitutional. As long as you are still in office nobody can stop you irregardless of whether you lose the election or won the election or choose not to run. Your term of office is up on the following January 9th. The bill itself is very good. My only concern is that if you are within your budget limit and you cannot hire plenty, you have to limit only five, this is my concern here.

Speaker: I think the key section of the bill is Section 3, as long as you do not exit your spending authority for first quarter allotment.

Hocog: I do not see any reason myself Mr. Speaker to hire any additional employment.

Speaker: That is correct.

Hocog: If my current employees are still on board, I do not see any reason why I should hire any new employees.

Fitial: If you are already lame duck.

Hocog: Yes, if you are already lame duck.

Floor Leader: Mr. Speaker, let us fool ourselves. There are times when we should accomodate some of your patronage supporters. We should address ourselves from there, or otherwise I move for the previous question.

Speaker: Ready?

Hocog: Ready.

Sablan: Mr. Speaker, can we give time to those farmers who pasture their cows and goats next to the road, a couple of weeks extensive educational, I notice that in my precinct (laugther) there seems to be a lot. I have to go out and talk to these people and make sure that they understand this law.

Floor Leader: I will assure my good colleague that I will personally write a letter to the Attorney General and make sure that they promulgate this law as soon as we pass it.

B. Sablan: You are challenging my statement Floor Leader. (Laughter)

Speaker: You are going to write to request the Attorney General to exclude. .

Floor Leader: To promulgate this law prohibiting the tethering of animals.

B. Sablan: Ready Mr. Speaker.

Speaker: I think the bill provides for a public hearing before streets are name.

Floor Leader: Mr. Speaker it is very clear that names to be pick should reflect the local culture and heritage.

B. Sablan: I am just reemphasizing Mr. Speaker.

Hocog: Can we make it clear Mr. Speaker that we only name the streets after a decease person.

Speaker: The bill provides for that.

Speaker: Yes, and there is a good reason for that. The person might be good today but tomorrow he might be something else. (Laughter) One wrong doing and that will destroy the whole thing.

Hocog: Yes but after all the contribution that he has made in the community.

Speaker: Yes, but one wrong doing and there it goes out the window.

Fitial: One thing may be good for the chamorro but seriously may not be very good for the carolinian. The carolinian, this is against their custom to bring back the name of the dead. I know this bill will only benefit the chamorros.

Speaker: But it could be culture because it allows for culture heritage.

Fitial: When a carolinian dies everything that he owns or she owns goes with the dead.

B. Sablan: But you see my good colleague, customs are changing and they continually change so eventually this will also serve the carolinians.

Speaker: The bill also provides for flexibility in regards to culture and heritage.

Fitial: I was just pointing the carolinian custom because it is still very much alive.

Speaker: Further discussion?

Fitial: Ready.

The Clerk called the roll for voting purposes on H.B. No. 63, Comm. Subs., The voting result, ten voting yes. H.B. No. 63, Comm. Subs., hereby passes the House on its First and Final Reading.

S.B. No. 4-61, S.D. 2, H.D. 1:

Floor Leader: I move for the passage of S.B. No. 4-61, S.D. 2, H.D. 1, First and Final Reading.

Vice Speaker seconded the motion.

Speaker: Discussion.

Fitial: This is a requirement that is presently practice for all elected officials under the election law.

Speaker: No that is only limited to election expenditure, campaign expenditure, but this has something to do with disclosing your financial assets, your financial condition as a public official.

Fitial: For some of us, without the campaign we will not have any financial disclosure.

Floor Leader: Mr. Speaker the term public official is very broad. Any government employee could be consider a public official unless we come with an actual definition as to who are this public official.

Speaker: These are elected officials.

Floor Leader: Public officials, there are some more provisions which inject the members of board and official. These are public officials.

Speaker: And also appointed officials.

Floor Leader: Yes they are appointed officials, but what about like the Board of MPLC, they are the board that requires . . .

Speaker: That is correct. It is all cover in this bill, Section 4 and 5.

B. Sablan: This committee report should have come out of my office. I do not know how it is routed. I have not seen this and I have not sanctioned it out of my office calendar. I do not know how it got out here.

Speaker: You were off-island I think.

Fitial: This was routed by a member of your staff upon the instruction of the legal counsel, Bergsma.

Speaker: I think this is one of the bill that you have instructed the legal counsel to refine.

B. Sablan: Yes but it should come back to my office.

Speaker: Unfortunately during that time you were in Guam for the APIL.

B. Sablan: I just want to point out the unusual route of such report.

Speaker: I think the original copy is still available if you want to put your signature.

B. Sablan: Thank you.

Hocog: Mr. Speaker in the event that any elected official do not have anything to disclose.

Speaker: He will disclose zero. We are required to disclose whether the amount is zero or one penny.

Floor Leader: Can I bring your attention to the heading? "A Bill for an act to establish financial requirements for elected and appointed public officials, for certain public employees and for other purposes."

Speaker: Section 5 of the bill covers "for certain public employees", page 1.

Floor Leader: Did we address ourselves Mr. Speaker to the departments whether they should disclose their financial standings? I do not think that it is fair for us to crucify Marianas Public Land Corporation and EDLF because that is where the money is. We should look into a broader sense.

B. Sablan: There are several others in here, not only MPLC.

Floor Leader: Well, Commerce and Labor, Immigration. Mr. Speaker, my argument at this point in time I should put it this way that rather than putting Immigration I rather that we put in a provision that we should not authorize them to hire any alien labors because that is where the papers for alien labors are being processed. If we are concern about corruptions even a janitor and even the employees at Public Works, there are time when we give them beer to drink while they are performing public services. If this is our intention then we should really be honest to ourselves. We should not crucify immigration because at times we hear news that one Korean guy tries to bribe some Immigration Officer \$300.00, or the Labor Depart. I believe that we should exclude these two departments Mr. Speaker. The recruiting of alien labors is where the conflict exist. Now, if we are concern about money under the table, let us not fool ourselves, even the janitor at Public Works get this bribe. I move Mr. Speaker that we strike out Immigrations and Labor and Commerce.

Fitial: Before any motion can be effected I will like to bring out a point also. I am in support of Section 3 and 4 and I am only partially in support of Section 5. I do not think that it is fair to require all the employees. You know some of these employees are Civil Service Employees and they have the Civil Service system, their rules and regulations to govern their contract of employment. I just feel that this is rather too much, SEction 5. It is asking too much of the employees of this respective agents of government. Perhaps the top employees or those employees who are holding responsible positions in these respective agencies should be subjected to this requirement, but not all employees. Especially when you look at Section 6, the context of the statement, some of these employees may find it rather difficult to fulfill or meet these requirements. We have to consider the employees involved and the complexity of the financial statement that this law will be requiring.

Speaker: If you look at Section 8 of the bill that requires the Public Auditor to make the rules and regulations and the necessary forms to be fill in.

Floor Leader: Mr. Speaker, experience will tell us that under the Third Legislature they passed a hill regarding alien labor. Under that bill they authorize the Director of Commerce and Labor to promulgate rules and regulations, up to now there is no rules and regulations pertaining to labor matter has been promulgated. Are we going to continue giving this authority to them? We might as well come up with a stature.

Speaker: The bill is for the Public Auditor, Mr. Floor Leader.

Floor Leader: I am referring to Public Auditor. We are giving the Public Auditor the authority to promulgate regulations, for how long. There is not even one public auditor report that has been presented to the legislature. Which is more important, to promulgate this kind of bill or audit the accountability of the government agency. I am not emotional this afternoon Mr. Speaker, but I think we should come out with the proper rules and procedures. Let us be fair. I am against those guys who are known crook.

Speaker: Let us have a short recess Mr. Floor Leader.

The House recessed at 3:50

Speaker: Strike the word "employees"?

B. Sablan: Yes, strike the word "employees."

Fitial: I think we have a concensus.

Floor Leader: We should put the word "shall" because this is questionable. If he has plans to promulgate he will promulgate, if he doesn't then he will not.

Fitial: I think our Floor Leader has a very strong and valid point.

Floor Leader: Shall we put the word "shall" Mr. Speaker?

Speaker: Do you want to offer that in the form of an amendment?

Floor Leader: So move.

Speaker: Why don't we just reach a concensus to change the word "may" on line 22, page 2, to "shall".

B. Sablan: Yes, I think that will be fine.

Speaker: Is there any objection from the members?

Fitial: You got my support.

B. Sablan: No objection.

Speaker: If there is no objection, the word "may" shall be change to "shall". Further discussion on the bill?

Speaker: The session shall now reconvene. Prior to recess we were on S.B. No. 4-54, S.D. 2, H.D. 1.

Floor Leader: I will like to make a motion to withdraw my previous motion to place this on today's calendar for its First and Final Reading.

Speaker: To withdraw?

Floor Leader: Withdraw. I will like to reinstate another motion to place this bill on First Reading only.

There were several seconds to the motion.

Speaker: Discussion.

Fitial: Mr. Speaker if I may, before the Second Reading I will like to request that Section 10(b) of Section 1, we review and possibly change to restrict the non-resident workers from $\frac{1}{4}\frac{1}{1}\frac{1}{1}$ getting temporary jobs.

B. Sablan: What page?

Fitial: Page 12, line 14 all the way down. Mr. Speaker we are encountering problems respecting the continuation of non-resident workers who are engaged in some grievances or cases in the court and the Labor Division have been granting temporary working office section, which is only supposed to be valid for 30 days, yet they have been under this authorization for more than a year, some two years and it is getting to the point where temporary is no longer an issue. I will respect the request that this particular concern be reviewed and analized so that we should prevent the extension of temporary working authorization to be no longer than 30 days.

Speaker: In other words to limit to 30 days?

Fitial: No longer than 30 days.

B. Sablan: Mr. Speaker the present practice of the Commerce and Labor is to have a temporary working permit or work authorization for 30 days and that upon the termination of the 30 days, they can reapply again so they go on a month to month basis. How do you propose to eliminate that loophole.

B. Sablan: May I ask my good colleague to point the other section in this bill because my good Chairman in R & D is not here and I have to act on it.

Speaker: I believe the Chairman of R & D will be back tomorrow.

Floor Leader: I notice that there are some provisions that are not accurate on this bill. For example, there is no provision in here that if a run away contract employee that we must give him a temporary working permit. If something happen and this employee dies, who will bear the cost to take or send the dead body to the Philippines.

Fitial: Under the present law Mr. Speaker, if I may. . . .

Floor Leader: Yes, but it is fair to let the original employer take the burden because the alien labor was the one that ran away to a new employer. Under this

legally the contract was retain by the original employer.

B. Sablan: No more transfers according to this bill.

Floor Leader: No . . .

Fitial: The concern from the Floor Leader is accomodated on page 13, line 4. The temporary employer will then assume the responsibility.

Floor Leader: "complaint by the chief", are we referring to the Fire Chief or some other chief? (Laughter)

B. Sablan: There is a definition already on the "Chief", the Chief of Labor.

Floor Leader: This might sound funny, but when the case comes up they will look into this.

Fitial: If you take a closer look in that concern you will see that they strike out "the Division of Labor". This is because if they put the Division of Labor then this becomes redundant.

B. Sablan: That is the reason why they struck this out. It has been defined on page 2.

Floor Leader: But the law, it doesn't matter whether it is redundant, we have to prove the language and the provisions.

Fitial: Sometimes redundancy is needed for clarity. (Laughter) Ready for the First Reading question.

Speaker: At any rate, those concerns will address before the Second Reading.

Floor Leader: Mr. Speaker I know this is not very nice for me to ask my colleagues, but this is the occassion to discuss the bill. I notice that on the Committee Report, Cong. Lifoifoi is asking for some investigation.

Speaker: No, Cong. Lifoifoi is a member of theR & D.

Lifoifoi: Mr. Speaker, I understand that this bill will be read First Reading and then back the original jurisdiction, the R & D Committee.

B. Sablan: That is why I am not opposing on theFirst Reading Mr. Speaker.

Hocog: Then Rep. Lifoifoi will sign the Committee Report without reservation.

Speaker: On Second Reading.

Fitial: Ready for the question.

The motion to pass S.B. No. 4-54, S.D. 1, H.D. 1, First Reading, carried by voice vote.

Floor Leader: Mr. Speaker I move that we adjourn until tomorrow at 9:00 a.m..

Fitial seconded the motion.

Speaker: We have two more bills.

Fitial: We have two more bills.

Speaker: Otherwise I will not take you guys out for a drink.

Fitial: In that case I withdraw my second.

Floor Leader: I withdraw my motion.

S.B. No. 4-79 (Relative to Senate Comm. No. 156):

Speaker: For this particular bill we need to suspend the appropriate rules, Rule 9 Section 7, Rule 7 Section and Rule 9 Section 8.

Floor Leader: So move Mr. Speaker.

Fitial seconded the motion.

Speaker: Okay, the motion is to suspend Rule 9 Section 7, Rule 7 Section 8 and Rule 9 Section 8.

The motion to suspend Rule 9 Section 7, Rule 7 Section 8 and Rule 9 Section 8 so that S.B. No. 4-79 be place on today's calendar for its First and Final Reading, carried by voice vote.

Speaker: You may now effectuate a motion Mr. Floor Leader to have this bill pass on First and Final Reading.

Floor Leader: So move.

There were several seconds to the motion.

Speaker: Discussion.

Fitial: Ready.

The Clerk called the roll for voting purposes on S.B. 4-79, pertaining to Senate Communication No. 156. The voting result, ten voting yes. S.B. No. 4-79 is hereby passed by the House on its First and Final Reading.

Second Reading

H.B. No. 43, Comm. Subs.:

Hocog: Before we act on H.B. No. 43, on behalf of my good colleague Rept. Juan T. Guerrero, I will like to ask the rest of the members to endorse the floor amendment offered by my good colleague.

Speaker: We will get to that during the discussion of the bill.

Floor Leader: I move for the passage of H.B. No. 43, Comm. Subs., Second and Final Reading.

There were several seconds to the motion,

Speaker: Discussion. I believe that there are two proposed amendments to be offered, one is from Rept. Juan T. Guerrero, who has asked the Rept from Rota to offer the amendment on his behalf. Also Chairman Ben Sablan have a proposed floor amendment.

Hocog: On page 6, line 24 insert the following language: "These classifications are solely for the purpose of establishing license fees, they are not intended to change tax classifications as established in 4 CMC Sections 1303 and 1304."

Speaker: How about the rest of the proposed floor amendments.

B. Sablan: May I offer also my floor amendment.

Speaker: Can we entertain the proposed floor amendment offered by Rept. Juan T. Guerrero and then we will to yours. Chairman Hocog there are two proposed floor amendments, one is the one that you have just read, and the other one is to change pages 4, 5, and 6. Why don't we put that into one motion as the floor amendment at this time.

Hocog: So move Mr. Speaker.

B. Sablan seconded the motion.

Speaker: Discussion on the proposed floor amendments.

Fitial: Yes, question. Why do we need this language after line 24. I thought the purpose on Section 2, line 3 of page 1 already made that point very clear.

Floor Leader: Mr. Speaker I move that we defer action on this bill. The original intention of the bill I concurred with my signature. I never knew that they were to make the changes regarding licensing. I cannot tolerate to sign this bill with this kind of . . .

Hocog: Privilege Mr. Speaker. We are not making any changes. We are proposing a floor amendment.

Speaker: We have not decided, We are discussing the floor amendment Mr. Floor Leader. I believe the language of the proposed floor amendment is to make it clear that this has something to do only with business licenses and do not apply to the revenue and taxation of P.L. 3-11.

Fitial: That is on Section 2, "Issuance of Licenses."

Speaker: No, the fees for each classification of businesses or categories.

Floor Leader: We are looking at the proposed floor amendment. I think we should reexamine ourselves whether we are really serious in trying to help our Commonwealth Government with the present financial situation or are we just trying to play Santa Claus. I am arguing on the proposed amendment. Mr. Speaker I will give you one example. The insurance business are making about a million dollars a year especially at this place. It is lucky if they disburse \$100,000 a year, and to let them pay \$150 to \$200 license fee is a sin to God. (Laughter) At this time you go to any insurance business and ask them their financial statement and see how much profit they are making.

Speaker: Floor Leader even at the current license fee, the proposed floor amendment is higher a little bit than the existing fee.

Floor Leader: From the beginning I was misled when I signed this Committee Report because this was not included. I do not think that it is fair for me to . . .

B. Sablan: This is a floor amendment.

Floor Leader: No, but with the original the Chairman told me that he will not change anything. I have registered my concern for a long time regarding the proposed fee and we made a compromise. Looking at this, this is a sin.

Fitial: Hotel fees went down very drastically, from \$1,000 to . . .

Floor Leader: Mr. Speaker I know that it is an election year and I do not think the busineses will take it seriously that we are trying to impose this burden on them. I am not doing this for my own interest. Whatever the government receives from these fees, they will be distributed equally to the resident of the Commonwealth people.

Speaker: I will like to point to the members that the license fees is not where we make or generate revenue.

Floor Leader: For that simple reason that this happens only once a year, because if it happen every month, even lowering it to \$50, I will agree, but you pay only once a year. How much revenue are we going to get?

Speaker: This is not for the general revenue.

Floor Leader: Irregardless Mr. Speaker. During our discussion with the committee I stated that even Jack and Jill, in order to discourage Filipinos who are here and if they have \$50 they will open their recruitment agency. I proposed to enforce \$500 license fee in order to discourage outsiders. When I went to Guam for the APIL Conference they come out and put \$150. This is not fair. What are we trying to do. We want to protect our people that is why I agreed with the original version, I proposed \$1,000 for any recruitment agency. There are about 50 recruitment agencies and most of them are owned by Filipinos. I am not prejudice nor bais , hut with the present system, should they have \$50 in their banking account they could open any kind of business. I hope my good colleagues will not mind me for speaking this long, but it is not fair.

Lifoifoi: Let us have a short recess.

Speaker: Let us have a short recess.

The House recessed at 5:00 The HOuse reconvened at 5:10

Speaker: Prior to recess we were discussing the proposed floor amendment as offered by Rept. Hocog on behalf of Rept. Juan T. Guerrero.

Hocog: I will like to withdraw my motion on the amendment of the bill, H.B. No. 43.

Speaker: Only the subsequent motion.

Hocog: The amendment on Pages 4, 5 and 6.

Speaker: But the rest, you want it adopted. Right?

Hocog: Right.

Speaker: Any second to that motion?

Vice Speaker Tudela seconded the motion.

Speaker: Discussion.

Hocog: Ready.

Speaker: The motion is to withdraw the original motion and that is to replace pages 4, 5 and 6 of the bill, but to proceed with the adoption of the language proposed amendment.

The motion to withdraw the motion of the original motion which is to replace pages 4, 5 and 6 of 11.B. No. 43, $\frac{44t+1}{44}\frac{4}{144}\frac{4}$

The motion to adopt the proposed amendment offered by Rept. Juan T. Guerrero, on page 6, line 24 of H.B. No. 43, Comm. Subs., carried by voice vote.

Floor Leader: I move that we refer H.B. No. 43, Comm. Subs., to the original committee.

B. Sablan: May I offer my floor amendment first.

Speaker: Proceed.

B. Sablan: In front of you is April 22, 1985, letter to the Speaker from my Committee's Office. In the form of a motion also Mr. Speaker, I am offering the motion ton amend Section 22, Penalties, by adding an additional Subsection (d) and the present Section (d) is redesignated as Subsection (e).

For Subsection (d) I would like to specify "Any licensee who is not a domestic business, a citizen or permanent resident of the Northern Marianas, or a citizen of the United States who violates any provision of this Act, 3 CMC Division 4, Chapter 3 and 4, or is convicted of a felony shall not be eligible for a business license and such violation shall constitute grounds for deportation and immediate revocation of all other business licenses issued."

Hocog seconded the motion .

Speaker: Discussion on the proposed floor amendments.

Floor Leader: Mr. Speaker, I seldom argue with my close colleague in here, but I cannot help it. I do not think it is constitutional to reject those people who are not Commonwealth or U.S. citizens in regards to this proposed amendment offered by my good colleague. I do not think this is fair to impose this kind of provisions. In Guam under the law, if you obtain a business permit then you are privileged and I am privilege to the law to conduct a business. Whether you are negro or Indian, if you are to be punish, you will be punish under the same provisions of the penalty. I do not believe that a negro will get a more severe punishment than the Indian. If one breaks the law, then he or she gets punish.

B. Sablan: 1 do not know where in my amendments that discreminates between non-residents. I am saying here that a licensee who is not a domestic business, a citizen or a permanent resident, I am not reclassifying to say those that are outsiders or non-resident or whatever. My intention are for citizens and permanent residents. I do not know where the argument comes in.

Floor Leader: What about those that are not permanent residents.

Hocog: Mr. Floor Leader it says here any licensee who is not a domestic business or a citizen of the Commownealth Resident. That means that all person doing businesses, provided however that it does not violate the law.

B. Sabla n Basically what I am saying is all businesses here. I am including the citizens and permanent residents. Is that satisfactory to you my good Floor Leader?

Floor Leader: For the time being. (Laughter)

Speaker: Any further discussion on the proposed floor amendments?

I. Demapan: Mr. Speaker, I tend to agree with Cong. Sablan, however I think deportation is quiet severe on the issue. They have to also consider the area of generating more revenues, more taxes for the government. I believe a fine is adequate for such violation. 5. Sablan: My intention here is only eligible, shall constitute grounds, which take this to mean that you are to be deported if you violate certain information of our law. I do not think that is the gist of the amendments. What I am simply saying is that if there is grounds $\frac{11}{10}$ ($\frac{11}{10}$) on this condition and somehody in the enforcement law and Judicial Branch will determine what that amounts to be, we are not dictating prose that an individual who violates will be deported by the way, "It says shall constitute for grounds of deportation." This is subject to discussion or debate on perhaps the administration or the Judiciary. I am only offering amendments that would assist in general the people of the Northern Marianas. In particular, if we have for instance like the Korean Bars who constantly violates our Civil Laws, these people I think should be deported. If there is no such law that protects the deportation or word including the word that would give them that thought that if we found them guilty and are convicted, let me remind you again that they have to be convicted in order for them to have grounds for deportation, then that grounds for deportation will be discuss.

Speaker: This legislation requires conviction of the violation.

Torres: Isn't this included in the Immigration Law?

B. Sablan: See there is no specify language that there will be a constitute grounds for deportation. We are adding that into the present law that we have in the Immigration Law, and so is this Domestic Business Act.

Speaker: Any further discussion?

Lifoifoi: Ready.

The motion to adopt the proposed amendments offered by Reprt. Benigno Sablan to H.B. No. 43, carried by voice vote.

Speaker: We will now go back to discuss the bill in the form of Committee Substitute, H.D. 2.

Fitial: Ready.

The Clerk called the roll for voting purposes on H.B. No. 43, M/D//2// H.D. 2, Comm. Subs.. The voting result, ten voting yes. H.B. No. 43, H.D. 2, Comm. Subs., passes the House on its Fifst/And/Final Reading.

Sepaker: Next bill on the calendar?

Clerk: None Mr. Speaker.

Floor Leader: Motion that the House stands adjourn subject to the call of the Chair.

Lifoifoi seconded the motion.

Sepaker: Before we entertain that motion Mr. Floor Leader, I will like to announce that there is a Youth Take-Over Day this coming Friday. I will like to reach a concensus that we have a session for this day at ten o'clock in the morning. Tomorrow we will have a session at 2:00 p.m..

Speaker: You have a good concern Mr. Floor Leader. I will like to ask each member to be prepared and have themselve ready. May be a mock session will be in order for the students to participate.

B. Sablan: Let us get some controversial bill.

Speaker: If you have any ideas, prepare a resolution or a bill for the students to really discuss, I urge that you prepare something. We can use old bills. Okay, can we adjourn until tomorrow at 2:00 o'clock.

Floor Leader: Do we have anything on the calendar?

Speaker: We are going to work on the Appro.

Floor Leader: So move.

B. Sablan seconded the motion.

The motion to adjourn the House until Wednesday at 2:00 o'clock, carried by voice vote.
