



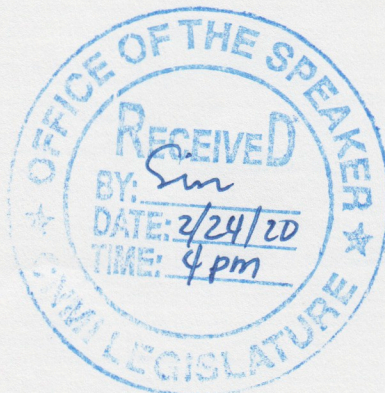





**House Local Bill No. 21-16, D1**

**A LOCAL APPROPRIATION BILL FOR AN ACT  
FOR THE FIRST SENATORIAL DISTRICT**

To appropriate \$127,209.00 for the Rota Municipal Scholarship Foundation Reserve Account (specifically under BU 2301).

**BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO  
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to appropriate \$127,209.00 from the Rota Municipal  
3 Scholarship Foundation Reserve Account (specifically under BU 2301) and for other purposes.

4 **SECTION 2. APPROPRIATIONS.**

5 The Rota Legislative Delegation hereby appropriates \$127,209.00 from the Rota  
6 Municipal Scholarship Foundation Reserve Account (specifically under Business Unit 2301)  
7 for the Rota Municipal Scholarship Foundation for the student housing assistance. The  
8 Scholarship Board shall submit the list of students to receive the housing assistance to the  
9 Mayor of Rota, the expenditure authority, and the Mayor shall in turn provide the list to the  
10 Rota Resident Director of Finance for disbursements.

11 **SECTION 3. FISCAL YEAR.**

12 The funds allocated under this Act shall be without fiscal year limitation(s).

13 **SECTION 4. SEVERABILITY.**

14 If any provision of this Act or the application of any such provision to any person or



1 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this  
2 Act or the application of its provisions to persons or circumstances other than those to which it  
3 is held invalid shall not be affected thereby.


4 **SECTION 5. SAVINGS CLAUSE.**


5 This Act and any repealer contained herein shall not be construed as affecting any  
6 existing right acquired under contract or acquired under statutes repealed or under any rule,  
7 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect  
8 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not  
9 have the effect of terminating, or in any way modifying, any liability, civil or criminal, which  
10 shall already be in existence on the date this Act becomes effective.

11 **SECTION 6. EFFECTIVE DATE.**


12 This Act shall take effect upon its approval by the Governor or its becoming law  
13 without such approval.
