**A LOCAL APPROPRIATION BILL FOR AN ACT  
FOR THE FIRST SENATORIAL DISTRICT**

To appropriate funds specifically allotted to the First Senatorial District under Public Law 18-30, as amended; and for other purposes.

**BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO  
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. SHORT TITLE.**

2           The purpose of this Act is to appropriate Twenty-One Thousand Two Hundred Seventy-  
3 Two dollars (\$21,272.00) of the funds specifically allotted to the First Senatorial District under  
4 Public Law 18-30, as amended, pursuant to the Secretary of Finance certification of funds as of  
5 January 31, 2021 and prepared on February 8, 2021. Accordingly, the purpose of this act is to  
6 appropriate Twenty-One Thousand Two Hundred Seventy-Two dollars (\$21,272.00) of the  
7 funds specifically allotted to the First Senatorial District under Public Law 18-30, as amended,  
8 for inter-island medical referral stipend for patients and their escort.

9 **SECTION 2. APPROPRIATIONS.**

10           There is hereby appropriated Twenty-One Thousand Two Hundred Seventy-Two dollars

1 (\$21,272.00) of the funds allotted to the First Senatorial District under Public Law No. 18-30, as  
2 amended, for inter-island medical referral stipend for patients and their escorts. The funds  
3 provided in this section is strictly for the Rota inter-island medical referral patients and escorts  
4 from Rota, not for hemodialysis or terminally ill patients who receive the Medical Subsistence  
5 Allowance.

6 **SECTION 3. EXPENDITURE AUTHORITY.**

7 The expenditure authority for funds appropriated under this Act shall be the CHCC CEO  
8 or designee.

9 **SECTION 4. FISCAL YEAR.**

10 The funds allocated under this Act shall be without fiscal year limitation(s).

11 **SECTION 5. SEVERABILITY.**

12 If any provision of this Act or the application of any such provision to any person or  
13 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this  
14 Act or the application of its provisions to persons or circumstances other than those to which it  
15 is held invalid shall not be affected thereby.

16 **SECTION 6. SAVINGS CLAUSE.**


17 This Act and any repealer contained herein shall not be construed as affecting any  
18 existing right acquired under contract or acquired under statutes repealed or under any rule,  
19 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect  
20 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have  
21 the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall  
22 already be in existence on the date this Act becomes effective.


1 SECTION 7. EFFECTIVE DATE.

3 such approval.


