

HOUSE LOCAL BILL NO. 22-33, D1

A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE FIRST SENATORIAL DISTRICT

To appropriate One Hundred Thousand dollars (\$100,000.00) from the Poker Licensing Fee Account (specifically under BU 3302); and for other purposes.

BE IT ENACTED BY THE FIRST SENATORIAL DISTRICT DELEGATION PURSUANT TO
CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 **SECTION 1. SHORT TITLE.**

2 The purpose of this Act is to appropriate One Hundred Thousand dollars (\$100,000.00)
3 from the Poker Licensing Fee Account (specifically under BU 3302) and for other purposes.

4 **SECTION 2. APPROPRIATIONS.**

5 Notwithstanding 10 CMC §1901, the Rota Legislative Delegation hereby appropriates
6 One Hundred Thousand dollars (\$100,000.00) from the Poker Licensing Fee Account
7 (specifically under Business Unit 3302) as follows:

8 (a) Ninety-Five Thousand dollars (\$95,000.00) for Medical Subsistence Allowance for
9 the Rota hemodialysis and terminally-ill patients under the expenditure authority of the Secretary
10 of Finance.

1 (b) Five Thousand dollars (\$5,000.00) for the operations of the Luta Soil and Water
2 Conservation District. The expenditure authority shall be the Chairperson of the Luta Soil and
3 Water Conservation District.

4 **SECTION 3. FISCAL YEAR.**

5 The funds allocated under this Act shall be without fiscal year limitation(s).

6 **SECTION 4. SEVERABILITY.**

7 If any provision of this Act or the application of any such provision to any person or
8 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this
9 Act or the application of its provisions to persons or circumstances other than those to which it
10 is held invalid shall not be affected thereby.

11 **SECTION 5. SAVINGS CLAUSE.**


12 This Act and any repealer contained herein shall not be construed as affecting any
13 existing right acquired under contract or acquired under statutes repealed or under any rule,
14 regulation or order adopted under the statutes. Repealers contained in this Act shall not affect
15 any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have
16 the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall
17 already be in existence on the date this Act becomes effective.

18 **SECTION 6. EFFECTIVE DATE.**


19 This Act shall take effect upon its approval by the Governor or its becoming law without
20 such approval.




