A LOCAL APPROPRIATION BILL FOR AN ACT FOR THE THIRD SENATORIAL DISTRICT

To re-appropriate Two Thousand, One Hundred Forty-Five Dollars and Seventy-Three cents (\$2,145.73) allotted under Saipan Local Law 17-18, specifically under Business Unit 3398P and Three Thousand, Three Hundred Eighty-Seven Dollars (\$3,387.00) allotted under Saipan Local Law 19-05, specifically under Business Unit 3752U; and for other purposes.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

SECTION 1. PURPOSE.

The purpose of this Act is to re-appropriate Two Thousand, One Hundred Forty-Five Dollars and Seventy-Three cents (\$2,145.73) allotted under Saipan Local Law 17-18, specifically under Business Unit 3398P and Three Thousand, Three Hundred Eighty-Seven Dollars (\$3,387.00) allotted under Saipan Local Law 19-23, specifically under Business Unit 3752U.

SECTION 2. RE-APPROPRIATIONS.

Notwithstanding any provisions, statutes, laws or regulations to the contrary, the Saipan and Northern Islands Legislative Delegation hereby re-appropriates Two Thousand, One Hundred Forty-Five Dollars and Seventy-Three cents (\$2,145.73) allotted under Saipan Local Law 17-18, specifically under Business Unit 3398P and Three Thousand, Three Hundred Eighty-

1	Seven Dollars (\$3,387.00) allotted under Saipan Local Law 19-05, specifically under Business
2	Unit 3752U, as follows:
3	(A) Two Thousand, Four Hundred Eighty-Four Dollars (\$2,484.00) for the installation of
4	two (2) speed bumps at Adobu Drive in Koblerville area; and
5	(B) Three Thousand, Two Hundred Fifty-Three Dollars and Sixty-Five Cents (\$3,253.65)
6	for the installation of street lights within the vicinity of the Koblerville Basketball
7	Facilities and the Koblerville Youth Center.
8	(C) The Department of Public Works, Technical Services Division has identified Two
9	Hundred Four Dollars and Ninety-Two Cents (\$204.92) as matching funds to fully fund
0	the remaining project costs of (A) and (B).
1	SECTION 3. EXPENDITURE AUTHORITY.
2	The expenditure authority for the funds under Section 2 of this Act shall be the Secretary
3	of the Department of Public Works.
4	SECTION 4. REPROGRAMING.
5	Notwithstanding any laws, provisions or regulations to the contrary, funds appropriated
6	under this Act shall not be reprogrammed for any other purpose.
7	SECTION 5. REPORTING.
8	The expenditure authority shall submit to the Chairperson of the Saipan and Northern
9	Islands Legislative Delegation a detail report showing the expenditure of the funds at the
0.0	completion of appropriations in Section 2 of this Act.

SECTION 6. FUND DISTRIBUTION.

HOUSE LOCAL BILL No. 22-9

Funds appropriated under Section 2 of this Act shall be distributed accordingly to the intended purpose and or entity upon this Act becoming law.

SECTION 7. FISCAL YEAR.

The funds allocated under this Act shall be without fiscal year limitation(s).

SECTION 8. SEVERABILITY.

If any provision of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

SECTION 9. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

SECTION 10. EFFECTIVE DATE.

This Act shall take effect upon its approval by the Governor or its becoming law without such approval.
