

To appropriate un-obligated funds under Saipan Local Law 23-01; and for other purposes.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:

1 **SECTION 1. PURPOSE.**

The Delegation finds that Governor Arnold I. Palacios line-item vetoed House Local Bill 23-01, S1 on March 10, 2023 un-obligating funds that had been appropriated to the Board of Parole (Specifically Section 2(E)), citing 6 CMC § 4207. Therefore, the intent of this Act is to appropriate un-obligated funds under Saipan Local Law 23-01 (in the amount of \$30,000.00) from the fees collected pursuant to Public Law 20-59.

SECTION 2. APPROPRIATION.

8 Notwithstanding any provision(s) of law, statutes, rules or regulations to the contrary and
9 pursuant to funds allocated to the Third Senatorial District the Saipan and Northern Islands
10 Legislative Delegation (SNILD) hereby appropriates \$30,000.00 of un-obligated funds under
11 Saipan Local Law 23-01(Specifically Section 2(E)) for the Board of Parole Saipan Office for

personnel/operations, expenditure authority shall be the Chief Parole Officer with the approval of 1 2 the Chairperson of the Board of Parole pursuant to 6 CMC § 4207. 3 **SECTION 3. REPROGRAMMING.** Funds appropriated under this act shall not be reprogrammed for any other purpose and 4 5 notwithstanding any provision of law, all funds appropriated under this Act shall be without fiscal 6 year limitation. 7 **SECTION 4. SEVERABILITY.** 8 If any provision of this Act or the application of any such provision to any person or 9 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act 10 or the application of its provisions to persons or circumstances other than those to which it is held 11 invalid shall not be affected thereby. 12 **SECTION 5. SAVINGS CLAUSE.** 13 This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or 14 order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding 15 16 instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of 17 terminating, or in any way modifying, any liability, civil or criminal, which shall already be in 18 existence on the date this Act becomes effective. 19 **SECTION 6. EFFECTIVE DATE.** This Act shall take effect upon its approval by the Governor or its becoming law without 20 21 such approval.
