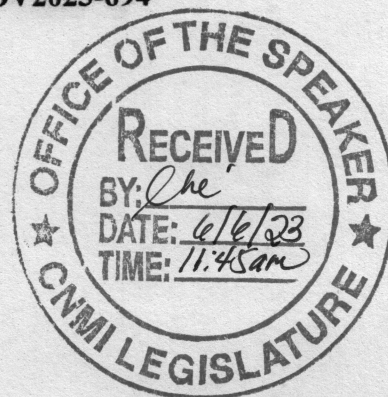





This is to inform you that I have vetoed **House Local Bill No. 23-06, D1** entitled, "To re-appropriate Eleven Thousand Two Hundred Forty-Six Dollars (\$11,246.00) allotted under Tinian Local Law 18-09; Fourteen Thousand One Hundred Fifty-Nine Dollars (\$14, 159.00) allotted under Tinian Local Law 19-13; Thirty Thousand Eight Hundred Eighty-Two Dollars (\$30,882.00) from Tinian Local Law 19-15; One Hundred Ninety-One Dollars (\$191.00) from Tinian Local Law 20-9; Five Thousand Dollars (\$5,000.00) from Tinian Local Law 20-17; and One Thousand Forty Dollars (1,040.00) from Tinian Local Law 20-17; and for other purposes." The bill was passed unanimously by the Tinian and Aguiguan Legislative Delegation of the Twenty-Third Northern Marianas Commonwealth Legislature.

In the purpose section of the Bill, it states that:

The bill proposes to re-appropriate what appears to be fund balances from various projects/funding items appropriated by earlier local laws, namely Tinian Local Law (TLL) 18-9; TLL 19-13; TLL 19-15; TLL 20-9; and TLL 20-17, with a combined total of \$62,518.00 for the following expenditures:

- \$40,000 to the Mayor for personnel and operations costs;
- \$20,018 to the Mayor's discretionary fund; and
- \$2,500 to the Tinian Athletic Sports Association.

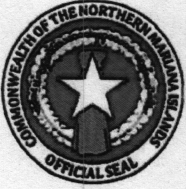
Due to the insufficiency of funds, I must respectfully exercise my constitutional authority to veto this Bill.



II. ANALYSIS:

A. Purpose:

To re-appropriate Eleven Thousand Two Hundred Forty-Six Dollars (\$11,246.00) allotted under Tinian Local Law 18-09; Fourteen Thousand One Hundred Fifty-Nine Dollars (\$14,159.00) allotted under Tinian Local Law 19-13; Thirty Thousand Eight Hundred Eighty-Two Dollars (\$30,882.00) from Tinian Local Law 19-15; One Hundred Ninety-One Dollars (\$191.00) from Tinian Local Law 20-9; Five Thousand Dollars (\$5,000.00) from Tinian Local Law 20-17; and One Thousand Forty Dollars (\$1,040.00) from Tinian Local Law 20-17. A total of Sixty-Two Thousand Five Hundred Eighteen Dollars (\$62,518.00) will be appropriated to the Mayor of the Municipality of Tinian and Aguiguan for personnel and operations.

B. Committee Findings:

C. Legislative History:



**BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT
TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

SECTION 1. PURPOSE.

The purpose of this Act is to re-appropriate Eleven Thousand Two Hundred Forty-Six Dollars (\$11,246.00) allotted under Tinian Local Law 18-09, §1(b); Fourteen Thousand One Hundred Fifty-Nine Dollars (\$14,159.00) allotted under Tinian Local Law 19-13, §2(b); Thirty Thousand Eight Hundred Eighty-Two Dollars (\$30,882.00) from Tinian Local Law 19-15, §3(c)(6); One Hundred Ninety-One Dollars (\$191.00) from Tinian Local Law 20-9, §2(m); Five Thousand Dollars (\$5,000.00) from Tinian Local Law 20-17, §2(b); and One Thousand Forty

1 Dollars (\$1,040.00) from Tinian Local Law 20-17, §2(c), for a combined total of Sixty-Two
2 Thousand Five Hundred Eighteen Dollars (\$62,518.00).

3 **SECTION 2. RE-APPROPRIATIONS.**

4 Notwithstanding any provision(s) of law, statutes, rules or regulations to the contrary, the
5 Tinian and Aguiguan Legislative Delegation hereby re-appropriates the combined total in the
6 amount of Sixty-Two Thousand Five Hundred Eighteen Dollars (\$62,518.00) from the following
7 Tinian Local Laws: Eleven Thousand Two Hundred Forty-Six Dollars (\$11,246.00) allotted
8 under Tinian Local Law 18-09, §1(b) Retroactive Salaries; Fourteen Thousand One Hundred
9 Fifty-Nine Dollars (\$14,159.00) allotted under Tinian Local Law 19-13, §2(b) Lump Sum
10 Payment for Annual Leave for Local Employees; Thirty Thousand Eight Hundred Eighty-Two
11 Dollars (\$30,882.00) from Tinian Local Law 19-15, §3(c)(6) Tinian Farmer's Market; One
12 Hundred Ninety-One Dollars (\$191.00) from Tinian Local Law 20-9, §2(m) Tinian Premiere
13 Football Club; Five Thousand Dollars (\$5,000.00) from Tinian Local Law 20-17, §2(b)
14 Patio/Outside Kitchen at the Tinian Guesthouse; and One Thousand Forty Dollars (\$1,040.00)
15 from Tinian Local Law 20-17, §2(c) Tinian Premiere Football Club, to the following:

- 16 a) Forty Thousand Dollars (\$40,000) to the Mayor of the Municipality of Tinian and
17 Aguiguan for personnel and operations.
18 b) Twenty Thousand Eighteen Dollars (\$20,018) to the Mayor of Tinian's Discretionary
19 Fund.
20 c) Two-Thousand Five Hundred Dollars (\$2,500) to the Tinian Athletic Sports Association
21 (TASA).

22 **SECTION 3. EXPENDITURE AUTHORITY.**

- 1 a) The expenditure authority for funds under Section 2(a) and (b) shall be the Mayor of Tinian
2 and Aguiguan.
- 3 b) The expenditure authority for the funds under Section 2(c) shall be the President of TASA.

4 **SECTION 4. SEVERABILITY.**

5 If any provision of this Act or the application of any such provision to any person or
6 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act
7 or the application of its provisions to persons or circumstances other than those to which it is held
8 invalid shall not be affected thereby.


9 **SECTION 5. SAVINGS CLAUSE.**

10 This Act and any repealer contained herein shall not be construed as affecting any existing
11 right acquired under contract or acquired under statutes repealed or under any rule, regulation or
12 order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding
13 instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of
14 terminating, or in any way modifying, any liability, civil or criminal, which shall already be in
15 existence on the date this Act becomes effective.


16 **SECTION 6. EFFECTIVE DATE.**




