This bill becomes **Tinian Local Law No. 23-17**. Copies bearing my signature are forwarded for your reference.

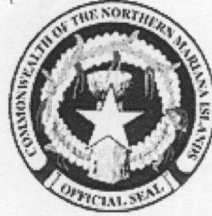

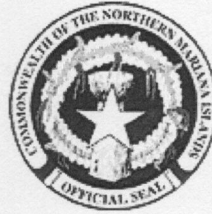

**A LOCAL APPROPRIATION BILL FOR AN ACT
FOR THE SECOND SENATORIAL DISTRICT**

To appropriate One Hundred Fourteen Thousand Dollars (\$114,000.00) from revenues collected from poker fees in the Second Senatorial District; and for other purposes.

**BE IT ENACTED BY THE SECOND SENATORIAL DISTRICT DELEGATION PURSUANT
TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE COMMONWEALTH CODE:**

1 **SECTION 1. PURPOSE.**

2 The purpose of this Act is to appropriate One Hundred Fourteen Dollars (\$114,000.00
3 USD) from revenues collected from poker fees in the Second Senatorial District. The certification
4 of funds was prepared on August 26, 2004 and was certified by the Secretary of Finance on August
5 29, 2024. This appropriation of local funds is not part of the FY2024 Budget Act. Therefore, this
6 local appropriation of local funds does not contravene 1CMC§ 7401 and 1 CMC §7404(d) or any
7 other provision of the CNMI Budget Act.

1 **SECTION 2. APPROPRIATIONS.**

2 Notwithstanding any provision(s) of law, statutes, rules or regulations to the contrary and
3 pursuant to funds allocated to the Second Senatorial District from poker fees, the Tinian and
4 Aguiguan Legislative Delegation hereby appropriates One Hundred Fourteen Dollars
5 (\$114,000.00) of the revenues collected for the Second Senatorial District from the poker fees as
6 follows:

- 7 (A) Six Thousand Dollars (\$6,000.00) to Tinian Municipal Council for operations.
8 (B) Five Thousand Dollars (\$5,000.00) to Tinian and Aguiguan Legislative Delegation
9 for operations.
10 (C) Eighty Thousand Dollars (\$80,000.00) to the Mayor of Tinian for personnel and
11 operations, expenditure of the funds under Section 2 shall be the Mayor of Tinian.
12 (D) Twenty-Three Thousand Dollars (\$23,000.00) to the Mayor's Discretionary
13 Account, expenditure of the funds under Section 2 shall be the Mayor of Tinian.

14 **SECTION 3. EXPENDITURE AUTHORITY.**

- 15 (A) The expenditure authority for funds under Section 2(A) shall be the Chairman of the
16 Tinian Municipal Council.
17 (B) The expenditure authority for funds under Section 2(B) shall be the Chairman of the
18 Tinian and Aguiguan Legislative Delegation.
19 (C) The expenditure authority for funds under Section 2(C) and (D) shall be the Mayor
20 of Tinian and Aguiguan.

1 **SECTION 4. REPROGRAMMING.**

2 Funds appropriated under this act shall not be reprogrammed for any other purpose and
3 notwithstanding any provision of law, all funds appropriated under this Act shall be without fiscal
4 year limitation(s).

5 **SECTION 5. REPORTING OF EXPENDITURES.**

6 The recipient of the funds allocated under Section 2 of this Act shall be responsible to
7 report all expenses responsible to report all expenses to the Secretary of the Department of Finance
8 by the end of the 2024 calendar year. Provided further that failure to provide all expenses, entities
9 that were afforded funds under this Act shall not be able to avail to any future funds appropriated
10 by the Tinian & Aguiguan Legislative Delegation.

11 **SECTION 6. SEVERABILITY.**

12 If any provision of this Act or the application of any such provision to any person or
13 circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act
14 or the application of its provisions to persons or circumstances other than those to which it is held
15 invalid shall not be affected thereby.

16 **SECTION 7. SAVINGS CLAUSE.**


17 This Act and any repealer contained herein shall not be construed as affecting any existing
18 right acquired under contract or acquired under statutes repealed or under any rule, regulation or
19 order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding
20 instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of
21 terminating, or in any way modifying, any liability, civil or criminal, which shall already be in

1 existence on the date this Act becomes effective.


2 **SECTION 8. EFFECTIVE DATE.**

4 without such approval.


