




#### Averting a fiscal disaster

In early March, I informed the Legislature that a revised budget was necessary to keep the Commonwealth government functional and ensure the continuity of essential services. Revising the budget for the current fiscal year became apparent during the fiscal recovery team's discovery that the two sources of federal funds from the Community Disaster Loan and the American Rescue Plan Act, which the previous administration had assured the Legislature would be available to supplement Commonwealth resources for FY 2023, were overspent and over committed. Had we continued on the original budget approved by Public Law 22-22, the Commonwealth Government would have ended in a fiscal disaster with a substantial operating deficit. My administration had no choice but to tighten the fiscal reins, cancel contracts, and reduce the biweekly standard work hours to 72 hours and to request that the Legislature revise the budget plan. The Department of Finance continues its review of ARPA funding to determine the extent of any transfer of funds that are not in compliance with ARPA regulations and law.

#### Properly funding medical referral, government insurance, and the retirees' 25% pension

With the revised budget, a sensible spending plan is in effect, bolstered by the cautious optimism that the Commonwealth's tax revenues will continue to trend upward and exceed the original revenue projections by 11% and the austerity measures that reduced the outlay for personnel expenses. The Health Network Program (medical referral operations under the CHCC), the government's group insurance program

(GHLIP), and the retirees' 25% pension, are now funded by Commonwealth resources as the previous administration had planned to exclusively use ARPA and CDL funds. **Overview, comments and actions on several key sections** 

Section 201. The section mandates allotments shall be made monthly and recognizes the inclusion in allowing advance allotments to the Commonwealth Healthcare Corporation. Advances are especially critical and necessary to accommodate the needs of the CHCC's health network program and arranging for medical care not available in the Commonwealth. With the advance allotments, CHCC is better equipped to take expeditious action the care of patients faced with life-threatening conditions.

**Section 202**. The suspension of earmarks removes the funding reserved for programs established by statute; however, I have vetoed Subsection (p) MPLT interest appropriation Public Law 21-3 because that was not included in the total local revenue and resources available for appropriation as referenced on page 14, line 7. The Legislature should be mindful that certain earmarks should be restored in the next budget cycle to ensure funding for programs that are essential to our economy and to fund the GHLIP. The revitalization of our economy through tourism promotion in countries that have the capacity to increase the number of airline seats to the Commonwealth and proper funding of the government's Aetna health insurance will require reinstatement of the suspended earmarked funds in subsections 202(g), (m), (n), and (o).

**Section 203**. The reporting requirements in this section calls for the Secretary of the Department of Finance to submit written quarterly reports to the presiding officers of the Legislature. I, as well as the Lieutenant Governor, recognize the need for transparency and accountability to monitor the fiscal health of the government.

Section 401. The last sentence has been vetoed as the report requested is included in the reporting requirements of Section 203.

Section 501. This section authorizes the Governor an additional 25% reprogramming authority that will provide flexibility to fund essential services, support personnel and non-personnel expenses such as the GHLIP payments, the Health Network program, fuel, communication, utilities, lease payments and other expenditures that will keep the government operational. Although my reprogramming authority increased in percentage, I am limited to reprogramming only the executive branch appropriation, which may affect the government's ability to address life-threatening situations in this fiscally challenging year.

Section 601. Timely payment of utilities is mandated but without any appropriation to fund the payments. CUC has informed the federal court overseeing compliance of the stipulated order relating to CUC's governance that not only CHCC but the Commonwealth central government also owes CUC substantial amounts that are past due. The Legislature should ensure the adequate funding for CUC utilities in future budget cycles.

**Section 602**. Salary cap exemptions were authorized for the resident department heads for the First and Second Senatorial Districts including the resident deputy commissioners for the Department of Fire. The enactment of Public Law 19-83 excluded any pay adjustments to Cabinet level positions creating a pay disparity between Cabinet appointees and their staff. I request your consideration to enact legislation amending the salary compensation statute to authorize the annual salary compensation of key Cabinet positions within the range of \$65,175 to \$100,000.

**Section 603**. Although I have vetoed this section, I emphasize that it is the availability of funding that effectively prevents the filling of vacant positions. To illustrate, I have yet to fill the positions of chief of staff and legal counsel and other key positions within the Office of the Governor because of the lack of available funding for the office. Some degree of flexibility should be accorded to fill vacant positions if funding becomes available later in the year. The executive branch should not be penalized for not filling vacant positions within an arbitrary deadline.

Section 604. This section has been vetoed on constitutional grounds that any measure that is intended to have the force and effect of law must be originally introduced as a bill in the legislature, which upon passage must be presented to the governor for approval. The procedures sidestep the constitutional lawmaking process and would require only legislative approval through a joint resolution and reduce my office's role to that of a consultant.

Section 703(b) and Section 704(a). The two subsections contain language that would suspend the proportionate reduction clauses of 1 CMC 7204(e) and 1 CMC 7604 (c)(4) of the Planning and Budgeting Act, as amended. All three branches of government receive funding from the same Commonwealth revenues and thus all three branches share the burden through proportionate reduction of their respective budget under the Planning and Budgeting Act should there be a decrease in revenue resources during the fiscal year. Proportionate reduction ensures fairness in the allocating the budget cuts across all three branches. As such, I have decided to disapprove the first sentence of Subsection (b) of Section 703, and Subsection (a) of Section 704.

**Section 705(c).** Under this section, the Secretary of Finance is to reserve \$7.2 million from the CDL to fund the local Medicaid matching. Not only would that provision violate 44 CFR §206.362(f), the previous Torres administration has exhausted all CDL funding and there is no balance in the account to allocate for any use. I have disapproved this provision as a line-item veto.

Sections 705(f), (g), (h), (i), (j), (k); 706(b); 707(f); 710(c). I have vetoed in each subsection referencing the number of NOPs that are apparently unfunded to avoid confusion over its intended effect. Schedule A provides for budget authority based on a two-item lump sum budget that indicates the respective budget ceilings for personnel and non-personnel/operational expenses, and the maximum NOPs each government agency is authorized to hire within the appropriated personnel budget. The provisions were added as explained in the Conference Committee Report to ensure that the unfunded NOPS "do not become funded liabilities in the upcoming Fiscal Year 2024 budget." However, the revised appropriation budget authority law along with the NOPs will expire at the end of the fiscal year. If the Legislature deems it proper to omit the unfunded NOPs from the FY 2023 level, it can do so in the new budget plan for FY 2024.

Section 707(c). I have disapproved this subsection because the appropriation authority for the developer infrastructure tax revenue is outside the scope of this legislation which excludes the developer tax revenue from the total local revenue and resources available for appropriation for the current fiscal year. Further the appropriation authority for the developer infrastructure tax revenue lies with the respective legislative delegation in which the revenues were generated. I will leave the decision to expend the Second Senatorial District's developer infrastructure tax to the discretion of the Tinian and Aguiguan Legislative Delegation.

Section 711. Under the section, Department of Public Lands must carry seven personnel from Tinian and Rota under the Division of Parks and Recreation though the Memorandum of Agreement signed by DPL and DLNR, which only relates to Saipan personnel. The Legislature added language that seven employees are to remain assigned to the Division of Parks and Recreation in Rota and Tinian, and not be placed under

the supervision of DPL. That would violate the fiduciary duties of the DPL Secretary. For that reason, I have disapproved the last sentence of the section.

**Sections 712 and 713.** The sections are disapproved because the reporting required by Section 203 will provide the Legislature with the necessary information to monitor revenue collection, expenditures, and fund status of the various accounts and entities of the Commonwealth government. Specifically as to Section 713, in addition to a separation of powers issue and the confidentiality of taxpayer information, it would be counter-productive to provide direct access on real time to the Department of Finance's information and data in the Munis Financial Management Information System. The department should be given the opportunity to review the data for quality control purposes and to explain the information in the system before its release to the Legislature. My administration will support authorizing the Legislature with access to the MUNIS System limited to the legislative accounts to designated users of the Legislative Branch by submitting a completed Munis System Access Form and Acceptable Use Policy to the Director of the Office of Information Technology through the Office of the Secretary of the Department of Finance. The form can be obtained through the Department of Finance website to initiate the request for access.

In closing, I express my appreciate to the Legislature for enacting the revised budget for the remainder of FY 2023, necessary to maintain essential services in the interest of protecting the public health and welfare. As explained the over-expenditure and over-commitment of ARPA and CDL funds last year precipitated the revision and the shift to the general fund appropriation personnel and other expenditures that under PL 22-22 would have been paid from those two sources of federal funds. Both the Legislature and the Courts are unaffected by the revision as PL 22-22 appropriated from the general fund the budget for their entire personnel costs. Austerity measures that are in presently in place for the executive branch including the shortened hours to 72 is expected to slash expenditures of the executive branch by \$6.9 million.

The road to fiscal recovery and reviving our economy will likely be long and challenging as the Commonwealth reopens to international tourism and travel. I greatly appreciate your input, insights and collaborative efforts as the joint leadership of the Commonwealth advances forward in improving our economy and identifying new sources of revenue.

I urge the Legislature to take note of the comments in this transmittal and act promptly to address the issues raised. This bill except for the vetoed portions becomes **Public Law 23-04**. Copies bearing my signature are forwarded for your reference.

The House of Representatives rejected the Senate amendments and the Bill was sent to Conference, which submitted Conference Committee Report 23-1.

H. B. No. 23-31, HS1, SS2, CCS1 is duly passed by the Twenty-Third Northern Marianas Commonwealth Legislature.


