Dear Mr. Speaker and Madame President:

This is to inform the Legislature that I have signed into law, House Bill 23-66, HS1, SS2, CCS1 (Appropriations and Budget Authority Act of 2024 or the Act) with the exception of several disapproved parts of the Act.

Although I commend the Legislature for passing the Act, I am compelled to express my concern that the Act does not meaningfully address the chronic funding shortfall for critical programs and services, such as:

- Medicaid;
- Medical Referral/Health Network Program;
- CUC Utilities;
- Solid Waste Management;
- Group Health and Life Insurance Program (GHLIP); and
- 25% pension payment.

Instead, the Act offers the flawed solution of punting the obligation to the executive branch to use the 100% reprogramming authorized in this Act. The reprogramming only works if there is sufficient funding available to meet the already anticipated shortfalls. Such funding has not been appropriated to the executive branch in this skeletal budget with only the estimated sum of \$500,000 available for reprogramming. Punting obligations down field or throwing Hail Mary passes hoping for miracles is not the responsible approach to budgeting when lawmakers knowingly approve a spending plan that is not adequately funded.

I also note the disproportionate reduction of funding between the three branches of government from the FY 2023 amended budget appropriation. Without question, the executive branch has the bulk of the responsibility of providing services and programs for our communities. Under this Act, however, the executive branch's budget allocation for operations (non-personnel) has been decreased by an overall 64%, while the corresponding allocations for Judiciary and Legislature decreased by only 27% and

0.46% respectively. Additionally, independent programs within the executive branch, including the Office of the Attorney General, have also been reduced by approximately 90% over FY 2023.

The disproportionate level of funding for the executive branch will force a review on whether to reduce, suspend, or close affected programs and government services because of lack of revenue to support the expenditure plan approved in this Act. The Medicaid Program and the GHLIP will see the most drastic drop in service levels, with Medicaid reducing its available federal funds by \$26.8 million and GHLIP potentially terminating health insurance coverage.

My proposal for the upcoming fiscal year included minimal revenue enhancement to bolster the resources for FY 2024. The Legislature has had time to consider my proposal but has yet to take any action despite promises to pass revenue bills. The promises must translate into positive action to approve revenue generating measures in the first quarter of FY 2024 to close the budget gap for these critical programs and services. Without the additional revenues, it will be almost impossible to operate the Commonwealth government responsibly on such a skeletal budget.

In addition to the foregoing concerns, I have line-item vetoed several parts of the Act of which I have found unclear, ambiguous, or problematic either in their inconsistency with existing provisions of Commonwealth or Federal law, or in their implementation or imposition of additional and unnecessary steps that would hinder efficiency in government operations.

My comments and actions are as follows:

COMMENTS ON APPROVED PARTS OF THE ACT

Sections 201 and 202

The suspension of earmarks that are intended to ensure continued funding of the GHLIP is an unwise decision that puts at risk the government's group health insurance program. Compared to the administration's proposal of \$6.6 million from the earmarked funds for GHLIP, the Act only provides the sum of \$68,590 to cover the government's contribution toward premiums to 2,142 health insurance subscribers comprising of both employees and retirees. If the budget gap is not resolved within the first quarter of FY 2024 through the passage of revenue generating measures, this will jeopardize the administration's ability to negotiate the continuation of health insurance coverage beginning January 1, 2024. I urge the Legislature to act swiftly on revenue generating legislation to close the budget gap, secure the funding of the GHLIP, and assure enrollees and their dependents of their continued access to health care insurance. Without the required funding in place, the suspension may force the cancellation of our current contract with our provider, leaving government employees and the retirees without any health insurance coverage.

Section 201 and 202 extended the suspension to the CIQ Overtime Revolving Fund. The Legislature is reminded that airlines pay Customs and Biosecurity personnel through NMIAC §§ 70-10.1-705(a) and 70-10.1-720, to cover the compensation of on-duty officers outside of normal working hours. Most international flights and those from Guam into Saipan occur outside of normal working hours. Suspending the regulations that govern the fees assessed for this particular purpose and the use of the fees to pay for such compensation lacks the assurance that the fees will be used to cover the costs as provided by regulation.

The earmark for Revenue and Tax enforcement under 4 CMC § 1803 takes away a dedicated source of funding for enforcement at a time when enforcement and collection is critical to meet our revenue projections. Taking away the minimal funding for such enforcement efforts is inconsistent with Senate Joint Resolution 23-02, and the objectives of meeting projection targets and collecting more revenue through enforcement. In the past two months the task force assembled by the Secretary of Finance has netted about \$1.9 million in actual payments of taxes due and \$2.1 million in pending installment agreements.

Section 403. Donation of Sick Leave Hours

The inclusion of Section 403 to address the donation of sick leave hours is timely in rectifying existing policies in their applicability to save the government from further compounding its obligations related to the use of the donated sick leave.

Section 501. Reprogramming Authority

As I have stated, under the skeletal budget appropriation of this Act, almost no flexibility is provided the governor to use the 100% reprogramming authority for Fiscal Year 2024 to move funds within the executive branch to cover the already anticipated shortfalls for Medicaid, Medical Referral/Health Network Program, GHLIP, CUC Utilities, Solid Waste Management program and the 25% pension payment.

Section 607. Cell #1 Marpi Landfill Closure Financial Assurance Mechanism

This section is an attempt to mitigate the impact of suspending Solid Waste Fund authorized under by 2 CMC §3551. I am hopeful that the collaborative efforts of the Department of Public Works, the Office of Planning and Development, and the Bureau of Environmental and Coastal Quality, and the U.S. Environmental Protection Agency will focus on the resources needed for this high priority project to complete the CNMI Comprehensive Solid Waste Management Plan so that the assurance requirement can be lifted utilizing the *Additional Supplemental Appropriation for Disaster Relief Act* (ASADRA) allocation that will address the closure of Cell #1.

Section 711. Department of Public Lands

This section requires the Department of Public Lands to carry seven personnel from Tinian and Rota under the Division of Parks and Recreation though the Memorandum of Agreement (MOA) signed by DPL and DLNR, which only relates to Saipan personnel. The MOA should be amended to include the seven personnel.

VETOED PARTS OF THE ACT

Section 203. Reporting Requirements for Secretary of Finance

I have disapproved Subsection (d) because the Secretary of Finance does not have the financial records for the Public School System, the Commonwealth Healthcare Corporation, Northern Marianas College, and the Marianas Visitors Authority. The Legislature should directly request the autonomous agencies and public corporations to provide the information relating to quarterly allotments for all local and federal funds. The Department of Labor's Contract Workers fee records will be included in the fund status report requirement in Section 801.

Section 401. Management of Funds.

The reporting requirements in Section 401 have been vetoed because they are duplicative of other reporting mandates in this Act and under the Planning and Budgeting Act.

Section 601. Utilities.

I am disapproving Section 601(c). I emphasize again that although I have been given 100% reprogramming authority of the appropriation for the executive branch, the stark reality of this Act severely limits what I can chip off the skeletal appropriation to close the budget gap for all underappropriated programs, including the under-funded utilities expenditure for executive branch departments and agencies. I am left with no alternative but to disapprove the provisions that would strap onto an already under-funded executive branch utilities account, the additional obligation to cover any budget shortfall for the utilities of the judicial and legislative branches, and the municipal governments. The budget process as designed by Commonwealth law provides for a realistic and rational approach to financing the operational needs of the government with adequate resources. Section 601 is wholly incompatible with that approach.

The Legislature is reminded that the timely payment of the government's usage of CUC utility services is being monitored by the federal District Court in *U.S. v. CUC and Commonwealth*. Although the central government's past due account has been significantly reduced, the Judicial Branch has a substantial past due amount. CHCC, a public corporation, has a staggering \$57 million past due for CUC utility services that must be addressed collaboratively with CHCC to settle the outstanding balance.

Section 605. Legal Holidays

I have disapproved Section 605 because of its ambiguous and vague language. It is unclear whether only federally funded employees would receive leave with pay for holidays and holiday pay for work performed on holidays. The lack of clarity also presented a legal question whether the restriction would apply only to new employees hired during the fiscal year.

Section 606. Excepted Service Employee

The vetoed provision would not have provided the necessary flexibility for salary adjustments under circumstances that warrant the retention of high performing employees. The limited appropriation provided under the Act dictates the careful exercise of discretion to raise salaries.

Section 608. Reduction of Work Hours

The section relates to the earning of leave and other benefits when austerity measures authorize a full pay period of less than 80 hours. The last sentence has been disapproved for clarity.

Section 703(b). Judicial Branch

While I do not object to providing an advance allotment for the Judicial Branch, fulfilling the remittance portion may be problematic when actual revenue collections are less than the projections. For this reason, I have disapproved this provision.

Section 707. Second Senatorial District

My budget proposal for the Second Senatorial District, Office of the Mayor was formulated based on the cash availability received from the American Rescue Plan Act (ARPA) which was confirmed by the Mayor of the Municipality of Tinian and Aguiguan. The same methodology was applied to the Third Senatorial District after confirming their ARPA cash availability. This methodology is consistent with the Planning and Budgeting Act, which requires the formulation of the Commonwealth budget by taking into account all revenue sources available.

I am disapproving Subsection (b), that would transfer both 24 NOPs under the Mayor's Office and their ARPA funding in fiscal year 2024 to the Commonwealth Treasury. The transfer of the employees and funding are not included in Schedule A. The Mayor's Office retains the option of keeping the 24 NOPS and funding them directly under its ARPA funds.

Section 709. Other Programs

I have disapproved the requirement in Subsection (e) that the CNMI Medical Referral Program/Health Network Program will include stipends, airfare, and lodging for patients and escorts in the inter-island medical referral services. The appropriation for the Health Network Program is insufficient to cover such costs. CHCC should have the flexibility to identify outside sources to address the budget gap.

Section 712. Reporting Requirements

I am disapproving Section 712 provisions because they duplicate the reporting requirements set forth in Section 203 and create additional and unreasonable administrative burdens that will be difficult to implement, especially in light of severely limited resources and current conditions of the government's financial books.

As you are aware, my administration inherited a government that was in total financial disarray, and the Commonwealth was behind on its single audits by two years. We are receiving assistance from federal partners and working closely with technical advisors to complete the single audits, reconcile data, and make all necessary adjustments in MUNIS. Because significant irregularities and questioned costs have been identified by my Fiscal Response Team and by the Inspector General, we are also pursuing forensic audits of the Commonwealth's American Rescue Plan Act and CARES Act expenditures.

As this work of the Department of Finance and the Fiscal Response Team is still ongoing, I am disapproving Section 712(b) at this time because implementation will be impractical and the risk of misleading or inaccurate analysis will be high absent the necessary manual adjustments that are continually being made.

That said, I fully appreciate, and share, the Legislature's desire for transparency, improved access to accurate data, and timely reporting. I am therefore directing the Secretary of Finance to work with the Legislature to develop appropriate protocols for expanding the Legislature's access to MUNIS, ensuring quality control for reports generated from MUNIS, and training the staff of the Legislative Branch in using and navigating MUNIS to obtain financial data in the format the Legislature requires in order to perform its own analyses.

Section 713. Violation of Spending Limits

I have disapproved the additional penalties and sanctions in Section 713. The Planning and Budgeting Act (PBA), as amended, has adequate enforcement provisions to assure compliance with the expenditure restrictions under the PBA and this Act.

Section 802. Outside Sources

I have disapproved parts of Subsection (b) because of inconsistency between the original language and U.S. Public Law 115-218 which governs the use and administration of the CW funds. The federal law does not limit training programs to only those for vocational training. The federal law also provides restrictions on the administration of the funds including reprogramming and fiscal year limitation.

As we implement the budget appropriation in this Act, I remind the Legislature of the urgency to pass revenue generating legislation, including my proposal for a limited increase in the gross revenue tax, to close the budget gaps for critical services and programs. The 100% reprogramming authority provided in this Act will not effectively address the severe under-appropriation of our Medicaid match, the GHLIP, Medical Referral/Health Network Program, CUC utilities and the 25% pension payment. For this reason, I urge the Legislature to fast-track the passage of revenue enhancement legislation. Failure to do so will jeopardize the critical services and programs that affect the lives and livelihood of our community, the health care of our public servants and retirees, and the essential services provided by CHCC and CUC.

My administration stands ready to work with the Legislature to iron out our differences and work collectively and cooperatively to address the government's fiscal challenges.

With my signature, this bill becomes Public Law No. 23-09. Copies of the public law bearing my signature are forwarded for your reference.

with amendments in the form of H. B. No. 23-66, HS1 and transmitted to THE SENATE.

IN THE SENATE

The Bill was referred to the Senate Committee on Fiscal Affairs.

THE BILL WAS PASSED BY THE SENATE ON FIRST AND FINAL READING, SEPTEMBER 11, 2023; with amendments in the form of H. B. No. 23-66, HS1, SS2 and returned to THE HOUSE OF REPRESENTATIVES.

The House of Representatives rejected the Senate amendments and the Bill was sent to Conference, which submitted Conference Committee Report 23-3.

H. B. No. 23-66, HS1, SS2, CCS1 IS DULY PASSED BY THE TWENTY-THIRD NORTHERN MARIANAS COMMONWEALTH LEGISLATURE.

TO MAKE APPROPRIATIONS FOR THE OPERATIONS AND GOVERNMENT OF THE ACTIVITIES OF THE THE NORTHERN MARIANA COMMONWEALTH OF ISLANDS, ITS AGENCIES, INSTRUMENTALITIES, AND INDEPENDENT PROGRAMS, AND TO PROVIDE BUDGET AUTHORITY FOR GOVERNMENT CORPORATIONS FOR FISCAL YEAR 2024; AND FOR OTHER PURPOSES.

BE IT ENACTED BY THE TWENTY-THIRD NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

SECTION 101. SHORT TITLE.

This Act may be cited as the "Appropriations and Budget Authority Act of 2024".

SECTION 102. PURPOSE.

This Act appropriates local funds for the operations and activities of the Government of the Northern Mariana Islands, its agencies, instrumentalities, independent agencies, and political subdivisions, and provides authority for government corporations for Fiscal Year 2024 commencing October 1, 2023 and ending September 30, 2024.

CHAPTER III.

GOVERNMENT CORPORATIONS AND DESIGNATED AGENCIES/ACTIVITIES

SECTION 301. APPROPRIATION AND BUDGET AUTHORITY.

Pursuant to 1 CMC § 7206 and as provided herein, budget and expenditure authority for the following activities is hereby approved. Expenditures in excess of the budget authority approved herein for agencies to which public funds are appropriated shall not be incurred or committed and hiring in excess of the number of positions authorized by this Act is prohibited, unless authorized by a legislative joint resolution in accordance with Section 7, Article X of the N.M.I. Constitution.

Notwithstanding the above dollar amounts, the entities above shall expend only the lesser of funds actually generated, collected, or received, or the amounts indicated above.

SECTION 302. PRIOR CERTIFICATION OF FUNDS.

No contract shall be entered into with the Commonwealth or any government entity therein without first receiving from the Secretary of the Department of Finance certification that lawful and sufficient funds have been appropriated. Notwithstanding any Commonwealth laws, regulations, or provisions to the contrary, this section shall not apply to the Judicial Branch, the Public School System, and the Northern Marianas College.

SECTION 303. REPORTING REQUIREMENT.

The expenditure authorities of the foregoing activities listed in Section 301 shall submit to the Presiding Officers of the Legislature, at the end of each quarter, a fund status report on the expenditures for personnel and operations of each government entity, and the payments of the public auditor's fee, for the quarter ended and, if applicable, year-to-date totals as of the close of the reporting period.

Furthermore, notwithstanding any provisions or laws to the contrary, all additional resources realized within the fiscal year outside of those specified and identified under this Act shall be reported in detail to the Legislature for-appropriation purposes.

CHAPTER IV. ADMINISTRATION OF APPROPRIATED FUNDS SECTION 401. MANAGEMENT OF FUNDS.

The expenditure of the funds appropriated and allocated under this Act shall be regulated and controlled by the Secretary of Finance so that no agency, department, instrumentality, program, or activity may expend the funds contrary to the law or fiscal management policies and practices of the Commonwealth. Provided further that, in addition to the report required under 1 CMC § 7209, the Secretary of Finance shall submit within

230 calendar days at the end of each quarter, a fund status report on the expenditures for personnel and operations of each business unit funded in whole or in part by the General Fund for the quarter ended and, if applicable, year to date totals as of the close of the reporting period.

SECTION 402. NUMBER OF POSITION(S) (NOP) CEILING.

Employment Ceilings. Pursuant to Article X, § 7 of the Commonwealth Constitution, the employment ceilings relative to the number of positions are hereby established as set forth in this Act.

SECTION 403. DONATION OF SICK LEAVE.

Notwithstanding any laws to the contrary, when an employee volunteers to donate sick leave, the donated sick leave shall be based on the donor's current base hourly salary and shall be converted into equivalent sick leave hours based on the recipient's current base hourly salary. Provided that the donated sick leave hours shall not exceed 1040 hours.¹

¹ Conversion:

⁽Sick Leave Hours Donated) multiplied by (Donor's Hourly Base Rate) = (Donor's Donated Dollar Value) (Donor's Donated Dollar Value) divided by (Recipient's Hourly Base Rate) = (Number of Hours Donated to Recipient)

SECTION 501. REPROGRAMMING AUTHORITY.

SECTION 404. EXPENDITURE AUTHORITY.

- (a) Notwithstanding 1 CMC § 7401(b), the Governor shall have 100% reprogramming authority for the departments, agencies, and offices of the executive branch, provided that the municipal entities shall not be subject to this reprogramming authority without the consent of the mayor. Provided further that the reprogramming authority shall not apply to Section 604 of this Act. Reprogramming shall not be used for the hiring of personnel or salary adjustment of active personnel. This authority to reprogram shall not apply to the funds appropriated to the Legislative or Judicial Branches as well as to those funds appropriated by the respective legislative delegations.
- (b) Pursuant to 1 CMC § 7402(e), all reprogramming shall be reported in writing to the Presiding Officers of the Legislature, the Chairperson of the House Committee on Ways and Means, and the Chairperson of the Senate Committee on Fiscal Affairs within 30 days after the end of each quarter of the fiscal year. Such reports shall include a description of each item reprogrammed, the reason for each reprogramming, the change in the approved budget caused by the reprogramming, the cumulative amount of all reprogramming during the fiscal year, and such other information as may be requested by the Chairpersons. The Governor shall submit

to the Presiding Officers and Chairpersons an annual summary of all reprogramming activity within 60 days after the end of a fiscal year.

CHAPTER VI. SUPPLEMENTAL ADMINISTRATIVE PROVISIONS SECTION 601. UTILITIES.

- (a) Except as provided in subsection (c), the CUC monthly utility billings for all departments and agencies shall be paid by the central government after all the funds in the general revolving accounts are exhausted.
- (b) For prepaid meter accounts, the authorized designee of the respective government agencies or offices shall follow the protocol of the Department of Finance for timely payment.
- (e) Except for the Judicial Branch and Legislative Branch, all utilities, including the municipalities of Rota, Tinian, Saipan, and the Northern Islands, shall be paid by the central government. Provided that any shortfall of utility payments of the Judicial Branch and Legislative Branch shall be paid by the central government.

SECTION 602. HIRING RESTRICTION.

- (a) Except as provided in subsection (b) of this section and Section 706(b), no new or vacant position shall be filled in the executive branch, except for positions that are essential for the delivery of public services such as the Department of Public Safety and the Department of Fire and Emergency Services personnel for each respective Senatorial District and other essential positions as determined by the Governor.
- (b) Notwithstanding any law or regulation to the contrary, if a Notice of Personnel Action has been executed by the hiring agency or a candidate to fill the vacancy has been selected or action has been initiated to fill the position by any department or agency and filed

at the Office of Personnel Management on Rota, Tinian, or Saipan, the vacant position shall be considered as processed and to be filled. The renewal of the contract for an existing employee shall not be considered as creating a vacant position.

SECTION 603. SALARY CAP.

- (a) For Fiscal Year 2024, the compensation of certain appointed officials shall be compensated as set forth in the attached Schedule A and pursuant to 1 CMC § 8245 and 1 CMC § 28003.
- (b) For Fiscal Year 2024, notwithstanding 1 CMC § 8245(c), the annual salary of the Resident Department Heads of the First and Second Senatorial Districts shall not exceed \$40,000 as set forth in the attached Schedule A.

SECTION 604. REVOLVING ACCOUNTS.

Subject to constitutional limits, notwithstanding any CNMI and/or local laws, regulations, and rules to the contrary and except for the suspended accounts as provided in Section 202 and special revenue accounts, all general revolving account expenditure limitations and restrictions relating to the scope of application or other subject matter requirements are hereby suspended in FY 2024. Accordingly, all legally established general revolving accounts and the funds therein may be expended by their respective expenditure authorities for the following operational expenses: fuel, communications, operational office supplies, and inter-island travel for training purposes. Provided further that Section 501 of this Act shall not apply to this section.

SECTION 605. LEGAL HOLIDAYS.

(a) Any employee required to work on a non-federal Commonwealth legal holiday shall be paid at the basic salary rate for the hours worked on that day without any additional adjustment for heliday leave with pay. Except for employees that are 100% or partially funded with federal funds

(b) Provided that any employee whose salary is partially or fully paid by federal funds shall receive leave with pay for logal helidays.

SECTION 606. EXCEPTED SERVICE EMPLOYEE.

The legislature recognizes that there are employees who are on an Excepted Service Contract in the government, including the municipalities. Upon renewal of an excepted service contract, the employee shall not receive a salary increase.

SECTION 607. <u>CELL#1 MARPI LANDFILL CLOSURE FINANCIAL ASSURANCE</u> MECHANISM.

In the event of any funding shortfalls caused by this Appropriations Act, the CNMI Government shall be fully responsible for all costs and expenses, not to exceed \$5,400,000.00, that are necessary to effectuate the closure of Cell #1 of the Marpi Landfill.

SECTION 608. REDUCTION OF WORK HOURS.

During Fiscal Year 2024, notwithstanding any laws or contractual provisions to the contrary, a full pay period for purposes of earning annual leave, sick leave, or other benefits, shall be 80 hours less the amount of hours deducted via austerity measures. This provision shall

CHAPTER VII. APPROPRIATIONS

SECTION 701. IN GENERAL.

Funds designated in Chapter II as available for appropriation for Fiscal Year 2024 are hereby appropriated pursuant to this Chapter.

SECTION 702. APPROPRIATION.

The amount of \$119,199,812 is hereby appropriated as set forth in the attached Schedule A which is inclusive of the Department of Public Lands.

SECTION 703. JUDICIAL BRANCH.

- (a) The Number of Personnel and appropriations for personnel, operations, and utilities for the Judicial Branch shall be as shown in Schedule A.
- (b) Notwithstanding 1 CMC § 7204 (e), funds appropriated for Fiscal Year 2024 to the Judicial Branch shall be allotted monthly. Provided that the allotment request for the last menth of the fiscal year shall be made no later than August 1st and the requested advance shall be remitted on or before August 15th.
- (c) Notwithstanding any laws to the contrary, the Chief Justice of the CNMI Supreme Court and Presiding Judge of the CNMI Superior Court may adjust the Judicial Branch work schedule and operating hours that are consistent with available funds for personnel and operations.

(d) The Chief Justice and the Presiding Judge may use any available outside source funds, including revolving accounts, to restore the reduced work hours of the Judicial Branch personnel.

SECTION 704. LEGISLATIVE BRANCH.

The Number of Personnel and allocations for personnel, operations, and utilities for the Legislative Branch shall be as shown in Schedule A.

- (a) Art. II Sec. 16(e) of the Commonwealth Constitution provides:
 - e) Beginning the second Monday of January 1998, the amount of the ceiling and all other dollar amounts stated in this section shall be adjusted every two years by the same percentage as the percentage change in the United States Department of Commerce composite price index during the two preceding fiscal years using the beginning of the fiscal year 1996 as the base.

The allocation ceilings have automatically increased every two years, beginning in January 1998. Using the price composite indexes developed by the Department of Commerce, Bureau of Economic Analysis for State and Local Government Consumption Expenditures and Gross Investment, the allocation ceilings for the Legislature for fiscal years 2022 and 2023 are as follows:

- (b) Notwithstanding 1 CMC § 7204 (e), funds appropriated for Fiscal Year 2024 to the Legislative Branch shall be allotted monthly.
- (c) Notwithstanding any laws to the contrary, the Legislative Bureau Director may adjust the Legislative Branch work schedule and operating hours that are consistent with available funds for personnel and operations.
- (d) The Legislative Bureau Director may use any available outside source funds to restore the reduced work hours of the LB personnel.
 - (e) Salaries of Legislative Members.
 - (1) The amount appropriated under this section to the House of Representatives under "personnel" shall be used to fund the salaries and benefits of the members of the House of Representatives. The expenditure authority for the amounts appropriated shall be the Speaker of the House.
 - (2) The amount appropriated under this section to the Senate under "personnel" shall be used to fund the salaries and benefits of the members of the Senate. The expenditure authority for the amounts appropriated shall be the President of the Senate. (f) Members' Office Accounts and Employees.
 - (1) Notwithstanding 1 CMC § 7401(c) to the contrary, each member shall be the expenditure authority of the funds appropriated to their individual sub-account;
 - (2) Funds appropriated for the operation of the member's office, including, but not limited to, the personnel costs of the member's employees and expenditures as authorized by the adopted rules of the Senate in the case of the Senate member, or the adopted rules of the House of Representatives in the case of a House member, or the

Legislative Bureau, may be expended to defray travel and incidental expenses for the purpose of attending to legislative business; provided that a member may receive a one-month advancement of funds appropriated to his or her office for expenditures;

- (3) Allocation of the maximum number of positions among House members shall be governed by the rules of the House; and
- (4) Allocation of the maximum number of positions among Senate members shall be governed by the rules of the Senate.
- (g) Senate and House Leadership Accounts. The leadership account of each house shall be \$100,000. The Presiding Officer of each respective house, or his lawfully authorized designee, shall be the expenditure authority and shall use such funds to support the operations and activities of the House of Representatives and Senate in accordance with its rules, provided that the Presiding Officer distributes a portion of the total allocation in equal amounts to all the standing committees for their operations and activities.
- (h) Legislative Bureau, BU 1770. The Number of Personnel and allocations for personnel, operations, and utilities for the Legislative Bureau shall be as shown in Schedule A. The expenditure authority of the funds appropriated for the Legislative Bureau shall be the Director of the Legislative Bureau or authorized designee. Notwithstanding any other law to the contrary, the expenditure authority for the Legislative Bureau shall have reprogramming authority to move funding from Personnel to Operations.
- (i) Northern Marianas Youth Congress, BU 1593. The Number of Personnel and allocations for personnel and operations for Youth Congress shall be as shown in Schedule A.

The expenditure authority is vested in the Director of the Legislative Bureau with the consent of the Speaker of the Northern Mariana Islands Youth Congress.

SECTION 705. EXECUTIVE BRANCH.

The allocation for the Executive Branch shall be as shown in Schedule A.

- (a) The Governor shall have authority to expend, obligate, encumber, or otherwise commit, all the funds appropriated to the Office of the Governor and all Other Offices of the Governor.
- (b) The Lt. Governor shall be the expenditure authority of the funds appropriated to the Office of the Lt. Governor.

SECTION 706. <u>FIRST SENATORIAL DISTRICT – MAYOR OF ROTA AND ROTA</u> <u>MUNICIPAL COUNCIL.</u>

The Number of Personnel and allocations for personnel, operations, and utilities for the First Senatorial District shall be as shown in Schedule A.

(a) Except as provided in this section, the Mayor of Rota shall have authority to expend, obligate, encumber, and otherwise commit, all the funds appropriated to the First Senatorial District. Appropriations to the Municipal Council shall be divided and distributed equally to each member of the Municipal Council in separate accounts. Each Municipal Council member shall be the expenditure authority of funds distributed to him/her. Additionally, except as provided in this section, in accord with the Superior Court's decision in the case of *Inos v. Tenorio*, the Mayors shall also have expenditure authority over resident government departments in the First and Second Senatorial districts respectively unless the Governor revokes expenditure authority in a manner consistent with the Superior Court's holding in

Inos v. Tenorio, to wit: expenditure authority over resident departments that are primarily concerned with the delivery of public services can be revoked only on a prior showing of just cause, but the Governor has the discretion to revoke expenditure authority over those departments that are primarily concerned with enforcing the law.


- (b) The three NOPs shall be provided to the Rota Customs Services for Customs Inspector positions, BU 1152. Upon the hiring of these three new positions the three NOPs under the Office of the Mayor of Rota shall be unfunded and removed.
- (c) Any shortfall in the appropriated funds as a result or due to payment of overtime, retirement, or benefits shall be borne by the municipality.

SECTION 707. SECOND SENATORIAL DISTRICT - MAYOR OF TINIAN & AGUIGUAN AND TINIAN MUNICIPAL COUNCIL.

The Number of Personnel and allocations for personnel, operations, and utilities for the Second Senatorial District shall be as shown in Schedule A.

(a) Except as provided in this section, the Mayor of Tinian and Aguiguan shall have authority to expend, obligate, encumber, or otherwise commit or reprogram, all the funds appropriated to the Second Senatorial District. Appropriations to the Municipal Council shall be divided and distributed equally to each member of the Municipal Council in separate accounts. Each Municipal Council member shall be the expenditure authority of funds distributed to him/her. Additionally, in accord with the Superior Court's decision in the case of *Inos v. Tenorio*, the Mayors shall also have expenditure authority over resident government departments in the First and Second senatorial districts respectively unless the Governor revokes expenditure authority in a manner consistent with the Superior Court's

holding in *Inos v. Tenorio*, to wit: expenditure authority over resident departments that are primarily concerned with the delivery of public services can be revoked only on a prior showing of just cause, but the Governor has the discretion to revoke expenditure authority over those departments that are primarily concerned with enforcing the law.



- (c) One new NOP shall be funded under BU 1485 at \$29,551 for a Landfill Supervisor for the Department of Public Works-Tinian.
- (d) Unfunded personnel under Department of Public Safety-Tinian and Department of Fire and Emergency Medical Services-Tinian shall be funded an additional \$1 each.
- (e) Any shortfall in the appropriated funds as a result or due to payment of overtime, retirement, or benefits shall be borne by the municipality.

SECTION 708. THIRD SENATORIAL DISTRICT – MAYOR OF SAIPAN; MAYOR

OF THE NORTHERN ISLANDS; AND SAIPAN AND NORTHERN ISLANDS MUNICIPAL

COUNCIL.

The Number of Personnel and allocations for personnel, operations, and utilities for the Office of the Mayor of Saipan, Office of the Mayor of the Northern Islands, and the Saipan and Northern Islands Municipal Council shall be as shown in Schedule A.

The Mayor of Saipan, the Mayor of the Northern Islands, and the Chairperson of the Municipal Council for Saipan and the Northern Islands or each of their respective designees shall be the expenditure authority for allocations for their respective offices.

SECTION 709. OTHER PROGRAMS.

The Fiscal Year 2024 Budget Appropriation for the programs under this section shall be as shown in Schedule A.

- (a) Northern Marianas College. The President of the Northern Marianas College or designee shall be the expenditure authority of the funds under BU 1605.
- (b) NMC Board of Regents. The Chairperson of the Board of Regents of the Northern Marianas College or designee shall be the expenditure authority of the appropriated funds under BU 1627.
- (c) Public School System. The Commissioner of Education or designee shall be the expenditure authority of the appropriated funds under BU 1607. Funds appropriated to PSS shall not be used for personnel and operations of the Board of Education.
- (d) Board of Education. The Chairperson of the Board of Education or his/her designee shall be the expenditure authority of the appropriated funds under BU 1624. The funds appropriated to the Board of Education shall include the cost and expenses of the student and teacher representatives to the Board of Education.
- (e) CNMI Medical Referral Program (Health Network Program). The Commonwealth Healthcare Corporation shall administer the CNMI Medical Referral Program or its successor, including both inter-island and off-island referrals, consistent with its duties and responsibilities under 3 CMC § 2821 et seq. More specifically, the inter-island medical referral

with the off island medical referral program. The expenditure authority for all funds appropriated to inter-island and off-island medical referral services and administration (inclusive of BU 1979, 1979A, and any new business units established for CHCC Medical Referral) shall be the CEO of the Commonwealth Healthcare Corporation or designee.

(f) Northern Marianas Technical Institute. The Chairperson of the Board of Trustees or designee in consultation with the Chief Executive Officer shall be the expenditure authority of the appropriated funds for the Northern Marianas Technical Institute.

SECTION 710. INDEPENDENT PROGRAMS.

The Fiscal Year 2024 Budget Appropriation for the agencies under this section shall be as shown in Schedule A.

- (a) Joeten-Kiyu Public Library. The Chairperson of the Commonwealth Library Council or designee shall be the expenditure authority of the appropriated funds.
- (b) NMI Museum of History and Culture. The Chairperson of the Board of Governors of the NMI Museum of History and Culture or designee shall be the expenditure authority of the appropriated funds.
- (c) Elected Attorney General. The Attorney General or designee shall be the expenditure authority of the appropriated funds.
- (d) The expenditure authority of the funds appropriated for the Public Assistance Program shall be the Governor.
- (e) Medicaid Program. The funds appropriated in this Act for the Medicaid Program, including Medicaid Reimbursement, BU 1951, Medicaid Agency, BU 1980, and Medicaid

Enterprise Systems (MES), BU 1981 shall be deemed a single budget reserved for the purposes of Medicaid Agency, Medicaid Reimbursement, and Medicaid Enterprise Systems. The Director of the Commonwealth Medicaid Agency may reallocate the funds appropriated in this Act to any of the expenditure categories, including, but not limited to, Agency, Reimbursement, and Medicaid Enterprise Systems. Provided further that for the Fiscal Year 2024, pursuant to the request of CNMI Medicaid, with the concurrence of the Office of Personnel Management, notwithstanding any other law to the contrary, all of the 11 NOPs for the Medicaid Enterprise Systems & Health Information Technology funded under BU 1981 shall be excepted service contract employees.

(f) For programs and activities not specifically mentioned, the expenditure authority shall be the Secretary of Finance.

SECTION 711. DEPARTMENT OF PUBLIC LANDS.

Pursuant to 1 CMC § 2803, \$4,960,881 is appropriated to the Department of Public Lands. In addition to the 84 NOPs set forth in Schedule A allotted to the Department of Public Lands (DPL) inclusive of the Saipan-based NOPs assigned to DLNR's Division of Parks and Recreation pursuant to the Memorandum of Agreement between DPL and the Department of Lands and Natural Resources (DLNR), DPL shall also assume fifty percent (50%) personnel obligations associated with seven (7) existing and current NOPs with the funds appropriated to DPL. These seven (7) NOPs shall consist of four (4) NOPs for the Division of Parks and Recreation Rota and three (3) NOPs for the Division of Parks and Recreation Tinian, provided further, these NOPs shall remain assigned to DLNR Division of Parks and Recreation.

SECTION 712.	REPORTING	REQUIREMENTS

(a) The expenditure authorities of the foregoing activities listed in Chapter VII shall submit to the Presiding Officers of the Legislature, within 30 days after the end of each quarter, a fund status report on the expenditures for personnel and operations of each government entity; and the payments of the public auditor's fee, for the quarter ended and, if applicable, year todate totals as of the close of the reporting period. Failure to report on the expenditures of such funds by each respective government entity shall result in a suspension of their future allocations until the delayed quarterly report has been submitted to the Presiding Officers of the Legislature.

(b) Access Provided to Legislative Fiscal Analysts

Notwithstanding any provision of law to the contrary, training and access to the following shall be provided:

(A) the Munic Financial Management Information System or other financial and accounting system to obtain the following: monthly collections and expenditures; including but not limited to funds status, and detailed expenditure reports in a format that is expertable or convertible to Excel files; and

(B) the following reports in a format that is expertable or convertible to Excelfiles shall be provided to the CNMI Legislative Fiscal Analysts 30 days after the effective date of this Act:

(i) All revolving accounts:

(ii) All business activities listed in Schedule A;

(iii) All accounts listed as earmorks in the Rudget Authority Act.

(v) All revenue accounts in the First, Second, and Third Senatorial Districts that are identified as budgetary resources in the Budget Authority Act;

(C) Any other financial information, not legally privileged or protected, relating

in writing within 10 days of said request

SECTION 713. VIOLATIONS OF SPENDING LIMITS.

The expenditure of funds in excess of allocations and reprogramming established by this Act is a violation of the Planning and Budget Act, 1 CMC § 7101 et seq. Any expenditure authority that violates The Planning and Budget Act shall be suspended without salary for at least 30 days and the salary shall not be restored until a fiscal plan is submitted to the Presiding Officers of the Legislature, Chairperson of the Senate Committee on Fiscal Affairs, and the Chairperson of the Heuse Committee on Ways and Means, and accepted by both houses of the hegislature to retire the over expenditure. Provided, they also shall not be entitled to indemnification, defense, or reimbursement under the Government Liability Act or any other Commonwealth Law.

CHAPTER VIII. OUTSIDE SOURCES

SECTION 801. ADMINISTRATIVE PROVISIONS.

(a) Notwithstanding 1 CMC § 7204, the outside source funds appropriated for Fiscal Year 2024 shall be allotted monthly; except programs that require one-time payments may receive advance allotments.

(b) Notwithstanding any law to the contrary, the Secretary of Finance shall submit to
the Presiding Officers of the Legislature, at the end of each quarter, a fund status report on the
outside-sourced funds that are transferred in and out of government business units and their
respective accounts, pursuant to Section 802 of this Act.
(c) All salaries of elected officials that are waived under 1 CMC § 8442 shall be

transferred by the Secretary of Finance to the Scholarship Trust Account and the funds from the account shall be spent for scholarship purposes only, without further appropriation, and without fiscal year limitation. The Administrator of the CNMI Scholarship Office shall provide a report to the Presiding Officers of the legislature within 30 days after the end of each quarter.

SECTION 802. OUTSIDE SOURCES.

The following amounts from sources outside the General Fund are available for allocation.

(a) Tobacco Settlement Funds. Pursuant to 3 CMC § 2173 and the funds allocated in this section pursuant to the submittal of a program and expenditure plan to the Secretary of Finance, the Tobacco Settlement funds in the amount of \$540,000.00, not subject to reprogramming or fiscal year limitation, shall be allocated as follows:

(1) Division of Public Health 40%:	\$216,000
(2) Public School System 20%:	\$108,000
(3) Youth Affairs Office 12.5%:	\$67,500
(4) Coalition of Private Schools 7.5%:	\$40,500
(5) Rota Mayor 10%:	\$54,000
(6) Tinian and Aguiguan Mayor 10%:	\$54,000

The expenditure authorities of the funds allocated pursuant to this Section 802(a) shall be the persons authorized by law for each respective office or agency. The expenditure authorities shall provide accountability and transparency by providing within 30 days after the end of each quarter an expenditure report of the funds to the governor and the Presiding Officers of the Legislature.

(b) Commonwealth Worker Fund (Source: U.S.P.L. 115-218).

In accordance with U.S. Public Law 115-218, the sum of \$2,000,000.00 in Commonwealth Worker Fee Funds shall be available for the sole and exclusive purpose of funding vocational education, apprenticeships, or other training programs for United States workers by Commonwealth educational entities for Fiscal Year 2024. Provided that the \$2,000,000.00, shall be allocated for the sole and evaluative purpose of funding vocational education, apprenticeships, or other vocational training programs for United States workers.

- (1) The expenditure authorities of all Commonwealth educational entities that receive Commonwealth Worker Fee Funds shall submit to the Presiding Officers of the Legislature, Chairperson of the Senate Committee on Fiscal Affairs and the Chairperson of the House Committee on Ways and Means, at the end of each quarter, a fund status report of the funds allocated under this subsection.
- (2) The recipients of the funds in this subsection shall submit to the Governor and the Department of Labor the required education plans consistent with and mandated by U.S. Public Law 115-218. The funds allocated pursuant to this subsection shall not be used or reprogrammed for any other purpose other than in accordance with U.S.

11.

Public Law 115 218. The funds allocated under this subsection are not subject to fiscal

year limitation.

(c) Reporting Requirement. The expenditure authorities of the funds allocated pursuant to Section 802 shall provide accountability and transparency by providing within 30 days after the end of each quarter an expenditure report of the funds to the Governor and the Presiding Officers of the Legislature.

CHAPTER IX. GENERAL PROVISIONS

SECTION 901. SEVERABILITY.

If any provision of this Act, or its application to any person or circumstance, is held invalid, the invalidity does not affect other provisions or applications of the Act which can be given effect without the invalid provision or applications, and to this end the provisions of this Act are severable.

SECTION 902. SAVINGS CLAUSE.

This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of this Act shall not have the effect of terminating, or in any way modifying, any liability civil or criminal, which shall already be in existence at the date this Act becomes effective.
