AN ACT

To globally amend Divisions 1 and 5 of Title 4 to rename "Commonwealth Free Trade Zone Authority" to "Commonwealth Economic Incentive District Authority"; and for other purposes.

BE IT ENACTED BY THE TWENTY-FOURTH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE:

Section 1. <u>Findings and Purpose</u>. The Legislature finds that the Commonwealth Free Trade Zone Authority ("Authority") was established by Public Law 12-20 "to aggressively market and promote the CNMI free trade zones internationally to businesses of the type determined by the Board by regulation to be desirable for the future economic development and diversification of the CNMI."

The Legislature further finds that the term "free trade zone" can be interpreted in a way that can be confusing to the stakeholders of the businesses the Authority is tasked with attracting. The Authority is best able to market and promote CNMI, in a manner that fulfills its statutory duties, if the name of the Authority and the zones the Authority administrates better reflect the economic incentives being offered.

Therefore, the purpose of this Act is to globally amend Divisions 1 and 5 of Title 4 to rename "Commonwealth Free Trade Zone Authority" to "Commonwealth Economic Incentive District Authority" and to rename "Commonwealth Free Trade Zone" to "Commonwealth economic incentive district".

Section 2. Global Amendment. The references in Division 1 of Title 4 and Chapter 14 of Division 5 of Title 4 of the Commonwealth Code and all references in any contract,

15 16 Executive Order, rule, regulation, or document to the "Commonwealth Free Trade Zone Authority" or "Free Trade Zone Authority" shall be amended to or read as the "Commonwealth Economic Incentive Zone Authority" or "Economic Incentive Zone Authority".

Section 3. Global Amendment. The references in Division 1 of Title 4 and Chapter 14 of Division 5 of Title 4 of the Commonwealth Code and all references in any contract, Executive Order, rule, regulation, or document to the "Commonwealth Free Trade Zone" or "Free Trade Zone" or "free trade zone" shall be amended to or read as the "Commonwealth Economic Incentive Zone District" or "Economic Incentive Zone District" or "economic incentive—zone district".

Section 4. Severability. If any provisions of this Act or the application of any such provision to any person or circumstance should be held invalid by a court of competent jurisdiction, the remainder of this Act or the application of its provisions to persons or circumstances other than those to which it is held invalid shall not be affected thereby.

Section 5. Savings Clause. This Act and any repealer contained herein shall not be construed as affecting any existing right acquired under contract or acquired under statutes repealed or under any rule, regulation, or order adopted under the statutes. Repealers contained in this Act shall not affect any proceeding instituted under or pursuant to prior law. The enactment of the Act shall not have the effect of terminating, or in any way modifying, any liability, civil or criminal, which shall already be in existence on the date this Act becomes effective.

Section 6. Effective Date. This Act shall take effect upon its approval by the Governor, or its becoming law without such approval.
