

THE SENATE TWELFTH NORTHERN MARIANAS COMMONWEALTH LEGISLATURE SECOND DAY, FIRST REGULAR SESSION, 2000

Second Day

Thursday, February 3, 2000

The Senate of the Twelfth Northern Marianas Commonwealth Legislature Second Day, First Regular Session, 2000 was called to order at 10:00 a.m. in the Tinian Courthouse, Tinian, Commonwealth of the Northern Mariana Islands.

(Singing of the Commonwealth Anthem by J. San Nicolas)

President Manglona: Si Yu'us ma'ase, Mr. San Nicolas. Please let me take this opportunity to welcome everyone this morning. We are very fortunate to have with us his Excellency Bishop Tomas Camacho, Pastor Ellis, Chief Justice Castro, Lt. Governor Sablan, Washington Representative Babauta, Speaker Fitial, and members of the Twelfth House of Representatives. I understand also that Mayor Borja is here as well as Chairperson Mendiola of the Tinian Municipal Council, Chairman Joe Rosario of the Rota Municipal Council, and the members of the Rota, Tinian and Saipan Municipal Councils. Also, the members of the Board of Directors of CDA and the Resident Directors of all our Departments are here. Para todo i taotao Tinian yan espesiatmente i familian I Honorable na ga'chong mame as Joe Dela Cruz yan i man atungo'-ña siha, buenas dias. This is our Second Day, First Regular Session. I now call the session to order. Senate Clerk, please call the roll.

The Senate Clerk called the roll and eight (8) members were present, Vice President Villagomez was excused.

<u>President Manglona:</u> We have the necessary quorum to conduct today's session. Before we begin, please let us all rise for a moment of prayer and invocation by His Excellency Bishop Tomas Camacho.

INVOCATION

Bishop Tomas Camacho: Gi na'an i Tata yan i Lahiña yan I Espiritu Santo, Amen. Almighty and eternal God, you have revealed your glory to all nations. God of power and might, wisdom and Justice, through you, authority is rightly administered and laws are enacted and judgement is decreed. Let the light of your divine wisdom direct the deliberation of the Honorable Senator-elect Jose Dela Cruz, who today joins the Senate of the Commonwealth of the Northern Mariana Islands, and shine forward in all the proceedings and laws framed for our rules and government. May he seek to preserve peace, promote happiness for the people of the islands and continue to bring us the blessing of liberty and equality. We, likewise, commended that to your unbounded mercy that all citizens of the United States and all those who make the Commonwealth their home that we may be blessed in the knowledge and sanctified in the observance of your Holy law. May we be preserved in union and that peace which the world cannot give and after enjoying the blessing of this life be admitted to those which are eternal. We pray to you who are Lord and God, forever and ever. Gi na'an i Tata yan I Lahiña yan Espiritu Santo. Amen.

CREDENTIALS COMMITTEE

<u>President Manglona:</u> Our first action this morning is to appoint a Credentials Committee to look over the credentials of our newly-elected Senator, Jose Dela Cruz. I appoint Senator Edward Maratita as Chairman of the Credentials Committee and Senator Adriano and Senator Ray Guerrero as members. At this point, I call for a very short recess so that the Committee can get together. Short recess.

The Senate recessed at 10:21a.m.

RECESS

The Senate reconvened at 10:40 a.m.

<u>President Manglona:</u> We are back to our regular session after a brief recess in order for the Credentials Committee to evaluate the credentials of our newly-elected Senator. I recognize the Chairman of the Credentials Committee, Senator Edward Maratita.

Senator Maratita: Thank you, Mr. President. Your Credentials Committee begs leave to report as follows: The Committee reviewed the credentials of member-elect Jose M. Dela Cruz, including a copy of his Certificate of Election, and found that he is in technical compliance with the law and entitled to be seated. Specifically, he was duly elected and has met the requirements of Section 2(c) and (d) of Article II of the Commonwealth Constitution. In addition, he has filed the Statement of Financial Interests required by 1 CMC 8511(c)(1). In conclusion, Mr. President, the Committee had found member-elect Jose M. Dela Cruz to have been duly elected and qualified. We recommend that Senator-elect Jose M. Dela Cruz be sworn in as a member of the Senate. Respectfully submitted, Edward U. Maratita, Chairman; Joaquin G. Adriano, member; and Senator Ramon S. Guerrero, member. Thank you, Mr. President.

President Manglona: Thank you, Chairman Maratita. Can I hear a motion for its adoption?

Floor Leader Reyes moved for the adoption of the Credentials Committee Report and several members seconded.

President Manglona: Is there any discussion?

Several members voiced "ready".

The motion to adopt the Credentials Committee Report carried by voice vote.

<u>President Manglona:</u> The Committee Report is hereby adopted. Can I hear a motion to resolve into the Committee of the Whole.

Floor Leader Reyes moved to resolve into a Committee of the Whole. Several members seconded and the motion carried by voice vote.

<u>President Manglona:</u> The Senate now resolves into the Committee of the Whole for the swearing-in of Senator-elect Dela Cruz.

The Senate resolved into a Committee of the Whole at 10:45 a.m.

COMMITTEE OF THE WHOLE

The Oath of Office was administered as follows by Judge Alex Castro.

I Jose M. Dela Cruz do solemnly swear that I will support and defend the Constitution and laws of the Commonwealth of the Northern Mariana Islands, the Covenant to Establish a Commonwealth of the Northern Mariana Islands in Political Union with the United States of America, the applicable provisions of the constitution, laws and treaties of the United States of America, and that I will faithfully discharge my duties as a Senator of the Commonwealth Legislature to the best of my ability, so help me God".

(Applause)

<u>President Manglona:</u> We will have a five minutes recess after we dissolve the Committee of the Whole. After that, we'll reconvene for about fifteen minutes and then we will have lunch. At this point, can I hear a motion to go back to our regular session? Floor Leader.

Floor Leader Reyes moved to dissolve the Committee of the Whole. Several members seconded and the motion carried by voice vote.

The Senate returned to its plenary session at 10:50 a.m.

President Manglona: We're back to our regular session.

Floor Leader Reyes: Mr. President, I move for a five minutes recess so we can congratulate our new member.

The President declared the Senate in recess at 10:49 a.m.

President Manglona: We're back to our plenary session. Thank you all for your patience.

President Manglona: Senate Bill No. 12-16 passes the Senate on First Reading.

SENATE BILL NO . 12-18: TO REPEAL AND RE-ENACT 1 CMC, DIV. 1, CHAPTER 4; AND FOR OTHER PURPOSES

Floor Leader Reyes moved for its passage on First Reading, and several members seconded.

President Manglona: Is there any discussion?

Several members voiced "ready".

The motion to pass Senate Bill No. 12-18 on First Reading carried by voice vote.

President Manglona: Senate Bill No. 12-18 passes the Senate on First Reading.

SENATE BILL NO. 12-9: A BILL FOR AN ACT TO AMEND TITLE 4, DIVISION 1, CHAPTER 4 TO ADD A NEW §1426 TO ALLOW DENIAL OF A CERTIFICATE OF ORIGIN FOR ANY GARMENT FACTORY FOUND IN VIOLATION OF THE NON-RESIDENT WORKERS ACT OR COMMONWEALTH MINIMUM WAGE ACT; AND FOR OTHER PURPOSES.

Floor Leader Reyes moved to file Senate Bill No. 12-9, and several members seconded.

President Manglona: Is there any discussion?

Several members voiced "ready".

The motion to file Senate Bill No. 12-9 carried by voice vote.

SENATE BILL 12-19: TO STATE AS PUBLIC POLICY THAT CONSTRUCTION OF AN 80 MEGAWATT POWER PLANT FACILITY BY PHASES, BEGINNING WITH IMMEDIATE INSTALLATION OF 60 MEGAWATTS OF GENERATING CAPACITY, IS IN THE BEST INTEREST OF THE COMMONWEALTH; TO FIND AND DECLARE THAT PHASED CONSTRUCTION OF 80 MEGAWATTS OF GENERATING CAPACITY IS CONSISTENT WITH THE REQUEST FOR PROPOSALS (RFP) UNDER WHICH PROPOSERS RECENTLY COMPETED FOR A CONTRACT FOR A NEW POWER PLANT ON SAIPAN; TO PROVIDE A TIME PERIOD DURING WHICH PROPOSERS MAY STAND BY THEIR EXISTING PROPOSALS FOR PURPOSES OF PROJECT AWARD; TO EXPRESSLY AUTHORIZE PROJECT AWARD AND NEGOTIATION OF A CONTRACT BASED ON EXISTING PROPOSALS; AND FOR OTHER PURPOSES.

Floor Leader Reyes: Mr. President, originally, I wanted to submit a substitute bill for S. B. No. 12-13. However, in consultation with the House prior to the Session, they requested that it be passed as it appears in the original bill. I will present the Senate Substitute One to the members of the House for their consideration. I'll ask them to look it over and if they agree with the Senate to incorporate it in their deliberation. <u>Senator Guerrero:</u> Being the former Executive Director of CUC, would it be a conflict for me to vote on this legislation? I totally agree with the legislation. I just want to clarify if there's any conflict-of-interest.

I believe that by being a former Executive Director, I do not see any conflict. I would like to ask you, Senator, to please vote "yes" or "no" and disregard your conflict-of-interest in this particular case. I think that this is a very critical legislation and we all have to participate. I ask your understanding on that.

President Manglona: Senate Resolution No. 12-1 is adopted by the Senate.

The Chair recognized Floor Leader Reyes.

<u>Floor Leader Reyes:</u> With your indulgence and the consent of the members, I feel that the Resolution Calendar is the appropriate part of the Agenda to make a motion to amend a section of the Senate Rules. Copies have been reproduced. One minute recess?

<u>President Manglona:</u> Floor Leader, I would like to recommend that we continue while copies are being made.

<u>Floor Leader Reyes:</u> Let me just state, Mr. President, so we can move on, that the amendment to the rules that I'm proposing is to make a change in the structure of one committee of the Senate to add one member. Instead of six members in the Standing Committee on EAGI, I want to make an amendment to add one more to make it seven.

President Manglona: Is that for only one committee?

Floor Leader Reyes: That is for one committee only. This is by the request of the members....

President Manglona: Is the Chairman aware of that? The Chairman of EAGI?

<u>Floor Leader Reyes:</u> Yes, Mr. President. Just a few minutes ago, he was made aware of it. Mr. President since he was—he indicated that he was not previously aware of it, but he had not indicated his disapproval of the....

Senator Adriano: Do you have that floor amendment? Can we have a copy of the amendment?

<u>President Manglona:</u> Seriously, we might want to consider other committees. Do you think that only the EAGI Committee should be increased to seven or is it the wish of the members to increase also the other committees?

Floor Leader Reyes: May I officially make the request for the amendment, Mr. President?

President Manglona: Okay, we all have copies, Floor Leader.

Floor Leader Reyes: The motion is to amend Rule 7, Section 4 of the Official Rules of the Senate. Pursuant to Rule 15 of the Official Rules of the Senate, the undersigned hereby moves to amend Rule 7, Section 4, of the Official Rules of the Senate to increase the maximum membership of the Committee on Executive Appointments and Governmental Investigations from six members to seven members. I so move.

Several members voiced "second".

President Manglona: Is there any discussion? Chairman Adriano.

Senator Adriano: May I ask the good Floor Leader, Mr. President, what is the reason for increasing it from six to seven?

Floor Leader Reyes: I yield the floor to the members.

The Chair recognized Senator Cing.

Senator Cing: Hu a'atan este, Mr. President, that since everyone of the members here are holding Chairmanship position, ilekko na buente chadek'-ña yanggin ta faisen ya uguaha kinemprende yan compromise between siha ya hu huyong uno guine, instead na para ta add uno sa siempre yanggin para ta add humuyong siete. Next time around, guaha siempre ta'lo Committee ni yaña para ufan add. Mauleg buente yanggin man compromise ha' ya uma accommodate si Senator Guerrero. Hu huyong ha' uno guihe.

Floor Leader Reyes: Quick privilege, Mr. President.

The Chair recognized Floor Leader Reyes.

<u>Floor Leader Reyes:</u> Mr. President, I'm just aware that in the Senate Rules we can introduce the amendment, but we cannot adopt it until our next session and I request...

<u>President Manglona:</u> So, we can entertain it in our next session. With that, I'm going to ask the understanding of the members to allow for the process. We can approve it in our next session. So, the motion is for the placement of the proposed amendment to the Rules of the Senate.

Senator Cing: But that's even better, Mr. President. Siña ha' man ásoddá before the next session ya ufan compromise ya uma resolve este.

<u>President Manglona:</u> There's no objection? So there's an official notice now before us to amend Rule 7. I hope that by the next session, we can act on this matter.

Senator Dela Cruz: Your Excellency Bishop Tomas Camacho, Representative Babauta, President Manglona, colleagues from the Senate, Speaker Fitial and members of the CNMI House of Representative, Mayor Borja, Tinian Municipal Council, Rota Municipal Council members, Saipan Municipal Council, friends, families and especially my dear people of Tinian. It gives me great pleasure to be here today to be sworn in during this First Regular Session of the CNMI Legislature in this new Millennium. Please allow me a moment to say thank you to Mayor Francisco M. Borja and his administration. Your support was truly essential. Equally important was the support that I received

from my colleagues among the Tinian Joint Legislative Delegation; Chairman Adriano, Senator Cing, and Vice chairman, our Congressman Norman Palacios. Further thanks are due to our Tinian Municipal Council members, Madam Chair Juanita Mendiola, our Vice Chairman Antonio H. Borja, and Councilman Antonio O. Kiyoshi and certainly a "dangkulo na si Yu'us ma'ase to you, President Manglona, my colleagues in the Senate, Speaker Fitial and members of the House of Representatives and all those wonderful people who contributed in one way or another to my election. And once again, thank you to the people of Tinian who voted for me during this special election. I am truly honored and humbled by the confidence you have placed in me. I pledge to do my best to live up to your expectations. I would be remiss if I didn't thank my lovely wife, Kay. Without her patience and diligent efforts, I will not be in this position today. Si Yu'us ma'ase, asaguaho. Thank you to my three wonderful daughters', Marjorie, Joanna and Soledad, who sacrificed a day at school to be here today to share my moment of honor. They are truly my inspiration. To my immediate family, "pop", yan hamyo ni manelu-ho guine yan i familian miyo, un dangkulo na si Yu'us ma'ase. Thank you for your undivided support. You're the core of my self-confidence. We have much work to do in the years ahead. I am prepared to face the challenge. I am confident, because I know I can work cooperatively with my colleagues. I believe that cooperation is the key to progress and prosperity for Tinian and our entire Commonwealth. I look forward to working closely together with our Mayor, our Tinian Municipal Council, and the members of the Senate, the House of Representatives, and the Executive Branch toward our common goals. I believe that if we work cooperatively, we can accomplish great things for our islands and our people. As we all know too well, the slump in the Asian Marketplace has caused a slump in our economy. For the sake of our people, we must work closely together to improve the economic condition of our islands. Tinian has made a commitment to the Casino industry. The Dynasty Hotel and Casino has also made a commitment to Tinian and our Commonwealth. Clearly, we must do everything necessary to make the Casino successful, if we want to continue to enjoy the benefits of their presence. Nurturing the Casino industry requires that the Tinian International Airport and Tinian Harbor be completed. Completing these projects is essential to creating more jobs for our people and the general prosperity of Tinian and the Commonwealth. Sustaining the economic development of the island requires an educated workforce. In order, to properly educate our people for the new Millennium, we must complete the construction of Tinian Elementary School, Tinian High School, and the new Tinian Northern Marianas College campus, and each must be provided with the necessary equipment, and the teachers, who will prepare our Youth to meet the technology demands of the twenty-first Century. There should be computers in every classroom, with cable and Internet connections. Although, we are in a period of economic austerity, I believe that they are mechanisms available that can make this educational vision a reality for our children. Previously, we didn't have sufficient attractions. Thus, they stopped using the CNMI as a destination. The Dynasty Casino, and hopefully a Tinian golf course, will provide the necessary attractions that will bring the "Love Boats" back to the CNMI. These are only a few of the ideas that I plan to pursue, in cooperation with my colleagues. The year 2000 presents great opportunities for our islands. I am optimistic that if we work together, we can achieve great ends that our children, and their children, will be proud of. Again, thank you all for your support and the confidence that you have placed in me. I look forward to working on these challenges. With the continued support of my family, friends, the people of Tinian, and the Tinian leadership, I have no doubt that we can achieve each of these goals. Thank you, buenas dias.

(Applause)
