The Senate of the Twelfth Northern Marianas Commonwealth Legislature, Third Day, First Regular Session 2000, was called to order at 2:50 p.m. in the Senate Chamber on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Paul A. Manglona, President of the Senate, presided.

I have discussed this with an attorney from the Governor's Office, and we both agreed that the severability clause should take care of this. I want to place that on record. I am ready.

HOUSE BILL NO. 11-221, SENATE DRAFT 1: A BILL FOR AN ACT TO REQUIRE THE COASTAL RESOURCES MANAGEMENT OFFICE TO CONDUCT A STUDY TO DETERMINE THE ENVIRONMENT IMPACT OF MOTORIZED WATERCRAFT ON THE COASTAL RESOURCES AND MARINE ENVIRONMENT; AND FOR OTHER PURPOSES.

Floor Leader Reyes moved to override the Governor's veto of House Bill No. 11-221, SD1, and several members seconded.

President Manglona: It has been moved and seconded. Is there any discussion?

The Chair recognized Vice President Villagomez.

Vice President Villagomez: Thank you, Mr. President. I want to comment a little bit on this particular message from the Governor. It states that the intent of conducting this environmental impact study on the coastal resources and waters of the Commonwealth is much supported. Then, he took out the mandatory requirement for the study and its submission to be made within a specific period of time--cannot be realistically implemented or enforce. I would appreciate if we override this veto, Mr. President and members of the Senate, because I understand that this agency, the CRM Office, has been very selective when they review applications concerning our marine environment. I was informed that CRM has issued a permit for an island, a floating island near Managaha Island, and have not done any fiscal impact study on the area. CRM went ahead and issued that permit. We need consistency and we need to force this agency to conduct an impact study of our coastal and marine environment, especially the area by Managaha Island. As you know, the Constitution mandates that the Manahaga Island is to be a recreational island--the area. If we destroy the coastal and

marine environment that we have out there for the people of the CNMI and our tourism, we might not be able to fix the problem. I don't think that the excuse regarding the time period should be the restriction in signing this legislation. I feel that the Governor should mandate his agencies to work in protecting our environment. Thank you.

President Manglona: Thank you, Mr. Vice President. Is there any other? Senate Clerk, call the roll, please.

As you know, we have received nominations from the Governor to the Board of Elections and the CDA Board. I have requested a copy of a legal opinion that was issued by the Attorney General's office. Sometime ago, we had a discussion with one assistant Attorney General in this Chamber regarding the position of the Executive Branch on confirmation actions by the Senate,

particularly, on individuals nominated to the Board of Elections or to the Board of CDA. I, now, have the legal opinion. In the legal opinion, it expresses that the Governor, in the spirit of cooperation, is sending over names, nominating names, and is asking the Senate for its advice and consent. However, almost at the same breathe, he is also saying that in a review by the Attorney General's Office, there is no need for confirmation by the Senate. Several things come to mind when I read this, Mr. President. I'm glad that you find it important enough to place it on Governor's Communication. First, why is he sending over names that don't require confirmation? I know that his intention is to cooperate, but if it's unnecessary, why do that? Secondly, my understanding of the legal opinion, and I don't have an attorney's analytical mind to dissect the opinion and make some sense out of this, is that if the Constitution is silent on the authority to nominate, the Legislature can not enact legislation to compel the confirmation of these individuals. I'm not very happy with this kind of opinion, because of existing law which established this precedence in the past. The fact that they arbitrarily disregarded the existence of a statutory authority, in my opinion and in my view, the office of the Attorney General took judicial action to decide on whether the existing statute applies or not. I think this is beyond the Attorney General's scope of duty. This is something that should be left for the Court to decide. Since there has been no challenge in Court, it should have continuing statutory application. I just want to share my understanding on this. Thank you.

The Chair recognized Senator Maratita.

Senator Maratita: Thank you, Mr. President. In line with what Senator Reyes was saying, we have to make sure that this body is consistent when confirming nominees. For example, the Governor submitted to us a nominee to represent Rota in the Board of Elections and this body took action and confirmed this individual. Now, we're saying that we need to take this to court and let the court decide. Whether or not a nominee to the Board of Elections or CDA is required to go through the process of advice and consent, what I'm saying here, is that we have to be consistent. My point is we, also, have to be consistent here. I heard from some of the members that the Governor must be consistent in his decisions. We have to be consistent also and make sure that what we say is what we practice. Thank you, Mr. President.

The Chair recognized Senator Guerrero.

Senator Guerrero: Thank you, Mr. President. My concern here is the Governor's letter to Senator Pete Reyes. It really does not define if the legal opinion by the Assistant AG was issued during former Governor Tenorio's time. I'm assuming that the Governor probably is looking at establishing relationship with the Senate. Don't you think that this would be good question to ask the next nominee for Attorney General--whether he agrees with the legal opinion by Sattler? Because there's nothing in the correspondence to Senator Pete Reyes that the Governor is honoring this legal opinion. It's just a transmittal of the copy, but we would like to find out how did the Attorney General's office stand on different legal opinions. I feel that this should be the major question to ask the nominee for Attorney General and see if he differs on this opinion. Thank you.

The Chair recognized Vice President Villagomez.

Vice President Villagomez: Thank you, Mr. President. Ti hutuñgo kao bai huchom sikosu pat magahet bai hu baba ya bai hu defende ya bai hu na consistent i posision i lehislatura. Gi public hearing, ma faisen si Sattler faisen kao ma nisisita advice and consent i appointment para i Board of Election. Ti hana comfortable yo' ni este lao ilekko na yanggin dinanche i Gobietno gi finenana na iyonña counsel na ti hanasisita advice and consent i Board of Election anai ta kuestona gi finenana, ti ha laknos si Connie Seman Camacho. Anai hu kuestiona i dos na appointment ginen Rota guato gi CDA, guaha siha iyokko correspondent ma sangani yo' na taya ha ma nisisita advice yan consent. Ta kuekuestiun i posision-ña i Senadot. In fact, i abugadu-ta, ta kuesto-tona ni etyi i bill ni para ta pasa pot i advice and consent gi as Herbert Soll. Hita la'mon kao para ta konfitma pat ahe. Qualify gue' pat ti qualify gue, hita ni Senadot—I Constitution hana'i hit. Direkchota kao para ta suppota pat ahe. Lao, ngaian para tana klaru hafa diretchon-ña i Senadot gi advice and consent yanggin I abugado ha' para chiña ya ti humalom gi kotte, para uguaha Judicial review. Antes de hu expired iyon ñiha nomination, parehu ha si Bennet Seman yan si Connie Seman, bai hu faisen este na gurupo, i membron Senadot ya ta chu'le este guato gi Judicial review ya uma kuestion, uma prioritize este. Yanggin ilek-ña i kotte na hunggan dinanche na diretchon-ña i Senadot na appointments para guato siha gi hafa na agency debi ufan ma konfitma gi Senadot, pues bai hu ofresi hamyu na bai hu kontinuha ya tafan arespeta. Lao, bai hu suppota si Bennet, bai hu suppota si Connie. Lao nisisita tana klaro lokue este. Tana'i guato I kotti pot fabot ya malago

ha' yo' later na bai hu move na i Presidente hu na'i direksion guatu i counsel gi bendision este na Senadot ya uma chule este na kuestiona guato gi kotte ya tana fonhayan fan este, once and for all. Si Yu'us ma'ase.

President Manglona: Thank you, Vice President. Is there any other comment? Senator Cing.

Senator Cing: Thank you, Mr. President. Fine'ne'na, ilekko na i rason na I Gobietno mo'na ha infofotma hit magi ni listan i nominees siha i pot para una tungo hit haye siha na taotao Commonwealth ha apunta para i Board siha. I mina dos, etyi i kuestiona guine, guaha na Board according gi iyotta Constitution ha spell out explicitly na ha require advice and consent gi Senate yan guaha na Board ti ha spell out. Enao gue' ilekku ni gaige I confusion. Now, gi hita ha' guine ni man ma ilihe, ilekku na impotante i Board of Election uma na klaro na etyo gue' na Board ha nisisita advice and consent. Ya ti kumeke ilek-ña na pot taigue gi Constitution sa ti ma spell out, tisiña na para tana guahaye lai para ufan dinikta este siha na klasen Board—I CDA ni ti ma spell out gi Constitution, i Board of Election ni ti ma spelled out gi Constitution. President Manglona: Floor Leader, kao para un oppe' si Senator Cing?

<u>Floor Leader Reyes:</u> Mr. President guaha esta lai ma pasa gi mina' dos Legislature ya ma fitma ni Gobietno. Guaha lai ya ha require este na statute na uguaha konfitmasion gi nominees para i Board of Elections. Ti-siguru yu' gi CDA.

What matters here is black and white, the Constitution or black and white gi statute. Thank you.

The Chair recognized Senator Maratita.

Senator Maratita: Si Yu'us ma'asi, Mr. President. Guaha pineligruña este. Sa gi pa'go, dinanche si Senator Villagomez na debi i kotte hu diniside este sa gi alatcha, taimano ha' husangan gi finenina, ta confirm unu na Board. Based gi hearing, nai....

Senator Maratita: Right, i iyokku point guine i hu fabobot si Vice Presiden. Sa gi finenina ta chu'li action ya ta confirm unu na Board member ginen Luta. Pues pagu para ta bira hit ya ta sangane i Gobietno na based gi A.G's opinion ti nisisario....i Board of Election yan i CDA.

President Manglona: Siña bai hu recognize i EAGI, Chairman?

President Manglona: Floor Leader.

Floor Leader Reyes: Mr. President, I rason na ti ta-act eyu i earlier na nomination, sa anai ta agang halom i Attorney General, man ma sangani hit na guaha legal opinion esta ma fotma. Lao taya in writing man ma provide hit. Hita ta nanangga enao para u tafan mana'i. Taya. Not until anai hu faisen guine pot este na recurring situation, nai. The Chair recognized Senator Guerrero.

Number two, ilekña na for this reason although not specifically required by either the Covenant or the CNMI Constitution, ha cha-challenge maisa este, nai. But yet, hana hanao magi. I think na para hu test i iyotta integrity. That's number three, Mr. Chairman. Ilekko na esta siña ta bota ya bai hu move na ta end debate ya ta direct iyotta counsel.

It also brings in the Division of Motor Vehicle from the Department of Public Safety and place all of that under the Department of Administration, which will be headed, supposedly, by a Commissioner of Administration. That's my understanding of this bill. Thank you.

President Manglona: Thank you, Floor Leader. Is there any further discussion? Senate Clerk, call the roll, please.

<u>President Manglona:</u> We're back to our plenary session. We have just voted to pass Senate Bill No. 12-53 and Floor Leader Reyes will be making a motion to amend the title. Floor Leader.

Floor Leader Reyes: Yes, Mr. President with the unanimous consent of the members, the corrections I need to make is on the title of the bill. After "functions" to just put "and to create a Department of Administration".

President Manglona: Is there any objection?

Senator Adriano: No objection.

<u>President Manglona:</u> With that motion, we are authorizing the Senate Clerk to amend the title to reflect the language.

<u>Floor Leader Reyes:</u> Thank you, Mr. President. By request, I would like to place on the Calendar two bills; Senate Bill No. 12-51 and Senate Bill No. 12-52.

SENATE BILL NO. 12-52: A BILL FOR AN ACT TO CREATE A BUREAU OF ALCOHOL, TOBACCO, AND FIREARMS IN THE DEPARTMENT OF PUBLIC SAFETY; AND FOR OTHER PURPOSES.

Floor Leader Reyes moved for its passage on Final Reading, and Vice President Villagomez and Senator Atalig seconded.

President Manglona: Is there any discussion?

The Chair recognized Senator Maratita.

<u>Senator Maratita:</u> Mr. President, my concern is on line 16, Section 4 regarding the transfer of personnel. When this personnel gets transferred to the Department of Public Safety, will they become police officers? Will their titles be police officers, or what?

Senator Adriano: I believe so, my good Senator. That depends on the Commissioner of Public Safety.

<u>Senator Maratita</u>: If they are to become police officers, then we need to have them go through basic training or to an academy in order for them to become full-fledge police officers to enforce the alcohol, tobacco and firearm law.

<u>Senator Adriano</u>: It should be. I believe that at the present time, these people would undergo police academy training whenever they are designated as ABC (Tobacco, Beverage and Alcohol) enforcement officers.

President Manglona: Is there any further question?

<u>Senator Maratita</u>: We need more clarification on this, Mr. President. It's a good bill and I'm supporting it. The only concern that I have here is on the personnel section. Can we call the Commissioner of the Department of Public Safety and find out whether or not when these people are transferred, they would have had the necessary training. I don't believe that right now, ABC Enforcement officers have the same qualification as full-fledge police officers.

<u>Senator Adriano:</u> Siempre nai, Senator, yañggin ta pasa este na bill, i Commissioner of Public Safety ha fa'tinas i regulation anai para unfan ma certify siha komo Law Enforcement Officers.

Senator Maratita: Lao automatic nai este. Ilelek-mo na all records personnel para ufan ma transfer yan kontodo i personnel. Kao during i time anai para ufan ma train, esta sina manman enforce, or do we need to train police officers right now to enforce the ABC regulations. I don't think that police officers right now are trained to enforce ABC regulations.

Senator Adriano: If you want to amend the bill, we'll amend the bill. Hafa I iyomo solution?

Senator Maratita: My solution is to make sure na man ma train i polisia siha guine.

<u>President Manglona:</u> Especially, when Section 3(c) deals with the enforcement of provisions of the weapons control law. Short recess.

The Senate recessed at 4:42 p.m.

The Senate reconvened at 4:59 p.m.

<u>President Manglona:</u> We're back to our session and we're still discussing Senate Bill No. 12-52 regarding the creation of the Bureau of Alcohol, Tobacco and Firearms Division.

Senator Adriano: Thank you, Mr. President. I have a floor amendment to offer.

On Page 1, line 18, add the following after the end of the sentence:

All personnel assigned to the Bureau of Alcohol, Tobacco, and Firearms shall be provided with the necessary training required for the performance of their duties.
