Floor Leader Reyes: In this case the House has not acted and we don't....

<u>President Manglona:</u> Normally, Floor Leader, I reserve my comments, but I think that this particularly bill is extra sensitive. The Senate had been accused in the past of not acting on a state funeral bill. I think that this being a House Bill, it's only proper that the House override their own bill. So, I urge all the members to act on this not as a sign that we are in conflict with the Governor, but as a message that the Senate is sensitive in recognizing our past elected officials. There have been two deaths in the past where the Senate was accused of not coming into session to act on a bill. Most recently, was the late Pete Nakatsukasa.... Once signed, it would allow the government to recognize, official recognition, of those people who have served us in the past. I think that the message here is to recognize our elected officials of the past. That's my comment. Thank you. Is there any other member who would like to comment?

Senator Adriano voiced "ready".

The Chair recognized Senator Cing.

Senator Cing: Mr. President, what was the Governor's concern, to override?

The Chair recognized Floor Leader Reyes.

<u>Floor Leader Reyes:</u> Mr. President, the Governor was concerned about the discretionary authority that we put in the bill. There is a provision that would allow the Governor the discretion as to who to extend a state funeral to and that is what the Governor is objecting to. There's no problem with the Governor, I think, with respect to the inclusion of former elected officials of the Legislature. I think that the problem here is where the Governor is given discretion and that discretion has a very wide range. And so almost anybody could be effectively qualified. If members of the Legislature want it to be very specific, then I think that we can be very specific.

The Chair recognized Senator Cing.

<u>Senator Cing:</u> Mr. President, two years ago, I introduced a bill that would give the Governor and the Lt. Governor like (\$5,000.00) five thousand dollars, for the Senators (\$4,000.00) four thousand dollars, for the House and so forth, down to the Municipal Council. I wonder if the Governor is familiar with that bill because if this bill that we have here today fails, then I might pull that out and reintroduce the same bill.

President Manglona: Let me just follow through with the Floor Leader's comment. I think that the main reason the Governor vetoed this is that it would allow him wide discretion. In other words, he fears that there might be pressure from the general public, if somebody dies and families or close friends want to recognize them. So he was kind of hesitant to sign this into law because then there would be a lot of pressure in recognizing even those that are less deserving. My point is that I agree with the Governor right now, but if the Governor were to issue, after the passage of this, for example, a regulation or some policies that we can stick to, and before somebody dies and that policy is out already then I think that the pressure will no longer be there. But if this is passed and somebody passes away and there's no policy, then I can understand where he is coming from. But it is not an issue on how much we are paying for the state funeral as far as the Governor is concerned. That is not the issue that is being raised. I think that the only difference between this and the present law right now is that we're including past elected officials of the Commonwealth Legislature. That is the only addition to the present law, if I'm not mistaken, -- we're including the Mayors and the Legislature.

The Chair recognized Floor Leader Reyes.

Floor Leader Reyes: Mr. President, this is just for clarification. Part of the concern which I think the Governor faces is those that could receive state funeral under the discretion of the Governor in the event that we don't have enough funding. State funeral services can be extended without the need to expend the normal three thousand dollars (\$3,000.00) for a state funeral. This is something, I think, the Governor looks forward to having us clarify. I want to make sure that the record is clear on my position. I support this bill and if we were to vote on it, I will vote in favor of the bill -- the override. I just think that it will not serve the purpose to override it here and have the House sit on it and not act on it. That's the only point that I'm trying to make.

The Chair recognized Senator Cing.

Senator Cing: I agree with Senator Reyes, Mr. President.

President Manglona: Vice President, do you have a comment?

<u>Vice President Villagomez:</u> Yes, I was just a bit concerned on the issue that was raised by the Governor on the amendment, "(i) others deemed appropriate by the Governor". I agree with you, Mr. President, that if we do have a set policy of who can qualify in the event of a state funeral -- because right now there's no restriction on who can qualify. If the Governor feels that it's appropriate to do a state funeral in the Commonwealth for a person who is not a resident of the Commonwealth, he can do it on his own with this provision here. I was going to make a recommendation that maybe as a policy, state funerals can be recommended by Joint Resolutions from the members of the Legislature. Those are some of the procedures that might be appropriate to go with, but right now there's no set policy of who and how that state funeral is going to be conducted. I do agree that we hate to do some amendment, but do we want to put in the statute again on who can qualify and who can't? I think that we have to revisit this issue. If we are going to vote for an override, I will be voting for the override, but there's that concern. Are we going to initiate the override action and then let the House sit on it again and pass a different version? It looks like we're being put on the spot here. I will support and vote for an override if it is placed on the table. But I caution the action.

The Chair recognized Senator Guerrero.

Senator Guerrero: Thank you Mr. President. I think that the issue here is if those that have served our community for such a long time are not recognized, then I should look at it that not even us and not even the present Governor, when we are asked to go upstairs --should be totally not eligible for a state funeral. If we cannot do it for the people that have --- or Covenant or the Constitution and they cannot be recognized. Since we are the present leaders that are in this position, I think maybe it's good to introduce a legislation that no one should be eligible at all. I think that the main reason that the original state funeral law was repealed, was because of the three thousand dollars (\$3,000.00). I'm talking now by experience because I was the first SAA that was given the authority to eliminate state funeral. And for your information, Mr. President and colleagues, a lot of families are not interested in the money. It's just the recognition. So therefore, I think the money issue here is irrelevant. There are families that do not-- there are families I have visited during my tenure I asked them if they would like the government to do the state funeral. Some of them, majority of them, refused that. All they want is a plaque placed on the coffin and that's it. I think the issue here is money. I don't care if the Governor feels otherwise, but one of my discussions with him was strictly monetary. There was no money to pay for state funerals. So I think in general, I am supporting the state funeral law no matter whether I like it or, whether I'm a politician or not. But we have to look at those people that are still alive and there are a few individuals that are still alive that have given us the right to what we are doing today through the covenant negotiation and the constitution. And if we do not recognize them just because of this act, then I feel that we should totally eliminate the state funeral act and let the legislature come up with resolutions.... I think Mr. President, that's the way it should be. Thank you.

The Chair recognized Senator Adriano.

Senator Adriano: Mr. President, este override ti ma dibebate gi iyotta rules. It is either vote yes or no.

The Chair recognized Floor Leader Reyes.

<u>Floor Leader Reyes:</u> One final comment on the state funeral issue, Mr. President. I'm supposed to be in charge of the following Senate pertinent rules here, and if we override we treat it like any other bill because this is a bill that is under consideration for action. And I just want to make one final statement that there is a lot of people that are deserving of a state funeral and I'll mention one. The late Honorable Henry Untalan Hofshneider for example, is deserving of a state funeral. And so I am sensitive of the need to recognize all these people and I think we should recognize them. The point that I'm trying to make is that if we were to pass something like that, for example, we need to be specific. We need to make sure that the Governor understands the extent of his authority to issue and what we intend to do. To give him a wide range of discretion is something that the Governor does not want to have. I would like to end debate and move for the previous question.

The Chair recognized Senator Dela Cruz for the first time.

Senator Dela Cruz: Mr. President, este na bill, nai. Abmam este na bill maigo both gi House yan i Senate, and we're worrying that the House of Representative might not take action on this bill, nai. Sesu ni man ma criticize hit gi Senate sa pot we're not taking action on this particular bill. Pumaticipate ha' yo' anai matai si difunto Nakatsukasa guine gi last time. I understand that maybe it is not a perfect bill, lao we should be mindful na of course, it would be nice yanggin siña ta na' fan fona i House ya siha finenena hu fan override. Let them decide for themselves. This is a very important piece of legislation, Mr. President. Sigi ha' i taotao-ta ni man masapet guine gi iyotta Commonwealth, man matai ya taya recognition ma extetende giya siha. Ya I feel na we should end debate ya' polo, ya ta bota este gi floor ya tafan go forth. Thank you, Mr. President.

President Manglona: Taya objection? We're back to the previous question. Senate Clerk, call the roll, please.

<u>Vice President Villagomez</u>: No, it's a ping pong. See House Communication No. 12-91. We acted on this bill. It was a House Bill that we amended. We did the amendment or it was crossed out, then it went down to the House and they took it out because they gave the \$6.5 million to Tinian. So, there's nothing concerning Tinian or Rota on this bill itself.

If we're talking about land mitigation program and moving this out in order to allow the land bank to decide an agreement, I think that the ranchers deserve to be mitigated also. I don't think its justice to just tell the ranchers to move out and not designate another land for them. We have been moving them from one area to another already. I disagree that the ranchers should be misplaced. I think that like any other development where there is a mitigation problem that the ranchers also should be mitigated. This is how I feel, I don't think that we should kick them out like we kick people out of apartments and tell them to go find their shelters. This is a bad message to those ranchers and I disagree with the intent of this bill. Unless, someone could come up with an alternate solution to again, place them where they can attend to their cattle and allow them to continue to raise. So, that is not ---.

The Chair recognized Senator Guerrero.

<u>Senator Guerrero:</u> Yes, Mr. President, I am in support with Senator Reyes. We have to look at our people that have invested a lot of money in that cattle ranch. They deserve too, even the recognition, not only because of that, it is a subsistence for their family who -- not only that to assist the public. And here we're trying to entice investors to come into the Commonwealth and we're trying to get our local people evicted rather than enticing the cattle ranchers to be given a loan from CDA to develop the cattle ranch. I hate to say it, but we are defeating the purpose of inviting people from outside of the Commonwealth to do their stand and yet we're not recognizing our local people to develop themselves to be real ranchers and be able to market their meat in Saipan. And I would like to see that this is withdrawn so that the committee can thoroughly look at the advantage and disadvantage of the ranchers. Mr. President. Now, I ask my colleagues to give us, the Saipan Delegation, to look into that matter --- Saipan.

President Manglona: It has been placed. I believe the motion is for its passage.

Floor Leader Reyes: The next motion, Mr. President, again, is to make sure that the suspension of the rules are also included for the passage on Final Reading.

Several members voiced, "no objection".

SENATE BILL NO. 12-78: A BILL FOR AN ACT TO REQUIRE AN EQUITABLE DISTRIBUTION OF BENEFITS BEFORE THE GOVERNOR OR ANY OTHER EXECUTIVE BRANCH OFFICIAL CAN ACCEPT ANY FEDERAL GRANT OR PROGRAM; AND FOR OTHER PURPOSES.

President Manglona: Before I recognize you Floor Leader, I believe Senator Dela Cruz raised his hand.

MISCELLANEOUS BUSINESS

<u>Senator Dela Cruz:</u> I just want to take this opportunity to thank all the members for the passage of House Bill No. 12-188. That bill has been long overdue and today, history of the groundbreaking in the Commonwealth. Thirty minutes from now, as you all are aware, they're going to be ground-breaking the Tinian International Airport and I just want to take this opportunity to thank the House of Representatives and my other colleagues here in the Senate for their support of the project. Also, on Senate Resolution No. 12-20, I really appreciated that -- just for that particular Resolution. I yield. Thank you.

The Chair recognized Senator Cing.

<u>Senator Cing</u>: Your Delegation to APIL, which comprise of Senator Dela Cruz and myself, wish to report back to the full Senate that our mission was successful and also we enjoyed ourselves on the island of Palau. On behalf of the Chief of Palau -- the rest of the Leadership of Palau have spoken --- and as usual, I would like to pass these to you as our President always as usual. I always return, I give it to you.

<u>President Manglona:</u> Thank you, Senator Cing. First, please provide us with your reports or photographs of your official trips.

Floor Leader Reyes: Thank you, Mr. President. I need to comment on some of the reading materials that I've seen during the passed few days and this makes reference to the situation of our legal counsel, Steve Woodruff. Mr. President almost every session that we have, I would complain about a letter that was supposed to be submitted to the Secretary of Finance with respect to our expenditure. A regulation now takes effect without any input from the Senate, because every time we raised this issue we get informed that the legal counsel is working on it and will be submitted to the Secretary of Finance. To date, I have not received this. This dated back to as far as March of this year. It is now September and the implementation of that regulation went into effect, which makes it compulsive for the Senate to comply with that regulation. We submit extra documents to attach to their terms. Further, I've asked the legal counsel for a draft bill that would give acting authority to people in the absence of the Mayor. I see that this is done in one of the bills that we passed today, but that bill has been in the making for several months already. At one point, I asked him to draft an initiative which would extend the life of those -- of our people who are working as teachers and nurses that fall under the two-year sunset clause of the double dipping situation. To date, I have not received this. I want to say that I think it is appropriate for me to say that this is a very frustrating experience. I don't think that any member of the Senate should be subjected to this kind of delays and inaction by a person who we assumed to be responsible. I understand that not only am I having this problem in the Senate, but I think members have aired also a similar situation.

<u>President Manglona:</u> Floor Leader, I am going to ask that the Rules Committee come up with recommendation on what action we need to take....

<u>Floor Leader Reyes</u>: My point here, Mr. President, with all do respect, I think that at this time even though we're on Miscellaneous, I think it is appropriate that we get a hold on the members of what to do with this. At this time, I ask because I think that to go into a committee to review again, is just going to further the problem and complicate the issue.

President Manglona: Can I hear comments from other members, Senator Guerrero?

<u>Senator Guerrero:</u> Yes, I would like to even make that motion, Mr. President either we would not renew his contract or we have to agree today because we have been running around. I have been running around in the Senate and I have been publicly put on the paper that one reason why I went down to Gualo Rai was because there's no legal counsel there. I've been a Senator for nine (9) months ---- so I would highly suggest that I'll initiate the move and I ask my colleagues to now replace him and I would highly suggest that the Senate considers Mr. Cabrera, the House Legal Counsel, to be transferred to the Senate as the Senate Legal Counsel....

Senator Adriano voiced "second".

President Manglona: It has been moved and seconded. Vice President.

<u>Vice President Villagomez</u>: I was just going to comment, Mr. President. I am also one of the committees that has been very frustrated with the position that we were placed in by our Senate Counsel. But I also came out that he should justify his priorities. I understand that the letter that you signed authorizing him to represent CUC on the Enron issue was for two weeks. The priority should be the Senate. Even if he should be addressing CUC concerns, it's supposed to be the Senate that is the priority. And I believe that we should go with the committee. I think that would be an appropriate action. I know that if we place it on the floor right now, everybody is going to vote not to renew his contract, but with all do respect, I sure would like to give him the opportunity to justify himself to the committee, the members of the Senate. I understand we are frustrated and we should come out with an official position. I know that as I pointed out if we vote on this, I believe everybody is going to...

President Manglona: So, are we going to vote on that?

Senator Guerrero: I already voted on the motion...

<u>President Manglona:</u> So, the motion is not to renew the contract of our Senate Legal Counsel and to negotiate for another legal service.

Senator Adriano: We have to retain him, Mr. President.

Floor Leader Reyes: Can I request for a very short recess?

President Manglona: Short recess.

RECESS

<u>President Manglona:</u> We're back to our session. We're still entertaining the motion on our legal counsel. I believe that the understanding during recess was the motion should state that the legal counsel's contract, Mr. Woodruff, will not be renewed and that further deliberation on the legal counsel's service --- shall be as recommended by the Committee on Rules.

The motion carried by voice vote.

President Manglona: The motion carried.

<u>Vice President Villagomez</u>: This is just a follow up comment. So this is an official notice. If it has a thirty days clause or sixty days clause --- this is the official notice that he

<u>President Manglona:</u> That's correct, Vice President. I guess we will instruct our legal counsel to effectuate a letter for my signature so that I can formally notify him.

<u>Senator Cing</u>: In line with that, Mr. President, because my concern now is, would that replacement be.... <u>President Manglona</u>: Those that Steve was assigned to handle, the new legal counsel will look after. Can we hear a motion for adjournment, please? Floor Leader Reyes: Mr. President, before we break, can we switch to the new counsel please. I move to adjourn subject to your call.

Several members voiced, "second" and the motion to adjourn carried by voice vote.
