Tuesday, December 19, 2000

The Senate of the Twelfth Northern Marianas Commonwealth Legislature, Sixth Day, Second Regular Session, 2000, was called to order at 2:20 p.m. in the Senate Chamber, on Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Paul A. Manglona, President of the Senate, presided.

President Manglona: Is there any comment on the messages from the Governor?

Senator Adriano: Yes, Mr. President. On Governor's Communication No. 12-461, the legislation to authorize the CPA enforcement officers to carry firearms including death benefit had been disapproved. One of the veto messages, Mr. President, is that the Governor disagreed to allow any more government employee to carry more firearms. The end, Mr. President. I discussed this with several CPA officers this afternoon. If I may, I would like to move that we override this veto, unless the members otherwise have another solution to this veto message. I so move.

Senator Guerrero and Senator Dela Cruz voiced, "second".

President Manglona: Is there any discussion?

Senator Adriano: Can we hear from Vice President Villagomez, first?

The Chair recognized Vice President Villagomez.

<u>Vice President Villagomez:</u> Mr. President, with regards to this legislation, again, the thing is we would like to put out our position on the legislation. But this is a House Bill and I know that we are independent of any action from the House. But there is a tendency here in the Legislature that we will act on a legislation that had been disapproved by the Governor and then the House would not take a position. We have shown our part in passing this legislation. If we are going to do an override, with all do respect to Chairman Adriano on this issue, he will be going down to the House and have the House act on this legislation. If not, with all do respect, I would like to ask that we differ action on this bill. We can always come back if the House takes a position and override this legislation. But it is useless for us to go ahead and override it and the House comes and sits on the whole issue here rather than override. Maybe we should lobby at the House for a position on that.

President Manglona: Is there any further discussion?

<u>Senator Adriano:</u> I am not really satisfied with Senator Villagomez' comment. I think that in the past, we have overrode bills and the House never acts on what we have acted on--whatever override from the Governor. So, the motion is still--I move.

<u>President Manglona:</u> It has been moved and seconded. We are still under discussion. Can we hear from other members?

Senator Dela Cruz: Mr. President, this particular piece of legislation was brought to my committee for review. As all the members are aware, this particular legislation was passed at the last session. I am also a little bit disappointed because these law enforcement officers do need this protection, but at the same time also I have a concern that if we do an override today, will we accomplish anything? Will the Lower House take the similar or same position? My concern here, and I apologize to my colleague from Tinian, Senator Adriano, but my concern here is we might be making an enemy or should I say we might be creating a problem with the Executive Branch and not accomplishing our mission as well. That is the only concern I have, Mr. President.

The Chair recognized Senator Maratita.

Senator Maratita: Thank you, Mr. President. I will vote for an override on House Bill No. 12-64, but I share the concern of the Vice President. We do an override here in the Senate and then we send it down to the House....

Senator Adriano: Mr. President, I withdraw my motion, thank you. I rest my case.

President Manglona: Senator Adriano has withdrawn his motion.

Senator Adriano voiced, "second".

The Chair recognized Senator Guerrero.

<u>Senator Guerrero</u>: Mr. President, I totally disagree with the amendment. Number 1, I did make an explanation that the handgun we are talking about for shooting resorts are based on the international standard which is not more than six inches long and not less than six inches below on the barrow of the gun. Therefore, these types of guns are exclusively used for shooting resorts. I ask my colleague to withdraw that because I am against the amendment. We are talking about shooting competition and there is a standard regulation, Mr. President. Thank you.

The Chair recognized Vice President Villagomez.

<u>Vice President Villagomez</u>: Thank you, Mr. President. I was looking at the web site today on the Olympic competition and I need some clarification on the intent of deleting the word handgun because in the Olympic competition, they do have handgun air rifle. If the intent is to prevent the importation of handguns, .22 caliber, .30 caliber or .45, I think that would be more specific on the restriction. Because I feel that the airgun, although, they are more powerful than pistol or rifle, what we have out here on air-gun are considered less threatening than if I were to use the word "than a .22 caliber or .38 caliber, 9 mm on that one. I understand that the International Sports Shooting Federation restricted their handgun ammunition to only .30 caliber, .38 and .45 caliber. Now if the intent is to prevent those kinds of guns, then I think that we should be more specific and point it to those kinds of firearms rather

than just handguns in general. Like I said the handguns that are used for the Olympic Competition--I believe that 9 millimeter was not part of the competition, but they did have air pistols and they were considered defined handgun. So, I think that we have to be more specific on the definition of handguns here.

Floor Leader Reyes: May I request for a short recess?

President Manglona: Short recess.

The Senate recessed at 3:14 p.m.

#### RECESS

The Senate reconvened at 3:19 p.m.

<u>President Manglona:</u> We are back to our session, we are still discussing House Bill No. 12-212, CD1, HD1, SS1, specifically, the floor amendment as offered by Floor Leader Reyes.

Floor Leader Reyes: Mr. President, on the floor amendment it is on page 2 of 10, line 13, the word "handgun competition" and on the same page line 21, the word "handgun" and on page 6, line 4, the word "handgun". That is the floor amendment.

Vice President Villagomez: Come again, on line 2 of 10.

Floor Leader Reyes: On page 2 of 10, line 13, "handgun competition", after the word "rifle and handgun competition", delete "handgun competition". On the same page on line 21, after "shotgun" delete "handgun", and on page 6 of 10, line 4, after "shotgun" remove the word "handgun".

President Manglona: Is there any further discussion on the floor amendment?

Floor Leader Reyes: As I indicated earlier, the concerns registered by the Youth Congress is the fear that allowing the use of handgun may have some safety threats against the general public. I know that we are not making amendments to the Gun Control Act that is currently in placed in the Commonwealth for the use of its citizens. I know that this is going to be strictly to the site, the location, and under extreme safety measures, but there is no other safer place than to just remove it. Because if we remove it, there is that possibility of this appearing in the street and so I offered this amendment on the basis of that concern.

The Chair recognized Senator Dela Cruz.

Senator Dela Cruz: I do understand, Mr. President the concern that my good colleague Floor Leader Reyes is offering. But for me, Mr. President, I don't see any difference between a handgun and a rifle here. We are talking about a proposed project here that would allow such shooting resort and by taking out particular tools on this particular resort. I think we are defeating the purpose, Mr. President. I move to end debate.

President Manglona: There is a motion to end debate.

Several members voiced "second," and the motion to end debate carried by voice vote.

President Manglona: Senate Clerk, call the roll please.

Floor Leader Reyes: Point of clarification, Mr. President.

President Manglona: I am sorry, we are voting on the floor amendment as offered by Senator Reyes.

Senator Adriano: Mr. President, I think I seconded the motion the first time. Therefore, I withdraw my second on that motion.

President Manglona: You mean when the floor amendment was made?

Senator Adriano: I did second that. So, now I am withdrawing my second on that motion.

<u>President Manglona:</u> Okay, just so there is an understanding here. There was a motion that was seconded. We have discussed it and we have ended debate on the floor amendment.

Senator Adriano: So, let us vote.

President Manglona: So, we are voting on the floor amendment.

The motion to adopt the floor amendment as offered by Floor Leader Reyes failed to carry by voice vote.

President Manglona: Motion defeated.

Floor Leader Reyes: Mr. President, let the record show that my vote is "aye" on the floor amendment.

<u>President Manglona:</u> Thank you, Floor Leader Reyes. Are we still voting or discussing House Bill No. 12-212, CD1, HD1, SS1? Ready for discussion?

That should not affect my personal feeling about the use of handguns. So, I just want to go on record saying that despite the defeat of my floor amendment. I wish to also support the intent of the bill in its general form. Thank you.

Senator Guerrero: Just a short comment, Mr. President. There is a letter written to me on December 4, by the Commissioner of Education. He said the version of the bill is good, he is the man in charge for safety reason. For the record, I thought that my explanation to the Youth Congress is very clear. The bill itself has a provision that there will be a police substation twenty-four hours a day and that is a very good safety reason.

Senator Atalig voiced "ready".

The Chair recognized Vice President Villagomez.

<u>Vice President Villagomez:</u> Thank you, Mr. President. I am not going to be drawn out from the handgun, rifle or whatever on that one. I just want to make sure that it is understood that the investment is a minimum of twenty-five million dollars. It does not mean that they can start out with their shooting range before the construction of the rooms. They have to do the actual investment of twenty-five million dollars in the CNMI before anything else. Thank you.
