President Manglona: Let us resume with our plenary session. We are still under Standing Committee Report.

STANDING COMMITTEE REPORT NO. 12-29: FROM THE COMMITTEE ON EXECUTIVE APPOINTMENT AND GOVERNMENTAL INVESTIGATIONS REPORTING ON THE GOVERNOR'S APPOINTMENT OF DAVID A. WISEMAN AS ASSOCIATE JUDGE OF THE SUPERIOR COURT OF THE NORTHERN MARIANA ISLANDS.

Floor Leader Reyes: Mr. President, we have four committee reports. I would like to make a motion to adopt Standing Committee Report No. 12-29.

Senator Cing voiced, "second".

<u>President Manglona:</u> On Standing Committee Report No. 12-39 from the EAGI reporting on the appointment of the Honorable David A. Wiseman, is there any discussion?

Vice President Villagomez: Mr. President, in front of us is the Standing Committee Report on the Governor's nomination of Mr. David Wiseman. Your Committee on Executive Appointment & Governmental Investigation recommends that the Senate confirms the nomination of Mr. Wiseman as the next Superior Court Judge of the Commonwealth of the Northern Marianas Islands. It is true that your Committee on EAGI have conducted a public hearing for the nominee on February 27, 20001. That was a week ago. At that public hearing, I asked the nominee about a sealed document pending with the CNMI Superior Court. The nominee stated that the sealed document is a disciplinary case against the nominee and the committee must not be concerned about the sealed document. It looks like your Committee on EAGI has agreed with Mr. Wiseman that the sealed document should not be a concern of the members of the Senate. Mr. President, I still say that the committee should have sought the court's permission with the consent of Mr. Wiseman to see the sealed document then make a sound decision in casting our votes for or against the confirmation of Mr. Wiseman. Mr. Wiseman himself stated that he was willing to give his consent to look at the sealed document, with the Office of the Attorney General agreeing that with the consent of Mr. Wiseman, your Committee on EAGI will be able to arrange with the Court to see the sealed document in question. But no, your Committee on EAGI decided that the public hearing was sufficient enough to make a decision on the Confirmation of Mr. Wiseman. I disagree with your committee on EAGI's recommendation to confirm Mr. Wiseman and I am voting no on Standing Committee Report No. 12-29.

The Chair recognized Senator Maratita.

<u>Senator Maratita:</u> (Inaudible) regarding the sealed document and after all the public hearing we have...(Inaudible) so I move that we vote...(Inaudible) President make that motion.

President Manglona: So, I believe --- with that motion, we should (Inaudible) voting.

Senator Atalig: Likewise, Mr. President, during that public hearing, I asked the Attorney General whether or not Mr. Wiseman is cleared on...(Inaudible) that was raised during the public hearing and the Attorney General mentioned that he is cleared as well as...(Inaudible) in regards to...(Inaudible) and he is found more (Inaudible) for Mr. Wiseman's nomination as far...(Inaudible). Like I said the three...(Inaudible) as far as the public auditor's concern also. So I believe we are ready to...(Inaudible) and let us vote on this nomination. Thank you.

The Chair recognized Senator Dela Cruz.

Senator Dela Cruz: Mr. President, if I am not mistaken, during our last session we were supposed to confirm Mr. Wiseman --- we gave an opportunity to our concern citizen Representative Stanley Torres to come in and --- body to the committee. During that period to show --- just like --- just like Senator Maratita and Senator Atalig had mentioned earlier --- AG's Office to Public Auditor's Office, Department of Public Safety ---. The Secretary of --- Association comment also on the important issue, he told us how a complaint is carried out to the Bar Association. He mentioned that --- complaint file for anything on the member of the BAR the procedure is to refer the matter to the Judicial. The matter was referred to the Judicial the matter was looked by the Judicial and honestly --- . Mr. President, just like I mentioned during that public hearing, I think that we should be very mindful that we should protect both sides --- inquire. We have given Mr. Stanley Torres an ample time to prove his case honestly it came out --, Mr. President ---. I am ready, Mr. President to vote in favor of Mr. Wiseman.

The Chair recognized Senator Guerrero.

Senator Guerrero: Well, I am not a member of the EAGI, but I participated in the confirmation hearing. I agree that Mr. Torres has been given a full request to appear which he did appear. Going through the documents provided to the committee, I made myself clear during that public hearing that I am in support for confirming Attorney Wiseman for certain reasons. One, hurting people is enough, trying to destroy a reputation of an individual, I think it is out of the question. My concern here, the Governor of the Commonwealth of the Northern Marianas nominated an individual with the full assumption that all of these questions have been verified by the Attorney General before the Governor submitted the nomination. All the documents that I have seen are documents from Former Justice Taylor dismissing the complaints of the Bar Association, but yet Stanley Torres came up with all of those issues including The Governor is right behind on his written summary. That's a shame on the the sealed document. Commonwealth's face if one individual can stand up and speak again and I hope that next time he does, he cleans his house before he cleans somebody's house. With my full support, I agree with my other colleagues, and I respect Senator Villagomez's position in this case, but I say that I signed the committee report just before the session and there's enough signature to certify that Mr. Wiseman is already confirmed. All we need to do is go on the vote and again I respect Senator Villagomez's position, but I feel that we have done other confirmation hearings also and I have other concerns how it is done. But we are going to have bigger confrontations and I think of my position and again I respect Senator Villagomez on his opinion. Thank you very much, Mr. President.

The Chair recognized Senator Cing.

Senator Cing: Thank you, Mr. President. I have...(Inaudible) Senator Villagomez for ---. However, I would like to say a little bit about the present position that Mr. Wiseman is holding as a part time job. I was the Chairman of EAGI when Mr. Wiseman was confirmed to be as part time job and that was back in 1996 or 1997, if I am not mistaken. The sealed document that have to come are very important issue here have --- way back and that is about fifteen (15) years ago and that case where that sealed document was involved, was dismissed completely and it is down for good. Now, let me go back to Congressman Torres and let me re-track all the statements and answers that he did during the time that Mr. Wiseman was nominated by the Governor. If I recalled correctly, he came out not only in the Legislature, but also in the medias, basically, that there are a lot of people, a lot of calls-have been calling his house and coming to his house to provide him information. When the public hearing was conducted, if I am not mistaken, again, there were only two or three opposing Mr. Wiseman compared to the pile of letters of support and petition that favors Mr. Wiseman. He went on to say, again, Congressman Torres, that if the Senate provided the public hearing then he himself will come up and present the sealed document. The hearing was conducted, completed, and then he turned around and asked us to --- that sealed document when he already promised the people that he himself would provide that document. We have to take a look at this and try to waive this, Mr. President, because Congressman Torres probably has different reasons against Mr. Wiseman. Take a look and --- all these the Bar Association, Chamber of Commerce, Attorney General's Office, Public Auditor's the petitions of the people from Rota, Tinian, Saipan and Northern Islands including Congressman Torres's son. Look at this. Now how are we going to deny this. Where are we going to base ourselves in denying this --- to Mr. Wiseman? Thank you.

The Chair recognized Floor Leader Reyes.

Floor Leader Reyes: Let me just say that I respect the positions of my good colleague and my good friend on the nomination of Mr. Wiseman. As you know, I believe --- those believe and I still do believe that the person is innocent until proven guilty. It is not the other way around. In this case, we are like any judge, like a regular judge. We weigh the allegations made and we are trying to find the facts with all the allegations being made. During the hearing, I asked Mr. Wiseman if he had done any of the allegation made, he said that he had not and I am satisfied that he had not. Also, with reference to the issuance of the sealed envelope he had expressly given his authority to let us open the sealed envelope if the court will allow. Later I found out through a correspondence, through a letter, and through discussion with members that the Judge has not granted authority to open the sealed envelope. Later I found out that the sealed envelope is a disciplinary action brought against Mr. Wiseman to the Bar Association. This is not a case involving a criminal or a civil case against Mr. Wiseman. It is a disciplinary complaint. We have heard the Attorney General expressed that this sealed envelope is a matter that has already been disposed by the Court. It has been cleared. I believe and I have expressed this to the members and even in the public hearing that it is unfair to try to question a person's integrity because we are not opening up a case that has already been disposed by the

court. It is not necessary to again, re-accused Mr. Wiseman of all those allegation made against him in the sealed envelope when this was already handled by the court. I respect what was done. This is democracy and the democratic system of government protects the innocent. So, members, it doesn't matter how many allegations are made. We sit here to judge him-the process of judging Mr. Wiseman. We have to make sure also that we are armed with factual information to make that decision. What's going, I have not seen that. I am not convinced beyond reasonable doubt that the allegations made against Mr. Wiseman are true and factual. It is our responsibility to be fair, every one of us. It is our responsibility to be fair and impartial. We should not sit in judgement at any allegation and try to convict a person who has not been proven guilty beyond a reasonable doubt. So, with this, Mr. President and members, again, I remind you that the work load is tying up in court because we have not acted to provide the judiciary with the judge vacant position that they need. They can all go on forever. The governor has nominated an individual for the position and we can deliberate until hell breaks loose. It is not going to help the workload in the judiciary. I am just as concern as everyone about putting a person in the position that is competent, able, beyond integrity, question that we need to be also concerned and I feel that the Chairman of the EAGI had conducted the public hearing that is necessary to ensure that. We are provided with all the information to make the decision we have done and I hope that everyone would vote his or her conscience. Make sure that whatever we decide on, we live by that decision. We are expected to make difficult decisions, but this is the position we are all elected to do. Sometimes decisions that we make are not popular, but as long as that position is right, we should make that decision. Thank you.

The Chair recognized Senator Adriano.

Senator Adriano: Mr. President, I guess the only obstacle that committee had during this deliberation, since the appointment on the Honorable Special Judge David Wiseman, is the seal document and that seal document, Mr. President, we passed in the public hearing several weeks ago. The Attorney General stated that when a document is sealed then there's no case against that person. So, the seal document against Mr. Wiseman, the committee found it unnecessary to pursue that. So, during the deliberation, we had about eight hundred supporters that came in and one of those supporters is the father of our good Senator Villagomez. So, with that, Mr. President, I ask that we move now. Thank you.

The Chair recognized Vice President Villagomez.

Vice President Villagomez: Thank you, Mr. President. I agree with the Chairman that my dad, Manuel Seman Villagomez, did submit to the Committee on EAGI a letter of support for the confirmation of Mr. Wiseman. I know that my dad is a close friend of Mr. Wiseman and his family. I have to take a position, Mr. President, not because I want to antagonize Mr. Wiseman and his family, or to put down his position as an attorney. In fact, I have taken a position since day one that I was just going to let it go and support his confirmation. At one time, I was thinking whether I should abstain from voting due to a conflict of interest. I had discussed the conflict with Mr. Wiseman and he said I should not worry about a conflict of interest. At the public hearing, Mr. Wiseman promised that he would authorize us to see the sealed document. I stated that I would vote on the outcome of the sealed document. I was not able to see the sealed document in question; therefore, I am not ready to support Mr. Wiseman's confirmation. I have taken this position not to be an obstacle to the confirmation of Mr. Wiseman but my conscience will not let me support him without first seeing the document in question. The eight members have pointed out that they are ready to support the confirmation of Mr. Wiseman. I am saying without reviewing the sealed document, I cannot honestly cast my support for Mr. Wiseman, but I will be the first to congratulate Mr. Wiseman for being the next judge, because I know that eight of the nine members of the Senate have signed the Standing committee Report and I know that eight of the nine members of the Senate will be voting for the confirmation of Mr. Wiseman. Thank you.

<u>President Manglona:</u> If there's no other member to make a statement, then we are ready to cast our votes on Senate Committee Report No. 12-29 on the nomination of Mr. David A Wiseman. Senate Clerk, call the roll please.
