The Senate of the Twelfth Northern Marianas Commonwealth Legislature, Third Day, Fourth Regular Session, 2001, was called to order at 2:00 p.m. in the NMC Campus Rm. C Tinian, MP 96950.

The Honorable Paul A. Manglona, President of the Senate, presided.

<u>President Manglona:</u> Before we begin, let me just say a few words. It is always nice to be on our beautiful island of Tinian, and since this is our First session since the great tragedy in New York and Washington D.C., where thousands of lives were lost and millions of dollars and damages were buried. I believe that everyone realizes that our freedom, not only in the US, but also in the entire world is now being threatened. I would like to ask the members to remember in our prayers this afternoon the victims and their families. Floor Leader Reyes is excused for today's session and the Chair would like to appoint Senator Adriano to be the acting Floor Leader.

A moment of silent prayer was observed.

The Senate Clerk called the roll and eight (8) members present and Senator Pete P. Reyes was excused.

President Manglona: With eight members being present, we have the necessary quorum to conduct today's session.

The Chair recognized Senator Dela Cruz.

Senator Dela Cruz: Under Governor's Communication No. 12-874, I just want to comment again on this particular action by the Governor, Mr. President. I am very, very, sad to find out that the Governor vetoed our one million dollars for the hemodialyses here in Tinian and likewise for Rota. And I just can not comprehend why the Governor can not fill the need for these two islands to make the lives of our hemodialyses patients here even more convenient. I am working very hard to try to identify funds for these particular programs, and I am a little frustrated to know that this type of service is not extended to the island of Tinian and Rota. Mr. President, it all goes down to the quality of life, and if you understand what these patients are going through, I am pretty sure that you will agree with my statement today. I do understand that under the constitution, he has the power to do this, but we are just hoping that he can be a little bit more sensitive to the patients undergoing the hemodialyses on the islands of Tinian and Rota. Thank you, Mr. President.

The Chair recognized Senator Atalig.

<u>Senator Atalig</u>: Thank you, Mr. President. Likewise, Mr. President, I am very disappointed with the Governor's line item veto of section 7, for the First Senatorial District and the Second Senatorial District. And, if I am in order, Mr. President, I would like to move for an override of this line item veto.

Senator Adriano: You are in order, and I second that, Mr. President.

<u>President Manglona:</u> We have before us a motion which had been seconded to override House Bill No. 12-374, CS1, SD2, and the provisions that were item vetoed by the Governor.

Senator Cing: Thank you, Mr. President. Before we entertain the motion for the override, I would like to know the reasons for the override.

<u>President Manglona:</u> The message from the Governor is numbered 12-874, and the members should have copies of it. Senator Adriano, would you like to respond to the question by Senator Cing?

Senator Adriano: The veto message, Mr. President, according to the Governor is that the expense of around \$1 million will be diverted for Tinian and Rota dialyses project will be cost saving more in terms of the funding. I

believe, Mr. President, that you saw my comment on the previous day with Marianas Variety. And the veto message, Mr. President, is just an excuse to get that project out and put it on Saipan. But putting it this way, Mr. President, we pay our people to go up to Saipan to watch our people. We pay our patients to stay on Saipan, while they are staying in Tinian and Rota. I believe it is not fair and we should get this funding and build our own dialyses center on Tinian and Rota. At the same time, Mr. President, with the 25% each for Rota and Tinian on federal funding that would be exhausted if we do not use that fund. I believe that is also an excuse from the Governor to get away with this veto message. Thank you.

President Manglona: I understand that when you refer to federal funding, you mean the Federal Highway funding.

Senator Cing: I am satisfied with the motion to override, Mr. President.

The Chair recognized Vice President Villagomez.

Vice President Villagomez: Guaha iyok-ko concern, Mr. President, on the Governor's Communication regarding his reasons for the veto. He pointed out that the section regarding dialyses was disapproved because on section 5 of the bill the First Senatorial District and Second Senatorial District, through a local delegation resolution, appropriated that one million each necessary for the new Rota and Tinian dialyses figures concern, Mr. President. We are just going into the fiscal budget that we are going to be addressing today. I appreciate the concern that the members of the Senate did not cut public safety and public health this time on the CNMI funding. But, going back to the Second Senatorial District on Tinian, it is recommended that public health be cut again by \$443,000. Rota on Public Health has been cut by \$322,000. So, I am not sure where our priority is here. We're going to vote on the override because the Governor is not going to give us the \$1 million, but then again it goes back to our own allocation to the Senatorial District and cut half of what the Governor vetoed. I need a direction from the Senate, Mr. President.

The Chair recognized Senator Dela Cruz.

Senator Dela Cruz: Mr. President the citation that Vice President Villagomez is referring to is the page that is not yet before us for deliberation. I am going to make an amendment to that particular page that his referring to. I do not agree also that there should be a cut on the Department of Public Health here in Tinian, likewise in Rota. So, back to the governor's message, we do understand clearly that we can take out a million dollars out of the 11.5 that is left over on our CIP here. But, let us not forget that those money are earmarked also for other needed capital projects and we found out that the Senate have real money and we're talking about real money here, the \$25 million. That is why we have decided to try to pull a million-dollar each for our hemodialyses in Rota and Tinian. Just like I mentioned earlier, this project is badly needed here. We are talking about quality of life; we are talking about people that are not functioning properly because of hemo problem. So, it all boils down to the quality of life here. Our patients here are being displaced unnecessarily, and if we do not start today then we will never finish this project and I'm very, very, frustrated with our Executive Branch for not allowing us to share with this project. Thank you, Mr. President. I am ready to vote.

The Chair recognized Senator Atalig.

Senator Atalig: I would like to further my motion for the override. Also, on page 3, for the Federal Highway for the First Senatorial District, Second Senatorial District and Third Senatorial District.

Senator Adriano: I second that. If I am in order, Mr. President, perhaps maybe we can launch on this override any line item veto that the Governor did and that appropriation bill is override in its entirety. Thank you.

The Chair recognized Senator Cing.

<u>Senator Cing:</u> I have one simple question, Mr. President. Did our legal counsel go over the item vetoes and see if we have the right, by the Constitution, to override Mr. President? If it is so, then let us proceed with the move.

<u>President Manglona:</u> I believe that it is properly done. The Governor has the authority under the Constitution and if I am mistaken, the Legal Counsel can indicate so, but I think that the Governor vetoed the section properly.

Senator Guerrero: Thank you, Mr. President. I think that the message of the Governor is quite clear. My concern here is that the original plan was to make CHC have a bigger facility for patients that go through hemodialyses, and the plan that was done, as I understand, was through matching fund by the federal government. When we, if I recall during our last session, passed the CIP project, none of us came to question whether to do oral amendment of providing one million for Tinian and Rota. Was there any intervention of the project that was already done and has completed the design? In fact, that design is ready to be bid it out and that was one of the concerns because of the federal matching for CHC. We never questioned when we did the oral amendment, and I voted for the one million for Rota and Tinian. I supported Rota, but it never came to us. None of us ever questioned whether there was a matching fund that was already planned and provided for by the Federal government to match the amount of money needed for the dialysis expansion of CHC, Mr. President. In good faith, while I support, I also would like to have my colleagues understand that the crisis that is happening now, affects the whole world including the CNMI. Whether we pass this budget or whether we override the Governor's veto, my concern is, if and when the Governor, assuming he resubmits the actual resources expected for Fiscal Year 2002 which I'm definitely sure is inclusive of CIP even though it is guaranteed under the Covenant, with what has happened in the States, all the money has been given to the federal agencies to assist in the rescue and to airport security that's needed in the world. Right now, before anybody vote for second I will abstain from voting on any increase project. I am very scared that whatever budget we will pass today, one, definitely, the house will not concur. Two, the total package of the budget will definitely, I will guarantee, that definitely it will take the entire budget to the final, Mr. President. Thank you.

President Manglona: Thank you, Senator Guerrero. We are back to the motion offered by Senator Atalig.

Vice President Villagomez: I would like to get a clarification on the motion. The motion to override....

<u>President Manglona:</u> The motion is to override the section item vetoed by the Governor. Two sections, the \$1 million each for Rota and Tinian and the other section is on the subject of the Federal Highway funding--providing the earmarking of the Federal Highway funds to 25% to Rota and 25% to Tinian on an annual basis. So, those sections were vetoed, and we are voting on the two sections that were vetoed.

<u>Vice President Villagomez:</u> Can I suggest that we vote on per line item veto? There is more priority on the concern on the dialysis than on the highway funds. Maybe the House will be willing to override on the dialysis section.

President Manglona declared the Senate recessed at 2:20 p.m.

RECESS

The Senate reconvened at 2:21 p.m.

<u>President Manglona:</u> We are back to our plenary session. Senator Atalig would you reconsider your motion and let us handle the override on item veto?

Senator Atalig: Thank you, Mr. President. I will withdraw my motion on the Federal Highway percentage, and we will just go ahead and concentrate on the hemodialyses.

<u>President Manglona:</u> Is there any comment on the motion to override Section 781 regarding the First Senatorial and Second Senatorial District for the dialysis? Is there any further discussion?

Senator Dela Cruz: Of the \$2 million under the \$Utilities, \$426,000 will to go to Page 2 of the Summary, item (f). The Second Senatorial District's total figure should reflect \$16.5 million. And on item (e) for the First Senatorial District, Rota, an additional of \$426,000. The bottom figure should also reflect \$16.5 million. Seven hundred thousand dollars should go to Northern Marianas College and that is on item (h), number 4. The rest should stay with CUC for payment. I so move, Mr. President, to replace pages 36 to 40 of the Budget worksheet. I provided already copies of the replacement.

<u>President Manglona:</u> Page 36 to 40 reflects the Second Senatorial District budget break down, and let us clarify this. So, the First Senatorial District break down is not much different.

Senator Atalig: Further clarification on the break down, Mr. President. For Commerce, I would like to add \$100,000, and for Public Health \$225,901, and, also, Lands and Natural Resources \$100,000 for operation. Overall, that should be \$425,901. Thank you.

President Manglona: With that, is there any discussion?

The adoption of the amendment as offered by Senator Dela Cruz carried by voice vote.

President Manglona: We are back to House Bill No. 12-404, SS1, as amended.

Senator Maratita: Si Yu'us ma'asi, Mr. President. <u>President Manglona:</u> The reasons why the Chairman summarized the motion—and let us have the legal counsel word the amendment. But, that is correct. The motion is for First and Second Senatorial Districts. Is there any further discussion?

Floor Leader Adriano: I yield to my good colleague, Senator Maratita.

Senator Atalig: Thank you, Mr. President. There are two points here that I want to make. As I reviewed the bill, I saw no compensation for the commission. That is one area I see and probably, it is because of our crises. And, number two, composition of the commission. I do not see Tinian and Rota being included in here. I do not know if I can make an oral amendment so that we can include Rota and Tinian also in the composition of the committee. It is very essential and important that one from Rota and one from Tinian should be part of this commission. I do not know if I am in order.

President Manglona declared the Senate recessed at 2:50 p.m.

RECESS

The Senate reconvened at 3:10 p.m.

<u>President Manglona:</u> Let us resume with our session. We are still discussing Senate Bill No. 12-127, and Senator Atalig has oral amendment to offer.

Senator Atalig: Thank you, Mr. President. I would like to offer an oral amendment. On page 1, line 20, after the word "act" delete the (.). On page 2, line 4, delete "13 members", and "seventeen (17) members". Also, I would like to add new subsections for additional members, one member from each Senatorial District, Rota and Tinian, and also to include the Speaker of the House and the President of the Senate. Also, after line 32, add a new subsection to read, "(d). "Commission members shall be compensated pursuant to 1 CMC 8247".

Senator Guerrero voiced, "second".

President Manglona: Is there any discussion?

<u>Vice President Villagomez:</u> Can we further make an amendment on the number of members so that we do not have to wait to get all the 17 members to organize?

<u>President Manglona:</u> Is there any further discussion?

<u>Vice President Villagomez</u>: I just want to comment on the communication, Mr. President. We are in a tight period especially after the crisis. I just want to point out the SEGC, the Strategic Economic Government Control have been very supportive and have been working without any compensation. They have done some recommendations over to the Legislature. I just want to point out that one of the recommendations was the fuel tax. And, after the recommendation we finally got it going again, but the recommendation came from the SEGC. I hope that when we created this task force, we were mindful of their recommendations because I don't think we need anymore commissions. If we want to create a commission and to be compensated for their meetings, we have to make sure that we at least try to address the recommendations that were submitted by the task force that we have created.

The Chair recognized Senator Atalig.

Senator Atalig: Can you clarify? I think Vice President Villagomez wants to include his amendment.

Vice President Villagomez: I just pointed out that SEGC....

<u>President Manglona:</u> On the amendment regarding the 17 members, do you want to make sure that at least fifteen members of the commission....

Senator Atalig: So, there is no clarification here as to the quorum.

President Manglona: On Page 2, line 4, it reads, "to be composed of no more than 17 members".

Senator Atalig: That is fine, 17 members. But how can we conduct business? How many members should be present to conduct business, or should we clarify that? Should we say that all the 17 members have to be present to conduct business? I need to clarify that.

Senator Dela Cruz: It needs two-thirds of that group.

<u>President Manglona:</u> So the word "seventeen" is okay. Let us say that they can conduct a meeting with nine members being present. I believe the amendment is clear to all the members.

<u>Vice President Villagomez:</u> Mr. President, so what happens if the appointment started out with or without eight (8) and the others were late? If after 30 days and there has been appointments of only nine members, what then?

President Manglona: That is a good point and I think that we should stick to the word "not to exceed 17 members". Even if we have 11 or 12, as long a there are more than 9, they still can proceed. So, the amendment would be to change the word "composed of 17 members" to "composed of not more than 17 members", the quorum of 9 members present, the amendment of one each from Rota and Tinian, and the amendment of subsection (d) regarding the composition. So, with that, is there any other discussion? Senate Clerk, call the roll please.
