President Manglona: Please, state your oral amendment.

Floor Leader Reyes: Can we have a short recess? I need to verify something with the Chairman.

<u>President Manglona:</u> Good evening. We are back to our session after an hour of recess. We are discussing House Bill No. 12-1, CS2, HD3, SD1. I recognize the Floor Leader.

Floor Leader Reyes: Thank you, Mr. President. I would like to make an oral amendment to the administrative provisions. On page 21, line 27, after the word "reserve", add "and pay", and after the word "purpose", add "and report it to the legislature." It should now read as follows: "...any such receipts in reserve and pay for this purpose and report it to the Legislature." I so move.

Senator Guerrero seconded.

President Manglona: Is there any discussion on the oral amendment?

There being no discussion, the oral amendment offered by Floor Leader Reyes passed by voice vote.

Floor Leader Reves: Mr. President, I would also like to make an oral amendment to the worksheets and copies of the corrections—excuse me, this is not an oral amendment but there are changes to the worksheets that are reflected in the copies that we have already passed out to the members. Pages 1 through 3 of the worksheets are changed as a result of my amendments, and also page 10 and 12. Mr. President, I made some changes by moving two FTE's from the Office of the Attorney General over to the Office of the Public Defender. The FTE's represent Assistant Attorney Generals from the Office of the Attorney General. Those changes resulted in the reduction of two ungraded positions in the Attorney General's Office and an increase of two ungraded positions in the Public Defender's Office. The changes associated with that appear on several pages and in pages 1 to 3 of the summary. Also, on page 7, there is an asterisk under the Lieutenant Governor's Office for the transfer-out of \$35,000 under the All Others Account. The asterisk indicates that this \$35,000 is for the Junior Statesman Program. I so move.

Several members seconded.

President Manglona declared the Senate in recess at 6:36 p.m.

The Senate reconvened at 6:38 p.m.

<u>President Manglona</u>: We are back to our session. We are still discussing House Bill 12-1, CS2, HD3, SD1. Floor Leader.

President Manglona declared the Senate in recess at 6:41 p.m.
