President Manglona: Floor Leader, my copy here has CS2, is that correct--House Bill No.12-39, CS2, SS1, CD1.

Floor Leader Reyes: Thank you Mr. President. The Committee Report is showing it here. We need to correct our Order of Business because it is still showing the CS1. Members, please correct your copy to CS2, SS1 and CD1.

President Manglona: Please have your records reflect such. Is there any discussion?

<u>Floor Leader Reyes:</u> Mr. President without objection, I just want to briefly discuss the changes that were made by the Conference Committee with the exception of the removal of the one thousand garments reserved for Tinian and Rota, each. That would be the most significant change that was made in House Bill 12-39. The rest of them were changes that were probably necessary. It was something that we did not take too much time to review and there was no significant interest except for the 20% on management level positions for Garment Industry, which was reduced down from 30 to 20, which the Committee at that time chose not to change. Other notable changes were insignificant enough to threaten the passage of the bill. I just want to make that statement for the record.

The Chair recognized Senator Dela Cruz.

<u>Senator Dela Cruz:</u> Mr. Chairman, also on the same provision on the 20% managerial for the U.S. resident reserves for our people here in the Commonwealth, I just want for the record, to mention that the salary imposed by this 20% requirement for managerial positions are only for U.S. residents. This is just to make sure that it is clear that we are not imposing a salary for the entire management of each particular business. I just want to clear that for the record so that the intent will be perfectly understood.

<u>President Manglona:</u> Thank you Senator Dela Cruz. Is there any other member. None? I believe we are ready to vote on House Bill No. 12-39, CS2, SS1, CD1. Senate Clerk, call the roll, please.

<u>President Manglona:</u> Let us resume our session. We recessed so that we can entertain legislation on CIP and other matters that the House was entertaining just before we went on a recess. Floor Leader Reyes, I believe you have those transmittals from the House with you. Can you please make the appropriate motion?

<u>Floor Leader Reyes:</u> We have House Communication No. 12-80 and House Communication No. 12-81 with reference to House Bill No. 12-229. It appears Mr. President, that I have House Communication No. 12-80 and House Communication No. 12-81 both being House Bill No. 12-229.

Senator Adriano: Correction on that, Mr. President. It is House Bill No. 12-228 and House Bill No. 12-229.

<u>Floor Leader Reyes:</u> Mr. President, may I continue? With reference to House Bill No. 12-228 and House Bill No. 12-229 and without objection, I would like to place these on today's calendar for Final Reading.

<u>President Manglona:</u> Floor Leader Reyes, earlier before the session, I spoke with you and some members regarding House Bill No. 12-228. I asked for the understanding of the members if we can have more time to review the legislation. The Senate will entertain this in its session tomorrow if there will be one or at the next available session. President Manglona: It has been moved and seconded. Is there any discussion? Senator Cing.

Senator Cing: Mr. President, I believe this is the bill that Tinian has been waiting on for a long time. We desperately need the amount of \$6.5 million for our Airport and Terminal on Tinian. But it seems like every time we place this out, either from the Senate side or from the House, there's always an obstacle blocking this particular bill. And Mr. President, for the information of the elected officials here in the Legislature, I mentioned earlier that we desperately need this because we have just opened the bid for this particular project. Now, the concern that Saipan will be getting almost all the amount of \$19 million balance of their CIP, Tinian will be getting \$12 million later on--I really don't see the logic of allowing to mingle with Saipan or Rota on this particular bill that will alleviate the situation on Tinian. If we go back to the record of the history of CIP or even contribution to the Commonwealth, Tinian has been sacrificed for a very long time, and every time Tinian needs the help from both Rota and Saipan, Tinian always get cut in the middle. There's never a time when Rota would allow Tinian to go forward, there's no time when Saipan would allow Tinian to go ahead by herself. And if we go back to history, you are going to find out that Tinian sacrificed itself for the whole Commonwealth. We even allowed loaning Saipan and Rota with our CIP. Now, every time we have this kind, we're going to get stuck here because we need also to accommodate si Fullano or si Fullana. I'm getting to the point also, Mr. President. This is too much already. I don't know what you are going to do with this bill, but we need the \$6.5 million. The bid is already opened. Thank you.

President Manglona: Thank you Senator Cing. Is there any other member?

Senator Adriano: Mr. President, I have a motion to defer House Bill No. 12-228 to the Committee. I so move.

Senator Dela Cruz voiced, "second".

<u>President Manglona:</u> We have two motions on the floor. Floor Leader Reyes, I assume that that with the original motion, we are consenting it to be withdrawn.
