<u>President Manglona:</u> By a vote of seven (7) yes and two (2) abstention, the Senate hereby confirms Mr. Victor B. Hocog to serve as a member of the Commonwealth Telecommunication Commission.

Senator Cing: While we're still with the Standing Committee Reports, I would like to voice the reason why I abstained from voting for the two nominees. I would like the record to reflect that on Standing Committee Report No. 12-39, which is the Governor's appointment of Ms. Rita Manglona to serve as MVA for Tinian-- my concern is that there are several Rita Manglonas on Tinian. I would like the record to reflect which Rita Manglona we are talking about. On Standing Committee Report No. 12-44, we discussed this on Rota concerning the qualification. I don't see the reason why Mr. Victor B. Hocog, a good reason, to be included here as Standing Committee Report No. 12-44 on today's session. I thought that we have resolved this before the session. Thank you.

<u>President Manglona:</u> On your first concern, which is Standing Committee Report No. 12-39, let me ask the Chairman of the Tinian Delegation to clarify the nominee's identification.

Senator Adriano: Thank you, Mr. President. On Standing Committee Report No. 12-39, the Governor's Special Assistant did not appear at the public hearing on Tinian, but through a telephone conversation, and this is not part of the record, Mr. Guerrero from the Governor's Office stated that this Rita Manglona is the former wife of Ignacio Quichocho, the former Mayor of Tinian. I have no problem recalling this nominee to further clarify who is the real Rita Manglona to serve on this board. On Standing Committee Report 12-44, which is Mr. Victor Hocog, the Rota Delegation made it clear that this should be placed on today's calendar and that is what the Chairman and the Committee signed for, for today's action. Thank you.

The Chair recognized Senator Guerrero.

Senator Guerrero: Thank you, Mr. President. I supported all the other Standing Committee Reports except for the Telecommunication Commission members. First of all, Josephine Deleon Guerrero Mesta is my niece, and that would be a conflict of interest. I want to be fair to everyone and I did not cast my vote. I abstained. Number two, in reference to Standing Committee Report No. 12-44, I had a discussion with the Chairman of PUTC of the House concerning the issue that Senator Cing brought up. And, as I understand it, there is supposed to be an amendment made to this provision. That is number two. And number three, I still feel that the law that created the Telecommunication Commission is too prohibitive and there are some constitutional issues that I am concerned with. Those are the three reasons why I abstained. Thank you, Mr. President.

The Chair recognized Senator Cing.

Senator Cing: Mr. President, let me clarify my position here. My intention is not to embarrass the Chairman and the Committee on EAGI. I only want clarification. If this Rita Manglona is the wife of former Mayor Quichocho, then let the record reflect that this is Rita San Nicolas Manglona and not Rita Aquininog Manglona or Rita Manglona Manglona. I would like the Chair to go ahead and put this on record that this is Rita San Nicolas Manglona that we are voting for. And the other one is on Mr. Victor Borja Hocog. I have nothing against this particular individual. If the Committee had decided that everything is clear, then I will go with that. I will change my position from abstention to a "yes" vote.

<u>President Manglona:</u> Senator Cing, are you asking to have the record reflect a change in your vote for Ms. Rita Manglona and Mr. Victor Hocog?

<u>Senator Cing:</u> Yes, if the findings of the committee is okay because during our discussion on Rota, we left it opened. I thought that we were going to discuss that further here, and to my surprise, we did not discuss that this morning. Then, it appears we are ready for vote and that is my concern.

Floor Leader Reyes: Point of clarification, Mr. President.

President Manglona: So, Senate Clerk, please have the record reflect the changes.

Floor Leader Reyes: This is for clarification. During the discussion on Rota, it's true that we discussed this and that the issue here is the qualification requirement which is a bachelor's degree of the candidate nominated by the Governor or equivalent related experiences. There's no definition as some of the members have expressed during the Leadership meeting in Rota and what criteria to use to measure the individual's qualification and what test to be administered to arrive at a conclusion. At that time, I made a statement that we have met two tests. The first test was the Governor's evaluation of the candidate when determining whether such a candidate is qualified to be nominated and then submitting the name to the Legislature for confirmation. The second test that I mentioned during that leadership meeting is the fact that the committee have met and decided that they will support the candidate after reviewing all the documents that were submitted. That, also, in my view, met that test. So the remaining test would be for the House of Representatives in its review of the candidate of Mr. Hocog to determine whether their committee and of course, thereafter, the entire body of the House of Representative would decide—whether that test also meet their satisfaction. And that is the reason why a decision was made to—and I thought a decision was made to go ahead and include this candidate through a Standing Committee Report for the Senate's approval. Thank you.

The Chair recognized Senator Dela Cruz.

Senator Dela Cruz: Let us not forget also that the law governing this Telecommunication Commission mandates that all five members should be confirmed in order, or should I say be in place, before anything can start. So that's also part of the reasoning behind making sure that we have a working commission rather than just coming in with piecemeal confirmation. On top of that, qualification area for Mr. Hocog, I think that thing can also be rectified at the Lower House because it is very specific on the bachelor's degree or equivalent. The only two bodies that are given the authority to define what is equivalent is the review process body, which is the House and the Senate as specified in the statute. Thank you, Mr. President.

Floor Leader Reyes: Mr. President, this is just a matter of clarification again. In order for a vote to be changed, I need to suspend certain section of the rules. With the member's indulgence, I would like to offer a motion to suspend Rule 10, Section 11. This is on the change of vote so that we can allow Senator Cing to change his vote.

Senator Dela Cruz voiced, "second".

Senator Cing: Thank you, Mr. President, but before we do that, I would like to yield for my good colleague here.

The Chair recognized Senator Guerrero.

Senator Guerrero: Thank you, Mr. President. The reason that I am concern is, Number 1, in yesterday's House session, the Speaker personally said that the issue on confirmation by the House is unconstitutional because of the provision in the Constitution that only the Public Auditor will have a joined confirmation. Therefore, I am concerned on that issue, too. Two, I personally met with the PUTC Chairman of the House and there were several amendments including the amendments to have Mr. Hocog qualified. Those are the concerns that I see. I hate to see that we have to come back again next week to make additional amendments regarding this concerns. I have been outspoken, saying that we should fix this law first before we make any further commitment, because we are assuming based on the statement that was made by the Speaker yesterday regarding the unconstitutionality of the law. I was quite surprised because we have legal counsels for both the House and the Senate and yet we went ahead with that provision and passed that law. Therefore, I still feel, for the record, that I should abstain even though with a conflict of interest, but I would like to see that in Standing Committee Report No. 12-44, is exactly what the intent is. The other concern I have is that everybody can have all the masters degree in the world, all the bachelors of art degrees in the world and, based on the law, they can be qualified. My concern is, are they technically telecommunication type commission that can do the function? It is not as simple as we think. We have made errors in placing commission members or board members and then we come back and start blaming them for their backgrounds. I want to make sure that this Telecom is precisely what we talked about during the public hearing. I asked if any of the members or those appointees have any knowledge on fiber optic cables and, for the record, they said no. I want to make sure that my position maintains that in order to have an effective Telecommunication--I don't care whether he has a masters degree or she has a masters degree, but if she doesn't know fiber optic cables and she doesn't know what the satellite does in communication, we're going to be back tracking. And we will back track and we will come back and amend the law again. I am deeply concern with this issue. My other concern is --- agreement between MTC and the government. Now, Verizon does that, have more than a million every year that we collect from the ---- fee. The law is very unspecific. I am concern and I will state my position, Mr. President, with the members' indulgence that I am not attacking personally. I'm just making sure that we have a Telecommunication Commission that will be very effective. Thank you.

The Chair recognized Senator Cing.

Senator Cing: Mr. President, if it is unconstitutional for the House to be included on these nominees, then I think we are still in order. Because even if the House does not want to accept this, it is our prime responsibility to vote on these nominees. I just received a note here, so can we have a five-minutes recess, Mr. President?

<u>Floor Leader Reyes:</u> Mr. President, with all due respect, and believe me Senator, I really respect that. I still have one more Standing Committee Report and I would like to do that before we go into recess if the members....

Senator Cing: I think that this is in line with the nominees also and that is the reason why....

<u>President Manglona:</u> I think that Floor Leader Reyes is referring to Standing Committee Report No. 12-45, that before we take a recess, we dispose of that Standing Committee Report. So, I guess, with your approval Senator Cing--can we delay that?

Senator Cing: That is the reason why, Mr. President, I am begging you. I would like to request for a five-minutes recess.

President Manglona: Five minutes recess.

The Senate recessed at 10:50 a.m.
