The Senate of the Fourteenth Northern Marianas Commonwealth Legislature convened in its Fourth Day, First Regular Session, on Wednesday, March 3, 2004, at 10:05 a.m., in the Northern Marianas College Library, Rota, Commonwealth of the Northern Mariana Islands.

The Honorable Joaquin G. Adriano, President of the Senate, presided.

A moment of silence was observed.

Additional amendment will include a new section as "Section 3" to read as follows: "Section 3. Third Senatorial District Appropriation. All interest from bonds not appropriated in Section 2 of this Act is hereby appropriated for capital improvement projects in the Third Senatorial District." All Sections thereafter should be renumbered accordingly.

President Adriano: We'll have the clerk correct that.

President Adriano: The motion has been seconded to that amendment. Floor Leader.

Floor Leader Mangloña: Short recess.

President Adriano: Short recess.
