In compliance with the Open Government Act, Senate President, Victor B. Hocog, issued a session call on August 08, 2019 that the Senate of the Twenty-First Northern Marianas Commonwealth Legislature will convene this open and public session. The notice, the official session call, and the session agenda was filed in the Office of the Senate Clerk; released to the media; and posted at the Entrance Halls of the Office of the Governor, the Senate and the House of Representatives, posted on the Commonwealth Legislature's website at www.cnmileg.gov.mp.

The Senate of the Twenty-First Northern Marianas Commonwealth Legislature convened its First Special, Second Regular Session, on August 09, 2019, at 10:20 a.m. in the Senate Chamber, Capitol Hill, Saipan, Commonwealth of the Northern Mariana Islands.

The Honorable Victor B. Hocog, President of the Senate, presided.

A moment of silent prayer was observed.

The Clerk called the roll, seven members are "present" and two "absent."

<u>President Hocog</u>: Thank you, madam Clerk. With seven members present, we hereby constitute the necessary quorum to conduct the Order of Business for today. And for the record, I would like to mention for Vice President Jude U. Hofschneider and Senator Paul A. Mangloña are hereby excused for today's session. Public Comments.

PUBLIC COMMENTS

President Hocog: Anyone from the gallery would to make any comments before we move on to our Order of Business? Recognized.

Ms. Agnes McPheters: Thank you very much, Mr. President and the whole Senate here. I am very thankful for having this session so that three of our trustees are in the agenda. And I urge this body to confirm them so that we can move on. It is very essential to have completed Board of Trustees we still have two more, but with these three, it will help us and make us feel much better that we are moving in the right direction. Thank you.

President Hocog: Excuse me, can you just state your name for the record?

No written or oral testimonies in opposition of the appointee were received by the Committee. Additionally, your Committee stated several recommendations, issues, and concerns to the appointee that are included in this report. Based on the overall assessment of Mr. Valentino's credentials, experiences, testimonies, goals for the department, and other relevant issues considered, your Committee is convinced that Mr. Valentino has the qualifications and leadership skills necessary to serve as a Member of the NMTI Board of Trustees. Mr. Mario Valentino was appointed by Governor Ralph DLG. Torres and Lieutenant Governor Arnold I. Palacios on April 8, 2019 to serve as a Member of the NMTI Board of Trustees. The appointment packet was forwarded to the Senate on July 9, 2019 and on July 9, 2019 the appointment of Mr. Valentino was referred to your Committee for consideration. The public hearing was conducted on July 31, 2019 here at the Senate Chamber of the Honorable Jesus P. Mafnas Memorial Building, Capitol Hill, Saipan. And during the hearing, certain recommendations, issues and concerns were raised for the appointee to address and look into when confirmed as a Trustee. And in conclusion, all required documents in conformance with Rule 8, Section 5 of the Official Rules of the Senate have been submitted to your Committee for review and consideration. Based on the submission of pertinent documents and testimonies, your Committee concludes that the appointment of Mr. Valentino to serve as a member of the NMTI Board of Trustees in accordance with 3 CMC § 12112. Therefore, your Committee consents the confirmation of Mr. Mario Valentino to serve as a Member of the NMTI Board of Trustees.
