The Honorable Acting President of the Senate, Karl R. King-Nabors presided.

Acting President Karl R. King-Nabors: Good afternoon everybody. I hereby call this First Day, Fifth Special Session to order. Today is July 31st, 2025, Thursday, the time is 3:05 P.M. in the afternoon. Here at the Vice Speaker Jesus P. Mafnas Memorial Building, Capitol Hill, Saipan. It's my honor to welcome all of you this afternoon. And before we proceed, I respectfully ask that all mobile devices be placed on silent mode and for the viewing public in today's session will be viewed on Cable TV, channel 23, Senate YouTube channel, the Northern Marianas Commonwealth Legislature Facebook page. And with that I'd like to ask for a moment of silence prayer.

Palacios and the constitutionally mandated ascension of then Senate President Dennis C. Mendiola to the Office of Lieutenant Governor on July 25th, 2025. Senator Mendiola was sworn in as our Lieutenant Governor. Accordingly, we are in receipt of his formal resignation from the Senate, which we will enter entertain in today's session. It is therefore the duty of this legislative body to reorganize the officers of the Senate and to move forward the remainder of the Twenty-Fourth Northern Marianas Commonwealth Legislature for the Senate. And at this time, we are going on to the election for President. The floor is now open for the election of President of Senate to serve for the remainder of the Twenty-Fourth Northern Marianas Commonwealth Legislature. I recognize Senator Manny Castro.
