6	was born on December 15, 1932, on the serene island of Saipan to her parents †Jesus Diaz
7	Deleon Guerrero and †Maria Sablan Deleon Guerrero who brought her to become the
8	caring individual remembered by all her loved ones; and
9	WHEREAS, Amparo Deleon Guerrero Tenorio was called to her eternal rest on
10	April 1, 2024; and
11	WHEREAS, Amparo Deleon Guerrero Tenorio shared a harmonious life indulged
12	in fond memories with her husband Jose Carlos Pangelinan Tenorio, and her children
13	Barbara A. Yamada; Juan L./Manuela A. Babauta; Richard A./ Marian A. Pierce; Francisco
14	Deleon Guerrero/ †Ursula L. Aldan; Pia Deleon Guerrero Aldan; Ramon A./ Missy A.

18	WHEREAS, Amparo Deleon Guerrero Tenorio studied meticulously and persisted
19	throughout her general education in different educational institutions including Saipan
20	Kogakko and Findley School. During her time at Findley School she also provided teaching
21	services; and

1 WHEREAS, Amparo Deleon Guerrero Tenorio lived through the hardship brought 2 to the Northern Mariana Islands by World War II with her family as they helped each other 3 and worked hard towards sustainability and betterment; and 4 WHEREAS, Amparo Deleon Guerrero Tenorio began working as a purchasing 5 agent for the Trust Territory Government, a position in which she persisted and built her 6 vocational capacity for 16 years. After her service in this position, Amparo took on the 7 responsibility of being a stay-at-home mother and wife and catered numerous years of 8 nourishment and care for her family which she loved dearly; and 9 WHEREAS, Amparo Deleon Guerrero Tenorio provided the Commonwealth of 10 the Northern Mariana Islands with over 25 years of volunteer service as one of the founders and members of the Commonwealth Health Center's Volunteers Association, during her 11 12 membership she devoted countless acts of service to patients and families as well as 13 thousands of hours towards raising funds for hospital equipment; and 14 WHEREAS, Amparo Deleon Guerrero Tenorio, aside from her work as a stay-at-15 home mother and volunteer for the hospital, has also attained accomplishments to include 16 being the Grand Marshall for the 2003 Liberation Day Festivities and Lady of the Year 17 from the Saipan Chamber of Commerce; 18 NOW, THEREFORE, BE IT RESOLVED that the Senate of the Twenty-Third 19 Northern Marianas Commonwealth Legislature at this moment joins the people of the 20 Commonwealth of the Northern Mariana Islands in honoring the distinguished life of the 21 late Amparo Deleon Guerrero Tenorio for her noble acts of service to the Commonwealth 22 healthcare system and community; and 23 BE IT FURTHER RESOLVED that the President of the Senate shall certify and 24 the Senate Legislative Secretary shall attest to the adoption of this Resolution, and 25 thereafter the Senate Clerk shall transmit certified copies to the bereaved family of Amparo Deleon Guerrero Tenorio; the Honorable Arnold I.
