1 WHEREAS on Saturday, March 22, 1986, Pope John Paul II announced the
2 appointment of the Most Reverend Anthony S. Apuron, Bishop of Agana, to be
3 the new Archbishop of the Archdiocese of Agana; and

4 WHEREAS the Archdiocese of Agana includes the Diocese of Chalan Kanoa,
5 which serves the people of the Northern Mariana Islands; and

6 WHEREAS Bishop Apuron will succeed the much revered Archbishop
7 Felixberto C. Flores, who passed away late last year; and

8 WHEREAS the Most Reverend Anthony S. Apuron was ordained a priest in
9 1972; and

10 WHEREAS the Most Reverend Anthony S. Apuron was named rector of the
11 Dulce Nombre de Maria Cathedral in 1978; and

12 WHEREAS Archbishop-designate Apuron was ordained as auxiliary bishop
13 in February of 1984; and

14 WHEREAS the Most Reverend Anthony S. Apuron will be the second
15 Chamorro archbishop; and

16 WHEREAS upon becoming Archbishop, Bishop Apuron will be one of the
17 youngest archbishops in the world; and

18 WHEREAS Archbishop-designate Anthony S. Apuron is very well-versed in
19 theology and the liturgies of the church; and

20 WHEREAS the people of Guam and the Northern Mariana Islands are proud
21 of the achievements of Bishop Anthony S. Apuron and are delighted at his
22 appointment to be Archbishop; and

1 WHEREAS the Most Reverend Anthony S. Apuron has dedicated his life to
2 improving the spiritual fellowship of his people; now, therefore

3 BE IT RESOLVED by the Senate of the Fifth Northern Marianas
4 Commonwealth Legislature that the Most Reverend Anthony S. Apuron be and
5 hereby is congratulated on his elevation to be Archbishop of the
6 Archdiocese of Agana; and

7 BE IT FURTHER RESOLVED that the President of the Senate shall certify
8 and the Senate Legislative Secretary shall attest to the adoption hereof,
9 and copies shall thereafter be transmitted to Archbishop-designate
10 Anthony S. Apuron; Bishop Tomas A. Camacho; Pope John Paul II; the
11 Honorable Ricardo Bordallo, Governor of Guam; the Honorable Carl
12 T. C. Gutierrez, Speaker of the Guam Legislature; and the Honorable Pedro
13 P. Tenorio, Governor of the Commonwealth of the Northern Mariana Islands.






