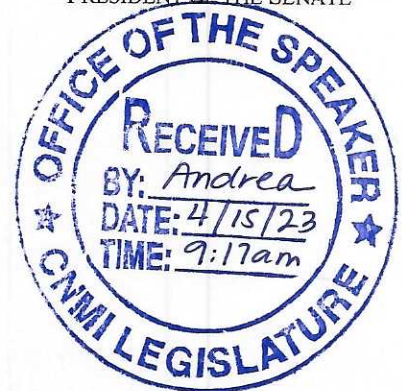


Subject: Conference Committee Meeting: House Bill No. 23-31, HS1, SS2
